

# Briefe aus Gefängniszelle 7: Im Jahre 2003 in einem kanadischen Hochsicherheitstrakt geschrieben Von Ernst Zündel

(übersetzt aus dem Englischen "Setting the Record Straight")

"Mein wirkliches Verbrechen ist, daß ich in einer jüdischen Welt Nichtjude bleiben wollte. Mein Verfahren würde schon lange beendet sein, würde ich mich nur entschuldigen und vor Zion zu Beden werfen. Im Augenblick stehe ich noch – na, nicht ganz; ich liege entweder auf meiner Pritsche in der Gefängniszelle oder bin über meinen kleinen Ecktisch gebeugt. Ich size auf meinem "Hocker" aus Büchern und Gerichtsdokumenten, da mir kein Stuhl erlaubt ist. Ich verbrauche meine immer kleiner werdenden Bleistiftstummel, um an meine Freunde zu schreiben, an öffentliche Dienststellen oder Politiker. Ich zeichne kleine Skizzen mit Bleistift für die guten Menschen, die [meiner Frau] Spenden geben, sodaß wir die teuren Anwälte bezahlen können, die tüchtig und tapfer in drei Ländern und auf zwei Kontinenten um meine Rechte kämpfen."

So schrieb der deutschgebürtige Ernst Zündel in 2003 in einem kanadischen Gefängnis, wohin er in Ketten geschleppt wurde, nachdem man ihn in Tennessee, USA am hellen Tag gefangennahm und entführte.

Zwei Jahre lang hielt man ihn in Isolationshaft in einer eiskalten, fensterlosen Gefängniszelle, in der das Licht nie abgeschaltet wurde – ohne daß man ihn jemals angeklagt und schon gar nicht verurteilt hat. Dann wurde er am 1. März 2005 in einem teuren aber geheimen Privatflugzeug nach Deutschland verschleppt, wo er als "Gedankenverbrecher" in einer anderen Zelle jetzt auf ein schweres Urteil wartet.

Sein "Verbrechen"? Er zweifelt den Holocaust an!

It covers the two Great Holocaust Trials (1985 and 1988) and the all-important, ground-breaking Leuchter Expedition to Auschwitz that put the nail in the coffin of the Holocaust Myth. It pays tribute to the many Zundel volunteers who helped make this breakthrough come true. It highlights subsequent information outreach efforts which triggered ever more brutal and stringent measures by the beleaguered Holocaust Lobby and, in the end, led to the use of legal and finally physical terror against Ernst Zundel, ending in his tragic political kidnapping in 2003 under the infamous Patriot Act. This DVD should not be viewed in one sitting. It is fast-paced and packed with information and emotion that can't be absorbed in one viewing.

**The 14-minute DVD** is a brief, compact introduction to the dramatic results and political significance of the two Great Holocaust Trials. It is a handy overview to give to journalists, teachers, neighbors, friends – even elected representatives who might be pressed for time. It is best used as a “foot-in-the-door” tool for someone still steeped in traditional Holocaust lore. It features a former Associated Press reporter, Michael Hoffman III, in conversation with Ernst Zundel.

**The 38-minute DVD** features the exciting, highly dramatic Leuchter Expedition into still Soviet-dominated Poland to take samples from the Auschwitz facilities to test them for the alleged poison, Zyklon B, claimed to be used in “gassings”. A quick introduction to the energetic Zundel activism that substituted unsubstantiated “survivor stories” with forensic findings solidly grounded in science.

**The 126 minute DVD** features informal debriefings at the historical Zundel-Haus in 1985, in addition to the Leuchter Expedition. This video was especially prepared for the Iranian Conference and was personally given to the President of Iran, Dr. Ahmadinejad.
