**To our friends around the world -**

It is invigorating to start a new year with such astonishingly good news! Just now, I had a call from Yvonne, Dr. Faurisson's sister, to wish me a Happy 2007. She told me of her brother's comment, quoted here from memory: “Who would have thought at the beginning of 2006 that we would end the year on such an upbeat note?” Indeed, who would have? Is this the beginning of the end of our nightmare?

I am speaking, of course, of the Revisionist Conference in Iran, titled “Review of the Holocaust: Global Vision” that was held on December 11-12 and brought us a virtual media tsunami! In my opinion, in the entire history of Revisionism, there has never been an event coming out of the blue to cause such a positive jolt to propel our Truth Campaign forward!

I must confess that, at first, I did not expect this Iranian conference to lead to anything significant. I realized early that there was serious dissent within our ranks about the direction the conference should go, pressure from Holocaust Lobby quarters on the Iranian as well as various Western governments not to allow it, and lots of negative feedback all around. There was talk about bribes offered to abort the event. Many Revisionists who should have been there were either in prison, without a passport, or too scared to risk life and limb to travel to Iran. I was invited; I was still free; I had a valid passport and certainly would have liked to have gone, but serious concerns, some of a personal nature, got in the way. My son's condition was still fragile, and of course I did not want to imperil Ernst's situation even more, should I be taken out of the ring by getting arrested or refused re-entry into the US, as I was warned might happen.

I was very apprehensive, especially when, at the last moment, I was told that Bradley Smith, who was to be the carrier of my DVD documentary, was “too ill to travel” – which turned out to be malicious disinformation! At literally zero hour, I FedEx'd the DVD to Britain and asked Lady Renouf to get it into the right hands. As you can see, she took that literally - that photogenic beauty in our ranks, dressed up to play the part, succeeded in handing the Iranian president personally a copy of the Zündel Saga! You see how it paid off that I dumped the fraudulent “Hollywood film company” and did my documentary my way?

As to the conference itself – over 30 speakers and representatives from 67 countries attended – and the Iranian hospitality was reported to be first-class! Israel Shamir, an Israeli dissident

journalist, conveyed some of the flavor of this astonishing event when he wrote:

### *They met in Teheran*

*The Teheran Holocaust Conference caused quite a storm in the world media. One might ask: what's so special about that? There are so many holocaust events and holocaust museums and holocaust festivals, sometimes attracting presidents and prime ministers galore, so why did the Teheran (or Tehran) conference draw so much attention and criticism; why were the White House, Frau Merkel, the Vatican and the EC willing to take some valuable time to condemn this small gathering in far-away Iranian capital?*

*The difference is that all other gatherings were amen-sayers accepting the official version provided by Jewish organisations as the Holy Writ given to Moses on Mt Sinai. The official version of the Holocaust goes even farther than Writ: you may deny Immaculate Conception and Resurrection of Christ, you may besmirch Muhammad, but if you have any doubt that six million of Jews were executed by Germans in gas chambers within the framework of a total annihilation project you may find yourself in a jail in Germany, Austria, France, Switzerland and other 'free' countries. The Teheran Conference is the first one ever to deal critically with the sad events of the World War Two. (...)*

*Every freedom-of-speech loving liberal should regret that even important historians are not free to express their views on the Holocaust issue. David Irving is in jail, and this week German Rudolf was taken to a German court chained hand and foot after he was deported from the US for publishing his book doubting the official Holocaust dogma. Such a taboo clamours to be broken. (...)*

*Though the world media has churned out thousands of news items connected to the Conference, they were practically identical, containing local official condemnation and the predictable Jewish reaction. Practically none of the reports and talks given in Tehran ever made it to the mass media. The conference participants were smeared as 'racist antisemites' though there were quite a few Jews, venerable Rabbis in their black hats and long coats, revolted by the Zionist privatisation of the World War tragedy.*

*If anything, the conference proved that the holocaust dogma is a basic tenet in the great world-embracing brainwashing machine of mass media described by Noam Chomsky as “the manufacture of consent Stalin could only dream of ... whose discipline, and uniformity, are really impressive”. This media syndicate is the*

enemy of free people everywhere, and it carries on a relentless war against Iran and other independently-minded nations. (...)

Shamir then cites his friend and countryman, Gabriel Ash, who wrote in the Dissident Voice:

*"The Holocaust is the most effective weapon in the hands of those bent on manufacturing a 'clash of civilizations.' The 'lesson' of the holocaust is good enough to justify the NATO bombing of civilian targets in Yugoslavia, the genocidal U.S. occupation of Iraq, Israel's massive bombing of Beirut, a future nuclear war against Iran, etc. The [Holocaust] is the ideology par excellence of Global Apartheid. The [Holocaust] acts like a quirky and capricious divinity, rejecting one comparison here, accepting an equally valid or invalid one there. It is a partisan divinity, a god that always blesses 'us' and curses 'them,' even as it simultaneously demands to be worshipped by all humanity and in the name of all humanity." (...)*

Shamir goes on to say:

*The Holocaust is indeed well integrated in the prevalent discourse as a justification of [rich and powerful] minority rights over [oppressed] majority needs. But its success and its integration show that the mass media machine is well integrated and concentrated in philosemitic, mostly Jewish hands. The occupation of Palestine by Jews is painful, but it is not more harmful than this captivity of free discourse.*

*These men can wield their lethal machine with the ease of a Jedi wielding his sword. They compare Ahmadinejad to Hitler, and forbid comparison of Israel to the Nazis, they besmirch Vladimir Putin as a KGB assassin and do not even report that Israeli courts of law consider assassinations legitimate, they made a spot on Monica Lewinsky's dress more important than the rivers of blood poured by George Bush, they turned respectable American scholars Mearsheimer and Walt into skinheads, and now they ferociously attack James Baker for his disengagement plan. They can bloody well do anything. They are almost omnipotent.*

*Our friend James Petras recently published an impressive book on Israel's Power in the US. But Israel's power is just a mere reflection of real Jewish power in the West, which is based – not on Israeli tanks, but on Jewish think-tanks; not on Israeli nukes, but on Jewish news. Unless the Jewish hold on discourse is broken, the West will keep sending its sons to follow the Pied Piper of Hamelin to the streets of Baghdad and to the hills of Lebanon.*

*Iranians came to conclusion that there is no chance to come to agreement with this world-wide Jewish media syndicate. There is no way to get to peace terms. One has to fight back, attacking the deepest sacral dogmas of their control. If this dogma were to collapse, the Jewish hold on discourse would be broken and the Jewish state would disappear just as the USSR did, said President Ahmadinejad. (...)*

*This is the reason why Iran hosted the conference. Nobody – and I do mean nobody, including British, French, American, German, Russian leaders – really cares about the victims of a war long past, Jewish or otherwise; they pay tribute to the Holocaust as nations pay tribute to their vanquisher.*

*Iran has refused to pay this tribute; when will the rest of you follow their courageous example?*

As far as I can tell, the presentations at this conference were top notch. I really savored those given in German. I hope that a book will be published before long that will make available to thousands of readers the flavor of this extraordinary event. Here I can only give you some quotes:

**Dr. Faurisson at his best!**

*"President Ahmadinejad has used the right word: the alleged 'Holocaust' of the Jews is a 'myth', that is, a belief maintained by credulity or ignorance."*

*"In the butchery that is a war, people suffer. In a modern war, the belligerent nations' civilians at times suffer as much if not more than their soldiers. During the conflict that, from 1933 to 1945, pitted them against the Germans, the European Jews thus had occasion to suffer but infinitely less so than they dare to assert with such a nerve. Certainly the Germans treated them as a hostile or dangerous minority (there were reasons for that), and against these people the Third Reich authorities were led to take, due to the war, more and more coercive police or military security measures. In certain cases those measures amounted to placement in internment camps or indeed to deportation to concentration or forced labour camps. Sometimes Jews were even executed for sabotage, spying, terrorism and, especially, for guerrilla activities in favour of the Allies, mainly on the Russian front, but not for the simple reason that they were Jewish. Never did Hitler order or permit the killing of a person because of his or her race or religion. As for the figure of six million Jewish deaths, it is a pure invention that has never been substantiated despite the efforts in that regard by the Yad Vashem Institute of Jerusalem."*

*"In the face of the formidable accusations thrown at a defeated Germany the revisionists have said to the accusers:*

*1) Show us one single document that, in your view, proves that Hitler or any other National-Socialist ordered and planned the physical extermination of the Jews;*

*2) Show us that weapon of mass destruction which, as alleged, was a gas chamber; show us a single one of them, at Auschwitz or elsewhere; and if, by chance, you claim that you cannot show us any because, according to you, the Germans destroyed the "murder weapon", provide us at least with a technical drawing representing one of those slaughterhouses which, as you say, the Germans destroyed and explain to us how that weapon with such a fabulous killing performance had been able to work without bringing on the death of either those who ran it or their helpers;*

*3) Explain to us how you have arrived at your figure of six million victims."*

*[I]n over sixty years, the Jewish or non-Jewish accusing historians have shown themselves to be incapable of offering a response to these requests. Thus they have been accusing without any evidence. That is what is called slander".*

*"Finding themselves on the ropes, the court historians have called on the law-courts to find against the revisionists, but, contrary to all expectation, it has sometimes happened that the judges have gone so far as to pay tribute to the revisionists' uprightness or to show their surprise before the sparseness or absence of the accusers' documentary evidence. Then, first in France and later in a number of other countries in Europe, these accusers have called for the passing of special laws to silence the revisionists. Here they have sealed their doom. To resort to special laws, to the police and prisons is to admit one's utter inability to use the arguments of reason, history and science."*

*"We are granted the privilege of witnessing, in this beginning of the 21st century, a serious calling into question of one of the greatest lies in history. The myth of the "Holocaust" may well be aglow with a thousand lights: in reality it is burning itself out. It has served to justify the creation in the land of Palestine of a warlike colony that has taken the name of "Jewish State" and endowed itself with a "Jewish Army". It imposes on the Western world the yoke of a Jewish or Zionist tyranny bringing itself to bear in all fields of intellectual, academic and media activity. It poisons the very soul of a great country, Germany. It has allowed the extortion from the latter, as well as from a good number of other Western countries, of exorbitant sums in marks, in dollars or in euros. It overwhelms us with films, with museums, with books that keep the flame of a Talmudic-style hatred burning. It makes it possible to call for an armed crusade against "the axis of evil" and, for this, to fabricate, on demand, the most shameless lies precisely in the pattern of the Great Lie of the "Holocaust", for there is no difference between Adolf Hitler's "weapons of mass destruction" and those of Saddam Hussein. It makes it possible to accuse nearly the whole world and to demand "repentance" and "reparations" everywhere, either for alleged actions directed against "Yahweh's chosen people", an alleged complicity in the crime, or an alleged general indifference to the fate of the Jews during the Second World War. Under its belt it has a glut of rigged trials, beginning with the loathsome Nuremberg trial. It has sanctioned thousands of hangings of defeated soldiers, an atrocious post-war Purge, the deportation of millions of civilians chased from their ancestral homelands, indescribable pillaging, tens of thousands of scandalous legal proceedings, including those carried out today against octogenarians or nonagenarians, attacked by "miraculous" Jewish survivors giving their false testimony. These abominations, this outrage of lies and hatred, this hubris that one day or another destiny always comes to punish, in short, all these excesses must end. No nation has shown more patience with this Jewish or Zionist hubris than the Arab nation; however we see that this nation itself has now run out of patience. It is going to throw off the Israeli yoke and have the West understand that the time has come to seek real peace instead of supporting and arming an artificial State that maintains itself only by force. Even in the West, even in the United States, the scales are falling off some people's eyes and there is now a certain awareness of the hazards imposed on the international community by such prolonged submission to the false religion of the "Holocaust", no. 1 weapon, sword and shield of the State of Israel."*

I did a quick Google search engine tally. Now remember, Google is hostile to Revisionism; it blocks many a dissident website, including the Zündelsite in Germany. It cannot block, however, the many, many websites that focus on and post mainstream news. Here is what my Google search looked like:

"Holocaust Conference Iran" – 2,690,000 Internet documents, most of them mainstream articles

"Holocaust Iran Conference Germany" – 6,390,000 (as you can see, the addition of "Germany" vastly increased the articles of the conference itself!)

"Iran Conference Zündel" – 35,600 hits!

A famous Internet essayist, John Kaminski, a man who wields a gifted pen, sent me his take on the Iranian conference and how it played on the world scene: (Note how he gets around naming the enemy...)

### **Other people know the truth: Why can't Americans get it?**

*The issue is freedom of speech. The key point is understanding the Js existed long before the Zs, and the Z scam is just like the Communism scam. What has been blamed on the Germans is actually a J invention. The larger picture from the mid-1800s, when they failed in their attempt to split the United States with a Civil War, reveals a massive infiltration that created this mindlock that a small group should create and control the wars and use everybody else as cannon fodder.*

*Every single person you see on television is employed by this group. (...) After more than 100 years of practice, the mechanisms for diversion of attention are very sophisticated. Every movie, every song, crafted for your consumption and with a purpose — to erode the fabric of what exists for profit in an endless planetwide war on life itself. In a world where deceit deceives itself, the shadow — being a perception of fear — must destroy the object that casts it.*

*But for most, it's simply too big to see. When we've been brought up on tribal principles that define our basic world view, it's very difficult to understand that these principles actually create the problems that threaten us. Justifying crime in the name of national defense is the usual excuse. Thus, the War on Terror. (...)*

*I offer only one piece of evidence that is the key to making the leap to understanding what is going on. Consider the world today.*

*Freedom of speech exists in Iran, but not in the United States or most of Europe.*

*One old friend who has spent most of his life running on the backroads surprised me when he confided, "I'm shocked at the amount of publicity that questions about the Holocaust are getting these days. I never thought it would have been possible."*

*Then he added with a twinkle in his eye, "Maybe they don't really control the media after all."*

*The most real question pertaining to the development of human society at the beginning of the 21st century anno domini has recently been discussed exhaustively in, of all places, Tehran, Iran. Credit must go to an Iranian society that can forthrightly discuss ALL matters of history and not be unduly influenced by the financial influence exerted on Western capitalist governments by the international J banking cartel that has turned World Bank-controlled human society into a charnel house of depopulation for profit. (...)*



*It is precisely here where the tapestry of lies that rule capitalist/religious prison society begins to unravel. A very serious lie has been perpetrated on everybody. And, as with so many other tribal inventions, it has changed the very nature of reality and history.*

*In no single historical event is the J stranglehold on the world's financial system better vivified and ritualized than in the thousands of Holocaust Museums that have sprung up around the world like so many mushrooms on the moonscape our beautiful world has become. The future will regard these mental mausoleums as Houses of the Lie, which numerous experts recently explained to their gracious and intelligent host, Iranian President Mahmoud Ahmadinejad.*

*Comparing the presidents of the two nations, the United States and Iran, is startling.*

*The presentation in Tehran was notable for two remarkable occurrences.*

*David Duke burst upon the world scene with forthright analyses of Jewish control of world media, demolishing CNN's Mossad-controlled Wolf Blitzer and other Ziomedia zombies in the process. His continuing eloquence in these matters increasingly overshadows the aspersions heaped upon him — and all the other free speech martyrs languishing in German jails — by the J media spin machine.*

*What the Holocaust conference in Iran really accomplished was a definitive, scientific proof that Hitler and the Germans NEVER developed a plan to exterminate anyone. Their so-called Final Solution was deportation to Palestine, to rid German society of Jewish influences which had ruled Germany cruelly and to unfair advantage stemming from the Jewish-devised Treaty of Versailles that ended World War I and guaranteed endless wars to come.*

*This argument has always been best articulated by a man known as the dean of Holocaust Revisionists, retired Professor Robert K. Faurisson of the University of Lyon, who at age 78 — after a half century of being beaten and having his jaw broken by J thugs, and fresh from his moral victory in court in France — was never stronger or more articulate.*

*"The holocaust is a put-up job done by the Jews," he concluded.*

*"... the 'Holocaust' remains the lone official religion of the entire West, a murderous religion if ever there was one. And one that continues to fool millions of good souls in the crudest ways: the display of heaps of eyeglasses, hair, shoes or valises presented as 'relics' of the 'gassed', faked or deceptively exploited photographs, texts of innocuous papers altered or purposely misinterpreted, endless proliferation of monuments, ceremonies, shows, the drumming of the Shoah into our heads as early as primary school, organised excursions to the holy sites of alleged Jewish martyrdom and great show trials with their calls for lynch-law."*

*This white-haired professor of French symbolist poets dominated the Tehran conference with the same basic questions he has been asking for 30 years.*

\* *"Show me or draw me a Nazi gas chamber."*

\* *"Bring me one proof, one single piece of evidence of your own choosing, on the grounds of which to assert that there was a genocide."*

\* *"Bring me one testimony, one single testimony,†the best one in your opinion."*

*The purveyors of propaganda who spout the term anti-Semitism battle mightily to blot out the truth. And yet they have failed. Faurisson explains:*

*"First in France and later in a number of other countries in Europe, these accusers have called for the passing of special laws to silence the revisionists. Here they have sealed their doom. To resort to special laws, to the police and prisons is to admit one's utter inability to use the arguments of reason, history and science.*

*"A hundred other arguments again could be recalled here to prove that, on the plane of history and science, the immense edifice of lies put up by the 'Holocaust' or 'Shoah' sect has been thrown down, with not one stone left upon another. In contrast to this expanse of ruins, we have seen the construction of a whole revisionist literature. In it can be discovered a profusion of documents, photographs, expert studies, trial transcripts, technical and scientific reports, testimonies, statistical studies, all of which bearing on a hundred aspects of the history of the Second World War that show what the lot of the European Jews was in reality, and demonstrate in striking manner that the Jewish version of that war is largely of the order of myth."*

*Faurisson demolishes the idea that the Germans "gassed" anyone at Auschwitz.*

\* *They cannot invoke a single document proving the crime.*

\* *They are unable to provide the least representation of the crime weapon.*

\* *They do not possess any proof nor even any evidence.*

\* *They cannot name a single truthful witness*

*Some Internet radio talk show hosts who pretend to be sincere insist we may not talk about the Holocaust lest we offend our J benefactors.*

*Understanding how the facts of history have been manipulated for the profits of a perverted few is essential to understanding all the other lies: Iraq, Afghanistan, and 9/11, to name only a few of the recent attacks upon our freedom of thought.*

*The Holocaust is the central lie of our time that must be understood in all its complexity if real peace is ever again to prevail in our world. Otherwise, Saddam's fate is truly our own.*

*A few days after that conference, I received word that a strategic meeting has been held and a committee formed whose thrust will be three-fold:*

**1. Constituting an international truth-seeking committee in matters of the 'Holocaust'.**

**2. Establishing an international justice commission for determining the penalties to be imposed upon those found guilty of**



having perpetrated the 'Holocaust'; in case the 'Holocaust' is found to be a lie, to determine the reparation to be paid to those who have been unjustly sentenced, and to determine the form of punishment for those who are found to be liars.

### 3. To organise the next 'Holocaust' conference.

Nice goals – don't you think? Barely had I digested that, there came a most important press release out of Argentina from an opposition party whose founder, Adrian Salbuchi, is a correspondence friend of mine. Inspired by the success of the Iranian Conference, in this press release Salbuchi sketches the outline of a South American Revisionist Conference with a particular slant, as he envisions it. I quote selected passages:

*Iran's hosting of this Conference brought with it "fire and brimstone" ire from Israel, the global mainstream media, international Zionist organizations and the US and UK governments. However, in spite of all the hysterical press distortions and abuse, the facts are that this event had three clearly defined objectives which the world press has not properly informed, much less addressed:*

#### *1) Achieving a more balanced historical perspective on this issue*

*"The Holocaust" Myth is clearly an integral part of the Propaganda Machine wielded by Zionist lobbies to generate unconditional support for Israel in the United States. This support includes huge financial and military transfers, unbending diplomatic backing, and giving Israel hundreds of nuclear weapons, a fact which Israeli PM Olmert has just admitted is true. The mass psychological impact of "The Holocaust" dramatizations through literally thousands upon thousands of very well financed "documentaries", "eyewitness reports", Hollywood movies, TV series, books, novels, plays, articles, monuments, anniversaries, cultural events, NGO's, lobbies, museums, school and university courses, news-clips and a myriad of other vehicles used to shove "The Holocaust" down the world's throat, has been so well orchestrated and stage-managed that, among all the horrific and cruel persecutions and genocides perpetrated in modern times, the persecution of European Jews by the National Socialist regime is the only one that has its own "Registered Trademark": "The Holocaust".*

*Other genocides, many of which were far worse than the one suffered by the Jews, are thrown into History's waste bin: the massacre of 3 million kulaks at the hands of Stalin in the thirties, the genocide of 2 million Armenians at the hands of the Turks in 1904, tens of millions of "disappeared" in the Soviet GULAG, 5 million killed in Cambodia by Pol-Pot's Khmer Rouge, 2 million killed by the US in Vietnam, and the now almost 2 million Iraqis killed by the Bush Family and their Associates since the First Gulf War in 1991 to date, to mention but a handful, are all tragic genocides where world public awareness is close to zero. Clearly, "The Holocaust" is the only genocide-show playing on Broadway.*

#### *2) Distinguishing between Political Mystification and rigorous Historical Truth -*

*History, as a discipline, requires permanent investigation of new sources, documents, data, information and analyses. This means that any serious historical research must keep an open mind permeable to whatever "revisionism" such new data and documentation may warrant. This applies to World History,*

*Ancient History, National History and, of course, Modern History, as it allows us to have an increasingly correct view of the past. This is actually notably important in the case of Modern History (which is when the persecution of European Jews took place), because the sources of "Modern History" are day-to-day politics and events that, as the years and decades go by, gradually become "history". At least that is how it should be. However "The Holocaust" refuses to become true "History" and, to this day, insists on remaining an autonomous Political System or creature, having clear political objectives.*

*The key question then is why scientific, objective and serious historical research regarding "The Holocaust" is banned, even banned by law as is the case in countries like France, Canada, Germany and Austria. This is why, for example, prestigious historians like David Irving from the United Kingdom and researchers like Germany's Ernst Zündel could not attend the Tehran Conference: both are presently in prison in Austria and Germany respectively, for having voiced their historical views on the subject. Clearly, very eloquent examples of the true "Newspeak" definition of the "Right to Free Speech" in today's "Democracies". (...) [Emphasis added]*

*Interestingly, the Zionist pro-Israeli mainstream media implicitly admits that any investigation [of the Holocaust] poses a grave danger to Zionism. Amidst all the insults and threats from such newspapers like the Los Angeles Times, in their 13-Dec-06 issue however, they ran an article called "Holocaust denial can be dangerous" which concludes by saying that, "...attacking the legitimacy of the Holocaust allows...(attacking) the legitimacy of Israel, which was created by the United Nations as a result of the Holocaust. If the first act didn't happen, then the second act wasn't necessary."*

*Now there's the rub! If "The Holocaust" did not happen as Zionists say it did, then Israel should not have been created the way it was.*

*The whole matter would then require being fully re-assessed and re-vamped, forcing all key players to the negotiating table to resolve the "Arab-Israeli conflict" in a balanced manner taking into account the interests of all the parts involved: Palestinians, the Muslim countries, all Jews and other players - and not just the Zionists' interests as is the case today. If it were to be proven that "The Holocaust" has, in fact, been stage-managed for political reasons in order to promote Israeli interests, then the State of Israel and the United States as public players, and the global Zionist organizations as private lobbying entities would have to accept their share of responsibility for the damage, suffering and hardship they have wrought upon the Middle East and the world and, accordingly, they should be held accountable.*

#### *3) Achieving a better understanding regarding the origins of the Arab-Israeli Conflict -*

*Finally, and independently of the actual results of "The Holocaust" Conference, there still remains one key and fundamental issue: If European Jews were persecuted by certain European countries in the thirties and forties, why then should the Palestinians have had to pay for those injustices? If there is one thing regarding which there is absolutely no doubt is the fact that the Palestinians had absolutely nothing to do with the persecution of European Jews and "The Holocaust". The problem is that over the past seventy years, the powerful Allies of World War II supported International Zionism helping them*

steal Palestinian territory from its rightful inhabitants, who had been there for over a thousand years, and thus allowing Zionist guerrilla groups like The Stern Gang, Irgun Zvai Leumi and The Hagganah to displace millions of Palestinians using the most violent and perverse terrorist tactics since before the founding of the State of Israel, until today. We have now seen more than six decades of Israeli Zionists persecuting, assassinating, discriminating, humiliating, torturing and maiming millions of Palestinian men, women and children and attacking all who try to help them. They could not do this without superpower support.

The key objective of "The Holocaust" Conference then, has been to show that the persecution of European Jews by Germany may not have occurred in the way Zionist propaganda insists that it did. It would delegitimize the very act of creation of the State of Israel, which would only remain supported by a weak set of half-truths, blatant lies, distortions and rigging of reality, imposed through violence and coercion upon the peoples of the Region. In other words, Israel's "Birth Certificate" would be shown as being fraudulent. (...) [Emphasis added]

The Argentine Second Republic Movement (MSRA - Movimiento por la Segunda Republica Argentina), also feels that these complex issues need to be openly and publicly debated in Argentina, so that our own populace may fully understand what this is all really about. (...) The day draws nigh when the peoples of the world will see for themselves that, no matter how loud you scream, a lie remains always just that: a lie.

#### *Ushering in a much-needed Public Debate in Argentina*

Lastly, the Argentine Second Republic Movement proposes that a Multi-disciplinary International Conference be organized in Buenos Aires next year, promoting an Open and Public Debate amongst all opinion sectors, with the view of establishing the true nature of power and leverage exerted by International and Local Zionists organizations and interests in our country. (...)

Such an Open Public Debate should focus on two key factors affecting Argentina, but which are also applicable to just about any country in the world:

1. Identify the true nature, extent and sources of financing of Zionist lobbies and leveraging over public affairs in Government, among politicians, in universities, and in the Media.
2. Design checks and balances to ensure that no minority group can acquire excessive power and then use it against the National Interest. (...) This becomes especially vital when such minorities are aligned with the interests of foreign warring powers.

(Movimiento por la Segunda Republica Argentina - (MSRA))

Next came word that David Irving had been unexpectedly released! He is already back in England. One of my list readers wrote:

*Irving is Free!*

Happy news in time for Christmas – David Irving was released from his Austrian jail and apparently left for England. This is the best finale for the Tehran Conference; pity he was not there, but surely this conference was not the last one.

The Jewish newspaper Haaretz noticed that the judge who allowed the old historian to go back home for Christmas was "a sympathiser of J'rg Haider", an Austrian right-winger. The newspaper forgot to mention that Haider would qualify as a soft leftie in the Jewish state. The newspaper never told us about political sympathies or relation to Jews of the judges who sentenced Irving and who tried Zündel.

Merry Christmas, David Irving, and all our readers! Let us hope for speedy liberation of other prisoners of Zion, from Marwan Barghouti to Ernst Zündel!

In response to Irving's release, I had quite a few jubilant calls from Costa Rica, Brazil, Canada and other places. People uniformly interpreted the release as a weakening of the Enemy Front - a very nice Christmas present indeed!

There is so much more I could tell you – about all the spin-offs that are now in the making, and some that have already taken place. Just now I learned that in Cairo, Egypt, another revisionist conference has already concluded. On Memorial Day at the end of May, there will be an International Revisionist Conference in West Virginia where I will be speaking. I was told that a massive distribution-of-flyers campaign – 500,000! – is going to start at the end of this month in Sweden that will focus on our prisoners of conscience, primarily Ernst Zündel. And there is more – and more and more!

So here we are – in a new battle field on a vastly expanded front. As I summarized all these development for Ernst, condensed here from several letters:

Hard to believe that another year has gone by – a nightmarish year in many ways for me, and I am sure for you. As you know since May all the way to the end of October I had [my gravely ill son's] situation on my hands, which was ghastly, in addition to many other things, and the stress took a lot out of me. He is settled now, and as long as I can manage to pay for [assisted living placement], he will be okay, but he is fragile. He has had another episode of dangerously low blood sugar, but he caught it himself. This time they didn't have to call the ambulance. He now wears a beeper on his chest so he can summon help immediately.

I look forward with real vigor to 2007 – because, Ernst, the feedback I get from all over the world feels good and energizing. The absolute disgrace of those Holocaust Protection Laws in Europe simply infuriate people. The revulsion is near-universal!

For us? First, there is Cincinnati where our habeas appeal will be heard. My attorney and I are planning a press conference and a showing of your documentary in Cleveland on Jan 22nd. In March, something important is being planned that I can't talk about as yet. On Memorial Day in May the National Alliance in WV is planning an International Revisionist conference, and I have agreed to be there. They are getting some good names together. Venezuela and Malaysia are said to be pondering Revisionist conferences. It is very clear, and commented on throughout the world, that after Iran the enemy has pulled in its tail and is licking its wounds because there were no arrests after the Iranian attendees came home – even though the Holocaust Lobby was spitting fire and flame. I think even hardboiled media folks were shocked at what the Iranian conference revealed.

It's very, very interesting to watch what is developing, Ernst – while most people are so deeply conditioned not to utter any doubt about the traditional Holocaust claims, they are very willing to take on the Holocaust head-on as a religion and as a political weapon! To me, that's much more intelligent and fruitful than beating a dead horse with stats.

Your German version of "Setting the Record Straight" titled "Briefe aus Gefängniszelle 7" is finally here – and a glorious little paperback it is! I am including two covers – one for you, and one for the snoops to put in their files. The book is an absolute gem. My young friend who visited from Germany said that he felt it is even more powerful emotionally than the documentary. I agree. It is a finely woven "soul exposé" of how you think and feel. I expect great things to come from that book. One of our early campaigns will be to spread it far and wide globally. The Audre booklet isn't here yet, but I got all three sub-documentaries that I prepared as part of my 2007 campaign – all paid for and ready to go. My next project will now be the dubbing of the documentary in German.

Ernst, don't worry that I will over-extend myself financially. I am very, very careful, having had to count my pennies all my life. Preservation of what we have already achieved is always the first order of the day – only after I have paid my bills, my taxes and insurance, after I have taken care of Erwin's home and have caught up with the attorneys do I go into other ventures. So far, with the help of our friends, I have managed – and this Christmas, again, has been good. I worried a bit by sharing our dream of the future with our supporters, the "Vordenker/Spartans of the Spirit" concept, but I had only two negative letters. The rest are behind us as ever.

If things go well, this will be the last letter before Christmas, hopefully given to you in time. Therefore, I want to make it special by giving you some hope amidst all the treacheries committed by the prosecution against all better evidence and reason – by punishing you, a principled man, while licking the boots of their own sworn enemies. I will never understand how Germans can allow themselves to be so despicably degraded!

But be this as it may, we are progressing toward freedom, inch by inch. As always happens, our enemies gave us a victory on a giant silver platter we could not in our wildest dreams have masterminded ourselves. They plain went cuckoo in their panic! I am sure you did not get to see a smidgeon of the media bonanza — it was one amazing sight to behold! Ernst, this is the watershed!

Two things were repeated, over and over, all over the world – that the Iranian president had called this conference together to 1) highlight that the Holocaust was a vicious, fraudulent political tool that led to the creation of Israel and the dispossession of Palestine, and 2) that the stool pigeons of the State of Israel, namely the Europeans and particularly the Germans, were brutally kidnapping and imprisoning Revisionists as a last desperate effort to keep the truth from coming out! We couldn't have put it better ourselves!



And all this time, with spring time in the air, our Ernstle is still languishing in prison – where, as he told me in one of his letters, "...my spirit is stalking the conference!" We'll get him out! We will! I can assure you that I, for one, am filled with confidence that the worst of this nightmare might be behind us! Rejoice with us, stick close to us, keep sending us your shekels for our Truth Campaign, and have a happy and healthy New Year!

Excerpts from a Special Report from the Academic Front

**A Visit in Prison with Ernst Zündel / By Prof Daniel McGowan**

### A Day in Court

An admirer once described Ernst Zündel as "an outgoing, good-humored man who is blessed with a rare combination of unflagging optimism and practical ability. He maintains this infectious spirit even under very trying conditions. He is an unusually alert and sensitive individual with a keen understanding of human nature. He inspires confidence, loyalty and affection." On December 7, 2006 I witnessed his trial in Mannheim and found this description to be uncannily accurate.

On that particular day those in the courtroom included Ernst, three judges, three jurors, a court reporter, three defense attorneys, four armed guards, twenty-four spectators, and one prosecutor, Mr. Grossman. Ernst wore an old blue suit with a red tie; he was attentive; he often smiled approvingly when something was said with which he agreed. The guards were friendly but disinterested. Facing the court, all the participants sat on the left hand side, except the state prosecutor who sat all by himself at a table on the right side. The jurors and the court reporter sat in line with the judges on an elevated platform along the front and the spectators sat in rows along the back wall. No media were present.

The spectators were clearly there for Ernst. Most were German men in their late 60s or 70s; there were also a couple of younger



women. Several men commented that they were proud of having been to every court session with Ernst over the past 21 months. Although they had not met him personally, they were following his trial closely and were supportive of him. They were helpful to my American Jewish colleague and me and guided us through the security outside the courtroom and made sure we got front row seats so that we could fully appreciate the courtroom experience. Many spoke English and had sons and daughters in America. Most were retired but one younger man had taken time off from work to witness this day of the trial.

Ernst and his attorneys have not been allowed to discuss or challenge the veracity of the facts about the Holocaust, including facts that Ernst disputes and about which he would like to submit scientific evidence and expert-witness testimony. *Offenkundigkeit*, the German version of judicial notice, precludes it. The court is only allowed to consider if Ernst denied these particular facts and if so, when and where and how. During our visit, one of Ernst's attorneys, 84-year old Dr. Herbert Schaller[1], read a lengthy and impassioned statement saying that he believed in the same facts of the Holocaust as does Ernst and by so stating this he too is guilty. He ended by saying that in over 53 years of practicing law he had until now never been guilty of the same crime as the man he was charged to defend. The head judge, Ulrich Meinerzhagen, appeared tired, agitated, and ready to explode.

### Visiting Ernst in prison

It is not easy to visit Ernst Zündel. He is allowed only two 30-minute visits per month, one hour if the visitor travels more than 100 km. Though I wrote and faxed the prison a dozen times beginning in February 2006, the answer was always the same, no answer. But through his wife, Ingrid, Ernst knew that a colleague and I wished to visit him and he asked the judge to grant us permission to do so. Finally on September 23rd Judge Meinerzhagen told Ernst to tell his wife to tell me to fax him and formally request a visit. We were to each include a copy of our rÉsumÉs and a copy of our passports.

Another month passed before we received the visitation permission. Once we had that document, stamped and signed by the judge, we were able to make an appointment at the prison in Mannheim.

On arrival the guards filled out a long form on each of us. They took our passports and had us put everything else in a locker. Then we were searched, warned against speaking English, and told to cross the courtyard to the visitation rooms. There we sat on one side of a table with a plastic shield in the middle; they brought Ernst from the other side and allowed him to sit across from us while a guard sat at the end to monitor both parties. We asked if it was permissible to shake hands and the guard smiled and said that would be all right.

Ernst began by asking us to contact his wife and tell her that he looked well and that he missed her. He had not been in contact with her for several weeks and he was worried that she would be worried about him. Then he asked if my colleague's family had discouraged him from making this trip. My friend understood what Ernst was asking, but he was unable to answer in German, so I had to tell Ernst that indeed pressure had been put on us both not to have anything to do with a Holocaust "denier."

We asked Ernst about life in prison and his relationship with guards and other prisoners. He described a typical day and told us that he had only limited contact with other prisoners, but that they were friendly towards him. So too were the guards, especially because he followed the rules and was a threat to no one. He often asked the man monitoring our visit to corroborate what he was saying, almost as if to include him in the conversation.

He talked about history and philosophy and about recent books he had read. He praised the prison library, which he said was markedly better than the one in the US jail in Tennessee, which had "only Tom Clancy novels and one old book on the US Presidents." I had been forced to leave my notes outside and though I had many questions, I was not allowed to ask him anything about the trial, not even the names of his attorneys.

The hour passed quickly and the guard soon told us we would have to go. When we stood we looked questioningly at the guard and he nodded to us. We shook hands with Ernst, slowly, he taking each of our hands in both of his. They were big, soft, and warm; although Ernst is only six years older than I, he reminded me of my father saying goodbye when we last parted.

### Holocaust Denial

Contrary to the warning given to people who currently tour Auschwitz, "Holocaust denial" is not infectious. In many ways the term is used as an epithet to discredit and demean those who question facts surrounding the Holocaust. Nor is Holocaust denial anti-Semitic; there are many Jews who question facts about the Holocaust and many more who object to its being used to elevate Jewish suffering above that of others. Treating those who question the Holocaust as heretics reveals the degree to which the Holocaust itself has become a religion, a faith to be accepted and worshiped with spectacular memorials, best-selling books, and mandatory curricula for school children.

Ernst believes that Jewish groups have wanted him jailed for promoting views that the Jewish-Zionist lobby considers harmful to its interests. He claims that the only sustained and institutionalized efforts to imprison him have come from this lobby, which includes the Simon Wiesenthal Center, the Canadian Jewish Congress, the Canadian Holocaust Remembrance Association, and the League for Human Rights of B'nai B'rith (with the Anti-Defamation League, its counterpart in the US). It is noteworthy that even the ACLU refused to defend his right of free speech.

Ernst Zündel is neither a monster nor a heretic. He is a man with strong convictions and the courage to express them. He views himself not as a Holocaust "denier," but rather as a Holocaust revisionist. For that he has been rendered by the United States, which otherwise professes to protect the right of free speech and the writ of habeas corpus, and by Canada, both countries in which he broke no law. To force him back to his birth country to be tried for a "crime" which he never committed in Germany is unjust. Those who would incarcerate revisionists like Ernst Zündel and hold them, without bail, for years on end to drain them of their resources and to silence them as "Prisoners of Zion" could well be labeled as "justice deniers."
