To our friends around the world:

October saw three major events that impact on our own struggle. The first is the Fredrick Töben arrest at London Heathrow while he was flying from the United States to, of all places, Dubai. Secondly, I want to bring you some of the most stunning words ever spoken in a German courtroom by Horst Mahler. The third item on my plate is, of course, the global financial meltdown and what it could possibly mean for the future. I intend to illuminate that topic by excerpting from Ernst's various letters.

I don't intend to spend a lot of effort on the Töben arrest. He is still in detention, and Britain is in the dock. Will they turn him over to be put behind bars by the Germans – or not? Let me just say that this arrest has caused a flurry of global attention and outrage that will greatly benefit our Cause, and therefore I will briefly touch on what is playing here as reported by the mainstream media:

Holocaust denier Fredrik Töben's trial soon: prosecutor / by Peter Wilson, The Australian, October 11, 2008

THE German prosecutor who wants to put Australian citizen Fredrik Töben on trial for denying the Holocaust warned yesterday that he was determined to see the former school teacher face justice.

Andreas Grossmann, the Mannheim district prosecutor handling Dr Töben's case, said that despite his attempts to avoid extradition from Britain to Germany, he expected Dr Töben to be on trial early next year. Mr Grossmann also warned that Dr Töben faced up to five years in jail and, although most prisoners in Germany served a third to a half of their sentences, the stubborn refusal of long-term Holocaust revisionists to recant their views meant they usually failed to win parole.

"These people have little chance of getting out before the end of their full sentence," Mr Grossman told *The Weekend Australian*. As a foreign citizen, Dr Töben would normally be sent back to Australia halfway through any sentence to serve the remainder there, but that move too would be threatened by a refusal to recant.

Mannheim has become the centre of German efforts to enforce laws that criminalise the denial, justification or playing down of the Nazi slaughter of Jews.

It's been more than five years already ! Please help us free Ernst Zündel!

As a result, the hulking, century-old prison in a quiet residential area on the edge of the city holds more prisoners convicted of those offences than any other prison in Germany, and it is where authorities hope Dr Töben, 64, will soon be incarcerated.

Holocaust deniers held at the brownstone prison include Ernst Zündel, a 69-year-old German [vilification slur deleted!] who lived in Canada for 42 years but was deported to Mannheim and is serving the maximum five-year sentence; and Germar Rudolf, a 43-year-old chemist [not true!] expelled from the US and jailed for 30 months for insisting the extermination of Jews at the Auschwitz death camp could not have happened on the scale accepted by mainstream historians.

Mr Grossmann, a softly spoken lawyer who took responsibility in 2005 for prosecuting political crimes in Mannheim, said the district's leading role on the issue was partly accidental and partly the result of the zeal of his predecessor, Hans-Heiko Klein. In April 1999, Dr Töben, who was born in Germany, visited Mr Klein's second-story office on a busy Mannheim street and explained his views of the Holocaust. Dr Töben was asked to come back the next day and repeat his comments; he was arrested and sentenced to nine months in Mannheim priscn.

As I commented in a ZGram to my Internet readers, this is a typical sample of sloppy reporting. In 1999, Töben had visited Klein to ask him for specific guidelines - what he could and could not say in Soviet-style Germany pertaining to the Holocaust. Klein asked him to come back the next day – at which time a policeman was waiting to arrest him. In other words, Töben was trapped into a political snare. And, of course, Germar is no longer in Mannheim!

As to Grossman, I wrote in a follow-up ZGram:

PLEASE NOTE: Andreas Grossmann was the prosecutor in the Zündel trial. Throughout the trial, he barely opened his mouth – Judge Meinerzhagen did his hatchet job for him. In olden days, this creature would have been tarred and feathered for bending the law like a pretzel and trampling on other people's rights! His background needs to be investigated!

And, furthermore:

This was again a desperate act to contain the ever more unraveling Holocaust swindle.

These impact persecution attempts are meant to strike terror in the public - but boomerang to an astonishing degree. Millions of people all over the world are drawn to Revisionist websites to find out for themselves what these bizarre arrests of Holocaust Revisionists are really all about. Not only write-ups but video

reports about these brazen human rights violations are now posted on youtube from as far away as Malaysia.

Many have commented that the Töben case is setting a "new precedent." That's only partly true. This case is different only from the Zündel kidnapping and other human rights violations in that the fig leaf has been dropped that this was anything but yet another political hit as punishment for questioning the Holocaust. England, to its credit, has courageously resisted a "Holocaust denial" law so far – therefore, a political arrest of this nature on British soil of a non-citizen in transit has a particularly nasty odor.

This will get interesting. England has a couple of high-profile celebrity Revisionists who are taking an active role in challenging what happened. I have been told that David Irving, England's *enfant terrible*, has offered Töben a place to stay in his home, should he be released on bail, and Lady Michele Renouf, that elegant and beautiful socialite, a well-known producer of DVDs of Revisionists' dramatic stories of political victimization, is capably putting together a legal team to launch an extradition advocacy defense.

An EXTRADITION ADVOCACY DEFENSE – let that melt on your tongue!

This is revolutionary! This should have been done with other high profile cases of Revisionist truth tellers who have been likewise politically nabbed and who idealistically and perhaps too trustingly relied on a "Truth is a defense" strategy – only to find out that the judiciary in the so-called *Bundesrepublik* is so corrupt through fear or blinded by political correctness that it is stony ground to hope for justice based on forensic science.

We hope that other countries will take notice and join in. This political kidnapping, just like the Zündel and Rudolf kidnappings a few years ago, highlights yet once again that Germany is nothing but a bully Zionist vassal, forcing its odious Holocaust Denial laws on other countries that want nothing to do with their hateful statutes to please the Noisy Lobby.

It will be interesting to learn if Britain is still strong and independent enough to resist.

The write-ups of the Töben arrest in mainstream papers have been lavish, but always with the predictable PC caveat: "Of course we dutifully hold our noses at Holocaust Denial, but with Voltaire we uphold the democratic principle..." Ad nauseam!

I hate that undertone! "Holocaust Denial" is not an opinion of fringe eccentrics - it is a scientifically based, responsible reaction to a deadly political weapon employed by the Jews and those who lick their boots. The "Holocaust", unfortunately, is still *the* most tabooprotected political weapon that even otherwise responsible and knowledgeable leaders on the Right are squeamish like spinsters to touch. Just who is pushing for this latest extradition? It isn't the Hottentots that plague us.

Frederick considered this trial particularly important in view of the developing world financial crisis, which is similar in many respects to that described by Gottfried Feder 75 years ago in his book *Kampf gegen die Hochfinanz* (The Struggle Against Globalism) – especially the chapter entitled *Das Manifest zur Brechung der Zinsknechtschaft* (Manifest for the Aboltion of Interest Slavery)}

Horst Mahler writes:

On 15 Oct 2008, Day 2 of my Potsdam show trial, the Court dealt with the treatise *Das Ende der moralischen Geschichtsbetrachtung führt zur Antwort auf die Judenfrage* (The End of the Ethical Consideration of History Leads to the Answer to the Jewish Question) which is posted at http://www.recht-zur-verteidigung.org.

The central assertion of this treatise is: "The Germans will not be free again until the Reich has regained its ability to function.

The Reich's path to sovereignty and self-realization leads by way of the abolition of foreign domination by the Jews, and this domination is faltering with the exposure of the Auschwitz Lie."

Against this background, I preferred an evidentiary motion in order to demonstrate the impossibility of proving intent to lie, which is available on the Internet at www.recht-zur-verteidigung.org/ BA_Leugnung_Endf.pdf.

Here is an excerpt:

Preliminary Remarks for the Professional Judges of the Court

Section 130 III of the Penal Code states that denying "Holocaust" is a criminal act. The courts of the Federal Republic, in particular the Mannheim District High Criminal Court, interpret this ruling to mean that statements such as "The genocide of Jews known as 'Holocaust' is not a proven historical fact" may not be uttered in public, regardless of how expressed.

Even a confidential conversation between two persons is interpreted as a public utterance if the possibility exists those third parties might possibly hear and understand the utterance. It makes no difference whether the logical determiners "right" or "false" are expressed in the course of this utterance.

The peculiar expression in Section 130 Paragraph 3 means that "denial courts" are required to consider "denial" cases even when they believe that "Holocaust" has no reality in space and time.

"Denial" is defined as expressed skepticism regarding an officially decreed true fact, and in this sense, skepticism has the same legal significance as a lie.

Please note: My correct zip code is 37863, <u>not</u> 37862. My printer made a mistake in the return address on my envelopes. However, anyone who, in opposition to the prevailing opinion, exposes an officially designated true fact to skepticism because he himself is of a different persuasion, is not lying.

He is merely possessed of a conviction that differs from the prevailing opinion.

Conviction as an internal phenomenon or Internum cannot be decreed by lawmakers. These convictions belong to the realm of abstract existence and are beyond the reach of measure or standard-ization.

According to accepted rules, subjective facts of the case – in this instance, knowledge of "Holocaust" — must be proven against the accused even in so-called "Holocaust" Trials. The courts' recent and oft-expressed opinion that the manifest obviousness of "Holocaust" is irrelevant is comprehensible if the idea is also expressed that nothing is relevant except the conviction of the accused. Thus, it must be proven that the accused is convinced of the reality of "Holocaust."

During oral argumentation it is appropriate conduct for the Defense to attempt, through appropriate evidentiary motions, to convince the Court that the subjective body of facts of "Holocaust Denial" cannot be proven.

[Mahler addressing the judges]: You are living and exercising your professions in a land in which defending attorneys, attorneys such as yourselves, are thrown into prison for making use of available evidence by submitting evidentiary motions — if they submit evidence that causes the allegation to appear questionable that "Holocaust" is actually an event of contemporary history, a "manifestly evident" event.

Have you ever reflected on your own actions in doing this? Is this what you swore to accomplish as your contribution to the betterment of the world?

The statement of the accused to the effect that he is firmly convinced the crime called "Holocaust" is merely feigned and affected, cannot be disproved. The firm opinion of the accused is based on intensive direct and indirect study and consideration of the "revisionist" literature listed below, which list is incomplete.

In the course of my defense of the singer Frank Rennicke, I read extensively in the literature of historical revisionism. From this intensive research came new knowledge and realizations, especially from the historical works I shall introduce below.

Concerning the Subject of Evidence and Much More:

You are standing at the intersection of two worlds with your mission to render me harmless by means of a conviction, as you will personally become aware. I assure you that in this trial I will thoroughly expose the "Mannheimer Way" as the path of treachery and criminality against the German Nation, as I have done in the other trials. I will expose it so thoroughly that everyone who has wit enough to add one plus one and arrive at the sum of "two" will have no doubts about the innate criminality of the Mannheim court.

Thank you for your continued support! We couldn't possibly do it alone!

The Mannheimer judges Meinerzhagen and his colleagues mounted the ultimate summits of Jewish "chutzpa" when they ascertained "... In the case at hand, the conduct of the accused (Sylvia Stolz) has led only in the direction of unreasonably questioning what cannot be doubted. Her reason for doing this was to introduce her untenable theses for the justification of her conduct. Her conduct is comparable to that of someone who is accused of fraud and, denying basic arithmetical operations and substituting his own operations, not only arrives at the conclusion that his victims suffered no financial damages but that they actually realized financial advantage from his doings."

With that, Meinerzhagen let the cat out of the bag. In his world view, 'Holocaust,' like God, cannot be doubted; Mannheim is Bethlehem; and Mannheim District Court is the Church of the Nativity. Meinerzhagen and his court are challenging our right to doubt – he is questioning our spiritual and intellectual existence!

In the interest of world Jewry, the real content and elements of this trial may not be made known, under any circumstances. That is the explanation for the amazing fact that, without exception, adjugication and literature bypass the real problem concerning Section 130 Paragraph 3 of the Penal Code. This has simply remained invisible. Now it will be made visible, however.

If it is said that the Germans are a nation of necktie-wearers, that is a humorous expression of an opinion over which we might chuckle. Who would be motivated to contradict such an allegation? Such a dispute does not affect the German people one way or another. But if it is said that the German people massacred the Jewish people, this is more than just an expression of trivial opinion. It is a serious attack on the existence of the Germans as a nation.

In the debate over Section 130, this slight difference has been studiously overlooked. The courts have acted as though nothing were involved except the minor issue of freedom of opinion, with which one can dispense, as Stefan Huser assures us.

The Germans, unlike the Jews, have never indulged in genocide. Unlike the Jews, the Germans do not believe that they have been chosen by their God to eradicate other peoples.

If we Germans are made to believe that we have murdered another nation, we feel guilty before our God. Such massive guilt feelings can morally kill an entire people, as E. P. Koch has pointed out.

Who would have believed that we Germans would so long remain silent about the spiritual murder inflicted on us? After all, we are not dealing here with an event that occurred in ancient history and now does its mischief only in yellowed schoolbooks. This moral genocide directed at the German nation is taking place in the present!

Even regardless of what occurred in the past: who would condemn the German nation to extermination without a real trial in a real court? What legal issues might be contested in a real trial? And how might they be judged and evaluated?

The Jews insist that the dispute entails acknowledgement of their national destiny of persecution and their dignity as victims of persecution. But can the preservation of their alleged sensibilities be the main consideration? Must we accept, for the sake of protecting Jewish sensibilities, our own passive demise as our inevitable destiny?

What is Law if not the will to self-preservation and self-realization of a free nation, the will to survive and evolve? Forced acquiescence in our own extinction can never be lawful!

Can there be a stronger will to resist than the will that grows out of the realization that Satan is threatening to destroy our own people and family – the dearest that we have in the world? Germans who are still determined to be German (and who do not merely wish that they were allowed to be German) are determined to resist this attempted act of genocide by the Jews at all costs. They can accomplish this by simply blunting the drawn Jewish murder weapon — by revealing the truth! Even if only a few persons are filled with determination to remain German, they will be enough to assure the end of the "Holocaust" lie.

The end of this monstrous lie will be the same as that concluded by the Weltgeist following the blessing that Isaac gave to his betrayed son Esau (I. Moses 27, 40): "You will live by your sword and serve your brother, and it will come to pass that you will also become a lord and throw off his yoke from your neck."

In the trials of Ernst Zündel, Germar Rudolf, Sylvia Stolz and myself, Judaism has finally encountered the German people's will to self-preservation, and it has [not] been thwarted. The insurgents among our people have torn away the mask from the face of our mortal enemy. Without its mask, the enemy's powers are wilting like the torn leaves of a tree in the midday sun.

You, the judges of Fourth Superior Criminal Court of Potsdam District, are not dealing here with a routine "Holocaust" show trial. In this trial, you are brushing against the cloak of history.

With a verdict directed toward truth and justice, you have the possibility of shortening the devastating economic depression that is descending upon the nations. The way out of this catastrophe is indicated in the program *Ehre! Wahrheit! Heimat!* (Honor, Truth, Homeland) that is posted on the Internet at www.voelkischereichsbewegung.org. This program is the updated form of the National Socialist program.

It is an obvious truth that "only organized will is power." Spirit, however, is the organizing factor. Michael Birthelm presents and explains the organizing spirit in a thoroughly practical way in his *Komm Heim! - Komm heim ins Reich* (Come Home Into the Reich) which is posted at www.voelkische-reichsbewegung.org/ Kommheim.pdf. The spiritual and intellectual foundations of a Reich that is once again capable of acting emerges from this work.

As for you sitting on the judges' bench — the nations are going to curse you if you allow this opportunity to escape because of your cowardice and willful blindness. You will be destroying millions of human lives if you decide to rule against empirical historical reality. These are lives that can still be rescued from need and despair if the path of National Socialism is taken immediately and not after years of economic and political infirmity.

What is needed for this to occur, is abolition of the deadly historical falsehoods that are presently distorting the German view of reality. With Germar Rudolf's book *Lectures on the Holocaust*, the historical bonfire has been prepared on which these lies will be consumed. The German Reich will arise, Phoenix-like, from the ashes of these lies.

Frau Maybohm, Herr Weber, Herr Dieltiz – will you really wager your life that Truth is not going to triumph over the demonstrable lies of Germany's enemies? You should not attempt to pretend to the public that you find the Mannheimer Line convincing. You have already expressed your reluctance to make such a pretense with your considered suspension of these proceedings dated 27 December 2007. Or must one assume that you now consider the pursuit of justice compatible with the persecution of witches? If this is the case, you should immediately return your judicial letters patent.

Is there an honest judge in all the land who does not reflexively ball his hand into a fist when he hears of the disgraceful actions of the Mannheimer judges? – Witch hunting is a danger to all, worse than arson or murder. It is a crime against the spirit, a sin against God.

Even under the occupation law imposed by Germany's enemies, you are still answerable to the Reich for your acts. For the sake of the survival of the German Nation, I must give you a warning, regardless of the consequences for myself personally: Culprits within the judiciary who take part in the spiritual murder of the Reich, rather than the Jews, can expect the death penalty under the laws of the Reich.

Now you are again going to say that I tried to intimidate you personally. Are we intimidating a thief when we remind him of the legal consequences before he commits the crime?

You would most certainly not take the risk of being yourselves brought to justice if you had no fear of Judaism. I warn you also that you are making yourself liable to charges of treason when you project your image of the devil onto me and others like me, knowing full well that we are not the devil.

Your fear of the Jews, your *metus judeorum* can no longer excuse and protect you, since the danger that you too can become their victim is now drastically reduced.

Jewish world power was dispersed on Wall Street's "Black Monday," 29th September 2008, when the political flunkeys of the Jewish kleptocracy in front of the American Congress took the oath of revelation for the sake of the "System." It has become clear to the whole world that the Jewish kleptocrats have totally plundered and enslaved the nations, in keeping with the command of their god as written in their holy book, even though it might take a few weeks until this discovery motivates the nations to flush out the thieves from their hiding places in order to seize them and bring them to justice.

You should be aware that you are not applying legitimate Law against me. Instead, you are forcing our enemy's worldview on the German nation. In every area of our society, there is already mistrust of all statements by the representatives of present policies. There is profound mistrust of the Jewish dominated and Jewish owned media.

From every direction we hear the question "How was this possible?"

The answer is clear and simple: The ruination of the world through usury and the enslavement of the nations through interest would long since have been overcome and the present robbery of the nations would be impossible if the beacon light of National Socialism had not been extinguished by the lies of our enemies. World Jewry was able to succeed in this because it had not yet been recognized for what it is by other nations. Only the German Reich had recognized it and the danger it represents. Its true nature was perceived as "the abnegation of the life of nations" (Martin Buber).

Furthermore the fact that only the Germans perceived the real nature of Judaism was misinterpreted on account of racism. The Jew was not yet recognized as the Satan that is justified in the evangels, not yet acknowledged as a servant of God who is our enemy for the sake of our salvation (Paul's Letter to the Romans, 11:28).

One does not hate an evangelically justified enemy, one overcomes him. This becomes ever more certain as we better understand that Satan's indispensability is derived from the life of the Spirit.

Legal Acknowledgement

If you consider the argumentation as it is developed in this trial, you can avoid the ignominy of a capricious and arbitrary verdict. Furthermore you need not prepare a ruling concerning submission under Article 100 of Basic Law, a ruling that would entail considerable risk on your part. All you have to do is admit the evidentiary motion.

Expert advisers will assure you that subjective belief in the body of facts of "Holocaust" denial in the sense described here is doubtful at the very least. Without resorting to expert testimony, however, you could decide that in your opinion an unusual degree of political stubbornness has been evident throughout the course of my life. It is clear that I firmly believe and mean what I say when I insist, from deepest conviction, that I in my "illusory world" doubt "Holocaust" and thus am not acting with the intent of a liar.

Revisionism on the March!

Larry KING: You say it didn't happen?

President AHMADINEJA: Let's just assume—what I'm saying is let more research be done on this—that history. There is a claim that the extent of the calamity was what it was. There are people who agree with it. There are people who disagree. Some completely deny it. Some absolutely agree with the whole account of it. ...

If it happened — it happened in Europe, if the crimes were committed in Europe, why should the Palestinian people be victimised as a result? Why don't the Europeans just give them a territory? In one of Ernst's recent phone calls to me, he said:

"What we are seeing is just the periscope sticking out of the ocean. This [financial meltdown] is bigger than 9/11..."

I think that is so true. 0/11 was a nasty shock to the American psyche, but it was still perceived as abstract. It was not brought home to the average American as something that struck to the core. This financial meltdown is going to hurt every man, woman, and child on this planet - the Western countries more than others, because they saw themselves as safe. There's bound to be a roar of rage the likes of which the Plutocrats cannot in their worst nightmares imagine!

You can get a clue where Ernst's head and his heart are by excerpts I am stitching together from several letters he wrote to me and others:

- I have never heard presidents and prime ministers around the world cry for help. Pakistan's new president, visiting the UN last week, asked – no, begged! – for 100 billion dollars in urgent aid NOW, or his country could go down the tube! Pakistan is the only Moslem nuclear power in a pivotal geographic and geostrategic area, right next to Afghanistan! He left emptyhanded. Words are cheap. An obviously disappointed, somewhat bitter Icelandic Prime minister seemed stunned in the newscasts of the last few days, and the disaster that has hit his country. This man had sought help from his European allies, the USA, England, in vain. He turned to Russia for a \$5 Billion rescue, a bridge loan, which is being negotiated apparently in Moscow as I write this. *Staatsbankrott*! Russia has offered Iceland to help that none of the Western powers would or could!

That is the new reality. We are broke. The Russians, or the Chinese, are the real super powers – still standing, flush with cash! Most of the cash that they have amassed came out of America's and Europe's pockets. They, in fact, are mining us.

Globalism [is] the curse of our times, advocated by our rulers, our elites. They are the ones who have gotten us into this quagmire and caused the near-death of the West. Oswald Spengler's prophesies of the 1920s in his famous book have sadly come true, as was foreseeable.

Ingrid, it was not inevitable, and still is not. We can reverse the decline with the right policies – still! Even at this late hour! But in order to achieve that, we have to adopt policies and evolve a new, life-saving ideology, a *Weltanschauung*, that our current elites in the Western world cannot evolve. In fact, Ingrid, they are fighting tooth and nail to prevent it from being articulated – much less allow it to be adopted by the powers that be.

adopted a policy of harassment through violence, arson, and ultimately bombing. And when, as in my case, the truth seeker and truth teller was not killed, they graduated to arrests without good cause and without warrants, and then went on to deport and expel their dissidents - peaceful advocates of evolution, not revolution! - by extraordinary renditions to states that they knew would be willing to act as accusers, prosecutors, and judges in kangaroo proceedings.

Imagine how desperate "they" must be to take such a step publicly!

As you and I know, these are Stalinist policies, refined. Stalin silenced his critics in the dark in perfunctory secret trials and tribunals, then sent his critics off in handcuffs and leg irons to his dreaded Lubyanka prisons and torture cellars. What is the difference between Stalin's methods and those used in Abu Ghraib and Guantanamo, or Thorold and Toronto West [as in my case]? Western methods are more hypocritical and more camouflaged, but the results are the same. Terrorism is terrorism, whether it is exercised against states or against individuals like you, me, Germar, Töben, David Irving, and others.

Ingrid, this is what our side has not explained in proper context. He who defines, controls! We have allowed them to define us. They not only took control of our lives through arrest and incarceration but also by their ritual defamation and labeling, distorting our ideas and our goals.

By silencing me - through their strict censorship and their semisecret trials, where we were not allowed to confront our accusers and were not even given specifics or details of the accusations - we, the *Gegenpol*, philosophically speaking, have not found our voice! They have defined us and still do. We are merely reacting to their terror tactics and state repression with a piecemeal pinpricks policy, desperately trying to answer their ritual defamation and their distortions of our words and deeds. We are reacting, always in a defensive mode, to put out a brush fire here, a new eruption there, while they hurl ever new flaming torches into the tinder-dry political landscape.

When I say WE, Ingrid, it's not you and I, as a tragic couple, caught up in this maelstrom not of our own making. It's weltanschaulich. We are the alternative to the current agents of decline and dissolution, but we have not found a voice. Shamir, and strangely, your friend Audre [who was killed], were the ones who came close. And, if I may be so bold, I have been the embodiment and the articulator of it for almost 50 years, cautious for obvious reasons which some deemed timid, others even cowardly – it was neither. By these constraints and in those Ernst-Zündel-specific circumstances on the ground I had to be as restrained as I was, or be ineffective.

Few people ever understood that part of my situation, which was a dilemma for me but would not have been a dilemma for [several names deleted]. Those who have the prerequisites do not have the insights. They lack the vision, the fire, the conviction that are needed to usher in these new ideas. That is the tragedy we have been witnessing.

the little nation of Iceland and its banks under the "Terrorism Legislation" passed by the British Parliament after 9/11! Ingrid, can you see to what purposes this 9/11 attack is already being used in international affairs? Friendly governments are using it against one-time equally friendly governments and allies!

These ritual defamations are the instruments of choice of ruling oligarchies. They demonize their opponents, their dissidents, and once these individuals are [sufficiently] isolated, nobody dares to come to their defense any longer. And now we know from films like *Taxi to Hell*, the Oscar-winning documentary, produced in America, how through fiendish tortures, beatings and waterboarding, unimaginable callousness and cruelty inflicted on mostly totally innocent people these psychopaths in power create and manufacture alleged 'terrorists' out of some broken wrecks.

Abu Ghraib and my experiences in Blount County in Tennessee and then Guantanamo North were the initial testings of their diabolical methods - which were then extended to leaders and even to states they had targeted - for whatever reasons. Every system, every repressive state or regime, always paints their critics as terrorists, revolutionaries, counter-revolutionaries, or "security risks." The labels are endless – because he who defines, controls.

They create their bogey men at will.

9/11 and the crackdown and extraordinary sweeping powers were created to allow the grey zones in which people like I, and by extension, you and others, were targeted. As long as it was only ritually defamed people or [non-Western] nations and their leaders – no one cared much! But CNN's newscast this morning showed Gordon Brown, prime minister of England, saying that he is applying Britain's anti-terrorist legislation to Iceland and the banks there, which "threaten the existence of the Icelandic state."

The old order is pulling out all stops!
