## "Wrong Way" Magnone

It's not often that human rights hysteria is laugh out loud fun for the whole family: "Once, he was **John Marshall Magnone**, a West Coast mariner who worked for the ferry division [we're not kidding!] of a British Columbia government ministry. Then, John became **Deborah** and got a job as a deckhand for **BC Ferries** [but insists] she was fired last year because she is a transsexual. She has filed a complaint with the **BC Human Rights Commission**. [There had been tardiness and rough landing complaints on her file, but, while still on probation,] on Sept 12, 2004, ... Ms. Magnone steered a boat in the wrong direction. She alleges that her transsexuality prompted her two main superiors to apply an 'overly stringent standard of performance to her.' ... The **BC Human Rights Tribunal** receives about 1,100 complaints a year. About 50 of those go to a public hearing stage." (**Globe and Mail**, October 6, 2005) The tribunal tossed out BC Ferries' move for dismissal and found Ms. Magnone's complaint meritorious enough to hear. Hopefully, we can all observe and learn.

## All Points Bulletin -- Cops Seeking Motorist Who Called "Faggot" at Male in Woman's Dress

Ontario is awash with drugs, Vietnamese marijuana grow-ops are everywhere, in nearby cottage, country homes are regularly burglarized, but, in Peterborough, there's an all-points police alert for some guy who called "faggot" at a film-making male student dressed as a woman. This is really one for the books. The shades of Canada's historical cross dressers can rest in peace, knowing that the hate crimes squad simply will not tolerate anyone saying unkind things about men dressed as women in period costume. "A film project being worked on by two university students has resulted in police seeking a man in connection with hateful comments made to one of the students. ## Alberta Pastor Being Persecuted by Homosexual Lobby

The militant homosexual lobby is after another Christian critic. We've warned our fellow Christians for years that Canada's pernicious "anti-hate" laws are really anti-free speech laws and that traditional Christians are among the prime targets. Christian mayors have been forced by fines and rulings to proclaim Gay Pride Days, despite their personal disgust with homosexual practices. Freedom of religion is under severe attack in Alberta. **The Canadian Press** (October 17, 2005) reports: "In a letter published in the **Red Deer Advocate** in June 2002, Stephen Boissoin wrote that **LGB &T** [*that's the latest politically correct shorthand for the sexually privileged and means Lesbian, Gay, Bi-sexual and Transgendered; you do need a handbook to keep track of the new types of sexually unusual and diverse*] civil rights activists and those who defend them are as immoral as pedophiles, drug dealers and pimps. After considering the case for three years, the human rights commission will finally hear a complaint filed against Boissoin by **Darren Lund**, a **University of Calgary** professor. Lund contends the letter contravenes Alberta's human rights law." Immorality, of course, is a subjective thing. The pastor's comments are merely his explanation of his own religious beliefs. Of course, Canada's **Charter of Rights and Freedoms** purports to protect freedom of religion. However, judges and the **Supreme Court** have gutted the protection. In the **Malcolm Ross** case, the **SCC** defended the right to hold only "nice" religious views. You couldn't hate someone under the guise of religion. However, many religions make hateful comments about non-believers.

Another pro-censorship voice from the past is helping to raise funds for the pastor's tormentor. "**Ron Ghitter**, a former Senator and member of the Alberta legislature, has helped raise money for Lund's legal bills. So have members of Calgary's legal community. Ghitter once led an Alberta government tolerance commission that toured the province following **Jim Keegstra's** 1983 conviction for promoting hatred against Jews. Keegstra, a teacher, was fired for telling his students about a world-wide Jewish conspiracy. Ghitter feels Boissoin's letter clearly crossed the line of free speech. 'When you take an identifiable group and say that about them, that is not only inappropriate and wrongheaded, it is also a criminal offence, if someone wanted to deal with it,' he said. 'It is never freedom of religion and freedom of speech when you use your religion as a guise to demean other people.' Ghitter's comments are laughable. Some of the scatological comments in the **Talmud** about Christians certainly demean people. Similarly, bloodthirsty exhortations in the **Koran** about murdering non-believers suggest that ex-Sen. Ghitter's comments are nonsense as he doesn't seem to be advocating the suppression of these religions.

Religious people, conservatives and White nationalists must be aware, none of us is safe. The politically correct censors, gag artists -- the apostles of tolerance who tolerate no dissent -- the Richard Warmans, the pushers of the homosexual agenda, the **Canadian Jewish**



Congress are after us all. They'll tolerate no views but their own. The time has come to fight! Good luck to the Pastor. Hey, Albertans, pack his hearing so that there's standing room only. Picket the hearing. Let the "human rights" mob know that we won't stand for OUR rights being limited any more. An end to minority rule! It's time for the Dispossessed Majority to stand up.

### Tom Winnicki: Another Dissident Gagged

The Canadian establishment has long "chased the Dragon" – prostrated itself in front of Red China hoping for the trade pot of gold at the end of the rainbow. From Mao admirers like **Pierre Trudeau** to silly "Team Canada" trade mission cheerleaders like **Jean Chretien**, our political elite has shown a remarkable comfort level with this totalitarian regime. Right now Red China is well into another campaign to crack down on free speech on the **Internet**.

So, too, is the highly politicized and debased Canadian justice system. Canada has just gained another political mute in the person of London dissident **Tom Winnicki**. In a classic example of police state – sentence him first and have the trial later – a federal court judge has enjoined Tom Winnicki from using the **Internet** to criticize ("expose to contempt") privileged groups. **The Canadian Jewish News** (October 14, 2005) enthused: "Last week, Judge Yves de Montigny ordered **Tomasz Winnicki** of London to refrain from communicating, by means of the **Internet**, messages that are likely to expose persons to hatred or contempt because of their religious, racial or national background. The interlocutory (interim) injunction is precedent setting, [Richard] Warman, an Ottawa lawyer, said, because 'for the first time a Federal Court has issued an injunction relating to **Internet** hate.' Previous interim court rulings dealt with hate messages distributed through the telephone system, he said. Although the court had not released the reasons for its ruling when **The CJN** went to press, Warman said the decision shows courts can restrain objectionable content from the **Internet** pending disposition of the case before a human rights tribunal.

Ottawa lawyer **Richard Warman** who has made a career recently of filing human rights complaints against dissidents was ecstatic: "Warman, who worked for the **Canadian Human Rights Commission** for two years, said he is targeting extremist leaders in a strategic and concerted manner. If we go after a small number of leaders, the White supremacist movement can be eradicated, he said. 'I'm doing this due to fundamental human rights,' I guess." In Warman's book, freedom of speech doesn't rate as a human right.

Warman doesn't like being called an enemy of free speech. He's suing **CAFÉ** and **Paul Fromm** for libel for just such criticisms of his fanatical behaviour. Of course, the **Canadian Jewish Congress**, one of Canada's most strident anti-free speech lobby groups, was equally delighted at seeing another dissident gagged: "**Len Rudner**, director of community relations for **Canadian Jewish Congress**' Ontario region, said the court has pre-empted Winnicki from posting problematic **Internet** content. 'I think the decision of the **Federal Court** is an important statement on the position that Canadian laws take on the question of alleged hatemongers,' he said." Even Rudner concedes that no court has yet found **Tom Winnicki's** writings to be hateful. Oh well, shut him up anyway.

Mr. Winnicki is currently facing a week of hearings (October 17-21) before a one woman (**Karen Jensen**) **Canadian Human Rights Tribunal** concerning postings he made on **Vanguard News Network**, an American-based **Internet** discussion board. Warman had infiltrated the board using the moniker "Axetogrind" and posted inflammatory messages himself. His complaint indicates that he

visited **VNN** numerous times, apparently to spy on **Tom Winnicki** and to be offended all over again. Warman claims \$70,000 in compensation for his outraged feelings. Warman has made at least a dozen complaints against Canadian dissidents in his campaign to weed out the **Internet**. When **Tom Winnicki** blasted Warman for his censorship activities in, admittedly heated language on **VNN**, Warman launched into his victim mode and further charged Winnicki for "retaliation." So, a self-appointed censor successfully complained, in 2003 to **Bell Canada** to try to get Mr. Winnicki's website shut down and, then, further complained about his **VNN** postings. When Winnicki complained publicly on **VNN** about Warman's activities, he was slapped with the further charge of retaliation. Warman strongly objected to the introduction of a **BBC** documentary about British New Age and conspiracy theory writer **David Icke**, which shows Warman and Vancouver **ARA** types plotting to disrupt his speaking tour and book signing. In one scene, Warman, a lawyer, is encouraging the goons to throw a pie at Mr. Icke. Pie-ing someone is considered assault, a **Criminal Code** offence, in Canada. One misguided fool who threw a pie at Alberta Premier **Ralph Klein** was sentenced to 30 days in jail. Warman griped that by turning attention to his *bona fides* and conduct as a chronic complainer Warman, Mr. Winnicki's counsel was "re-victimizing the victim."

### ARA Goons Try to Intimidate Fromm at Winnicki Hearing

Four goons, at least one with a previous arrest for attacking **CAFÉ** associates after a September, 2004 protest for **Ernst Zundel** showed up (as is their right) at **Tom Winnicki's Canadian Human Rights Tribunal** hearing, October 17 and 18. **CAFÉ** Director **Paul Fromm** was to be Mr. Winnicki's sole witness. On October 18, during the noon break, the four closely followed Mr. Fromm and three associates down an escalator to a food court, up the escalator when the free speech foursome changed their minds, and then several blocks down the street before the free speakers shook them. At least eight policemen monitored the entrance to the downtown Toronto office building where the hearings were being held and two plainclothesmen were present in the room for part of the hearings. They had obviously been alerted to potential mayhem on the part of the **ARA** who have a long history of advocating and initiating violence. Mr. Fromm advised the police at the Tribunal hearing what had happened. **Tom Winnicki's** lawyer **Chi-Kun Shi** (partner of **Ernst Zundel's** lawyer **Peter Lindsay**) strongly objected and brought the matter to the attention of **Karen Jensen**, who went on the record as considering the intimidation of witnesses "a very serious matter." One of the **CAFÉ** associates snapped pictures of the **ARA** prowlers and these are being turned over to **Metropolitan Toronto Police** as part of a complaint about the incident. Complainer Warman was the keynote speaker at an **ARA** conference in Toronto in August.

### Epithets Are Indeed, Slippery Stuff

"**Wahida Valiante** of the **Canadian Islamic Congress** ... says the repeated references to 'homegrown terrorists' among Muslim communities incites hatred. 'Homegrown! homegrown!' I mean, this is scary stuff," said Valiante. 'I don't know where the homegrowns are. I move around the community. What frightens us is if this rhetoric doesn't die down and the government takes no notice, we Muslims are in for a rough ride.'" (**Canadian Press**, July 23, 2005) The phrase homegrown terrorist may not immediately strike the rest of us as particularly stigmatizing, but another term much more in evidence -- "racist" -- has gained currency as a stigmatizing term of racial animus calculated to intimidate and silence. "Racist" is a perfectly acceptable alternative to "White trash" or any other term of abuse aimed at Whites. It is a term by common consent that is simply never levelled against non-Whites and should be condemned where encountered as the rankest form of racial abuse.
