Former London Cop Sued for Libelling Northern Alliance Killed in Murder-Suicide

"A retired detective and the highest-ranking woman on the London, Ont., police force were killed early yesterday, in a murder-suicide that ended when the van they were in crashed into an apartment building. Both had suffered fatal gunshot wounds. They have been identified as Acting Insp. Kelly Johnson, 40, and former superintendent David Lucio, 57. ... Police said Lucio had been driving the van. Johnson's gun was found at the scene, and while the sequence of events is unknown, it appears she was the shooter, Const. Amanda Pfeffer said. Johnson was on duty and did not have permission to take the gun home, Police Chief Murray Faulkner said. ... Faulkner said there was a "relationship" between the pair, but its exact nature is unknown." (Kitchener-Waterloo Record, June 08, 2007)

In the late 1990s, the Northern Alliance was a vibrant group of young White nationalists in London. Then led by Raphael Bergmann, it led a number of counter protests or Straight Pride Strides against the annual "gay pride" marches. The Northern Alliance experienced considerable success in attracting support from church goers. Suddenly, Detective Lucio and the London Police Service put out a statement accusing the Northern Alliance of having "neo-Nazi" ties and with being "urban terrorists." Church support faded away and Raphael Bergmann found his reputation so smeared that he moved away. He filed a lawsuit against Lucio and the London Police Service. His lawyer is the "Baffling Barrister" from Victoria, Doug Christie. As with most civil actions, this one has proceeded very slowly.

It's a strange old world. David Lucio, the London policeman who went after Raphael Bergmann was killed by a fellow officer recently. It appears the Northern Alliance, smeared as "urban terrorists," wasn't as dangerous as his fellow police officer, and a female officer at that!

Warman the No-Show

Once he'd finished his testimony at Marc Lemire's hearing back in February -- and presumably no longer received taxpayer's travel money as a witness -- Richard Warman ceased to attend the misery he set in motion with his complaint against webmaster Marc Lemire. Paul Fromm, representing the Canadian Association for Free Expression, has on each of the 18 days of hearings ever since brought the matter to the attention of the Tribunal. Member (judge) Athanasios Hadjis acknowledges the delinquent Warman's absence, notes that he wishes he could compel his attendance and then lets the record show that Warman is not there. His behaviour clearly demonstrates that this is a vexatious complaint meant to cause Marc Lemire "maximum disruption" as part of Warman's campaign to "get" those whose politics he doesn't like.

Who says trying to stifle dissent doesn't have its percs? On June 15, Richard Warman received the Saul Hayes Human Rights Award from the Canadian Jewish Congress in Ottawa. Efforts to find out through Access to Information how much Richard Warman has been paid to be a witness in recent hearings and how much the taxpayers have paid for the bodyguards who accompany him and the Commission lawyers to Sec. 13 hearings have run into a complete

road block. "Privacy" and Mr. Warman's "security" the government information gatekeepers say, despite the fact that the money being spent is taxpayers' money!

Warman Complaint Behind Police Raid on Terry Tremaine

"Regina police are investigating a former university professor accused of spreading hate online. Terry Tremaine, 58, who was let go from his job as a University of Saskatchewan mathematics professor in 2005, is the subject of a criminal complaint by Ottawa-based human rights lawyer Richard Warman and the Canadian Jewish Congress. They accuse him of wilful promotion of hatred in on-line postings that target Jewish, black and First Nations people in Saskatchewan. On Friday, police entered Tremaine's home and seized his computer. No charges have been laid, but Tremaine said he knows what the authorities are after. 'There are certain groups within this country who want to sentence us, who want to silence people with views like mine,' Tremaine told CBC News on Monday. Warman said Tremaine has been posting 'extremist racist and bigoted anti-Jewish, anti-black material to a U.S. neo-Nazi website called Stormfront.' Tremaine was the subject of a federal human rights complaint in October 2004 initiated by Warman.

In February, the Canadian Human Rights Tribunal fined Tremaine \$4,000 and ordered him to stop using phone lines to make discriminatory comments exposing people to hatred or contempt. He was let go from his job at the U of S in Saskatoon in the spring of 2005, three weeks after Warman sent some of Tremaine's postings to university president Peter McKinnon." (CBC News, June 11, 2007)

As we suspected Friday's raid on the Regina home of Terry Tremaine (Mathdokter99 on Stormfront) was the result of a complaint by Ottawa arch complainer and free speech opponent Richard Warman. A frequent Warman tactic using his "maximum disruption" technique against political dissidents, is to file simultaneous Sec. 13.1 Internet censorship (Canadian Human Rights Act) and Sec. 319 (hate law) complaints. He's done this in the Alexan Kulbashian, Marc Lemire, Glenn Bahr and Jessica Beaumont/Ciaran Donnelly cases. Often the victim is raided by the police who take his computer and other goods. Mr. Tremaine lost his computer and software as well as books, which were not mentioned in the warrant. No victim to our knowledge has ever gotten his computer back from the political police in this poxy politically correct tyranny.

The Canadian Association for Free Expression (CAFÉ) is accepting donations to buy Mr. Tremaine another computer. "We hope to have him back in business by the end of the week," Mr. Fromm said. Marc Lemire's Constitutional Challenge: Hints We're Winning

The Canadian Human Rights Commission is falling apart at the seams. They are in total disarray due to the Marc Lemire case. As of a few weeks ago, they have hired outside counsel from Toronto to represent the CHRC. Former CHRC chief prosecutor Giacomo Vigna is off finding his "mental serenity" somewhere. There is no question - WE ARE BEATING THEM! Monday, June 25, will see

three days of examination of **Harvey Goldberg**, a long time policy setter for the **CHRC** and a member of the "hate team", a select politburo of **CHRC** planners who oversee the **Sec. 13 Internet** persecution cases. For the first time ever, Goldberg will face tough questions from the two most respected and free speech lawyers in Canada, **Barbara Kulaszka** and the Battling Barrister from Victoria - **Douglas Christie**.

The **Canadian Human Rights Commission (CHRC)** is seeking to have a fine imposed and a lifetime speech ban placed on **Internet** webmaster **Marc Lemire** for content placed onto his website - **The Freedomsite**. The **CHRC** and **Richard Warman** allege a violation of **Section 13** of the **Canadian Human Rights Act**, Canada's notorious **Internet** censorship legislation, which has so far ensnared 100 victims and raked in close to \$100,000 in fines.

This is a classic freedom of speech case, as none of the complained of material, is a single word that Mr. Lemire has said or written, but rather mostly revolves around a public **Internet** message board, hosted on the **Freedomsite**, where any **Internet** user could debate and join virtual conversations on a variety of topics. As part of **Marc Lemire's** vigorous defence against these allegations, he has launched a Constitutional challenge to the **Canadian Human Rights Act**, specifically **Sections 13 and 54**. The **Canadian Human Rights Commission** have now been put on trial!

There has already been over a month and a half of hearings into this case, spanning 22 hearing days across three cities. It has included history making testimony from numerous world-renowned expert witnesses called by the defence. The **Lemire Defence Team** is headed up by courageous **Section 13** expert and lawyer, **Barbara Kulaszka** who, with amazingly in-depth research spanning over 20 years, has thoroughly exposed this law to be politically motivated and a clear violation of the **Canadian Charter of Rights and Freedoms** and the **Canadian Bill of Rights**.

At the beginning of the hearing, **Barbara Kulaszka** successfully argued for and received from the **Tribunal**, three subpoenas against employees of the **Canadian Human Rights Commission**. This is the first time in a **Section 13** case that a subpoena has ever been issued. The **CHRC** is in complete disarray over the Constitutional Challenge. It appears the complainant, **Richard Warman** has largely abandoned the case. (Warman left in the middle of the second week of hearings, and has never returned.) The **CHRC's** counsel has claimed he has no "mental serenity" and apparently withdrawn from the case. The **CHRC** has now hired outside legal counsel to represent them, which will cost taxpayers a small fortune.

On the first day of the **Marc Lemire** hearing, those seeking to uphold **Internet** censorship basically laughed at the defence team. After 22 hearing days, nine witnesses, dozens of **Section 37** invocations [where a panicky government seeks to hide its misdeeds by claiming "public interest"], four exposed infiltrators, numerous motions won and over 2,000 pages of documents submitted by the defence, they are not laughing any longer! -- **Marc Lemire**

The Costs of Tyranny

If Canadians fully understood the fortune being wasted to silence **Marc Lemire** and the **Freedomsite**, they'd revolt. Repression costs not just people's freedoms but scads of taxpayers' money. **Marc Lemire** estimates that the government has spent over a millions dollars on his case. For instance, we learned that **Human Rights Commission** "expert" witness **Dr. Karen Mock**, who was exposed as having basically recycled an old report, added a new introduction and

a few new paragraphs, and presented it as her "expert report," received \$20,000 in fees, plus \$771 in expenses, presumably to stay at the Mississauga hotel where the hearings were held (despite the fact she lives in Toronto). **Marc Lemire** discovered through **Access to Information** that, as of April this year, the **Attorney General of Canada** had spent \$127,330.91 just to intervene in this case. Most hearing dates have at least one or two **Attorney General** lawyers, led by **Simon Fothergill**, sitting through the proceedings. The taxpayers pick up their travel and hotel costs, as well.

Then, there's the cost of hiring outside lawyers to continue certain cases. Since **CHRC** lawyer **Giacomo Vigna** faded from the scene, presumably to find his mental "serenity", he would appear to have remained on the government payroll. Taking his place for three days in the "**www.bcwhitepride.com**" case in Penticton, June 18-20, was Victoria lawyer **Catherine Boies-Parker**. With about 15 years experience, she would be billing at about \$300 an hour. Three days of hearing plus, presumably, at least a week's preparation would ding the taxpayer for about \$20,000, plus expenses. Similarly, pinch hitting for the missing Mr. Vigna during the **Marc Lemire** hearings in Oakville June 25-28, will be **Margot Blight** of Toronto, a lawyer with similar experience to Boies-Parker. Her preparations would have to be more extensive due to the complexity of the Lemire case. Again, it's hard to see her services coming in for anything less than \$25,000. And the cash register just keeps clanging.

Wiesenthalers Boast They're Prosecuting Marc Lemire

The Wiesenthal Insider (Spring, 2007) boasts: "**FSWC (Friends of the Simon Wiesenthal Centre)** is also on the prosecution team - along with **CJC (the Canadian Jewish Congress)** and **B'nai Brith** -- of **Marc Lemire**, a leading Canadian White supremacist and Holocaust denier who is challenging the constitutionality of **Section 13** of the **Canadian Human Rights Act**." Those endlessly dunned by Wiesenthal fundraisers might be a little let down to learn that: 1) the **Friends of the Simon Wiesenthal Centre** are actually merely "interested parties", they are not, at least officially, the prosecution; and 2) representatives of the intervening Jewish groups which include the **FSWC** have shown up just three times in 25 days of hearings. Are the Wiesenthalers perhaps letting the cat out of the bag that they are the real force behind the **CHRC's** persecution of **Internet** dissent. **Richard Warman**, now up to 26 **Canadian Human Rights** complaints, attended a conference co-sponsored by the Wiesenthalers in Paris in 2003 as part of the **Canadian Friends of the Simon Wiesenthal Centre** delegation, although he claims not to be "of the Jewish faith." He's refused to say who paid for this trip when he was still an investigator for the **CHRC**.

This Spring, former U.S. **Vice President Al Gore** was the guest speaker at a fundraiser in Toronto for the Wiesenthalers. The master of ceremonies was none other than the upwardly mobile **Ben Mulroney** son of former **Prime Minister Brian Mulroney** a shameless Israel Firster. The Honourary Chairman of the event was **Samuel Belzberg** and the chairman was **Gerald W. Schwartz**, mega financier with **Onex Corporation** and a frequent advisor to Liberal and Tory politicians. A recent Wiesenthal fundraiser sent out by **Leo Adler, Director of National Affairs**, boasted: "Friends was instrumental in getting a neo-Nazi website removed after we alerted the Ontario Provincial Police to the hate-filled site." **The Wiesenthal Insider (Spring, 2007)** reports more Wiesenthal mischief making and spying on their fellow Canadians: "We recently forwarded the personal information of key members of the **National Socialist Party of Canada**, a group dedicated to denying the holocaust to the **OPP** and an investigation was subsequently launched."
