## ARA-Calgary Harasses WN University Student

The campus of the **University of Calgary** has been blanketed by an inflammatory poster harassing and targetting a second year female student who has been an activist in the **Aryan Guard**. The group doing this is **Anti-Racism Action, Calgary**, apparently in conjunction with a website called **Anti Racism Canada**, which is run by anonymous people, although **Richard Warman's** legal documents seem to appear up there even before the printer's ink seems dry on them.

The posters say, in parts: "Meet ... **Natalie Sonne** on **Facebook** and other sites, and 'Hiraeth' on **Stormfront**. and her own blog. .... Little Natalie's parents are paying for her education and evidently are not pleased about their little girl's involvement in far right politics. She's about 5'7" with naturally brown hair and is currently in her second year at the **University of Calgary**. Started in Business but switched to Computer Science.

**If you see her she should be approached with disdain, mocking laughter, and much finger pointing. Feel free to express your own view-points on racism to her, as she is hear [sic] to learn."**

Then it says, "with a little bit of help from our friends at **ARC**" and provides the link to that. It is signed **ARA Calgary**, with the email [antiracistcalgary@gmail.com](mailto:antiracistcalgary@gmail.com).

**ARA-Calgary**, some of whose circle assaulted peaceful marchers at last the March 21 **White Pride Parade** in Calgary, has been headed by a perennial **Communist Party of Canada** candidate **Jason Devinc**. He ran most recently in the 2008 federal election in Calgary East, piling up a mere 323 votes and finishing dead last just 20,988 votes behind the Conservative winner.

The poster would seem to clearly violate the **University of Calgary's** policy forbidding "personal harassment" which is defined thus:

*"Personal harassment is harassment not based on any of the prohibited grounds as stated in human rights legislation but generally abusive, insulting and degrading conduct for which there is no legitimate purpose. Personal harassment can take a variety of forms. Obvious bullying behaviours include public humiliation; personal insults and name-calling; persistent criticism; spreading malicious rumours; freezing out, ignoring or excluding; and constantly undervaluing effort. Other less obvious bullying behaviours include removing areas of responsibility; deliberately sabotaging or impeding work performance; refusing to delegate; constantly changing work deadlines; withholding necessary information; over-monitoring, especially with malicious intent; setting up individuals to fail (example: impossible deadlines); blocking applications for leave/promotion; and instigating complaints from others to make the individual appear incompetent."*

The **Anti Racism Canada** website has been featuring and baiting Miss Sonne for several months, publishing her pictures and emphasizing that she is a university student.

This poster technique seems based on **Richard Warman's** strategy announced in a speech by the same name to a conference

sponsored by the **ARA** in Toronto in August, 2005 -- "*Maximum Disruption : Shutting Down the Neo-Nazis By (Almost) Any Means Necessary.*"

In 2006, a motley band of about 25 **ARA**, flying the flag of communist Cuba, arrived in a bus that an **ARA** sign thanked **Richard Warman** for paying for, and demonstrated outside the Port Credit townhouse of **Paul Fromm, Director of the Canadian Association for Free Expression** who had clashed with Warman as he defended many of Warman's victims in **Sec. 13 Internet** tribunals. The **ARA** twice leafletted Mr. Fromm's neighbours making wild and defamatory remarks. This is a tactic used by homosexual radicals called "outing" -- denouncing a person in front of his co-workers or neighbours in an effort to get them to ostracize, exclude or hurt that person. Warman later denied paying for the bus, but, significantly for such a litigious person who sues people who criticize him, as far as we know never sued the **ARA** for their supposed misinformation. Representations have been made to the university urging them to enforce their anti-personal harassment policy and protect Miss Sonne so that she can go about her business as a student.

## Coming up in March

Political prisoner **Ernst Zundel** is scheduled to be released from Mannheim prison in Germany around March 5, having served every day of a five year sentence for expressing his doubts about Germany's new state religion (no, not Lutheranism or Catholicism, stupid), the religion of holocaust. Had he been a drug pusher, rapist, or assault artist, Mr. Zundel would have benefitted from a considerable remission (similar to parole) of his sentence.

Former political prisoner **Terry Tremaine's** preliminary hearing into **Sec. 319** charges resumes in Regina, March 10. The charges resulted from a complaint to the **Regina Police** by **Richard Warman** who had already launched a **Sec. 13** complaint against Mr. Tremaine and complained to the **University of Saskatchewan** where Tremaine was an instructor in math and computer studies. The complaint cost Mr. Tremaine his job at the jittery university. Warman's complaints dealt with Mr. Tremaine's political opinions expressed on **STORMFRONT** and on his own website.

## 61 and Counting – The Defamation Suits Filed By Richard Warman

**Marc Lemire** did a thorough search recently of libel or defamation suits threatened or filed by **Richard Warman** against people who criticize him. The number, which may not be complete, comes to 61! "I am compiling a list of victims of **Richard Warman's** libel threats, under the **Libel and Slander Act**.. So far, I have identified 61 people! To some this might prove that Warman is using the **Libel and Slander Act** to silence anyone who criticizes him, and as a **SLAPP** suit against his critics," says Marc. Warman's latest suit seems a little grandiose, but now he's taking on the Asper empire. The **Anti-Racism Canada** website, in an item headlined "**Warman Lawsuit Last Nail in Coffin For Canwest?**," reported: "This past Friday [January 8, 2010], **Richard Warman** files a claim seeking \$500,000.00 in damages against a number of **Canwest** employees and companies in response to a defamatory article written by **Walker Morrow** in the **Cowichan Valley Citizen** which falsely alleged all sorts of malfeasance on the part of Mr. Warman. And then **Canwest** filed for **bankruptcy protection**. Coincidence?"

We're not exactly certain what Warman does over there in the

bowels of the **Department of National Defence** but one does wonder how he manages his desk job and this torrent of litigation.

### **Wish the Supreme Court Had Made this Ruling a Year Ago**

Last April, a three person panel of the **Supreme Court of Canada** denied leave to **Paul Fromm** and the **Canadian Association for Free Expression** to appeal against a lower court decision, upheld by the **Ontario Court of Appeals**, finding that **Richard Warman** had been libeled by comments calling him a "censor" and awarding him \$40,000. The panel certainly created a reasonable apprehension of bias, as it included two Jews [Jewish groups had loudly backed and honoured Warman], **Rosalie Abella** and **Mr. Justice Fish**, and **Mr. Justice Ian Binnie** who had been the **Canadian Human Rights Commission's** first outside counsel in 1996 in the prosecution of **Ernst Zundel** for the **Zundelsite**. That decision marked the end of the line. **CAFÉ** and **Mr. Fromm** had to scramble to pay the hefty judgement, complete with mounting interest. So, a recent decision by the same supremos, while positive and encouraging for newspapers and **Internet** bloggers like **CAFÉ**, seems to have come eight months too late. It's consolation of sort but the sort of consolation felt by friends of the last man to be hanged before the abolition of capital punishment.

"In a ruling hailed by media organizations as important extension of the right to free expression, the **Supreme Court** has widened the legal protections for journalists who report on issues in the public interest. The court ruled in favour of the **Ottawa Citizen** and other media organizations by creating a new defence from defamation lawsuits based on "responsible communication" of issues of public importance. Journalists or Internet bloggers who are sued for libel or slander will no longer have to prove in court the absolute truth of every allegation. Instead, they can rely on the new defence if the issue is of public importance and they took proper steps to verify the information. The court said that defamation law must balance freedom of expression on these issues against the need to protect a person's reputation and privacy. 'I conclude that the current law with respect to statements that are reliable and important to the public debate does not give adequate weight to the constitutional value of free expression,' wrote **Chief Justice Beverley McLachlin** in a unanimous decision." (**Ottawa Citizen**, December 22, 2009)

### **Political Prisoner Ernst Zundel in Hospital**

'I have been 'under the weather' with a very painful, almost paralyzed left arm. I had a latent fever and basically felt lousy.

Since as a prisoner, one undergoes some pretty dehumanizing procedures like being chained to a metal hospital bed, etc., I wanted to spare myself this humiliation. ### **Jennifer Lynch & Human Rights Commission Busted by Taxpayer.com**

Canada's chief censorship bureaucrat **Jennifer Lynch** has been busted by the Canadian **Taxpayers Federation (CTF)** for wasting taxpayers' money on expensive flights to international meetings of arguably little, none, or even negative value. Using **Access to Information & Privacy (ATIP)** requests, the **CTF** has learned that Chief Commissar Lynch spent \$8,323 on accommodations, meals and a business class flight for a junket to Geneva, Switzerland in 2007. The purpose of this was to meet with the likes of "human rights" officials from Algeria and Morocco as well as the **Asia Pacific Forum**, which is an umbrella organization that includes the likes of Jordan & Palestine.

In 2008, Lynch made another trip to Geneva at the cost of \$8,083 for her business class airfare alone. Including her other costs, that trip cost more than \$10,400. The purpose of her trip in this instance was a committee meeting linked to the UN "**Human Rights Council**", which includes: Bangladesh, Cameroon, Cuba, Kyrgyzstan, Russia and most importantly, Saudi Arabia. One must wonder why Canada would spend its money on and lend its reputation to a body made up of some of the world's worse human rights violators. If these countries have anything to learn from Lynch, it is only how to subvert human rights with more tact and subtlety than their own traditional methods (guns and ropes).

Lynch had a busy year of meeting with other human rights defenders in 2008 however; also traveling to Kuala Lumpur, Malaysia on a business class airfare of \$8,893, plus all other expenses. This confab was hosted by the **Human Rights Commission of Malaysia**, which is a part of a government that – according to the **US State Department** – restricts freedoms of the press, speech and religion, including "barring Muslims born into Islam from converting to another religion," allowing religious courts to enforce apostasy cases under *shariah* law. This country's human rights example was on display just this summer when a woman was convicted by an Islamic *shariah* court in Malaysia for drinking a beer, that sentenced her to "six beatings by cane". But that's little more than a transparent application of the same law that she used to prosecute **Ezra Levant** and **Mark Steyn** [and several dozen **Internet** dissidents like **Marc Lemire**.]

In what was an ironic travel destination, Commissar Lynch traveled to Dublin, Ireland and Copenhagen, Denmark at the cost of \$8,087 for her airfare (business class), totalling more than \$10,300 after expenses. For those who need their memories jogged, Denmark is the country where a set of innocent cartoons were originally produced and printed that sparked world-wide riots by religious extremists. Joining the extremists in calling for the prosecution of any who dare reprint them, "Human Rights" Commissions in Canada attempted to censor **Ezra Levant**, who had them printed in the magazine for which he was editor.
