Political Centre of Gravity Shifts As Identity Crisis Deepens

A thought-provoking article by ANTONY MILNE argues that multiracial Britain is fast becoming dysfunctional. On another level, his predictions about the collapse of civilized standards in Britain could apply equally to other white countries invaded by swarms of asylumseekers and immigrants, legal or illegal . . .

CONTINUED immigration into Britain is now taking on revolutionary dimensions which bode ill for the future, since it will completely and utterly alter the character of this country and will have a negative impact upon intellectual life for decades to come.

Forget about political correctness: all of the medical, moral, and economic problems the media now worry about will, in about 20 years' time, be replaced largely with questions of anthropology, nationalism and identity, urban violence and crime.

Cultural civil war

Present-day headlines about the 'Tale of Two Countries' won't be about the north-south economic divide but about the ethnic/racial one. Diseases and social problems will come and go, but the word 'racism' will never seem to vanish from the journalists' lexicon. The courts will increasingly be dealing with 'race-hate' show trials.

This last fact alone means that future debates about this country's destiny won't be placid, seminar-like occasions either: they could become extremely rancorous because cultural civil war between the indigenous British and the ever-growing diaspora communities is already breaking out.

To say that Britain has been transformed in the last 30 years would be a gross understatement. According to figures from the Office for National Statistics (ONS), the proportion of the population now living in this country born overseas has almost doubled in 50 years to a record one-in-twelve. The largest increase occurred between 1991 and 2001 — just ten years — during which four million foreigners came to Britain to live permanently, a population about equivalent to that of Ireland, and which in total is larger than the combined populations of Slovenia, Estonia and Cyprus. This is a fact that everyone in London has seen with their own eyes. Some areas of the city's outer suburbs have been transformed into versions of New Delhi or Lagos.

Ethnic minorities, from my experience, are too often regarded as virtual colonisers, people having no historical, cultural or racial links with this country, or in most cases even with other EU countries.

We aren't talking here of ancestral peoples who have lived in one region for centuries and are disputing how much cultural or political power they are entitled to: we aren't, for example, alluding to Sunnis, Shi'ites, Turkomens, Tadjiks, Chechens or Pashtuns, or any of the hundreds of other tribes living in sutu; we are talking about a motley crew of foreign invaders, speaking more than a hundred different languages, who have nothing in common either with each other or with the host community among whom they have chosen to live, who will have only the faintest idea of the history of this land, and hardly any geographical knowledge of the townscapes or landscape. Every street and town they live in will reflect the identity of another race of people. Every single brick from which their dwellings are built will have been made by us, the British. Every bus and train they travel on are our buses and trains.

Many of these people struggle desperately to drag us white British into their existential crisis. When the foreign-born Yasmin Alibhai-Brown wrote Who Do We Think We Are? she was hoping that we would all be jointly worrying about this question, when she was really only referring to the dilemma of the diaspora communities themselves, with many of the cultures of whom she herself, ironically, would be personally unfamiliar.

Dependence on Liberal Establishment

If the immigrant communities, to justify their presence here, come up with the other argument that they were legally allowed to live here, they then have to associate themselves, in virtual perpetuity, with the liberal political establishment who they trust will guarantee their safety and not deport them. But if the politicised reasons they give for their being here are not the same as ours, the potential for prolonged enmity is very real indeed. On top of the absence of a common identity or culture, there will be these added political cleavages. The minorities will be seen only as an alien manifestation of left-liberalism, propping up an increasingly unpopular and shop-worn treacherous political establishment.

If I were a black man, I would be extremely worried about the number of English flags adorning English windows, which were kept up long after England were knocked out of the Euro 2004 championship. I would also be worried about the phenomenal vote for UKIP in the recent Euro elections, and the continued firming up of the BNP vote. As Roger Scruton wrote recently, "We, the English, have in recent years been denied a political identity, have been told to repudiate our national history and culture, and are being herded into a multicultural future that we never wanted and were never asked to choose."

Bedrock norms shattered

As the civic moral order is in danger of collapsing, the politicians have not grasped that the centre of political gravity has also shifted.

The increase in yobbish behaviour and the blatant licentiousness revealed in our street life, drinking habits and clothing fashions, and the brutalised look of many of our young men, are manifestations of an underlying anxiety about the threat to our national identity. This in turn means that the traditional moral values that have long underpinned this nation, including the maintenance of high educational standards - in other words, the civilised standards upon which the ethnic minorities rely for the maintenance of neighbourliness and tolerance — are also undermined. In other words, left-liberalism has already shattered our bedrock norms of respectability and responsibility. The churches, police, lawyers, civil servants and universities have actively promoted this moral slide, with drastic effects on the social order and national character.

The ethnic minorities should ask themselves whether they have contributed to this new seedy moral order. Communities, after all, depend upon a degree of social cohesion, and that in turn rests on a critical mass of familiarity, shared lan-

guage and traditions. The first generation of migrants should have seen that continued foreign settlement into this country would destroy this cohesion upon which they, like the rest of us, depend, and should have joined in campaigns to stop further immigration instead of abusing the white British for doing just that. The fact that they have connived in further immigration proves that they have colonising instincts along the lines of 'there is safety in numbers'.

Let me give a specific instance: Scotland Yard is to launch a specialist unit to tackle an explosion in Asian crime: the murder rate for South Asians has almost quadrupled in the last decade. Lord Ahmed, a leading Labour Moslem peer, has said that many serious crimes are never solved because the police have little knowledge of the inner workings of Asian communities. More to the point, he complained that there is "a widespread problem of indiscipline among our young people ... faced with prevailing lax moral standards."

But these lax standards have been actively promoted by the liberal intelligentsia who, following World War II, adopted such a pathological hatred of Nazism that this turned into hostility towards all forms of authority structure. The support of mass immigration into Britain is a form of ideological fanaticism, and is a threat to democracy itself.

A small degree of diversity — as between tribal variations of the same racial

stock — might be good for a country, but not extreme diversity pushed through at such an alarming rate. British society is becoming dysfunctional, and that hints that Britain will sooner or later become a 'failed state'. Life in the big cities will become increasingly unpleasant for the ethnic citizens. Communities have been breaking down in inner cities because they are becoming overburdened with too many overlapping ethnic, economic, social and housing problems.

The ethnic community leaders and their political lackeys must be held at least partly responsible for this state of affairs.


The Invisible Race Gap

A new absurd law in SA is to disallow not only the idea of racial superiority and inferiority, but also any suggestion that the races are different. This will mean that articles such as the following in a mainstream daily newspaper would be taboo!

FROM afar, racially mixed suburbs such as in Maplewood, New Jersey, appear to be the fulfilment of the Brown v. Board of Education desegregation ruling a half century ago. They seem to make the need for affirmative action passé.

But they are not what they appear to be, as Ronald Ferguson, a Harvard professor, knows from surveying 34,000 7th to 11th graders in 15 of these racially mixed suburbs across the USA. Everywhere, he finds the achievement gap, with whites averaging B+ and blacks C+.

Whites and blacks taking similar level courses report that they spend the same time on homework. It is just that the results are different: 38% of whites who



spend 2 hours on homework nightly get all their work done; only 20% of blacks spending 2 hours finish their homework.

It would be politically convenient for Prof Ferguson, a black man raising his two children plus a neph-

He is that rare and refreshing Southerner who never apologises.

Grissom starts with four distinctively Southern traditions: a feudal theory of society; a code of chivalry; a firm concept of the gentleman; and a pervasive religiousness. Southerners thought seriously about what God, honour, and breeding required of them. Men avenged insults on the field of honour, and "falsehood, like an act of cowardice, was supposed to lose one his standing in society ... Every woman was a lady; ladies were to be protected; their virtue assured; their honour unquestioned." The total war Sherman and Sheridan waged against the South was an incomprehensible outrage against this deep sense of propriety ...

When outsiders began to interfere with race relations, delicacy became a disadvantage. Yankee-born Carleton Putnam wrote: "The truth is that responsible Southerners have deliberately weakened their own defence because of their unwillingness to raise the underlying problem. They talk of states' rights when they should be talking anthropology, and they do so out of instinctive kindness. There is a point at which kindness imposed upon ceases to be a virtue."

Among whites, "the moderate became the liberal's best friend," writes Grissom. "Always counselling moderation, inaction, passivity, the moderate never managed a stand on anything." The South was also betrayed by its newspapers, many of which were owned by Northerners. Church ministers were also quick to capitulate, and whites became so demoralised that "the presence of a single black is enough to intimidate a whole room full of whites."

The 1960s saw not only the overthrow of the racial order but virtually every other order as well. "We are always only one generation from apostasy; and one untaught, untrained, undisciplined generation is all it takes to break the chain of civilisation's perpetuity. That generation was the one the 60s gave us."

The white man, he writes, "doesn't even realize he is in a war. He fails to comprehend the seriousness of his own situation and probably won't until he is in the minority — and then it will be too late."

... Immigration and low birthrates are quickly eroding the majority and if the white man disappears, "he will take with him his sense of fair play, his unswerving commitment to the underdog, his belief in personal responsibility, his willingness to aid those in distress, his aversion to crime, his strong sense of family, and his ability to create and maintain stable gov-

Realism about race

IN an interview with Jared Taylor, author and American Renaissance editor, the British monthly Right Now asked (among many other questions):

Q: CAN you tell us when and why American Renaissance was founded? A: I started AR in 1990 for what many would consider radical or even dangerous purposes: to encourage whites to think of their interests in explicitly racial terms, to recognize what every



other race in the U.S. does so instinctively, and to understand that if whites fail to act as a group, they jeopardize their long-term survival as a distinct people with a distinct culture and way of life.

Needless to say, this is not a message welcomed by the establishment. However, ordinary Americans increasingly understand the crisis our country faces ... [Our] position is increasingly winning recognition despite ingrained and intense hostility to any form of racial consciousness on the part of whites. Q: WHAT policies should be adopted to solve or at least mitigate some of America's current race problems?

A: I have always recommended only two policies: an end to mass immigration, and the abolition of anti-discrimination laws. The population of the United States is increasing like that of a Third World country, mostly because of immigration. 90% of immigrants are unassimilable minorities who will bring divisiveness and tension. Population increase will also strain environment and infrastructure. There were 125 million Americans in 1945, and no one thought

the country under-populated. There are now about 290 million of us, with about half a billion expected by 2070 or so. Ending immigration would stop this mad expansion.

As for anti-discrimination laws, private citizens should have the right to choose employees, school-mates, or neighbours for good reasons, bad reasons or no reason at all — just as they choose their spouses.

Prejudice a normal feature of behaviour

IT is not surprising that systems which are sufficiently differentiated, such as biological organisms and societies, will tend to develop mechanisms that will enable them to exclude foreign bodies likely to menace their integrity.

At the biological level, such devices are known as rejection mechanisms. Experience with organ transplants has revealed that to suppress these mechanisms is to increase one hundredfold the patient's susceptibility to cancer, i.e. to the anarchic proliferation of cells.

[Rejection] mechanisms of this kind are essential at all levels of organisation. Of the 3,000 simple societies so far examined by anthropologists, all appear to have laws of exogamy and endogamy. Marriage is forbidden within a restricted family circle, but also outside the cultural group; the object being to avoid cultural hybridisation and hence the production of sub-systems that are differentiated parts of neither one system nor of another.

What is today regarded as prejudice against people of other ethnic groups is a normal and necessary feature of human cultural behaviour, and is absent only among members of a cultural system already far along the road to disintegration. The notion of the universal brotherhood of man is therefore totally incompatible with the nature of human cultural systems. It is as absurd as the notion that the cells making up a vast number of different organisms can be shuffled and still give rise to viable biological systems.

Economic growth is leading to increased mobility. Industrial countries tend to develop labour shortages and import foreign labour. In this way quite large ethnic minorities are being built up in many countries. In addition, economic

development is tending toward everlarger political units which often embrace ethnic groups with little in common with each other. All this is creating a very unstable situation; one which can only lead to civil wars and the massacre of minorities singled out as scapegoats when inevitable economic and social crises occur.

THE JIHAD

THE threat that Islam with its billion adherents poses to the white world is not religious, but ethnic and political, as are threats from other organised non-Europeans now living in white lands.

very beginning in the 8th century A.D., Islamic armies have periodically invaded Europe, in what they call a Holy War, or *Jihad*.

It started when they first advanced on Constantinople. Leo stopped them there in 717 A.D.

Meanwhile in the West, Spain, Sardinia, Corsica, the Balearic Islands and Aguitane fell to them. And it was only in 732 that Charles Martel was able to defeat Abd al-Rahman's Saracens decisively at Poitiers. But it took many centuries more before the invaders were finally pushed out of Gaul and Spain. Ferdinand and Isabella expelled them in 1492; and a combined Venetian, Spanish and Papal fleet defeated the Turkish fleet in 1571. A united Europe was pivotal in their expulsion. Even today we are witnessing the effects of the Islamic Turks having penetrated to the heart of Europe when they subjugated Albania, Bulgaria, Roumania, Hungary, Greece and the Balkans, and menaced Vienna many times between 1529 and 1683.

An article by Pierre Vial in *Identité* (Paris, March/April 1990) gives explicit details of Islamic conquests, holding ransom, pillaging and enslavement of European populations from the 9th Century AD: the Aghlabides, Sicily, Provence, Italy, Marseilles, Arles, Tarente. The arrival of the Normans was pivotal to the political and military alliance which defeated the Moslems.

The problem of Islam

A Mail on Sunday (London) article of 11/7/2004 reads:

SOON it will be illegal to say this, so I had better do it now. Islam — yes, even 'moderate' Islam — threatens our freedom and civilisation. If we do not work out soon how to counter it in open debate, we will find that its influence has gone too deep for us to challenge or resist.

He hoped Mohammed Bashir, a trustee of the city's Masjide-Bilal mosque, could talk local Moslems out of deserting New Labour.

Terrified publishers

A distinguished British writer and academic says leading publishers turned down his latest book because it is too critical of Islam. David Selbourne, who

has had more than a dozen books published, suspects that publishers are shunning The Losing Battle With Islam because it could provoke anger from Islamic extremists and other critics. His book suggests that Islam is not a religion of peace, balance and compassion, as many of its adherents claim. The book is a record of what has actually happened during the Islamic revival. It also discusses the fatwa that was issued against novelist Salman Rushdie after publication of The Satanic Verses, and the "cruel bounty repeatedly offered for Mr Rushdi's head."

"Many people," he says, "don't want to face up to the scale of the challenge that the non-Moslem world is facing."

THE MILOSEVIC TRIAL

If this man is a war criminal, where is all the evidence?

IN the great film with Marlene Dietrich and Charles Laughton, The Witness for the Prosecution appears in court and gives exactly the opposite testimony from what was expected. You would not know it from our media - which passed over the event in silence — but the same thing happened at The Hague [two years ago], in the most important war crimes trial since Nuremberg, that of former Yugoslav president, Slobodan Milosevic. One of the prosecution's star witnesses said precisely the opposite of what he was supposed to say, dealing what seemed like a fatal blow to a prosecution case which was already reeling from several previous blunders.

The star witness in question was Rade Markovic, the former head of the Yugoslav secret services. Before he appeared in the witness box, the media universally hailed him as the insider who would finally give the clinching testimony that Milosevic had personally ordered the persecution of the ethnic Albanian popu-

lation of Kosovo. This is the single issue which NATO used to justify its otherwise illegal attacks on Yugoslavia: without it, the moral justification for NATO's war in 1999 completely disappears.

The urge to hear Markovic's testimony was all the greater because the prosecution's last "star witness" had been a severe embarrassment. Radomir Tanic had presented himself as another "insider", and had claimed that he had actually been present when Milosevic gave the genocidal order. Under cross-examination, however, Tanic was shown to be an agent of the secret services of various Western countries, and to be so unfamiliar with the corridors of power that he could not even say what floor in the presidential palace Milosevic's office had been on

The embarrassment over Tanic was equalled only by that caused when an Albanian witness produced a list of names which he alleged was of Albanians whom the Serb police were to execute. On closer examination, the list turned out to be a fake: the spelling mistakes were so numerous that only an Albanian could have written them.

Enter, therefore, Radomir Markovic, the secret police chief who knew more about what was going on in Yugoslavia than anyone else. But, in painstakingly detailed testimony lasting nearly three hours, he told the court that Milosevic had never ordered the expulsion of the Albanian population of Kosovo; that the former president had repeatedly issued instructions to the police and the army to respect the laws of war, and to protect the civilian population, even if it meant compromising the battle against Albanian terrorists; and that the mass exodus of Albanians during the NATO bombing was caused not by Serb forces but instead by the Kosovo Liberation Army itself, which needed a constant flow of refugees to maintain the support of Western public opinion for the NATO campaign.

Q: "Did you ever get any kind of report," Milosevic asked him, "or have you ever heard of an order, to expel Albanians from Kosovo?" A: "No, I never heard of such an order. Nobody ever ordered for Albanians from Kosovo to be expelled," Markovic replied.

Q: "Did you receive any information about any plan, suggestion or de facto influence that Albanians were to be expelled?" asked Milosevic. A: "No, I never heard of such a suggestion to expel Albanians from Kosovo."

Q: "At the meetings you attended, is it true that completely the opposite was said, namely that we always insisted that civilians be protected, and that they not be hurt in the process of anti-terrorist operations?" A: "Certainly. The task was not only to protect Serbs but also Albanian civilians."

Q: "Is it not true that we tried to persuade the flow of refugees to stay at home, and that the army and police would protect them?" the former president asked. A: "Yes, that was the instruction and those were the assignments."

Q: "Do you know that the Kosovo Liberation Army told people to leave, and to stage an exodus?" A: "Yes," said Markovic. "I am aware of that."

The media greeted this stunning evidence with complete silence. Indeed, it even failed to report the most extraordinary assertion of all made by Markovic, namely that he had effectively been tortured by the new pro-Western authorities in Belgrade, in order to make him testify against Milosevic. Markovic

claimed that the new Minister of the Interior in the Western-backed government in Belgrade had taken him out to dinner and offered him release from prison and a new identity in a country of his choice, if only he would agree to testify against his former boss at The Hague. Markovic also alleged that the Tribunal's own prosecutors had falsified and embellished the written statement he had given them.

These were amazing allegations. With them, the whole prosecution case seemed to crumble. But even more stunning was the reaction of the British presiding judge, Sir Richard May. A judge is supposed to be a neutral arbiter between the prosecution and the defence: May, by contrast, distinguished himself throughout by his belligerence towards Milosevic — who is conducting his own defence — and in particular for his habit of interrupting Milosevic, even sometimes switching off his microphone whenever the former Yugoslav leader's cross-examination showed up inconsistencies in a witness's evidence.

As May listened to Markovic, he tried desperately to stop him making allegations against the Prosecutors ... When Milosevic insisted that the Tribunal's own investigators had falsified Markovic's written evidence, May interrupted him tartly by saying, "That is not a comment which it is proper for you to make." In Judge May's book, therefore, it is irrelevant if the prosecution is lying, or if it an accomplice to torture ...

These events provide spectacular proof of what critics have always said — that the International Criminal Tribunal is a political kangaroo court in the hands of the West.

Other aspects of the trial THE Nuremberg-style court for so-called 'war crimes' ... means that a political or military leader anywhere in the world can be taken from his country and sentenced before an enemy tribunal that has no objectivity or any grounding in Western legal ethics.

Milosevic towers above his accusers and judges, and has shown that NATO forces committed carpet bombing of civilians. While the U.S. was backing the Taliban (in Afghanistan), Milosevic and the Serbs were standing as Europe's frontline against Islamic terrorism. Milosevic is condemned for doing exactly what George W. Bush demands now of all countries. The Serbian fight was for European interests.

The Kosovo Liberation Army, now

darlings of the globalists, were as recently as 1998 being described by U.S. special envoy to Bosnia, Gelbard, as "terrorists". The U.S. State Department had previously prepared a report detailing the methods of intimidation used by the KLA to press Kosovar Albanian ethnics into supporting them. Prior to Milosevic's intervention to restore order, in what is after all a province of Serbia, the KLA had the population of both Serb and Albanian ethnics in a state of terror. U.S. official sources were reporting that Albanian ethnics were fleeing from villages in their entirety from the KLA.

Also well known to both U.S. and European police agencies are the connections the KLA have with organised crime in Europe and Turkey and the funding they derive from heroin trafficking. The KLA — backed by various Islamic states and Albania — desires a state

that embraces all of Kosovo, large parts of Serbia and Macedonia, parts of Greece, and Montenegro.

One of the principal demands of NATO was that the Yugoslav Federation adopt a free market economy. Yugoslavia was racked by the same kind of IMF-imposed stringency economics that brought chaos to many other nations.

Kosovo is one of the most mineralrich regions in the world. This is centred at the Trepica Mining Complex, worked 24 hours a day, which has the richest lead and zinc mines in Europe and is ranked third in the world. Lignite deposits are sufficient to last 13 centuries. Gold, silver and cadmium are also mined. The region was mined first by the Greeks 2000 years ago, followed by the Romans. It was a prize fought for in WWII and taken by the Germans.

Russian-American journalist probed Russian 'business', murdered

N Russia, investigative journalism can have serious, even fatal, consequences. None the less, Paul Klebnikov, the American journalist and editor of the business magazine Forbes Russia, was fearless. He was shot dead in Moscow at the age of 41 on July 9th this year.

He had gone to Moscow from the New York-based parent publication prior to the launch of the Russian-language edition in April this year, and it bore his personal stamp.

Energetic and hard-working, he believed that Russia's often chaotic, highstakes business world had become calmer and more civilised, and he wanted to produce a serious publication capable of contributing to this improved environ-

In its first issue Forbes Russia did what no other magazine in that country had ever done: its journalists researched and reported on Russia's 100 richest people, estimating how much they owned and how they had acquired it. This authoritative list is often cited in local media, to the fury of wealthy Russian-business people who prefer to keep their affairs quiet. Klebnikov made himself no friends among them with his publication.

He was a dedicated digger, who moved easily from socialising with Russia's richest men to clandestine meetings with Chechen rebel commanders.

Though born in New York, the de-

scendant of émigrés who had fled after the 1917 revolution, he was motivated by a passionate identification with Rus-

sia and its culture. He attended American and British universities. Fluent in Russian and French as well as English, he joined Forbes in 1989 and rose to become a senior editor, specialising in Russian and eastern European politics and economics, and investigating the criminal underworld's links to business and politics. Before assuming the editorship of Forbes Russia, he was best known for his research into the business and connections of oligarch Boris Berezovsky, whom he accused of corruption and excessive influence over the Kremlin during Yeltsin's presidency (1991-1999). His book Godfather of the Kremlin, Boris Berezovsky and the Looting of Russia was published in 2000, and appeared in paperback as Godfather of the Kremlin: The Decline of Russia in the Age of Gangster Capitalism. His second book, published in Russia last year as Talking with a Barbarian, was based on conversations with the Chechen rebel commander Khozh Akhmed Nukhayev, and dealt with the role of organised crime in Chechnya.

tions become clearer. The oligarchs and corporate raiders are playing for high stakes.

In an ideal world, one would wish Russia to give Chechnya its independence, and in return expel every Chechen, mafia member or not, from Russian soil. But the consequences are so imponderable, the expanses so vast, the ethnic identities so complex, the entrenchment of the mafia so deep, that the best that Putin can do in the real world for the moment is clean up the Augean Stables bit by bit, handle the crime, assassinations and atrocities in as capable a manner as a chief of the former KGB would know how.

SINCE Vladimir Putin took over the presidency, Russia's situation has improved steadily. From being one of the biggest debtor nations in the world, it has become just four years later a creditor nation. This could be dangerous for the country because once it is free of debt it becomes free to make its own decisions.

Red Mafiya: How the Russian Mob has Invaded America, by Robert Friedman

PERHAPS the reason why the mainstream media has adopted a low profile towards this book in recent times is the sudden death — probably murder — of the author, Robert Friedman.

When it was first published in 2000, the Washington Post said the book was "first rate", and described the Red Mafiya as "one of Russia's most dangerous exports." Associated Press said it was "An under-world far



more dangerous than its Italian counterpart"; the Arizona Republic: "The most savage and vicious bunch of thugs ever to reach American shores; and the Houston Chronicle: "The most violent, unpredictable and fastest-growing crime organization in America."

The book was praised also by the Chicago Sun-Times, The Boston Globe, Publishers Weekly, the Columbus Dispatch, the St Petersburg Times and the San Diego Union-Tribune.

These days, Red Mafiya is obtainable only with great difficulty, but now Thinkers Library have managed to secure a limited stock. The extraordinary aspect of the book is that in spite of most of the members of the Red Mafiya being Jewish, the author Robert Friedman was himself one of the brave Jewish truth-sayers.

During the detente days of the 1970s and later, Soviet leaders, bowing to Western pressure and eager to rid themselves of a troublesome minority, agreed to allow a steady emigration of Soviet Jews to Israel and the USA. Released from their Soviet gulags by the KGB, undesirables swarmed into America, not to participate in the American dream, but to steal it.

Flourishing in the gullible and naive U.S. economic climate, and with the reassuring fall-back position of Israel's open-arms policy should there be too much 'heat' (Israel of course has no extradition treaty with any other country), these unscrupulous criminals infiltrated American business, politics, finance, media and professional sports with chilling ease. They are now major players in the American economic land-scape, employing two strategies to facilitate and hide their consummate criminality.

By buying the best PR that money can secure, they promote and palm themselves off as the embodiment of decent business and charitable benignness. If this facade fails, there are always murderous enforcers, many of whom are ex-Israeli secret service members, permanently to silence snoopers, exposers and law enforcement agencies that become too zealous in their work. Shortly after the publication of this book, Robert Friedman had a \$100,000 contract put on his head. He is now dead.

While TV viewers are enchanted by the TV's "The Sopranos", the real Kosher Nostra is taking over America. Back in motherland Russia, Fortune Magazine estimated that 50% of Russia's raw wealth is still in the hands of robber barons, most of whom are Jewish.

This book gives a new insight into politics, foreign policy and news reporting. It reveals a termite problem that is chewing the beams of world order and existence. The book mentions the visit to South Africa of some members of the Red Mafiya in their flight from American law enforcement agencies, but does not say if they remained here.
