"As a POW who has been down for 20 years I have seen a number of attempts at forming viable organizations with goals of providing a voice for political prisoners and tackling prison issues in general. Most have faded with time, and most have failed to accomplish anything. This is in part because these things were headed up by well-meaning but generally unqualified souls. By which I mean those who have never been forced to spend time in Amerika's gulags, or prisoners still confined to prison, or those well-meaning ex-cons who had not created a stable life for themselves before setting out to help their Brothers and Sisters left behind. This has changed. LibRA has been in the works now for a few years, providing a potentially more effective voice for our political prisoners than we have seen before. Directed by brother John Gerhardt, a more-than-well-proven activist and advocate for prison reform and an ex political prisoner, with years of experience in the pro-White cause, and with

the experience of one who has known the foulest political accomplishment of the system (prison), John has not forgotten those he left behind, and has proven himself a more effective activist than most who have had the leisure of life without prison.
