ABRAHAM LINCOLN REGARDING NEGROES

"Negro equality! Fudge!! How long, in the government of a God, great enough to make and maintain this Universe, shall there continue knaves to vend, and fools to gulp, so low a piece of demagoguism as this?" From Fragments: Notes for Speeches, September 1859 (Vol. III, p.399)

"In the course of his reply, Senator Douglas remarked, in substance, that he had always considered this government was made for the white people and not for the negroes. Why in point of mere fact, I think so too." (Speech at Peoria, Illinois; October 16, 1854, during first Lincoln-Douglas Debates, Vol. II, page 281)

"I will say then that I am not, nor ever have been in favor of bringing about in any way the social and political equality of the white and black races (applause)--that I am not nor ever have been in favor of making voters of negroes, nor of qualifying them to hold office, nor to intermarry with white people; and I will say in addition to this that there is a physical difference between the white and black races which I believe will forever forbid the two races living together on terms of social and political equality. And in as much as they cannot so live, while they do remain together, there must be the position of superior and inferior, and I as much as any other man am in favor of having the superior position assigned to the white race." (Fourth debate with Stephen A. Douglas at Charleston, Illinois, on September 18, 1858, Vol. III, pp. 145-461)

"Judge Douglas has said to you that he has not been able to get from me an answer to the question whether I am in favor of negro citizenship. So far as I know, the Judge never asked me the question before. (Applause.) He shall have no occasion to ever ask it again, for I tell him very frankly that I am not in favor of negro citizenship (renewed applause) ...Now my opinion is that the different States have the power

to make a negro a citizen under the Constitution of the United States if they choose . . . If the State of Illinois had that power I should be opposed to the exercise of it (Cries of "good," "good," and applause) That is all I have to say about it." (Speech at Springfield, Illinois, on June 26, 1857, Vol. II, pp. 405-409)

"See our present condition -- the country engaged in war! - - our white men cutting one another's throats ... and then consider what we know to be truth.

"But for your race among us there could not be war, although many men engaged on either side do not care for you one way or the other... It is better for us both, therefore to be separated ...

"You and we are different races. We have between us a broader difference than exists between almost any other two races. Whether it is right or wrong I need not discuss, but this physical difference is a great disadvantage to us both; as I think your race suffers very greatly, many of them by living among us, while ours suffers from your presence. In a word we suffer on each side. If this is admitted, it affords a reason at least why we should be separated". (Address on Colonization to a Deputation of Negroes in Washington, DC, on August 14, 1862 (Vol. V, p. 371)

Alligators Move in Behind Katrina. Report Posted on: 2005-09-13 19:26:13. Possible gruesome explanation of relatively low body count. (The Independent on Saturday)

Alligators are stalking the flooded waters of New Orleans and rescuers fear they will eat the bodies of Hurricane Katrina's victims. Michael Rieger, a public information officer for the Federal Emergency Management Agency (FEMA), said crews in patrol boats searching for survivors had seen many alligators in the flood waters, some with bloody snouts. Authorities have just started the operation to recover what could be thousands of bodies in the water, on the streets and trapped in homes.

But Rieger said: "Many people are never going to be found. There are a lot of alligators, and alligators love that type of stuff." The spokesman said the emergency services had been leaving Global Positioning System indicators on bodies they find so they can return to them after evacuating the living. With about 10,000 people estimated to be left in New Orleans, which last week had a population of about 480,000, the evacuation effort has slowed, he said. Where are all the alligators? All the alligators in the swamps and rivers of southeastern Louisiana, now provided an express route to downtown New Orleans via all those breached levees. There are lots of them. Where are all the bodies? You know, the "thousands" of people that the New Orleans Mayor says died during the recent Hurricane Katrina. Maybe the alligators got them and tucked them up underneath submerged ledges and logs, in order to "ripen" them to just the condition they like. Lack of coverage of alligators and dead bodies, alone, tells you just how censored and managed is the news for even a huge, breaking catastrophic event in America today.

The widespread anarchy and looting in what now should be dubbed "The Big Uneasy" are just samples of what lies in store for our big cities in the very near future, after the wheels fall off the rolling tent show we call America. Some estimate that 50-100,000 people remain in New Orleans even now, not including those being raped, robbed and murdered inside the SuperDome (because they are government certified to be free of anything with which to defend themselves, of course). One Black leader reported one case of cannibalism. In happier times, New Orleans' population was comprised of 67% Blacks and 28% Whites. It is likely that those remaining in The Big Uneasy now are almost exclusively Black and getting Blacker with every gunshot.

After watching endless videos of looting, suddenly there is nothing about looting. I wondered how long it would take for the commissars of political correctness to put an end to the boundless display of Black depravity. Actually, they would probably find at least one White looter to videotape and put that into endless replay. I'm sure they looked, but couldn't

Orleans.

I was completely amazed but soon understood what kind of ridiculous PC capitulation our government engages in--now more than ever. I realize what having 500 New Orleans blacks in our community means. I will never be able to feel safe in the small town again.

Helena is fairly densely populated but isn't spread out over a large area, due to mountains. One can see the whole city from a hill without turning one's head. The low income housing that has been set aside for these people is right in the middle of town next to one of only two high schools. I have seen the "diversity" my city has inherited first hand yesterday while driving to the store.

Two 20s something, gangsta-dressed, shaved-head, obvious (displaced persons) gang member, trash were waiting to cross the street in a residential area. They walked out in front of a car they could have easily waited to pass--only a few cars for many blocks. It was apparent they did this for the fun of it. One gang member wandered towards the front of the car and gestured, one hand on his crotch and one in the air, a display of simian dominance.

This gang maneuver was done to intimidate a stranger that had been forced to stop for these degenerates in a town where there has never been gangs. In all the years I've lived in Montana, I have never seen this kind of thing. I can only compare it to the mentality of someone publicly and deliberately poisoning a city's water supply and DARING anyone to say something about it. I am sick of this scum-loving, liberal political plague and so I have to ask what can be done? Really?

I know there is an agenda for this to occur so what the hell? Karate and blowguns? Old-fashioned western vigilantism? Is it even possible to find a city in America that has enough sense to arrange its infrastructure to keep gangs, welfare generations and degenerates out? In Salt Lake City, Utah, the media wonder why people don't believe what they report! Anne, writes that the son of her neighbor, Liz, works for the Salt Lake City Fire Department. Let me tell you a few things about the wonderful group of

evacuees they received in Utah. The first plane arrived with 152 passengers. Of the 152; 10 were children. Three of the children had been abandoned by their parents.

As these passengers attempted to board the plane, the National Guard removed from their person; 43 handguns (it is illegal to own a Handgun in New Orleans), 20 knives, one man had 100,000 dollars in cash, 20 pounds of marijuana, 10 pounds of crack, 15 pounds of methamphetamines and 10 pounds of various other controlled substances, including heroin. Upon their arrival here in SLC, two people immediately deplaned and lit up a joint. During the course of medical evaluations, it was discovered that parents were using their kids to carry loads of looted jewelry (price tag still on) and other items. One third of the people who got off the plane were angry that they didn't get to go to Houston or San Antonio.

Over the course of the next 36 hours SLC received an additional 430 evacuees. Most of these, like their predecessors had to be relieved of illegal items. Additionally, most of them, were the owners of exceptionally prolific criminal records, just like those in the first flight. By the second night in the shelter, there was one attempted rape of a relief worker, sales of drugs ongoing and a gang had begun to rebuild. When the people arrived at the shelter, they were given the opportunity to dig through piles of donated clothes from local church groups. Many complained that they were second hand clothes. The state set up a reception center with relocation assistance, Medicaid and workforce services among many assistance groups. This past Saturday, workforce services held a job fair. Eighty-five of the 582 evacuees attended, 44 were hired on the spot 24 were asked back for a second interview. Guess the others had no desire to work. Yesterday they began relocating evacuees to be with family or friends who had agreed to take them in as well as three to the county jail. Now in the health arena; 4 with AIDS, 15% of those 582 had some form of STD, one case of TB, 2 heroin withdrawals, 15 mental health admissions, one brain tumor and 15 nursing home patients. Like everyone in this nation, I watched as the news media blasted FEMA and President Bush for the "poor response."

While everyone on TV saw nothing but people being let down by government, I saw people letting down people. Who would have ever thought that we would reach a point in time that US citizens would lie around in piles of trash complaining that no one had come to pick them up out of it. What ever happened to people pulling together to make their circumstance better? Why couldn't they get up and move on their own or at least just clean up the area where they had to wait for evacuation? Why did they feel the need to take a crap in the aisle of the Superdome? FEMA did not fail them. FEMA is not a response agency. State and local government is responsible for the first 72 hours. But more important, we all have a responsibility to help ourselves and neighbors.

Poverty is not an excuse to behave like animals. Difficult situations are not an excuse to loot your neighbor 24 hours before the storm even hits. I have always said New Orleans was a toilet; now everyone has proof that not only was it a toilet, but a toilet long overdue for a flush!!!

OUR PROGRAM

The NSV advocates a survival program. We recommend that all White Nationalists be armed with legal firearms and plenty of ammunition, store food, insure a drinkable water supply and stock survival items. We also recommend that White Nationalists move to rural areas and network with other White Nationalists for mutual defense and support in preparation for that day when death and chaos engulf the world in Armageddon (essentially a race war and house cleaning). Other than this survival program, we recommend that White Nationalists engage in legal organizations and political activities of their liking

OPERATIONS

GERMANY: On April 15th and 16th, unknown nationalists painted anti-Jewish slogans during the night to Tuesday on a synagogue in the small City of Herford (German state: Northrhine-Westfalia). One slogan was "Six Million Jews Were Not Enough-We Support the PLO."

On April 21st, there was an election day for the State Parliament in the German state of Saxon-Anhalt. The German People's Union (DVU) did not run for seats to defend their successful election result (12.9% = 16 seats) of 1998. It is heard that the DVU has problems, finding candidates, and money worries. The internal trouble between DVU members of the Parliament was a problem too. The right wing party United Rights (VR) that split away from the DVU Parliament faction did not run for seats either. Only the second splinter party, Free German People's Party (FDVP), did run for seats to defend their former DVU seats in the State Parliament. They got election campaign help of the Austrian FPÖ Chairman Joerg Haider. The FDVP had gained only 0.8% of the votes (0 seats).

On June 24th and 25th, during the night to Tuesday, unknown nationalists painted swastikas and anti-foreigner slogans on shop windows of immigrants in the small town of Steinhagen (German state: Northrhine-Westfalia). It is not okay that an immigrant can buy houses and real estates in a foreign country.

FRANCE: On April 21st, was the first round of the presidential election in France. A surprise success for the FN chairman, Jean-Marie LePen, because he gained 16.86% of the votes nationwide and he reached the second place in the presidential election. Mr. Chirac (conservatives) gained 19.88% of the votes nationwide and the socialist Mr. Jospin gained only 16.18% of the votes. The other right-wing candidate, Bruno Megret of the Movement National Republican (MNR), gained only 2.3% of the votes. Mr. Megret demanded of his voters to vote in the second round of voting for Mr. LePen. Nearly all socialist, communist and trotskyite candidates demanded of their voters to vote in the second round of voting for the conservative Chirac. The election campaign was about the inner security-fighting, burglars, thieves, murders etc. It

means that a woman can go out by night without fear. The criminals are a problem in Europe. Congratulations came from the Russian nationalist leader, Zhirinovsky (liberal democrats). Dr. Gerhard Frey (German People's Union or DVU) and Franz Schoenhuber (former chairman of the Republicans or REP). If Mr. LePen wins the presidential race, he will cancel the EU treaty. Also Mr. LePen and Mr. Chirac will go through the second round of voting on May 5th.

On May 5th, there was the second round of the presidential election between the kosher conservative Mr. Chirac and nationalist leader LePen in France. Mr. Chirac gained 82.21% of the votes nationwide and FN leader LePen gained only 17.79%. Mr. Chirac won this election only because de facto all conservative and left parties made a united effort to vote for him.

HUNGARY: On April 7th, there were Parliament elections in Hungary. The Hungarian Life and Justice Party (MIEP) lost all their 14 members of Parliament because they had gained only 4.36% of the votes nationwide. In Hungary, a political party needs a minimum of 5% nationwide. The MIEP chairman, Istvan Csurka, opposed the EU membership and a sell-out of real estates and houses to foreigners and international combines. EU, UN and the foreigners are weapons of the international Jew. Hitler was right!

DENMARK: On the same day, there was a pro-Israel rally in the City of Arhus, Denmark, with 250 demonstrators. A group of Palestinian immigrants and members of the skinhead group, White Pride, hurled bottles and stones at the pro-Israel demonstrators. Arrested were 31 skinheads and Palestinians.

ENGLAND: On May 2nd, there was a very good result for the right wing party British National Party (BNP) by the local council elections in England. The BNP won three seats on the borough council in Burnley. The three BNP councilors are Mr. Grogan, Mrs. Hughes and Mr. Edwards.

GEORGIA: White Unity Rally (date unknown): Auntie Racist extends her sympathies to all who missed out on the Aryan Unity Rally hosted by the Haralson County (Georgia) Free Knights. Robert and Traci Ray knocked themselves out to provide everything a crowd could possibly need and then threw in some extras. Traci made some magnificent quilts and sold raffle tickets to give first choice of any of them to the winner. Meanwhile, the Blood Drop quilt served as a back drop for photos and lent atmosphere to the event.

The Rays provided food for sale and even some free food to make sure no one went hungry. Auntie Racist was only privileged to hear two of the speeches, as obligations elsewhere were pressing. Brad Jenkins and Pastor Redfearin were really putting out the word. Auntie Racist hopes the other speakers did not think she left because she was not interested in their ideas. ALABAMA: This year's Klan Jam just prior to June 10th in Fort Payne was a big success as reported by Auntie Racist. It was a picture perfect, breezy June day with 150 to 200 (Its hard to count them when they keep walking around.) Aryans coming together from all around the eastern United States. At the invitation of the speakers, 12 white people crossed the street from the spectator corral and joined their fellow Aryans.

Don Romine, who founded this annual event, attended part of the rally, but had to leave early because of his health. He spent several years working hard on building up this event and has now left it in the hands of some able successors, so that the rest of us could stay on and enjoy the spectacle.

When the speeches began, a young man named Jake DeLaney announced a new group, the Armageddon Warriors of America. He promises that he and his people will be heard from in the future. He also chastised White America in general because of their fickle attitudes toward those in the white power movement. They are quick to call on Aryan groups when they have a problem they need help with, he says, as if Aryan groups are "a bunch of mercenar-

ies". But, unless they need something, they don't know us. During Brad Jenkins' speech, he directly addressed a White man in the spectator section who was carrying a small child in his arms. Brad promised to give the man a list of child molesters in Alabama and told him he needed to know things like that. The man later came across the street to join the Aryan gathering.

Ricky Draper spoke very briefly. As he spoke, he turned his back on the spectators and spoke instead to the assembled Aryan people. He said these were the people who were important to him. He called on everyone to stop fighting with one another and to stick together.

Jill pointed out for one and all that, while the hordes of immigrants flocking into our borders have come here to improve their lives, their presence is not improving ours at all. And WE don't have some other golden shore to sail to. This is it.

Ken Gray, a two-seed man, said that he has been in the Movement all his life (He's old enough to have grandchildren.) and has not seen a time when things are happening the way they are now. He said we will prevail because we have Yahweh on our side.

And yes we do. And that's another good reason for rallies and gatherings such as the Klan Jam. The young and the new can be with the elders and the seasoned veterans. There can be a sharing of wisdom and a sharing of fresh energy.

Thank you to those who organized the rally and made it work. It takes a lot of know how and work to make it all look so easy.

IDAHO: On May 17, 2002, two skinheads, David A. Johnson, 24, and his girlfriend, Karena Giselle, 27, had

been ordered out of Pastor Richard Butler's private residence in Hayden, Idaho, after it was determined that their presence there would cause problems since Johnson especially had warrants out for him in a number of states and he is apparently a career criminal. Johnson and Giselle had been living at the pastor's home for about a month before the decision was made to ask them or tell them to leave.

Some time before moving into the pastor's residence, Johnson and Giselle were living in Mississippi at the home of a Mississippi klan grand dragon named James Maxie from whom the two stole money and most likely credit cards from Maxie. This was all under the the guise of being Movement patriots. When Maxie learned of the theft, he reported the credit cards stolen and filed a police report.

Subsequently, Johnson and Giselle contacted Jeff Schoep of the National Socialist Movement, wanting to stay with him because they had nowhere to go. Jeff told them that he had no place for them to stay but that he would gladly try to help them get an apartment. They told Jeff that they only had \$40. The couple stayed with a local NSM member as the member did not know what happened in Mississippi or that he was harboring fugitives.

After the klan notified the NSM of the couple's dealings, the couple was ejected from the house in which they were living. Eventually, the pair went to Hayden, Idaho, and found a place to stay in the guest bedroom as they mooched and freeloaded off the pastor for about a month. As the word has it, the two had tried to seek support from other National Socialist groups and individuals in the past also. Jeff Schoep told this writer that he had received reports that David Johnson was seen going in and out of the office on several occasions, and trying to get into the computer. An NSM supporter also saw Johnson go into the pastor's bedroom several times when the pastor was not there.

While the pastor was in York, Pennsylvania, he was talking to a Black attorney who told the pastor that it was highly unusual for Mike Teague, former Aryan Nations Chief of Staff, to have a legal judgment against him, resulting from the now-famous trial, to not have paid anything in settlement of the \$600,000. Surely, this lawyer said, Mike would have had to pay something. The pastor got out from under the debt by turning over his property and Jesse Warfield is (or was as this report is three years late) currently paying \$10 or \$20 every two weeks. Mike Teague pays nothing. The Black attorney told the pastor that it looks like Teague is working for the other side.

Mike McNabb, former printer and handyman at The Church property, works part time at a coin shop in Coeur d'Alene. He occasionally visits the pastor. McNabb told the pastor that on several occasions, he has seen Mike Teague's car parked outside Norman Gisel's office. Norman Gisel worked with Morris Dees and the Southern Poverty Law Center to sue Pastor Butler and the Church of Jesus Christ Christian. After this information reached the pastor, he ordered Mike Teague not to come around his house again. Mike Teague

was informed several other times also that he is not welcome at the Butler residence.

On May 17th, just before midnight, David Johnson and Karena Giselle showed up at the pastor's doorstep, claiming that they had forgotten some of their belongings. Mike Teague was hiding behind his truck and out of sight. Niki McLeod, the fiancée of Shaun Winkler, current Aryan Nations Chief of Staff, answered the door. Johnson entered and told Shaun that there was an intruder and that he (Shaun) should get dressed. As Shaun was getting dressed, Mike Teague and Karena Giselle tried to force their way into the house as Johnson cut the telephone line and let the three German shepherd dogs out into the back yard. A fight ensued between Karena and Niki just inside the house, then went out onto the lawn and finally into the street. A neighbor called the police.

The Hayden Chief of Police, Jason Felton, and three officers arrived at the scene. The fight between the two women stopped with Niki's blood on the carpet, on the outside of the front door and the wall of the house.

Mike Teague was on the doorstep and attempting to gain entrance to the house but he was confronted by Shaun Winkler. David Johnson did not participate in any fighting, but was standing near Mike. Just as the police chief crossed the threshold of the house, Shaun used pepper spray against Johnson but only got the back of his head because Johnson turned and ran quickly. Mike Teague got some spray in his face but most of the spray went into the police chief's mouth as he tried to intercede in the ruckus.

By this time, the pastor was downstairs, trying to find out what was happening. Shaun was arrested for interfering with an officer and booked in the local jail. He was since released with court dates pending. David Johnson and Karena Giselle went home with their hosts, Mike and Christian Teague, and their three young children. Shaun told this writer that Mike Teague, David Johnson and Karena Giselle smelled like a brewery.

A week later, on May 24, 2002, Shaun Winkler was at the the CITGO 7-11 Store on Government Way and Hayden Avenue, getting some gas for a lawnmower, when Mike and Christian Teague, their three children and David Johnson arrived. Some angry words and threats were exchanged between Mike Teague and Shaun Winkler. When Shaun went for his pepper spray, David Johnson turned tail and fled the area, leaving Mike Teague to be sprayed a second time in as many weeks by Shaun. The spray not only hit Mike Teague but glanced off him and struck his wife, Christian, and a couple of the kids. Shaun told the employee at the store to call the police because there will be more damage done as soon as Mike Teague got up off the pavement and began to recover from the spray. Mike Teague made a citizen's arrest on Shaun for assault with the spray, Shaun was arrested a second time, Christian was crying and David Johnson managed to avoid any involvement. What Karena was doing at this time was unknown.

The drama continues and the show is not over yet. For those of you who are new to the Movement, this writer would like to greet you with a hearty "Welcome to the Movement!"

OREGON: In what now seems to be an annual event, Volksfront had its second annual Althing in the Mount Hood National Forest on June 28-30. The Althing includes overnight camping from Friday afternoon to Sunday morning along with barbecue on Saturday. It was hoped that such an event would be good spiritually for not only the adults but especially for the children. As with the previous year, the weather was supposed to be sunny and warm but whoever supplied the weather information probably checked the weather predictions for Portland and not for the Mount Hood National Forest which had rain often during the summer. In fact, the camp site looks like a prehistoric rain forest with the lush green vegetation, moss over rotting trees and shady as tall evergreens provided a canopy over the area.

On Friday, there was a little bit of rain. One of the organizers told this writer that the event cannot be stopped by a little rain. This was true but that little bit of rain started to become heavier as the afternoon progressed. Most people at the gathering enjoyed seeing each other again, especially the women who stayed up to about 3:30 a.m. on Saturday, sitting under one of the many tarps which had been set up to keep the attendees dry. At times, the rain became heavy, almost extinguishing the camp fire, and then it would lighten a little. Responsible drinking was allowed and there were no problems. After all, there were really no strangers at the gathering.

By Saturday morning, just about everybody had enough of the rain, mud and water in the tents so the rest of the weekend event was canceled. The \$10 registration required to finance the food was never collected. You might say the best was made of a disappointing situation as the people who came from the north, such as Seattle, went to a home in Vancouver where a barbecue was held in the back yard and food consumed. Those people who came from the south, such as Salem and Eugene, went to a home in the Salem area where they too had a barbecue set up in the back yard and ate the food before the food spoiled.

About 41 adults and 14 children were present and, had the weather been good, there would have more than twice that on Saturday. In either case, Volksfront normally has a barbecue on a summer Sunday. HIGH SCHOOL MAILINGS:

We continue to mail the "NSV Report" to high school students mainly in the Northwest. As with placing flyers under car windshield wipers and tossing Movement newspapers onto front porches, there is not always an initial reaction reported by the newsmedia. We are giving you this report of

our most recent mailings.

On May 6, 2002, 517 issues of the "NSV Report" went to seniors at Willamette High School and South Eugene High School of Eugene, Oregon. We have not heard of a reaction from the newsmedia but we do know that there has been a reaction among the school faculty, students, parents, police and postal employees. This is normal. This mailing was too close to the end of the school year so the controllers of the newsmedia apparently figured to let the matter die rather than give us publicity.

Shaun Winkler, then Aryan Nations (AN) Chief of Staff, told us that AN received about 10 telephone calls from Eugene from boys who expressed sympathy to the Movement after they received the "NSV Report" containing the AN telephone number. This issue was the one with main article "The Truth about Blacks." The high school students who gave this report were South Eugene High School seniors.

On this same day, we also mailed 40 reports to students of unknown classes at Ferndale High School in Ferndale, Washington, with no response.

On May 13th, 40 issues of a different report went to unknown classes at Ferndale High School and 172 reports went to freshmen, sophomores, juniors and seniors at Lynden High School in Lynden, Washington.

On May 14th, a different report went to the same 172 students at Lynden High School and 130 reports went to sophomores, juniors and seniors at Lynden Christian High School, a private school, in Lynden, Washington. There were two newspaper articles in "The Lynden Tribune" of May 22nd and one newspaper article in "The Bellingham Herald", of May 30th.

On May 24th, the JAN/MAR 2000 "NSV Report" was sent to 386 juniors and seniors at Lake City High School and Coeur d'Alene High School, both of Coeur d'Alene, Idaho. There has never been any newsmedia response to our knowledge.

"The Lynden Tribune" of May 22nd reported that this writer "is busy upsetting students, parents and school officials in Lynden. And he's doing it all within the legal limits of the law." The article also reported that some of the mailings came in white envelopes printed with the words "express mail" on a yellow stripe. The reporter is not only apparently dyslexic but also color blind because the envelopes, which we got free from a sympathetic printer, read across "Expedited Message Service" on an orange stripe. Those of you on our regular mailing list have received one of these envelopes so you can see for yourself.

Lynden High School Principal Ken Axelson stated that his biggest concern was how we were getting the names and addresses of the students. Axelson said the only connection they were able to ascertain as of May 21st was that all the male students who received mailings shopped at the

Zumiez clothing store in Bellingham. Nobody in the Zumiez corporate office could be reached for comment.

Lynden Postmaster Dale Pomeroy stated that it is all perfectly legal. "Unless the material contains sexually oriented or fraudulent material, then unfortunately he's just exercising his right to free speech," Pomeroy said.

One parent did complain to the post office, and Pomeroy sent the material to the US Postal Inspection Service in Seattle but he is not sure they can do anything about it. Pomeroy admitted they have their hands full right now with Anthrax and mail bomb threats. Pomeroy also stated that he can advise the parents to snoop in their kids' mail and have anything they do not like sent back to us. Lynden High School Vice Principal Kris Peterson told the students to take the letters to the police. (Yeah, right; as if the police can do anything about the mailings.)

Carol Broersma said her severely handicapped 16-year-old son who attends the school's Life Skills program received a mailing and the father contacted the Federal Bureau of Investigation about it. (Oh, my!)

Principal Axelson reported that one teacher said 15 out of 29 of his morning class students had gotten a copy. The students at Lynden High School discussed the mailing in English classes Tuesday, May 21st. Lynden Christian High School Principal Keith Lambert said it would be mentioned in the bulletin and they would make reference to it in Chapel Tuesday.

Principal Axelson said, "One good thing coming from this is the kids read this thing and realize how far off these people's ideas are." We say, just wait until these kids grow up and get out into the world on their own and begin to see things the way we do. Then they will wonder why they were so mislead when they were in high school.

In "The Bellingham Herald" of May 30th, it is reported that the mailings to the students have tapered off in Lynden. Actually, we had just recently come across the mailing lists for the two Lynden high schools so the mailings will continue until the class of 2005 graduates. Similarly we have more addresses broken down by class for Ferndale, Blaine (WA) and Nooksack High School which is shared by students in three towns. Guess what? Bellingham (WA) has a third high school now so mailings will resume in Bellingham. All high school mailings will continue in September 2002.
