OBERAMMERGAU 2000 by Frank Abbott Sweeney

An idyllic hamlet in the Bavarian heartland, Oberammergau has for decades been a raging epicenter of controversy. Once every ten years, the Catholic villagers perform a Passion play in Christ's name, commemorating a covenant that they made with God centuries ago.

The origins of the play date back to the Thirty-Years' War when Protestants and Catholics slaughtered one another in the name of Christianity and Germany was ravaged by plague. The pious peasants of Oberammergau prayed to God and promised that if He would deliver them from this pestilence, once every ten years forever after, they would perform a play honoring Christ. And the honest, noble folk of this quaint village have kept that covenant.

The controversy began in 1966, rooted in charges brought by American Jewish organizations claiming that the Passion play was Judeophobic, that it vilified and demonized Jews, blaming them for Christ's death. The Jewish organizations urged a boycott of the play, demanding that changes be made in the play's text; especially upsetting was the word "bloodcurse." Full-page advertisements condemning the production were taken in newspapers worldwide. Letters were written to German Chancellor Ludwig Erhard and to Pope Paul VI requesting that they intercede to stop the play. But to no avail. The boycott failed and the play went on with no changes.

But 39 years later, Jewish rancor toward the play is more vitriolic than ever. Determined this year to either dismantle the production or to force changes that would render the festival unrecognizable, the Jews have unleashed their attack dog, Eli Wiesel, the pit bull of American Jewry.

Wiesel is a pseudo-savant who teaches Holocaust studies

at Boston University. A dour, unkempt-looking man of gargantuan hubris and a burning loathing of all Gentiles, especially Germans, he has grown fat and rich roaming the world bemoaning his years in Auschwitz, even though no evidence can be found to prove that he was ever there! In addition to his professor's salary, his income is augmented from Holocaust lectures, commanding fees of \$30,000, and from the many books that he has authored, really little more than self-aggrandizing treatises. Wiesel's influence is global and his venom is lethal. He is a master manipulator with a bagful of tricks.

In a concerted effort to destroy or at least derail this year's Passion play, Wiesel has gathered together an oddball commingling of sycophants: rabbis from the Simon Wiesenthal Center in Los Angeles; the Jewish writer James Shapiro who has written extensively about past Passion plays, deeming them "hair-raisingly anti-Semitic;" a coalition of American Catholics who never tire of apologizing for imagined misdeeds against Jews; debased Protestants led by the whining, groveling, left-leaning Calvinist theologian Reinhold Niebuhr. These zealots, Wiesel's pathetic collection of toadies, are at the ready to storm into Oberammergau with a single-minded endeavor, harass and intimidate the villagers, prevent the peasants from performing this decade's dramaturgy.

But as of this writing, the stoic denizens of Oberammergau refuse to be frightened by Wiesel's minions. They stand firm and clean like the legendary German oak. The little village is likened to a Christianity that exists nowhere else in the world.

It is vital that the Passion play be continued at Oberammergau; for never has the menace of Jewry been so convincingly portrayed as in this production of what happened in the time of the Romans.

The movie "Arlington Road" was released in the fall of 1999 and had an interesting twist. Professor Michael Faraday

(played by Jeff Bridges) taught an American history course called American Terrorism at George Washington University in Washington, DC. Textbooks used in his class included an original sketch of the unabomber before the unabomber was caught, an NSLF (National Socialist Liberation Front) leaflet, a lynched Black man and a couple other popular Movement leaflets. (Indeed, listed in the credits at the end of the movie were two books about the Movement: "Women of the Klan: Racism and Gender in the 1990's" by Kathleen Blee and "Nazis, Communists, Klansmen, and Others on the Fringe" by John George and Laird Wilcox.) The professor was deeply puzzled why American citizens would resort to terrorism against the government. He noted that fewer Americans were voting and that more Americans were affiliating with and joining militant groups (which is true). Prof. Faraday was also troubled by the actions of a man named Scobee who had driven a vehicle, containing 50 pounds of C-4 plastic explosives, to the Roosevelt Federal Building in St. Louis, Missouri, and blew up the building which contained the regional office of the Internal Revenue Service, federal offices and a day care center. In the explosion, dozens of offices were destroyed and 60 people were killed, including children (vaguely like the Oklahoma City bombing). Government investigators reported that Scobee was successful in life, had just gotten a promotion and raise at his electrician job, was a friendly guy who was well liked and acted alone. Prof. Faraday never believed that Scobee acted alone which increased his obsession to find answers for American terrorism.

Another national incident occurred which troubled Prof. Faraday. His late wife was a Federal Bureau of Investigation (FBI) agent who was part of an FBI team which was to investigate and question a man named Sorenson who had previously bought about 100 military style and other guns, and then purchased a secluded piece of land out in the woods at a place called Copper Creek. The FBI was notified of the purchase and it became concerned that right wing extremists were up to something. As the FBI team approached the small house. Sorenson's youngest son (about 10 years old) was returning from fishing. He saw the group and became frightened, then dashed towards the house. One man of the FBI team opened fire on the boy and fire was returned by the house occupants. In the 2-hour gunfight, two of Sorenson's sons were wounded, his youngest son was killed and his wife was killed. A couple of the FBI team were wounded. Prof. Faraday's wife was killed by a shotgun blast to the face by Sorenson's daughter-inlaw who held an infant in one arm and fired a shotgun with the other. Subsequent investigation revealed that Sorenson had inherited a large amount of money, the guns were legally purchased, Sorenson applied for and had received a firearms dealer's license and he was going to engage in legal business. The land was legally purchased and Sorenson had informed his family that some people may want to try to steal the guns so they were not to allow anybody into the house or trust anybody. Furthermore, the FBI agents never identified themselves and Sorenson himself was not even home. As with the incident at Ruby Ridge, Idaho, ZOG (Zionist occupation government) never apologized, never admitted wrong-doing and overall was not even accountable for its actions. This too bothered Prof. Faraday.

As "Arlington Road" starts, Brady Lang (about 10 years old) is walking down the middle of Arlington Road in Reston. Virginia, just across the Potomac River from Washington. DC. Prof. Faraday notes that the boy is his neighbor, a friend of his own son, Grant (also about 10 years old), and has a badly injured left forearm and hand. Prof. Faraday takes the boy to the local hospital emergency room where he first meets Brady's parents, Cheryl (played by Joan Cusick) and Oliver (played by Tim Robbins) who live just across the street from him. The adults, including the professor's girlfriend, Brooke (played by Hope Davis), became good friends at first but then Prof. Faraday began wondering why Brady Lang wanted to play with explosives and started becoming suspicious over what seemed to be inconsistent statements by Oliver Lang regarding Lang's employment and mail addressed to another name in Lang's mail box, mail which the professor began stealing and investigating. Eventually, Oliver Lang learned about the professor's spying and their friendship became negatively affected. Brooke too began to wonder about the Lang family and what seemed like a simple investigation on her part lead to her death under suspicious circumstances. One thing led to another.

Near the end of the movie, Prof. Faraday became fanatically obsessed with the belief that his son, Grant, was going to be indoctrinated by the Langs to be a future American terrorist because of his son's tight friendship with Brady Lang. He also believed that Oliver Lang was involved in a plot to blow up the FBI building in Washington, DC. A fight ensued during which Oliver Lang delayed Prof. Faraday from following a van which the professor believed contained his kidnapped son, Grant, and also a bomb. It was apparently at this time when a bomb was placed in the professor's rented car's trunk. When the professor drove past the guards into the parking lot underneath the J. Edgar Hoover Building to supposedly prevent the building from being blown up, and thus becoming some kind of hero (as we would expect from a movie created by the Jew- and queer-controlled Hollywood movie industry), he himself became the bomber.

At the end of the movie, the FBI Building in Washington, DC, is blown up and 184 people are killed. Unknown to Prcf. Faraday and the FBI, one of the professor's own female students was involved with what Prof. Faraday would call "terrorists" but what we would call "patriots." Lastly, government investigators of the J. Edgar Hoover Building bombing concluded that Professor Michael Faraday acted alone.

Nowhere in "Arlington Road" were the patriots called "patriots" or "racists" but the Langs entertained only White people at their backyard barbecues and house parties, and their complaints against ZOG are our complaints. It is indeed refreshing to see a movie in which the good guys win and it is no wonder that the mass media in this country chose to largely ignore the movie "Arlington Road."

OPERATIONS

GERMANY: On January 6, 2002, the right wing party, German People's Union (DVU), local branch Bielefeld (German state: Northrhine-Westfalia) was upset after personal disagreements between the local branch Chairman Rathbone and the chairman of the German state Northrhine-Westfalia, Mr. Wiegraefe.

On January 30, 2002, the Superior Court of Frankfort on the Maine (German state: Hessen) sentenced Comrade Manfred Roeder, 72, to 2 years in jail for revilement of the Federal Republic of Germany. He wrote an open letter in April 2000 to the government and the members of Parliament. He used such expressions as "genocide against their own flesh and blood" and "The new reich must come back." His lawyers will make an appeal against his jail sentence. Effective January 27th, you can visit the Anti-Wehrmacht Exposition in the historic museum of Bielefeld (German state: Northrhine-Wesfalia). The organizers are disappointed because most visitors are only school classes. The pupils have no choice.

On February 2nd, the Nationaldemocratic Party of Germany (NPD) (German state: Northrhine-Westfalia) organized a protest rally under the slogan "Our Fathers Weren't Criminals" against the Anti-Wehrmacht Exposition in the City of Bielefeld. The dirty system cops gave the following directive in the forefield of the NPD protest rally: (1) No boots and bomber jackets; (2) No slogans such as and Honour the Waffen-SS" and "National Resistance"; (3) No drums, torch lights, Reichsflags (black, white and red), liquor or beer. The NPD must allow the system cops to check all marchers and many other discriminatory directives against them. Approximately 1,700 nationalists (Internet: 2,000 marchers) marched peacefully with party flags, political banners and paint posters in their hands through the City of Bielefeld (east end). The speakers were Holger Apfel, federal vice chairman at the NPD; Steffen Hupka, former NPD member; Friedhelm Busse, former FAP chairman; Hartmut Wostepatsch, independent; Timo Tradel, vice chairman of the NPD in the German state of Northrhine-Westfalia; and Christian Worch, leader of the so-called Free Fellowships. Later Comrade Tradel and Comrade Worch had to leave the rally because they had shouted banned slogans. The 2,300 system cops and 470 border patrol troops tried always again to find a reason to break up the event. The organizer for the counter rally was the Federation of Trade Unions (DGB). About 8,000 counter demonstrators were there. Clashes broke out between several Reds and system cops/border patrol troops. Between 11 and 20 left-wingers were arrested. It was a good powerful rally but the police directives for the rally were scandalous.

On February 25th, former SS officer Julius Viel, 83, is dead. He died in a jail hospital because the Jewish courts would not give permission to release him so that he could die at home. The cause of death was a cancer illness.

The dirty Superior Court of Ravensburg (German state: Bavaria) found guilty the former SS officer Viel for murdering seven Jewish forced laborers in wartime. He was sentenced to 12 years in jail last year, April 3, 2001. The witness for the prosecution was a former war comrade, Adalbert Lallier, who lives now in Canada. He has made his deposition only in Canada.

On March 2nd, there was again a protest rally against the Anti-Wehrmacht Exposition in Bielefeld. The organizer for this rally was the so-called Free Fellowships under the leadership of Christian Worch. The system cops and border patrol troops checked all marchers in the forefield of this rally. Between 550 and 600 nationalists marched peacefully through the streets of Bielefeld (German state: Northrhine-Wesfalia). Some of them held political banners in their hands. The organizer for the counter rally was the Federation of Trade Unions (DGB) with approximately 1,500 left-wingers. A small group of Red skinheads screamed to the nationalists that they were the real skinheads and "Nazis Out!" Small clashes between left-wingers and system cops/border patrol troops. Arrested were 17 left-wingers and 2 nationalists. The protest rally was very successful.

On March 3rd, there were local elections in the German state of Bavaria. The right wing party Republicans (REP) had gained 1.2% of the votes in the City of Munich and one city councillor. The right wing group Citizens Committee Foreigner Stop had gained about 2.3% of the votes in the City of Nuernberg and 1 or 2 seats in the city council. There was no permission given to run for the mayor's office for Comrade Guenter Deckert through the city election committee because of his criminal records from free-speech crimes.

On March 6th, the highest civil court in London pronounced the British revisionist David Irving bankrupt. He could not pay his 2,000,000-pound debt to Penguin Publishing.

On March 14th to 15th, during the night to Friday, unknown nationalists painted such anti-Jewish slogans as "Jews Out!" and Celtic crosses on the wall of the art gallery in the City of Rostock (German state: Mechienburg-Vorpommern)

HONG KONG: The Jewish community has condemned the sale of Nazi memorabilia at a local shopping mall. Adolf Hitler, Heinrich Himmler and Hermann Goering miniatures, as well as scores of toy soldiers waving swastikas, have gone on sale at King and Country in Pacific Place. Rabbi Yaakov Kermaier of Ohel Leah Synagogue called the items offensive but suggested two explanations for their popularity. "Firstly, a lot of people like to collect and, secondly, there is a problem here with the gross ignorance of what the Holocaust really stands for, especially among teenagers and young adults", he said. King and Country owner Andy Neilson said, "Less than 1% of the figures we seil are Nazis", and added that it was hard to depict the Second

World War without them. He said that the mall also stocked memorabilia relating to other wartime leaders such as Winston Churchill. "We cover many historical periods", he declared. "Swastikas are not banned here", he said. "We have no sympathy with the perverted ideals of Nazi Germany but we are interested in history." (The above was published in the "Jewish Chronicle" of January 11, 2002.) Note: If Mr. Neilson was not making money by selling these miniatures, they would not be for sale. The more the Jews complain, the more attention will be brought to the matter and the people will ask themselves just what is it that the Jews have done to be so disliked.

MISSISSIPPI: (Information from this article was taken from "The Times Magazine" of July 8, 2000. Some of the system bias was removed and this excerpted article edited to conform more to a White Nationalist viewpoint.) Few people in Jackson paid much attention to Larry Wayne Shoemake. True, there had been a couple of brushes with the law for drug possession and drunk driving, but the 53-year-old Vietnam veteran generally kept to himself. Neighbors outside his immaculately-kept home recalled him as being a harmless, if slightly eccentric, loner but they certainly took notice one spring afternoon in 1996 when Shoemake calmly packed a bag with four assault rifles, a shotgun and two handguns, and took up position in an abandoned restaurant in a Black neighborhood. From there, he began blasting away at any non-White unlucky enough to stray into his path. By the time he took his own life, later that evening, he had killed one man and injured 10 more-all of them Black. Later, a search of his home revealed a Nazi flag draped over his bed where White Nationalist literature and a copy of "Mein Kampf" were laid out alongside a Bible like a presentation. But if events had caught Jackson police off guard, they came as little surprise to Shoemake's ex-wife, Cynthia, who said he was first exposed to extremist propaganda in the mid-1980s when he borrowed a book from a friend. She said it changed his life. "There was a distinct difference in him", she remembered. "It was like an eye-opener for him."

The name of that book?--"The Turner Diaries", a novel whose hero, a 30-something, all-American, computer programmer, embarks on a campaign of political assassination and race war as a means to an Aryan revolution. For more than 20 years, it has provided the inspiration and sometimes the blueprint for some of America's most famous White Nationalists.

OKLAHOMA: Long-time White Nationalist Dennis Mahon informed NSV Management Director Cooper several years ago that undercover federal informant Carol Howe had sold the rights to her story regarding her involvement with the Okahoma City bombing, Dennis Mahon and Elohim City to actress Meg Ryan for either \$15,000 or \$50,000. To date, no such movie has ever been made. At the time when Dennis told this to Director Cooper, Dennis had heard that the person being considered to play the part of Dennis was a virtual dwarf named Danny DeVito. Dir. Cooper told Dennis that should DeVito be selected to portray the tall dashing Dennis with his full head of hair that the movie pro-

duction company should be sued for slander and defamation or character. To this date, no such movie has been produced and it remains unknown to us whether this was because the script writers were uninterested in writing the script or whether Meg Ryan was unwilling to have a movie sex scene with Danny DeVito.

COLORADO: A former district attorney candidate is found guilty in IRS arson, and faces 58 years in prison (by KYLE HENLEY of "THE GAZETTE" of Colorado Springs, August 5, 2003). In the movie "Arlington Road", a fictional parallel situation is given to a real situation of the Oklahoma City federal building bombing, a fictional parallel situation is given to a real situation of the Ruby Ridge massacre, and the following real situation could very possibly be the basis for the fictional situation of the IRS office destruction by a man named Scobee.

In Denver, James Cleaver was found guilty Monday of masterminding the 1997 arson that destroyed the Colorado Springs Internal Revenue Service office. Cleaver, 49, a former write-in candidate for district attorney in El Paso County, faces as many as 58 years in prison for his role in the May 3, 1997, blaze at the IRS office on North Academy Boulevard. The arson did \$2.5 million in damage.

"This is a good victory," said John Suthers, U.S. Attorney for Colorado. "These are pretty dangerous folks. "These are folks who pass up lawful means available to them to let their view be known. Anytime we hold these folks accountable, it is a good day."

The jury trial began July 28 in the courtroom of US. District Judge Richard Matsch. (Note: Judge Matsch presided over the trial in which David Lane, a member of The Order, was convicted of denying Alan Berg the right to work for a living after the obnoxious Jew talk show host was machinegunned on June 18, 1994. Judge Matsch also presided over the Timothy McVeigh trial.)

After a week of testimony, jurors began deliberating about 10 a.m. Monday and returned with the guilty verdict at 12:10 p.m. Cleaver was convicted on four charges - destruction of government property, interference with the IRS, witness tampering and subordination of perjury. Prosecutors say they will ask the judge to sentence Cleaver to the maximum amount of jail time. Sentencing will be October 24, 2003.

A conspirator in the case, Jack Dowell, recently was sentenced to 30 years in prison for acting as a lookout in the crime. A jury found his cousin, Thomas Dowell, not guilty of related charges in June. A fourth accomplice, Ronald Sherman, reached a plea agreement with prosecutors in exchange for his testimony against the Dowells and Cleaver.

Sherman told the jury last week he helped Cleaver plan and carry out the attack. Sherman, who drove the getaway car, pleaded guilty to perjury for his role in covering up the attack and faces as long as five years in prison. Sherman said

Cleaver used a sledgehammer to break into the IRS office. He doused it with 5 gallons of gasoline and left a timing device to ignite the fire.

The men were motivated by their hate of the federal government and tax system, Sherman said. Prosecutors also produced three witnesses who testified Cleaver told them he did it and another who said Cleaver threatened to kill him if he didn't help with the cover-up. "We felt we had a better case against James Cleaver than we did against Thomas Dowell because Cleaver had made some incriminating statements to other people," Suthers said.

Cleaver, who founded the Sons of Liberty and was a leader in the local Patriot movement, acted as his own attorney during the court case. He tried to convince the jury that FBI agents bungled the investigation and that minor differences in the testimony of witnesses made all of their statements suspect. (Note: Unfortunately Cleaver was caught so now nobody can vote for him. In April 1999, other apparently unidentified patriots attacked the same IRS and failed to destroy it.)

Two White Supremacist Anti-Abortion Extremists Sentenced. 12/3/2001 - Benjamin Matthew Williams and his brother James Tyler Williams were sentenced last Friday in conjunction with the 1999 arson of three synagogues and the firebombing of Choice Medical Group, a women's reproductive health clinic that performs abortions in Sacramento, California. Benjamin Matthew Williams received a mandatory sentence of 30 years in a federal prison, and his brother received the maximum sentence under a plea agreement of 21 years and 3 months. Benjamin Matthew Williams received a longer sentence since the court determined that he had planned the attacks. Both brothers were also ordered to pay \$1 million in restitution. (Note: Where are the brothers to get money to pay a fine that high?)

The brothers will face additional charges next year in the murder of a gay couple. Prosecutors in that case will seek the death penalty. (Yeah, right—a death penalty will insure that the survivors of the queers will not get one red centl) The brothers have pleaded innocent, and Benjamin Matthew Williams plans to use his belief that the Bible condemns homosexuality as his defense. (Note: We have mentioned the Williams brothers previously in the APR/JUN 2000 "NSV Report.")

In Lancaster, hate group, arsenal linked: Agents may make more arrests. This story appeared in the Antelope Valley Press March 31, 2001 (by Alan Schnepf of the "Valley Press").

Law enforcement agents on Friday connected at least one

more person to a 73-piece arsenal of guns and grenades found in a Lancaster storage facility Thursday and more arrests could be on the way.

Investigators found the cache of weapons, later tied to white supremacist groups, after they responded to an anonymous call at 3 p.m. reporting someone tampering with a storage shed at Stor Stuff in the 42000 block of Challenger Way.

Among the ordnance found in the shed were 41 long guns (two were fully automatic .45 caliber machine guns; one was a sawed-off shotgun), 28 handguns and three inert grenades. All the pieces to render those grenades live were found in the shed. Also found in the shed were body armor, a sheriff's uniform, a Sheriff's Department handgun and a high-tech silencer.

When they arrived at the scene and found that the shed had been tampered with, deputies opened the building. They saw the weapons inside and called the department's Arson and Explosive Unit to the scene, along with agents from the U.S. Bureau of Alcohol, Tobacco and Firearms. The ATF seized the weapons. So far, six of the guns have been confirmed as reported stolen.

Already in custody is Scott Kuhn, 29, of the 8200 block of West Avenue C-4 in Lancaster. He was identified as a corenter of the storage facility. He was booked Friday morning on suspicion of illegal possession of destructive devices.

After learning who rented the storage shed, investigators executed search warrants at two Lancaster residences Thursday night. As curious neighbors watched from a distance in the black of night, deputies from the Sheriff's Arson Explosives team scoured a house at 1702 Mesa Drive in Lancaster. They didn't find any weapons at that home, but they did find a photo album with pictures of the guns found in the shed. The photos also indicated the people pictured were affiliated with white power hate groups, deputies said.

Sheriff's officials say they believe the suspects are linked with the Nazi Low Riders, a violent white supremacist gang. Lt. Ron Shreves of the Lancaster Sheriff's station said the initial call about the shed came under "suspicious circumstances," and that the purpose of building up such a lethal arsenal is still under investigation. "We don't know of any conspiracy for use of these weapons," Shreves said.

Three people were detained at the Mesa Drive location. Deputies arrested one of them, 22-year-old Marcello Castellano, for possession of methamphetamine and violating his parole.

Investigators also found a surveillance system at the Mesa Drive house that allowed the occupants to watch what was going on outside while they were in the garage. Children apparently lived at the home, investigators said; toys and plastic playground equipment were in the back yard.

Investigators found more weapons (daggers and rifles) at the comfortable home where Kuhn stayed with relatives. The home was a bustle of activity in an isolated stretch of desert in the wee morning hours Friday as Kuhn's relatives answered questions fielded by sheriffs deputies. Law enforcement agents at the scene said Kuhn's family had become angry with his misbehavior. Some deputies said the relatives seemed truly bewildered by what was happening.

Among the other items law enforcement agents pulled from the home was a photo of Kuhn and another man that had the letters "P" and "W" on the frame, possibly a reference to a decades-old white supremacist group called "Peckerwoods." Some of the weapons had swastika logos and deputies also seized what appeared to be a tin photo negative of Adolf Hitler.

The weary deputies finally started leaving the residence sometime around 3:30 a.m. Friday. Barry M. Caires, resident special agent in charge with the ATF, said the arrest of another person linked to the shed is pending, but that no arrest warrant had been secured as of Friday afternoon. That subject is a member of an outlaw motorcycle gang, Caires said. "We haven't obtained an arrest yet," Caires said. "(The individual) has been linked to the firearms. He's the one we're going to be seeking charges on about the firearms found at the storage shed." He also said the sheriffs uniform and gun found in the shed are not an indication that a member of the department was involved in the illegal arsenal.

"It just means that it was there," Caires said. "It could be stolen, it could be a firearm that was surplussed by the sheriff's department to a firearms dealer and then something happened to it." Shreves said the arsenal and its apparent ties to hate groups do not mean that the groups are gathering steam for misdeeds in the Antelope Valley. "This certainly does not indicate a resurgence in Nazi Low Rider power," Shreves said. "The dynamics of that world shift constantly." Caires, the ATF agent, said the charges against the possible third suspect are to be filed in federal court.

Rising star in the skinhead movement, groomed by widely known Fallbrook racist Tom Metzger, falls in love, renounces his white-suprernacist philosophies on TV talk shows and, as a result, is crucified literally by the same skinheads he'd recruited and then betrayed. (See "NSV Report" for JUL/SEP 1987.) The tale was spun repeatedly in the late 1980s by newspapers, television and "People" magazine. Actor Woody Harrelson bought the rights to make Withrow's life into a movie. There was even a possible book deal. His fame grew as he preached antihate messages on behalf of the Anti-Defamation League and other organizations in San Diego and around the country. Leaders wrote glowing reports, calling Withrow "brave" and "courageous". He even testified in favor of hate-crime laws in 1993 before the state Senate Judiciary Committee.

Now, 14 years after his conversion, Withrow says it was a hoax. That he ordered those skinheads to tie him to a board and drive nails through his hands, and to slash his throat with a razor on August 8, 1987. Why? So he could act as a double agent and "Infiltrate" civil rights organizations and the government, and "report back to my own race." And, so he could reverse hate-crime laws and free his cohorts. "I would suffer a thousand crucifixions if it meant the freeing of but one of my soldiers," the 40-year-old bricklayer said during an interview Thursday from his home in Oroville. A lawsuit filed in Butte County on the 14th anniversary of his crucifixion demands that California hate-crime legislation be overturned and "political prisoners" convicted of hate crimes be released. Withrow contends the legislation is based on his perjured testimony." The only way to get our people to be heard was for me to go in as a lone wolf and Infiltrate those Senate judiciary hearings and at a later time attempt to overthrow these very same laws," Withrow said in the Interview. Acting as his own attorney, Withrow Identified for the first time the men he says crucified him: Brothers Rick and Roger McKrill, Dane Peterson and Duane Nutt, according to the lawsuit. He said the men, who were never prosecuted, were part of his plan. "I did nothing different than what Jesus Christ did," Withrow wrote in the complaint. "I went throughout the land telling lies, and afterward allowed myself to be crucified I ordered them to do It and to keep their mouths shut. They all have done so. Hence, I shall never press charges against them." "The breaking of my bones was genuine, the breaking of the jaw in four places, the broken nose, the cracked ribs, the slit throat and the nailing of my hands was authentic. The pain was also real," Withrow said in the compliant. Withrow said his marriage to a Mexican woman, a relationship that came years after the romance that supposedly inspired him to convert, was part of his deception. He Is on probation for spousal abuse stemming from his wife's discovery of the racist plot, he said. "I loved her as one might love a dog or a slave. "The lawsuit names the Southern Poverty Law Center, the Anti-Defamation League of B'nai B'rith, the National Association for the Advancement of Colored People, the FBI, the state Senate Judiciary Committee, Gov. Gray Davis and other politicians. Withrow's suit seeks \$32 million in damages for those convicted of hate crimes, and for Metzger, his former mentor, who lost his house and business after a civil jury found him responsible for Inciting skinheads to fatally beat an Ethiopian immigrant In Oregon. (See "NSV Report" for OCT/DEC 1990.) Metzger hasn't spoken to Withrow in years because he believed Withrow's conversion was authentic, because he thought Withrow accused him of ordering the crucifixion. Metzger said Withrow mailed him a copy of the lawsuit. Though he has no plans to reconcile with his former protege, he does feel vindicated."I'm really happy that he finally, after all these years of saying I nailed him to a cross and cut his throat, admitted I had nothing to do with it," Metzger said. Those who were once convinced by Withrow are shocked and saddened."I was fairly astonished when I read Mr. Withrow's complaint," said James McElroy, a San Diego attorney for the Southern Poverty Law Center and the Anti-Defamation League. "It obviously is very disjointed and he does not sound terribly coherent

and I'rn sure it's a case that will be dismissed pretty quickly." He added, "this guy changes sides more than most people change their underwear." Morris Casuto, head of the Anti-Defamation League in San Diego, said. "How sad, how pathetic. Poor Greg Withrow. He sounds like a lonely man trying to get back Into the good graces of a bad crowd." The league carefully checked Withrow's background, Casuto said, "and were not only satisfied that he was credible and truthful about his having left the movement, but the reality is that when he spoke to audiences, he in fact sent the correct anti-racist, anti-extremist, anti-bigotry messages."

(Note: On December 2, 1987, one of our supporters, who has remained in contact with Greg Withrow through Greg's ordeals, wrote to us, stating that Greg had informed him that he had dinner with Sean Penn regarding the proposed movie previously mentioned,. To this date, neither a book nor a movie ever became a reality.)

From Tom Metzger: There is a lot more coming out about the ADL-SPLC conspiracy to destroy the Metzgers. One point: Withrow has admitted that he was paid a \$1,500 bribe by Morris Dees to go to Portland and testify falsely about the Metzgers. Withrow also knows that the star witness, David Mazella, lied in his testimony against the Metzgers in the Portland trial. Mazella was bribed to the tune of many thousands of dollars for his testimony and for 5 years after the trial. Only after the Metzger appeals were ended at the U.S. Supreme court did Dees stop paying off Mazella.

Judge cuts all but one defendant from supremacist's suit (by Terry Vau Dell of the "Mercury-Register" of Oroville, California, June 15, 2005). All but one government defendant has been dismissed from a federal civil rights lawsuit brought by Oroville white supremacist Gregory Withrow. Withrow, 45, claimed in the \$330,000 lawsuit his civil rights were violated when swastikas and certain writings, including legal documents, were seized from his home during a probation compliance search Jan. 8,

Rejecting claims by the Butte County District Attorney's Office that the seized items were "gang-related," a local judge subsequently ruled their possession did not violate Withrow's probation in connection with a prior domestic violence conviction.

Withrow sued the district attorney and the Butte County Probation Department, the California Highway Patrol and the FBI, demanding \$1,000 in damages for each of 330 days that he said his probation period was extended because of the "warrantless" search.

Without ruling on the merits of the case, U.S. District Judge Craig M. Kellison last week held that all named state and county officials have immunity against such civil lawsuits, accept (sic) Karen Young, the county probation officer who reportedly supervised the search of Withrow's property.

Kevin Nourot, the Sacramento attorney hired to defend against the lawsuit, said Tuesday he plans to file written

objections in the District Court seeking to have Young removed from the civil case as well on immunity and other grounds.

Withrow, who in recent weeks admitted twice having himself nailed to a makeshift wooden cross in front of the state capitol building in Sacramento to "protest the Iraq War and the failure to close United States borders," said he will seek to have the other county officials reinstated in the lawsuit.

The former founder of a "White Student's Union" at a Sacramento-area community college in the 1980s. Withrow has been suspected more recently of leafletting homes and businesses in Butte and other counties with white supremacist literature.

"This government kicked down the door of a white man because they were against my right to pamphlet, Now, I'm using their own tools, the law, to fight back," said Withrow of the civil suit.

WASHINGTON: Senate Committee Kills Plan To Rename Jefferson Davis Highway. March 4, 2002. In Olympia, the Washington State Senate committee on Monday quietly killed a proposal to rename Jefferson Davis Highway after William P. Stewart, a Black Civil War veteran and early Washington settler. "It's pretty disgusting," groused Rep. Hans Dunshee, D-Snohomish, who sponsored the bill to rename the highway, better known as state highway 99. "This is a statement about what Washington state thinks is important."

A small stone marker near the Canadian border dedicates the highway in honor of Davis, president of the Confederacy. A group called the United Daughters of the Confederacy placed it there in 1939, part of an effort to create a national Jefferson Davis highway. Dunshee noticed the marker as he was returning from a kayaking trip earlier this year. When news of his proposal to rename the road reached the South, he was bombarded with nasty E-mails, some of them threatening.

Despite the opposition, Dunshee figured the proposal would sail through the Legislature in Washington, thousands of miles from any Civil War battle sites. The House passed it unanimously. But the Confederate president has some fans outside the South. Dunshee's bill died when the Senate Transportation Committee failed to pass it out by a Monday deadline. "It's not a priority for me," said Sen. Georgia Gardner, vice chairwoman on the Transportation Committee and a Democrat. The marker is in Blaine, her home town.

Gardner complained that Dunshee was just trying to grab publicity with his bid to rename the highway. Dunshee, also a Democrat, is up for election in a recently redrawn district with many new voters. "He's got to get his name around," Gardner said.

Gardner defended Davis, saying he accomplished good

deeds as a soldier, U.S. Senator and Secretary of War before he led the South in the Civil War. She also said the committee was too busy with the transportation budget to pass Dunshee's memorial.

Dunshee agreed the transportation budget matters more than renaming the highway. But he said the Senate routinely spends its time on less pressing issues. "It's more important than spending half a day honoring Jay Buhner," Dunshee said - something the star-struck senators did earlier this year for the Seattle Mariners outfielder.

Dunshee acknowledged he's using Jefferson Davis' name for his own purposes. "Politicians today use the symbols of yesterday to further their agendas," Dunshee said. "The agenda I'm trying to further is renouncing the glorification of racism."

Dunshee vows that his proposal shall rise again. He said he will try attaching the name change as an amendment to the transportation budget, or getting support for it from the Transportation Commission, which is independent of the Legislature.

Jefferson Davis highway markers were originally placed in Vancouver, at the southern end of Washington, as well as Blaine. Two Vancouver city officials quietly removed the marker from a city park there a few years ago.

Dunshee's proposal, House Joint Memorial 4024, would have named Highway 99 after William P. Stewart, a black man who volunteered and fought for the Union Army. He settled in Snohomish County after the war and became a successful farmer. His descendants still live in the area today.

Davis was arrested and jailed after the South lost the Civil War, but was never charged with treason. He defended slavery and secession until his death in 1889.

The NSV advocates a survival program.
