"IGNORANT"?

Given the climate of our times, any White person who expresses pride in his or her race, and/or a desire to live among one's own kind is immediately condemned for his beliefs. Truly "enlightened" people date, socialize and sleep with individuals of other races, or so we are led to believe. The theory of multiracialism has been advocated by the media, churches and government in a steadily increasing chorus, especially over the past five decades. Now, no "respectable" politician, minister or 'community leader' will dare to express sentiments that could be construed as 'racist.' Every so often, a sports star or political figure will voice comments that are considered 'out of bounds', and the resulting reactions range from excessive to downright ridiculous. Everyone from the nation's top newscasters to late night comedians berate the 'offender' as the establishment attempts to further indoctrinate us with the theory that 'racism is ignorance' and that racists are 'haters.' This idea has been pounded into our collective consciousness for so long that most folks simply accept it without question. Please consider these facts before you accept the multiracial dogma perpetuated by both the reactionary 'right' and the neo-marxist 'left' in today's society.

Statistics show that Blacks are 22 times more likely to kill Whites than Whites are to kill Blacks. (Source: FBI uniform crime reports, 1993.) In armed robbery cases, 167,924 Whites were mugged by Blacks compared to 7,031 Black victims of White muggers. When it comes to rape, we find that 100 Black women were raped in one year's time by White assailants, whereas some 20,204 White women were raped by Blacks. (FBI crime statistics, 1991, as analyzed by the American Enterprise Institute)

Is a White person showing "ignorance" simply for wishing to live in a safe (i.e., predominately White) area? Is it really

'hateful' for a lone White woman (or even a White male) to avoid Black neighborhoods? Incidentally, there is little reason to doubt the severity of the government's statistics. The United States regime of today is committed to 'diversity' and the 'melting pot' by its own admission. If anything, the figures cited above are not blunt enough. So called 'Affirmative Action' has been standard policy in US government hiring practices as well as in many areas of the private sector since the Nixon administration. Is a White person who loses his job or a well deserved promotion to a less qualified 'minority' being 'ignorant' and blindly "hateful" when he objects to such treatment? Wouldn't you be angry? Various breeds of animals exist, each with their own characteristics, strengths and weaknesses. A bulldog is clearly distinct from a greyhound. Would a person who refused to bet on the bulldog in a race against the greyhound be 'ignorant'? If anything, only an ignoramus would bet on the bulldog! If we acknowledge distinctions within the animal kingdom, why is it so far fetched to state that there are differences between the various breeds (races) of humanity?

Webster's New Riverside Dictionary defines ignorant as: "1. Lacking or displaying a lack of education or knowledge. 2. Not aware: Uninformed", while Hate is defined as: "1. To feel animosity or hostility toward: Detest. 2. To have distaste for." Contrary to what the advocates of multiracialism would have you think, neither word has anything to do with racism. Further, in and of itself, hate is an emotion that is as necessary as love to our survival in this society and one we all feel from time to time. As the late George Lincoln Rockwell, founder of the post WWII American Nazi party, said in his last book, 'White Power', "LOVE, the natural, healthy kind is indeed what makes the world go round, and it is the most beautiful, holy miracle we ever see here on this earth. But without a deadly HATE of that which threatens what we love, love is an empty word."

Let us ask ourselves this one final question: If people who

are convinced that differences between the races exist are 'ignorant', what is it that (supposedly) makes advocates of the 'melting pot' so 'wise'? Acknowledgement of facts, no matter how controversial and unpleasant, can never be 'ignorance', and the denial of reality can never be 'wisdom'!

REVIEWS

The book "The ANM Story", which is the Australian version of The Order, has been reviewed by members and former members of the American organization. Here is what they say about the book.

Richard Kemp--In the late 1980's a group of Australian patriots were tired of the huge influx of Asians into their Country. The Australian politicians had announced a plan in 1979 to bring in 250,000 Asians per year. By the mid-1980's Jack van Tongeren founded the Australia Nationalists Movement (ANM) to combat and thwart these plans. THE ANM STORY, written by van Tongeren is a book giving a first person account of the actions taken by his organization.

Van Tongeren is not a highly polished author. Many of the tales of his exploits are sometimes self-serving and heavily biased. He has a knack for trying to make acts of common vandalism sound like noble deeds. He lacks the objectivity that a third-party, removed from the action, can bring to the story.

I have difficulty, myself, in bringing objectivity to this review as I believe the author is less than honest. I believe the author saw a problem and was creative in his means of addressing that problem, but once he was caught for his actions, that he freely discusses in the pages of his book, he claims innocence and whines about how brutal the system is toward him. The entire time I was reading this book and some articles and letters written about van Tongeren; I find myself thinking, "Buck up, man! You knew you were playing with fire and now that you burned your fingers don't come crying to us."

The author clearly emphasizes the things the ANM opposed yet offered little in tangible methods of changing the system, other than giving the pie-in-the-sky ANM Policy in the last 20 pages of his book. He spends 190 pages writing about posterizing up Aussie cities with posters containing racial and anti-Asian messages. While I admired the tenacity of the ANM, I thought most of their actions amounted to acts of vandalism and had difficulty seeing how their stunts gave them the moral high ground.

The back cover says, "This is the story of noble ideals inspiring ordinary people to do brave and extraordinary deeds." No doubt, many of their covert operations, conducted by some of the more daring members, were ballsy, but I have difficulty elevating their action other than to agree these were bold attacks on the system.

The most inspirational portion of this book was the defiant statement of ANM member John van Blitterswyk where he told the Perth District Court on September 10, 1990, prior to being sentenced to almost 16 years in an Australian prison: "... I care about my Nation, I care about my children and I care about the rest of my Australian people, and I care about all those old Diggers and men and women who went and fought wars all over this Nation and built and pioneered

this country. I care for them too, and I don't want to see them just stuck into rooms and put away to die and all out old Diggers giving their lives for nothing. That is why I fought. That is why I followed Jack van Tongeren."

No matter what I think of the author, I would say this book is worth reading to find out why men like van Blitterswyk were willing to cross the line and stand to fight.

Bruce Pierce--"The ANM Story" chronicles van Tongeren's life and struggle for the preservation of our race and the re-establishment of the values that made us great. What we are witnessing is the slow but unalterable rising of the vanguard, the awakening of our race to its glorious history and its mature destiny that cannot be denied. I pray that those who read "The ANM Story" and the others like it (See H. Covington's trilogy.) will likewise be motivated to stand against the corruption of the forces that seek our destruction.

Gary Yarbrough--"The ANM Story" was a great read. I passed it around to other White prisoners to inspire them and show just what a simple few can accomplish when they are motivated and dedicated. A couple of the Aussie folks involved in this story used to write me long ago. They were inspirational and I am proud of them all. They set a good example. They did not "almost" stop the Asians. They are just a few of a long list of heroes who have a special place in the history of our race and struggle our folk will not forget. They invested in our race's future and it will pay off. People such as Judi Lyons and the others insure that our folk will have its place in the sun. Hail Victory!

Richard Scutari--"The ANM Story" was interesting. I salute all who were involved as they are part of an unique family of Aryan warriors.

David Lane--Congratulations to the true soldiers of the ANM. I know that you operate under greater restrictions against free speech than we do here. David Tate--"The ANM Story" is the history of the Australian Nationalists movement as related by its foremost leader, Jack van Tongeren, a Vietnam Vet and White patriot imprisoned for his racial political struggle.

There is not one White "European" nation upon Earth that is not experiencing forced alien immigration and integration. Citizens of White nations were not asked whether or not they wanted to share their land with Foreigners, nor if they wanted to integrate their unique God-given heritages with incompatible racial aliens. Australia is no exception, a nation slated for Asian immigration.

In many nations, homegrown resistance has sprung up as a natural reaction against alien behavior and practices. But the history of the Australian Nationalists Movement is preserved as a lesson for all of us. Jack van Tongeren has filled his book with numerous quotable sayings and points of insight. And he does a decent job of enlightening the reader on the structure and political principles of National Socialism.

Americans in particular can learn that the Struggle against the genocide that is race-mixing is alive and well in other lands than our own. We are not alone in the fight for White preservation. Resistance will continue until we have firmly preserved the existence of our race and a future for White children.

OPERATIONS

GERMANY: On February 3rd, there was election day in the Parliament House in the German state of Niedersachsen. The right-wing party Republicans (REP) gained 0.4% of the votes (0 seats). You need a minimum of 5% of the votes for seats in the Parliament House.

On the same day, there was an election for the Parliament House in the German state of Hessen. The right-wing party Republicans (REP) gained 1.3% of the votes for 0 seats. This was printed in the German system newspaper "Frankfurter Rundschau."

On March 6th, the Superior Court of Dortmund (German state of Northrhine-Westfalia) found guilty Comrade Siegfried Borchardt, 49, for showing a Hitler salute and a defamation of a system cop. He was sentenced to 4 months in jail. Comrade Borchardt was the Federal Vice Chairman of the banned far right-wing party Free German Workers Party (FAP) and worked at last in the so-called Free Fellowships. His nickname is "SS-Siggi."

On March 7th, the Ministry of the Interior in the German state of Schleswig-Holstein has banned the far right-wing local organization Alliance Nationaler Socialists for Luebeck and confiscated the organization's property. The cops searched three homes of members. This organization did run by the local elections (March 2, 2003) in the German state of Schleswig-Holstein only in the City of Luebeck and snatched 0.8% of the votes for no city councillor. The reason why they have banned this organization is that the policy is against the constitution of Germany told a speaker of the State Ministry of the Interior to reporters.

On March 18th, was a victory for the right-wing party National Democratic Party of Germany (NPD) through a court decision by Germany's Federal Constitutional Court in the City of Karlsruhe (German state of Baden-Wuerttemberg). It is Germany's top highest court. The court has no other choice to dismiss of the wish to ban the NPD through the government because the evidence from paid agents was tainted. It was not legal to spy on the NPD during the trial and very delicate is that about 30 of the 200 members inside the NPD leadership are paid agents. It should not be a value judgement that the NPD is a democratic party. Three of the seven judges agreed for the dismissal. Some minutes after the court decision, the lawyer of the NPD, Mr. Horst Mahler, declared that he is no more a member of the NPD. It is very suspect. Is he a friend or foe?

On March 26th was the trial against the seven young nationalists that had made an arson on a mosque of Wolfenbuettel (German state of Niedersachsen) last November. The Superior Court of Braunschweig (German state of Niedersachsen) found guilty all the seven nationalists for the arson on the mosque. The main evidence came through the five nationalists that made a confession by the system cops. Four nationalists were sentenced between 30 and 45 months in jail. The three other nationalists were sen-

tenced to a period of probation.

SERBIA: On February 24th, the leader of the right-wing party Serbian Radical Party (SRS), Vojislav Seselj, plans to fly to the Netherlands voluntarily on the reason that he will surrender to the United Nations tribunal in The Hague for alleged war crimes in Herzog-Bosnia and Croatia in 1991. He will fight for the interests of the Serbian people in the courtroom, he said to the reporters. Police officers in plain clothes arrested him at the airport. One day before he left Serbia, thousands of Serbs turned out in freezing temperatures for a farewell rally in central Belgrade, Serbia. He told his supporters that he was ready to defend himself and urged them not to give up the Serbian nationalistic goals. "I will destroy the United Nations tribunal under the rule of the USA. I'm the last Serb that flies to The Hague and I will come back soon. Long live greater Serbia!" The crowd shouted, "Serbia and Seselj", and waved thousands of party flags and national flags of Serbia.

February 26th was the first day for the leader of the right-wing party Serbian Radical Party, Vojislav Seselj, in the United Nations courtroom in the City of The Hague, Netherlands. As the body of judges came into the courtroom, he did not stand up. He rejected every defender in this trial because he will defend himself. He demanded of the UN tribunal that they must read the complete bill of indictment in the courtroom.

AUSTRIA: On February 15th, the two members of Parliament, Mr. Peter Sichrovsky and Mr. Gerhard Hager, in the European Parliament, resign their memberships of the Freedom Party of Austria (FPO). Both want work in the European Parliament as independent members of Parliament. Mr. Sichrovsky's reason for resigning his membership in the FPO was the internal controversy about the party line in the FPO and the bad result in the 2002 November elections. The FPO has only three members of Parliament in the European Parliament today.

On February 28th, repeat of the fusion administration between FPO and kosher conservative OVP in Austria. The following offices for the right-wing party Freedom Party of Austria (FPO) are Infrastructure Minister Mr. Gorach, Social-Permanent Under Secretary Mrs. Haubner (sister of Mr. Joerg Haider), Sport-Permanent Under Secretary Mr. Schweitzer, Minister of Justice Mr. Boehmdorfer, Social Minister and Vice Chancellor Mr. Haupt, Floor Leader Mr. Scheibner, Permanent Under Secretary in the Ministry of Health Mr. Waneck.

March 30th was election day in the Austrian state of Niederoesterreich with a very poor election result for the right-wing party Freedom Party of Austria (FPO) again. The election result was 4.5% of the votes for 2 seats in the State Parliament of Niederoesterreich. Minus 11.58% of the votes equals minus 7 seats. It is bitter that the FPO has lost the right to be a faction in the Parliament House of Niederoesterreich.

DENMARK: On March 12th, a Danish court has jailed the founder of the right-wing party Danish Progress Party, Mr. Mogens Glistrup, 76, for racist remarks against Muslims. The former parliamentarian told how the Muslims immigrate to Denmark to claw the power. This remark is against the racial discrimination law in Denmark. He was sentenced to 20 days in jail. It was an appeal proceeding.

In the January 24th "Seattle Post-Intelligencer" is the heading "Scout group conducts Nazi-themed game." A Danish scout group acknowledged that it "may have crossed the line" by organizing a game of tag in which adults pretended to be Nazis chased children dressed as Jews around a phony concentration camp. The Danish Christian FDF scout group put up swastikas and Nazi-type slogans, and had the children wear yellow Stars of David as they were chased around the school yard at the Kongeaadal school, 161 miles southwest of Copenhagen. One sign had the German words "Arbeit macht frei" or "Work makes you free", the infamous (sic) inscription over the entrance of the Auschwitz concentration camp in Poland.

PENNSYLVANIA: KKK leader accused of bomb plot; Abortion clinics target of his wrath, agents say Friday, February 14, 2003. (By Torsten Ove and Dennis B. Roddy, Post-Gazette Staff Writers)

Federal agents yesterday arrested a Washington County Ku Klux Klan leader with links to the neo-Nazi Aryan Nations, charging him with plotting to bomb an abortion clinic. David Wayne Hull, 40, of Amwell, a longtime Klansman and adherent of the racist Christian Identity religion, was arrested at his farmhouse yesterday morning and arraigned in U.S. District Court, where a magistrate ordered him held pending a detention hearing this morning.

According to an affidavit, Hull arranged for the purchase of hand grenades in November and told an FBI witness he intended to use them to blow up abortion clinics. A federal affidavit does not say whether he named the clinics he planned to target. Hull also gave the informant components for a pipe bomb he built in his basement and indicated he had two other bombs buried on state game lands which he would later bring to Lancaster, where the informant apparently lives.

Hull appeared in shackles yesterday afternoon before U.S. Magistrate Ervin Swearingen, who said he would appoint a lawyer to represent him. Hull said he is unemployed, lives on Social Security disability payments and has three children as dependents.

Hull is the self-declared Imperial Wizard of the White Knights of the Ku Klux Klan, which civil rights investigators described as a seven-member unit that grew out of the now-defunct Invisible Empire Klan. Unlike many other Klan leaders in Pennsylvania, Hull avoided public appearances. "Our Klan is a super-secret Klan," he wrote on his Web site. "All of our activities are shrouded in a mist of secrecy. ... Our officers never speak to the press about anything."

In July, Hull was a guest at the world congress of the Aryan Nations faction led by Charles John Juba of suburban Philadelphia. Juba and Hull were members of the same Klan faction a decade ago and Hull later invited Juba to his farm in Washington County for a cross-burning ceremony.

A researcher for the Southern Poverty Law Center said yesterday Hull is believed to have tested bombs on his property in Washington County. "There was a lot of gunfire and explosions heard up on the property," said Joe Roy, an SPLC investigator. Assistant U.S. Attorney Margaret Picking would not discuss details of the case, but prosecutors did unseal an affidavit supporting the arrest by the Joint Terrorism Task Force, a team of federal, state and local law enforcement officers.

According to the affidavit, a confidential witness recruited by FBI agents in Philadelphia drove to meet Hull at a Washington County truck stop in November to discuss a deal involving hand grenades and pipe bombs. Over lunch, Hull said he wanted to buy 10 hand grenades, but when he was told they cost \$200 each, he said he could only afford to buy five. Hull said he expected delivery in February.

He also said that he had sent two men that day to retrieve two bombs he had buried, and that all of them would meet at his property after lunch. While driving after lunch, the informant asked Hull what he intended to do with the grenades. Hull said he was going to blow up abortion clinics. At first, he said he intended only to cause property damage, but when discussing the possibility of people being in the buildings, he said "if they're there, they are killers or a woman killing a fetus; either way, [profanity] 'em." During the drive, Hull also spoke to a woman by cell phone who said she was trying to acquire blasting caps from miners for him.

After arriving at his home, Hull learned that the men he sent to dig up his bombs had failed to retrieve them. He then gathered the components to complete one bomb and told the witness how to assemble the pieces. The informant left with the unassembled bomb and some explosive powder, and Hull explained that he would bring the other two bombs to Lancaster "in a week or two." The informant later turned over the unassembled bomb to FBI agents.

On Jan. 14, the witness received a package in the mail from Hull that contained a fuse the witness had mistakenly left at Hull's house, along with a copy of Hull's "Knight Watch" newsletter. The March 2001 edition of the newsletter urged readers to write to Oklahoma City bomber Timothy McVeigh "to tell this great man goodbye and give him a well-deserved pat on the back for a job well done."

WASHINGTON: (This article by Amy ME Fischer was excerpted from "The Daily News" of Longview" dated January 21, 2003.) Cynthia Washington clutched a handful of white-supremacist fliers torn from light posts and park signs, her eyes full of tears.

"This is what we're trying to stop," Washington, one of Longview's 250 black Americans, said in a shaking voice Monday. "It hurts. It's not right. We're trying to show you what diversity is. We don't want to be cut down by stupidity" Washington and local community groups had been celebrating Martin Luther King Jr. Day at the McClelland Arts Center in Longview when AmeriCorps volunteers discovered the fliers posted outside the building and down Delaware Street.

The fliers, published by the white-supremacist groups Volksfront of Portland and National Affiance, of West Virginia, labeled Martin Luther King Jr. as a fraud." They asserted that non-whites commit the majority of crimes in the United States, quoted Abraham Lincoln in support of segregation and decried the U.S.'s "Unconditional Support of Jewish Occupied Palestine."

The rest of the above unedited article consisted of the day's events at the McClelland Arts Center along with whining and bellyaching about racism by the AmeriCorps volunteers.

(This article appeared in "The Columbian" of Vancouver on January 27, 2003.) Racist fliers posted before MLK Jr. Day event in Longview. Someone observed Martin Luther King Jr. Day in Longview by distributing white-supremacist fliers. Local community groups celebrated the day at the McClelland Arts Center in Longview and found the fliers posted outside, according to Longview Daily News. They were published by the racist group Volksfront of Portland and National Alliance of West Virginia, and labeled King a "fraud."

CALIFORNIA: Man pleads guilty in 1997 bank robbery. The most recent time that this writer saw Forrest was at the first Marty's Day Vigil on December 10, 1988. The following article was printed in "The Oregonian" on January 29, 2003.

A man accused of a 1997 Damascus bank robbery in which a shot was fired into the ceiling pleaded guilty this week to charges of armed bank robbery and using a firearm during a violent crime.

Forrest E. Bateman, Jr., 31, made his plea Monday in U.S. District Court in Portland. He is scheduled to be sentenced April 3 and could face as many as 20 years in prison, said Frank Noonan, an assistant U.S. attorney.

Bateman and Fritz A. Springmeier, 47, were indicted by a grand jury in January 2002 on charges of armed bank robbery, use of a firearm in a violent crime and possession of a destructive device in a violent crime. The two were accused of robbing the Damascus branch of Key Bank of Oregon on Oct. 8, 1997.

That afternoon, according to Noonan and police, Bateman dressed in battle fatigues, approached a teller and demanded money. About 10 minutes before the robbery, which netted \$6,000, a bomb was detonated at the Fantasyland Adult Video store, 16014 S.E. 82nd Drive, six miles to the west and about 10 minutes away by car. Investigators think the explosion was a diversionary tactic.

Police said Springmeier and Bateman were members of the Christian Patriot Association, an ultra-right-wing group based in Boring. Forrest can be reached at Forrest E. Bateman, Jr., #65210-065, P.O. Box 019001, Atwater, CA 95301.

OREGON: On Jan. 25, 2003, Volksfront (VF) held a Rock Against Communism event for a VF comrade wrongfully charged with assault for an act of self-defense against an ARA (Anti-Racist Action) terrorist. The show was hastily put together in under a month in order to raise funds for the legal defense of our comrade. With help from comrades in the Oi bands Cut Throat, Intimidation One and Aggressive Force, our friends at Panzerfaust Records and other organizations, we were able to hold a successful event in record time.

The planning began with our contacting local bands to get a decent line-up and our brothers in local bands quickly volunteered their services on a moment's notice. With critical sound and stage help from Jason of Intimidation One, we had only to acquire the venue and arrange the logistics.

The day of the event arrived. As usual, it was a difficult chore, rounding up people and equipment after a long night of band practice the previous evening. We were quickly 2 hours behind schedule but made the venue in time to open the doors to the first arrivals. Sound testing and set-up was finished by 5 pm, and the kegs were tapped and flowing.

At 6 pm, Cut Throat began their first live appearance and immediately impressed everyone with their sound. For a new band, they had an excellent set (although too short) and were very tight and had great stage presence. One of their more notable tunes was "Executioner". Cut Throat's sound has been compared to the Danzig/Misfits genre of music but they still bring a style their own and are definitely going to shake up the WP music scene in coming years. Their first CD is due out soon. We guarantee you it is going to be a must have.

Aggressive Force took the stage second, immediately getting a good crowd response with their well known songs "It's Time for War", "White Power Skinheads" and "It's OK to be White". The pit really picked up for Aggressive Force and they are excellent on getting crowd participation and bring people up to sing choruses of well-known songs. They played a great full-length set and really got people in a good mood. Aggressive Force has a new CD coming out on Panzerfaust shortly. Their new material is sure to surpass their previous album.

Portland's own Intimidation One took the final slot and kicked out some great songs and a new duet with Jason and Thora "Middle Europe" an English language Landser cover. Thora has a beautiful voice and German accent and it got a huge crowd response. Expect to be hearing more from Thora soon on upcoming music projects out of Portland. With much crowd pressure we were able to convince Intimidation One's original vocalist to take the stage for a song, "Gang Riot", and it was a blast from the past to see two of the original members live again. They played a great set and really capped off a great evening.

The show wrapped up around 11 pm. Fortunately about the same time the kegs went dry. Everyone got home without incident and there was absolutely no police or anti-White presence during the entire show. Merchandise was donated by Panzerfaust Records who, in its usual generous manner, donated 150 top name CDs to help raise funds for the legal defense of our comrade. Nearly half sold and the rest were given away to guests along with Panzerfaust Records stickers and business cards. With Panzerfaust's help we were able to cover all costs of the show and raise nearly \$700 for the legal defense of our VF brother. With an end turn-out of about 70 we had a good time and raised money for a good cause. We saw many new faces to our growing local scene as well as many old comrades who have been missing in action for the last couple years. With your help we will show the police and their Zionist masters that "SELF DEFENSE IS NO OFFENSE!"

On March 25, 2003, from 1120 to 1230 hours, NSV Management Director Rick Cooper was invited for the second time this 13th consecutive school year to address Professor Joseph Gallegos' Cultural Diversity in America Class at the University of Portland, a private Catholic School. There were 27 students, mostly White. There 3-4 Asian students and 3 students in ROTC uniforms. There were enough students to keep the interest and conversation going up to the end of the class period. Thirty issues of the JUL/SEP 2003 issue of the "NSV Report" was left at the front of the classroom for any student who wanted one.

Director Cooper gave the same basic introduction to the White Nationalist Movement as given in the lead article from the JUL/SEP 1991 "NSV Report" with the following additions. Now included with the basic talk was a definition of

"Armageddon", what it involves and why it is inevitable. Also standard now is our survival program. As a reminder, Armageddon is basically a race war and house cleaning. Armageddon needs two basic ingredients--massive racial integration and a financial collapse. ZOG (Zionist Occupation Government) is doing its best to flood the United States with non-Whites without any signs of letting up on this influx of non-White immigrants. The last that we heard is that the Bantus, a persecuted Black minority in Somalia, are now being given refugee status and are being settled in various large cities in this country. Financial problems continue to worsen. Such is the price that we will pay for allowing an economy based on usury. To balance the national budget, eliminate usury or even ban the use of all credit cards would lead to an economic collapse. Armageddon is inevitable and there is nothing that the ZOG can do to stop it. Our survival program is the same. We advocate that all White Nationalists (1) store long-storage survival food, (2) have drinkable water supply available, (3) stock various survival items, (4) be armed with legal weapons and have plenty of ammunition, (5) move out of the cities which will be virtually unliveable and move to mountainous or rural areas, and (6) link up with like-minded people for mutual defense and support. The discussion went well with no Devil's advocates.

Professor Gallegos later reported to Director Cooper that the talk generated a lot of interest among the students as determined by the discussion at the next class meeting.

Leaflets aim to stir division in Springfield Centennial Boulevard residents respond to fliers attacking Dr. Martin Luther King Jr. (by MATT COOPER of "The Register-Guard", March 14, 2003)

The leaflets showed up Thursday, tucked into doors and under the windshield wipers of parked cars, all of them vicious attacks on Dr. Martin Luther King Jr. The response along this residential strip of Centennial Boulevard was also passionate. "Kinda ridiculous, kinda stupid," 24-year-old Chastity Vincent said. "Trying to defame a dead man is kind of sad," added Sarah Cole, also 24. And Susan Edson, another neighbor: "It's sad there are still people who live in so much fear that they have to attack other people."

The leaflets tagged the late civil rights leader with a number of inflammatory labels and urged repeal of the national holiday in his honor. But residents in and around the 1100 block of Centennial Boulevard could only speculate as to why their neighborhood had been targeted, why now, and by whom. The general consensus was that the fliers were distributed in response to the recent controversy surrounding the possible renaming of Centennial Boulevard for King.

While Eugene (OR) continues to study renaming its portion of the roadway, Springfield Mayor Sid Leiken reiterated Thursday that his city won't rename the street, although it will consider other ways to recognize King.

The leaflets profess to be a public service announcement by Volksfront, which, according to Eugene human-rights advocate Greg Rikhoff, is "probably the most active hate (sic) group in Oregon for the last two years or so." The group has about 30 to 40 members statewide, Rikhoff said, and it claims to "set the international standard for pro-White activism." A Volksfront representative had little to say.

In response to an e-mail inquiry sent to the group's Web site, someone who identified himself as Volksfront press secretary Erik Sorrensen wrote back, "We've had no sanctioned activities in Springfield recently," and wouldn't answer other questions.

Police recorded the incident, but they have no plans to investigate. "Putting the fliers out is not a crime--you have to have a victim," Sgt. Mike McCarthy said. "It's freedom of speech. If you get one of these fliers and you disagree with it, just throw it away." Leiken said he would like to do more, although he accepts the constitutional protections afforded to anyone with an opinion. He planned to discuss the matter with the police department and the city's human rights representative, and he urged anyone to call if they (sic) have information on who distributed the fliers. "The old saying of Springfield from decades ago, where a minority coming through at night wasn't in a safe place, has reversed itself 180 percent," Leiken said. "This type of hate is not going to be tolerated."

Marilyn Mays, president of the Eugene-Springfield branch of the NAACP, found the incident "disheartening," even as the two cities continue to take steps toward racial tolerance. Mays counted more than 400 people in this year's Martin Luther King Day march, up from "a couple hundred" a year ago, she said. More people are showing interest in joining the NAACP, she added, and they're not just people of color. "There are allies being built in this community," Mays said, "but also a lot of people who are in denial about the existence of racism."

HIGH SCHOOL MAILINGS: In September, 2001, we marked the one-year anniversary of the terrorist attacks of Sept. 11. As a nation, we grieved the deaths of innocent victims and saluted the heroism of men and women in New York, Washington, D.C., and Pennsylvania. We also renewed our commitment to work for a world in which such atrocities are no longer a possibility.

It was with dismay that we learned that for the second time this year high school students in Lynden have received unsolicited copies of The National Socialist Vanguard Report. This quarterly neo-Nazi publication spreads its virulent message of racism, revolution, anti-Semitism and bigotry from a post office box in The Dalles, Ore. In the issue just received, for example, NSV Director Dan Stewart laments the fact that terrorists:

"...Did not have enough aircraft to crash into the headquarters of the Central Intelligence Agency, Federal Bureau of Investigation, Internal Revenue Service, Federal Reserve, Treasury, White House and Capitol Hill."

A truly horrific statement to make in light of the devastation we witnessed a year ago. We do not know if all members of the National Socialist Vanguard movement rejoice at the events of Sept. 11. We do know as Christian clergy and members of the Lynden Ministerial Association that such ideas cannot remain unchallenged, especially in the face of a concerted effort by the NSV to recruit young people in our community. On this latter note, we want to encourage parents and guardians to watch the mail, for your child may receive such a mailing as some of our children have - unsolicited.

We publicly condemn the hate mongering of the National Socialist Vanguard and its sister organizations in this and every community across our nation. And we ask our fellow Christians, people of other religious traditions and people of goodwill everywhere to stand up with us in the face of hate and to affirm the fundamental dignity and worth of every human being. On January 30, 2003, 928 "NSV Report" issues were mailed to high school students at various schools in Whatcom County, Washington. There was no known media response.

On March 6, 2003, 224 "NSV Report" issues were mailed to students at Coeur d'Alene High School and Lakeview High School in Coeur d'Alene, Idaho. There was no known media response.

IN MEMORIAM

ROBERT MARVIN SHELTON: Died of a heart attack at age 73 on March 17, 2003. He headed the largest Klan organization during the post World War II era. After leaving the U.S. Air Force, he joined the Klan at age 22. In 1957, he was elected Grand Dragon of Alabama. He was a personal friend of State Attorney General John Patterson.

When Patterson ran for governor in 1958, he sent letters to all Klanspeople, asking for their support, citing his endorsement by Shelton. After his election, the B.F. Goodrich Tire Company hired Shelton as their sales representative. Governor Patterson gave Shelton a \$1.6 million contract to purchase tires for all state vehicles.

In 1960, Eldon Edwards, the Imperial Wizard of the United Klans of America (UKA), died in Atlanta. At a national Klonvocation, Shelton was elected to take Edwards' place. Under Shelton's leadership, the Klan fought racial integration throughout the South, including the freedom riders and the Martin Luther King Selma-to-Montgomery March.

President Lyndon Johnson ordered a Congressional investigation of the UKA in 1965. The committee ordered Shelton to turn over a list of Ku Klux Klan members. Shelton refused and was found in contempt. Shelton served nine months in a Texarkana (TX) prison. He returned more popular than ever and even the Jewish Anti-Defamation League credited

him with having over 26,000 members.

The UKA ceased functioning after it was bankrupt by a suit filed in 1987 by the notorious con-artist Morris Dees. The honorable Robert Shelton was indeed a great Klansman!

BOB SCOGGIN: Passed away at his home on March 29, at age 80. During WW II he served in the Navy in both the Pacific Theater and the Atlantic. Bob received two Purple Hearts and was 100% disabled. Despite this, he was eventually elected head of the state UKA in the 1960s.

Bob Scoggin began taking "The Thunderbolt/The Truth at Last" in 1958. He was a charter subscriber and life long friend of Dr. Ed Fields. He ordered extra copies of every issue up to and including the last one. Bob Scoggin never moderated his views and was a true patriot in every sense of the word right up to the end.

AUGUST KLAPPROTT: Passed away at his home on March 31 at age 96. He had an unbelievable life.

The German-America Bund was established in 1936 to keep America out of another World War and to defend Germans from boycotts organized by the Jews. Klapprott was head of the Bund's New Jersey district and by 1941 second-in-command of their national office located in Manhattan. Klapprott, being 6'2" and very strong, was head of the Bund's "Order Guard" which protected their huge 1939 Madison Square Garden rally. (Some 22,000 people attended.) He served as commander of the Bund's Camp Nordland in New Jersey and was the editor of the Bund's English language pages of their newspaper, "The Free American."

Klapprott and 32 others were charged with sedition in 1942. It was alleged that they were, "undermining the war effort and had insulted Pres. Roosevelt." After Roosevelt died in 1945, all charges were dismissed. However, Klapprott continued to be held in prison - longer than any other Sedition Trial defendant, from 1942 to 1948.

Roosevelt interned over 120,000 Japanese during WW II and 1,825 Germans and Italians. Pres. Clinton passed a bill granting the surviving Japanese \$35,000 each in reparations. (Many had their homes and businesses sold at fire-sale giveaway prices.) However, the Germans and Italians received nothing. No politician in Washington dared to speak up to help them as it would offend the all-powerful Jewish community.

August Klapprott was a life-long reader of "The Thunderbolt" (AKA "The Truth At Last"). NSV Director Cooper talked to him briefly at an NSWPP congress and always remembered his words of wit: "If you let one nut into the organization, they will only bring more with them."
