In Memoriam

RICK COOPER (1946-2006)

Dear Racial Comrades:

It is with deep regret and a profound sense of personal loss that I must inform you that our friend and comrade Rick Cooper of Goldendale, Washington died in the hospital at 8 PM PST, Sunday, November 26, 2006 of massive kidney failure. Rick's health had not been good for some time. Although he ran marathons well into his fifties, three years ago Rick suffered a stroke, and it took him a long time to work his way back to where he could write and type.

Rick Cooper and I were the last men standing from the Wilson Boulevard Club—that small, true band of brothers who have seen the sun come up over Wilson Boulevard behind the duty desk at the old NSWPP headquarters on a small side street called Franklin Road in Arlington, Virginia. We were young and full of fire and idealism, and we were going to change the world. We failed, but if you have ever felt that glorious fire and you have no memories like that from your own youth, then I am truly sorry for you.

There are still a few of us left—I think Carl Geharis and Scott Earbend might have pulled a few all-nighters on Franklin Road, and they send me an e-mail every now and then to let me know they are still alive—but Rick and I never hauled down our colors. We were the last ones from “the Old Days” still publicly active in any way. I lost a good chunk of my past when he died.

For many years, Rick Cooper was the “American Nazi Party Guy To Go To” on the West Coast. He knew all the men whose names were household

words in our little subculture—Allen Vincent, Joe Tommasi, Jim White, the Raymond brothers, Dan Stewart, John Fogarty, Bill Gould, Paul “Wild Man” Mooney, Tiny Knowlton, Mike Brown of the old ANP Motorcycle Corps, the ineffable and irrepressible Sean Maguire. We all lost a chunk of the Movement's past when he died.

Rick finally broke with Matt Koehl in 1982, slowly, in agony, long after all the good men were long gone. He never joined another organization, because he felt it was wrong to abandon the party that Commander Rockwell founded. When I tried to get the NSWPPP back together in the mid-90's I practically begged Rick on my knees to come with us, but although he wished us well, he told me, “Harold, even if you succeed, you know it will never be the same. Backlash never replays like the original.” And I knew exactly what he was talking about. There were never any hard feelings.

But Rick never lost his own faith in the ultimate rectitude of the National Socialist cause, or in our final victory; Rick Cooper became the quintessential National Socialist lone wolf. He published his own newsletter, the National Socialist Vanguard, for almost a quarter of a century, at first in conjunction with Dan Stewart and then later on by himself. He regularly lectured to high school and college political science classes throughout the Northwest, and so cogent and articulate was his delivery that Rick was invited back again, year after year. Every June you could count on Rick hitting the news again, when he collected the names and addresses of hundreds of graduating White high school seniors and sent them packets of National Socialist literature at his own expense.

Rick was kind of an impresario for Events. He worked closely with the late Pastor Richard Butler

and organized many of the famous gatherings at the Hayden Lake, Idaho compound, as well as organizing annual commemorations for our fallen heroes, Bob Mathews on Whidbey Island and the murdered Weaver mother and child at Ruby Ridge. He supported the Northwest Migration concept, albeit from the NS point of view, at first through Pastor Butler and later on through the NPA. Rick was of immeasurable assistance to me in ways I am not at liberty to discuss, but I hope some day that part of his story can be told.

Towards the end his health slowed him down considerably. His newsletter was always late, and his e-mails grew fewer and farther between. But he never gave up. Like all of us, Rick did what he did not out of any hope of personal gain or benefit, not even for the Victory itself. He did what he did *because it was right*.

Give me a hundred Rick Coopers, and the White race will have our Northwest Homeland some day.

ANOTHER GOOD MAN DIES

The pro-White Movement has been blessed with the most patriotic, the most dedicated and the most sincere political activists. One of these activists was Rick Cooper. He was active in the most far right portion of the pro-White movement from 1970 until his death Sunday evening, November 26th, 2006. He wasn't a gifted speaker or dynamic leader, but he was a dedicated and tireless worker for a great cause.

Cooper joined the pro-White Movement in 1970 just three years after the death of George Lincoln Rockwell, the most dynamic and dedicated American pro-White leader of the twentieth century. For decades after Rockwell's death, the pro-White Movement suffered from a scarcity of leaders. Many individuals like Cooper wound up forming their own organizations trying to organize White people in their home areas. Cooper was active in northern Oregon and had a P.O. box in "The Dalles,"

Oregon, for decades. Everyone who met Rick was impressed by his dedication and optimism.

Rick Cooper's greatest misfortune was the apathy of the very people he was trying to save. The average White American (a.k.a. Joe Sixpack) refuses to take politics seriously. Mr. Sixpack refuses to ditch the evil and thoroughly corrupt two-party system. Even the presence of drunks, bribe-takers, perverts and a pedophile in mainstream politics has not yet convinced Joe Sixpack to look for a third party solution.

If White Americans had supported the pro-White movement in the early '70s when Rick was first politically active, all our race problems could have been solved peacefully simply by separating the races. 40,000 Whites would not have been murdered by Blacks. Millions of White women would not have been raped by Black men. Several pointless wars for the interests of Zionists and/or big corporations would have been avoided and thousands of US soldiers would not have died needlessly.

Instead of sitting quietly and watching the wealth of the nation stolen by Halliburton, Israel, minority welfare parasites and outsourced to Asia, Americans could have enjoyed a Golden Age with full employment and free medical care for all—just like Germany after it defeated its own corrupt two-party system in the 1930s. The national debt would have been paid off long ago instead of ballooning to nine trillion. There would never have been the outsourcing of millions of manufacturing jobs thanks to corporate pirates with no sense of loyalty to the White race.

If anyone should make it to heaven, it would be a brave, heroic, noble man like Rick Cooper, who tried to stand up to the forces of evil. If anyone should make it to hell, it will be the two-party scoundrels, who sell their souls to the children of satan and who vote away our freedoms without the slightest hesitation.

COMRADE RICK COOPER 1946-2006

A former member of the N.S.W.P.P. and long time publisher of the NSV (National Socialist Vanguard)

Report, Rick Cooper's time of service to the White nationalist movement stretched back more than 30 years. Although a stroke left this Oregon activist partially disabled in later years, he never gave up the struggle. Massive kidney failure finally sent this Comrade to Valhalla on November 26th of 2006.

Rick's activism included public street rallies, question and answer sessions at area high schools and mass mailings of the NSV Report that numbered in the tens of thousands. In addition, Rick assisted Pastor Butler in organizing the Aryan World Congress events at Hayden Lake, Idaho for many years. It was at the 1987 meeting where I first met Rick and began a friendship that lasted to the end.

When the roll call of activists of the past is one day read from the new Reich's Chancellery, the name Rick Cooper will be recalled as one who helped make the new dawn of National Socialism a reality.

WHAT IS NATIONAL SOCIALISM?

Henry Ford had much influence on Hitler.

National Socialism is a world view for White People, based on the ideas and concepts of the German racial nationalist philosopher and statesman Adolf Hitler (1889-1945). National Socialism was adapted to the political and racial conditions of the United States by the late U.S. Navy Commander George Lincoln Rockwell (1918-1967).

Owing to the tragic and unnecessary suffering which took place during the Second World War, and because certain powerful elements in our society to this day maintain an interest in obscuring and concealing the truth, half a century after the war's end massive misconceptions still exist in America today about what National Socialism was and is. The National socialist body of belief is founded on three principles:

1. **NATURAL ORDER.** We believe that the universe is governed by natural laws. In order for Man to be happy and successful, he must first learn what these laws are and then follow them. We believe that Man is a part of the natural world and that he is

in no way separate from or distinct from it. Because of this, we believe that society should be structured in accordance with the laws of Nature, and not in opposition to them as is the case today.

2. **RACIAL IDEALISM.** Racial idealism is based on the love of one's own people. It means placing the interests and the welfare of the racial community to which you belong ahead of your own personal interests and desires. As racial idealists we have no wish to harm, exploit, or persecute any other racial groups, despite a persistent media propaganda campaign of abuse and deliberate falsification to the contrary. We are only interested in protecting our own people against extinction; a fate all too likely if nothing is done about present conditions in America.

We believe that all men are NOT created equal. Just as every individual has his own strengths and weaknesses, so each race has certain qualities which make it different from other races. We believe that the White (or Aryan) race has the right to maintain its own biological, cultural, and political independence and integrity, and that we have the right to control our own destiny. We also believe that the White race has the right to defend itself against all physical, economic, and spiritual assaults, no matter where they come from.

3. **THE UPWARD DEVELOPMENT OF THE WHITE RACE.** We want to do more than just defend our race; we want to see it improve. This can be done by encouraging a high birth rate among those sections of the White population which are the healthiest, strongest, and most intelligent. At the same time, our science should work to eliminate hereditary weaknesses and defects among our people. Our goal is that each new generation of White children will be better than the one before it.

AMERICA'S PEASANTS: WHITES LABOR SO ALL MAY EAT

One of my hobbies is medieval history. Some years ago I was reading a scholarly volume on the Middle Ages when I came across a translation of

a textbook or primer used to teach children of the nobility to read, kind of a fourteenth-century "See Dick and Jane" kind of thing. The book described all the various people who existed in the medieval world and their functions: the king rules by divine right, the baron gives justice and protection to his people, the knight does deeds of valor for his ladylove, the priest intercedes with God for the souls of men, the merchant brings goodies from foreign lands. It continued on down to the tradesmen such as the weavers, the butchers and bakers and so forth, you get the picture.

At the very end was a single sentence thrown in almost as an afterthought which described people who in those days were at least 90% of the entire population. It was a phrase which has stuck in my mind from that day to this:

"And the peasant labors so that all may eat."

I can think of no better way to describe the role of the White man today, and many White women excluding the artificial affirmative action-created female managerial class. We are peasants. Our function in this society is simple. White men build and drive the trucks that deliver the consumer goods, manufacture and package the junk food, maintain the power plants that keep the air conditioners and televisions running, cut down the trees and make the paper which keeps the bureaucracy going. White police and soldiers loyally carry the guns and pull the triggers for ZOG, everywhere in the world. Above all, White men pay the overwhelming bulk of the taxes which keep the whole rotten system afloat.

We are serfs on the great worldwide consumer plantation, producing the wealth and keeping everything going while our multifarious masters sit on the veranda eating and drinking the products of our labor and spinning their pointless little intrigues. Like all peasants, we have no place in the political process. Our role is to work so that all may eat, accept with gratitude such consumer goodies as our betters see fit to fill our bowls with, shuffle, tap dance, tug the forelock, vote the way we are told to vote by our natural superiors, the liberals, and apply our lips in the prescribed manner to whatever derrières are presented to us. Finally, we must keep our minds squeaky clean of

any impure doubt or racist thought.

But peasants have been known to revolt. Think guillotine, my brothers, with a pile of heads on the Capitol steps higher than Tamerlane's. Think gallows on the White House lawn, with rows of bodies in thousand-dollar suits with pedicured toes turning slowly in the wind. The French did it. The Russians did it. The Germans did it. Even the Iraqis and Iranians did it. So will we.

WHO'S KEVIN SHIFFLET?

How many names of hate crimes victims, off the top of your heads, can you name in ten seconds? I can name several, but I didn't know Kevin Shifflet's name until last week, three months after his life ended in a violent race crime. The second-grader's throat was slashed on April 17th of this year (2001) as he played with siblings in his front yard, and racial words were used by the attacker. Despite his being the victim of one of the most horrible hate crimes in a decade, his name just didn't ring a bell when I heard it!

Did anyone hear about the brutal race murder of the 8 year old in Alexandria, VA on CNN, MSNBC, your local news or did you read about it in your local newspaper? One would think a CHILD killed in a racially-motivated knife attack would attract the news media and civil rights leaders like MAGGOTS on dead flesh. A child as a poster boy for opposition against racial hatred! What a golden fund-raising opportunity for Morris Dees and the Southern Poverty Law Center. But Morris, Jesse, Mfume and Al are working overtime to create other stories to distract us from this innocent White boy's death. Because of Kevin's race, his funeral was avoided (boycotted) by civil rights leaders and activists. They don't want to draw attention to hate crimes, they want to create more hatred against White people, and that is as obvious as the perpetrators' race.

Due to the MISSING IN ACTION status of the selectively indignant anti-hate crusaders and liberal anti-White media, I put my feelers out to get more details. I mentioned it to a friend, and he sent me a copy of a politically incorrect publication

(The Truth at Last), which prints excerpts of the race crimes the media won't touch. At the time the murder happened, all Alexandria residents knew is that a man slashed the throat of a little boy, and he was still on the loose. They knew the victim was White because his photo was run in the local newspaper. Later, police artist sketches revealed the suspect was black. This is the sole reason Geraldo Rivera and co-conspirators didn't take issue with it. If the races were reversed, all of Europe and Canada's PC reporters would have picked it up on AP, and at least half the news stations and papers would have printed the story. As it goes, because the victim was White, only local papers reported the murder. Nonetheless, White activists have circulated a recent story from a mainstream newspaper exposing the racial motive and subsequent cover-up. It is safe to say journalists and talk show hosts who read the *Washington Times* know about the racially-motivated murder. Still, there is nothing but a deafening silence.

PIGMENTATION PRIVILEGE

I wish I could tell you if Kevin Shifflet enjoyed fishing with his father or playing soccer with his friends at the neighborhood park. But I can't, he has yet to be humanized by even those few brazen reporters who have dared to cover his murder. White children are not as sacred as black males. It's more important to protect the civil rights of black killers than it is to cherish White children. We wouldn't want to encourage public sympathy for one who would someday have grown to be a "White male." Kevin has yet to be mourned by anyone outside of his family or circle of friends or remembered with a candlelight vigil. No tearful "kumbaya" chorus led by a wise black woman. Don't think of it, Kevin was a mere White male, not deserving of remembrance or even a few crocodile tears from Bill and Hillary Clinton.

You see, the media, prosecutors and pontificating politicians have more important people (MOPs) to humanize and create sympathy for than the likes of those "racist wite kidz," as Kevin's killer called him. For goodness sake, there is this carjacking black thug who shot a cop whose civil rights were violated! There are two stories a day on the AP lamenting the fate of this PUNK CRIMINAL, while

Kevin Shifflet's name hasn't appeared on even ONE press wire! Kevin Shifflet wasn't so noble as to be a cop-killing carjacker, a shoplifter killed by a choke hold after resisting arrest, or a pervert in drag hanging from a tree.

No, he was a mere "White male" who had just returned home from school. In broad daylight, in his own front yard, in the company of his younger brother and older sister, 29-year old "African-American" GREGORY DEVON MURPHY jumped into his yard and slashed the second-grader's throat. Murphy had concealed the knife in a paper bag as he walked through the middle-upper class neighborhood of Del Rey. His 80-year old grandmother and a 51-year old neighbor tried to stop the bleeding, but Kevin died on the spot, right in front of his two siblings.

At the time of the crime, the people are told, cops had no clue as to the motive. Even after a witness stated Kevin's killer made anti-White statements during the murder, the Alexandria police department acted as if they had no motive. The top brass wouldn't release "racially sensitive details" unless they (tell me it ain't so, Moe) KNEW FOR SURE race was the motive. Kevin was killed two days after a handwritten note was left in Murphy's hotel room which read "kill them racist white kids." Because the Alexandria police didn't share this information with the F.B.I., the apprehension of Kevin's killer was delayed. No clueless White zombie knew or suspected anything until a newspaper recently exposed Kevin's black killer as a racist with a history of anti-White crime. Murphy had a litany of violent crimes under his belt, including one against a White man who he called "whitey" as he attacked him. No hate crimes charges were filed in that case. If they had been filed, Murphy probably wouldn't have been out on parole at the time he killed Kevin, since hate crimes charges bring an additional 3 years prison time. After having committed several violent assaults, including rape, assaulting police, malicious wounding and sodomy, Gregory Devon Murphy was a free bird.

EUROPHOBIA

Let's be honest, folks. Every time we learn of a horrible race crime against a White victim, the media calls the NAACP (or the other way around) to get

another race story to distract the public's attention from anti-White hate crimes. As a result of shrewd planning and sensational "poor black man" stories, crimes like Kevin's murder magically find their way down the memory hole. The anti-White establishment fear (the laughable idea of) White reprisals. This is called "Europhobia." They don't fear the (not-so-laughable) reality of BLACK RAGE and gleefully give the public every detail of every race crime or allegation thereof, as long as the perpetrator is a White man. Make no mistake, this is meant to elicit rage against People Without Pigmentation (PWP). They don't care that 90% of all violent crime is black-on-White or that 63% of the murders in this country are perpetrated by the 6% of the population that is black and male. They will never tell you that 1 million White Americans are the victims of black interracial violent crimes each year. They prefer to harp on the average 132,000 interracial crimes against blacks and "racial profiling" instead. It doesn't matter to these white-collar criminals that blacks commit 7.5 times the violent interracial crimes as Whites, despite the black population being 1/7th the size of the White population. When adjusted on a per capita basis, blacks are 50 times more likely than Whites to commit violent interracial crimes.

Instead of acknowledgement of the facts, we get to hear the assertion that "blacks kill more blacks than Whites." I beg to differ... but now we have hate crimes. This is a way blacks can showcase the rare White-on-black crime and take the focus off of their obvious BLACK RAGE and elicit yet more BLACK RAGE against MY people. They are "busting myths" they claim. In reality, they are CREATING FALSE MYTHS of the White hater. Unless the law is applied equally, hate crimes laws are a useless civil rights tool. In practice, they are used as a way of VIOLATING the civil rights of White people by creating longer sentences for us for the same crime, a violation of the Constitution. Blacks are rarely PROFILED as race criminals the way Whites are. If a White woman is raped and the black attacker says "spread them legs or I'll blow your honkey head off, bitch," the police and prosecutors are unlikely to publicize the slur or charge the attacker with a hate crime. I suppose this is a way of "leveling" the playing field out. Black race advocacy groups complain they get longer sentences for the same crimes as Whites, so our prosecutors give White folks longer

sentences by selectively wielding hate crimes laws. Never mind the fact that blacks get longer sentences because they are more likely to have prior records. Jesse Jackson would rather see White children die than to have a black felon spend three more years in jail for a hate crime. In fact, Jesse wants to give black felons the vote. Figures, they are his followers and the liberals' constituency.

RACIAL INTIMIDATION

Jesse Jackson and Al Sharpton and Kweisi Mfume have White people so intimidated, they would fear for their safety if they held a rally against BLACK RAGE or flew a Confederate flag outside of their home. They have intimidated every prosecutor, police officer and politician in the country. It ain't about civil rights, folks, it is about "paying them white people back". Equal rights has nothing to do with this, this is WAR and anyone who doesn't understand this is either brainwashed, wimped out or mentally out to lunch. I predicted two years ago that the hate crime cover-ups will extend beyond race rapes of White women and evolve into covering up hate crimes against White children. It is happening on more of a regular basis than you think. This has gone way too far and it is time to face the race issue honestly.

The systematic racial intimidation against Whites constitutes a federal hate crime against my entire race. Racial intimidation silences politicians who may otherwise take action to correct the glaring issues we have before us. Racial intimidation causes White police officers to avoid apprehending black criminals in public places for fear of rioting. It causes White families to be internal refugee in their own country. It cows White people into remaining silent against what they know are injustices. It causes our press establishment to turn the other way when a White child is brutally murdered by a minority. It causes White men to be forced out of their jobs because the Jose's of the world need a job and the boss is a racist if he hires a White guy. It causes us to be mocked and spat upon in our own country.

NEVER FORGET!!!!!!!

In closing, I apologize for getting off-message and into the WHITE RAGE. The most important point I want to make is that we should NEVER FORGET the Shifflet family's grief, their community's fear and the loss Kevin's classmates and friends are feeling.

We should ALWAYS REMEMBER Kevin will never have the chance again to pet his dog, win his first wrestling match, go to 7-eleven for a slurpee or play baseball with his friends. He will never kiss his parents goodnight, sit on his grandma's lap or hug his brother and sister again. He'll never get an embarrassing pimple or experience his first love. His brother, sister and elderly grandma will ALWAYS REMEMBER Kevin lying in the front yard, with blood spurting out of his neck as the last time they saw him. His parents will always remember the phone call, and wonder if they were too harsh on him the last time they punished him. All of these people will be traumatized for life.

Kevin's community will never get a visit from the Southern Poverty Law Center's Morris Dees to explain why racism is wrong. The ADL will never call the Shifflet's, express sorrow or ask them to testify to Congress for the latest hate crimes bill. Kevin's classmates will never see the whites of the eyes of Simon Weisenthal's "teaching tolerance" lecturer. In fact, these organizations won't even list this as a hate crime.

Which begs the question—WHY?

ARYAN ANCESTORS ON THE SILK ROAD

Political correctness has gotten a slap in the face recently from a number of archaeological discoveries in the Orient which indicate that the founders of many Eastern civilizations, which are so revered by trendy New Age types who despise anything White and European, were in fact racial Aryans. One famous example is the country of Iran, which takes its name from its original conquerors; until 1978 one of the many formal titles of the Shah was "Lord of the Aryans."

It has long been known that around the first century A.D. the northwestern part of China was inhabited by a Caucasian people who spoke a language called by scholars Tocharian. In the early part of this century, French and German archaeologists excavating in the northwest provinces discovered extensive written manuscripts in this language,

and when they were astonished at the similarities between this supposedly isolated Oriental tongue and ancient Germanic and Celtic languages.

Now the PC academic and scientific establishment who want to rewrite history to make it "Afro-centric" and get rid of "dead White European males" have gotten another kick in the pants from the truth. Recent excavations in the Tarim Basin in Xinjiang province have uncovered more than 100 naturally mummified corpses of people who lived there between 4,000 and 2,400 years ago, indicating that the Aryan incursion into Asia was in fact far earlier and far more extensive than anyone previously believed. The bodies were amazingly well preserved by the arid climate, and according to the New York Times "...archaeologists could hardly believe what they saw."

The mummies had long noses and skulls, blond or red hair, thin lips, deep set eyes, and other unmistakably Aryan features. Dr. Victor H. Mair of the University of Pennsylvania said, "Because the Tarim Basin Caucasoid corpses are almost certainly representatives of the Indo-European family, and because they date from a time period early enough to have a bearing on the expansion of the Indo-European people from their homeland, it is thought that they will play a crucial role in determining just where that might have been."

[NB.- My own understanding is that the ancient homeland of our people was by the shores of Lake Baikal in what is now Russia, from whence we began our migrations untold millennia ago when we were all one nation known as "The Children of the Sun". As to where we came from before we were hanging around the lake—I have my own theory, but that's another story, which I won't get into now for a variety of reasons.]

One such mummy of a teenaged girl with blond hair and blue eyes, found in a cave, has become quite a tourist attraction in Beijing. She has been nicknamed "The Lady of Tarim" and she is on display to throngs of museum visitors in the Chinese capital. Apparently she was a princess or a priestess of some kind over 3,000 years ago, for she was buried in fine embroidered garments of wool and leather, along with beautiful jewelry, jars and ornaments of gold, silver, jade and onyx. Her remains are in a such a remarkable state of preservation that the dead girl looks as if she were just sleeping.

"Diffusionism can now be taken seriously again," chortled one historian, Michael Puett of Harvard. Diffusionism is the theory that the ostensibly advanced Middle Eastern and Oriental civilizations of the ancient world all benefited from contact with Aryan migrants, merchants, wandering tribes, etc. and acquired much of their knowledge and attributes from these contacts; this theory can actually explain quite a lot about history, from the Indo-European roots of the Hindustani language to the Quetzalcoatl legend of the Aztecs to the mysterious ruins of Zimbabwe which were so clearly never built by blacks.

Diffusionism has been replaced over the past twenty years by the new, Politically Correct dogma of "independent invention", which holds that there was no contact at all between White people and any Asian or pre-Columbian civilization, or if there was it was bad because all White males are "imperialist exploiters". The PC theory teaches that EVERYTHING in ancient non-White societies was invented by the indigenes, EVERYTHING WITHOUT EXCEPTION, no ideas or influence from European contact, nothing good or beneficial at all even if there was any White contact, which there wasn't because White males are not the world-exploring hotshots they are supposed to be, so there! I guess we made up Leif Ericson and Columbus was really a monkoid. Don't laugh—I have heard both of those idiocies advanced seriously by "Afrocentric historians".

(The PC eggheads also claim that Columbus was a Jew. Yeah. Right, Ferdinand and Isabella, who had just finished expelling the Jews from Spain in 1492, then proceeded to hock the queen's jewels to finance a major nautical expedition by a Jew. What's wrong with this picture?)
