## **OPERATIONS**

**GERMANY:** On July 2nd, In the forefield of his appeal proceedings, the many-year activist Manfred Roeder, 73, was arrested because the judge issued an arrest warrant. During his appeal proceedings, he was in handcuffs. The Superior Court of Rostock (German state: Mecklenburg-Vorpommern) sentenced Comrade Manfred Roeder to 21 months in jail for revilement of the Federal Republic of Germany, hate speech and an offense (calling the government an asshole, dirty pig etc.). His appeal proceedings brought him only 3 months less. The treatment of Comrade Roeder was unfair and scandalous. (Note: It is not known which offense he did. It may have been an offense against the Jews or the government.)

On July 5th, the former SS Major Friedrich Engel, 93, has been found guilty of the murder of 59 Italian prisoners during WWII. He pleaded not guilty to charges of murder and was spared a 7-year jail term because of his age. (Note: The reason for the executions was a bomb attempt on a cinema full of German soldiers by Italian communists. All allies have done the same things in WWII.)

On July 6th, Christian Worch, the leader of the so-called Free Fellowships, organized a protest rally against left-wing violence with approximately 250 nationalists (most of them skinheads) in the inner City of Magdeburg (German state: Saxony-Anhalt). The reason for the protest rally was attacks on nationalists and arsons, and attacks on nationalist property through left-wing terrorists. The left-wing scum held their own gathering near the central station of Magdeburg with approximately 50 Reds. Both rallies were peaceful.

On the same day, in the City of Dortmund (German state: Northrhine-Westfalia) in a tram, six nationalists made first offenses to an ape couple (niggers) and later

they were punched in their faces several times. The ape couple were injured but they could find a way to escape with help of a citizen. The six young nationalists, ages between 16 and 19 years, were arrested.

On July 11th, the Federal Minister of the Interior, Mr. Schily, and all other Ministers of the Interior in the German states would not give out information about the names of agents to the Federal Constitutional Court in Karlsruhe (German state: Baden-Wuerttemberg) in the trial to ban the NPD. The dirty system will try to start the trial in October. (Our correspondent does not believe that the NPD has a real chance to win after this agreement between the Ministers of the Interior.)

On July 16th, the Federal Ministry of the Interior searched 40 homes of alleged members of the skinhead organization Hammerskins in seven German states and confiscated CDs, propaganda material and lists of names. The Hammerskins organization is in Germany and not legal and the system describes the organization as a criminal association.

On July 27th, there was a protest rally against the collaboration between system and anti-fascists with 60 nationalists in the City of Dresden (German state: Saxony). Some nationalists held in their hands political banners. The protest rally was organized through a free fellowship with the name "Free Forces of Saxony." Several hundred counterdemonstrators were there. The mayor of Dresden marched with the Red counterdemonstrators and gave a speech to the Red scum. No arrests were made by the system cops or federal border troops. Both rallies were peaceful.

On July 28th and 29th, during the night to Monday, six Red bastards made an assault on the NPD local branch leader of Stralsund (German state: Mecklenburg-

Vorpommern), Dirk Arendt. The bastards knocked down and injured him. Each Red bastard a bullet in the head!

On August 17th, there was a rally to honour the prisoner of peace, Rudolf Hess, in the small town of Wunsiedel (German state: Bavaria). In this small town of his burial place since 1987, between 2,600 and 3,000 nationalists marched powerfully and peacefully through the small town. Under the marchers were guests from Denmark, Sweden, France, Austria, Switzerland, Spain, Netherlands, Finland and Estonia. Some foreign guests read messages in their language to the marchers. The organizers of this rally was lawyer Juergen Rieger from Hamburg and the vice chairman of the NPD, Holger Apfel. There were speeches by Rieger, Apfel, Wolfgang Juchen and Thomas Wulff. About 100 Red counterdemonstrators were there. No chance for the Red scum because they had trouble with the town folk. The town folk agree with the nationalist cause to honour Rudolf Hess. The system puppets checked all the nationalists and proofed their identity cards in the forefield of this rally for 6 hours. Only 25 nationalists were arrested because the system slaves found knives, truncheons and gas pistols. These things are illegal at rallies in Germany. Our correspondent has heard that four Red trouble-makers were arrested too. The nationalists will come back next year to honor Rudolf Hess again.

On September 7th, there was an open air election campaign meeting with approximately 130 NPD supporters near the railway station of Wuppertal (German state: Northrhine-Westfalia). The campaigner gave a speech about the risks of immigration for Germany. Some NPD party members held during his speech NPD party flags in their hands and built up an information table with free NPD propaganda material. Nearly 1,500 communists and several hundred cops were there. There was no violence or arrests.

On the same day, unknown nationalists smashed 10 grave-stones with a round set hammer on a Jewish cemetery in the small town of Buetzow (German state: Mecklenburg-Vorpommern). Swastikas and SS runes were painted on other gravestones.

On September 14th, there was an NPD protest rally with approximately 75 comrades in the City of Potsdam (German state: Brandenburg). "Stop the mass immigration of Russian Jews--Germany for Germans" was the rally slogan. One thousand counterdemonstrators were there. Jews out!

September 22nd was election day for the Lower House of the German Federal Parliament. There were poor results for the German right-wing parties Republicans (REP) and National democratic Party of Germany (NPD). The Republicans gained only 0.6% of the votes nationwide and the NPD gained 0.4% of the votes. It is sad that the German people always vote for the rotten and corrupt system parties under the hidden rule of the dirty Jews. The

final solution is the only solution!

On the same day, there were elections for the State Parliament House of the German state of Mecklenburg-Vorpommern too. There were not much better results for the right-wing parties regarding the Federal elections. The NPD and Republicans (REP) did run for Parliament seats. The results are 0.8% of the votes for the NPD and 0.3% for the REP.

FRANCE: On July 14th, the French nationalist Maxime Brunerie, 25, fired a single shot from a 0.22-caliber rifle as French President Chirac passed by the Arc de Triomphe in the capital city of Paris on Sunday but some citizens overpowered Nationalist Brunerie. It is a legal holiday to celebrate the Jewish French revolution in the year 1794. Brunerie did run for the right wing party Movement National Republican (MNR) in the local elections last year. He is a member of a far right wing students fraternity, GUD, and a sympathizer of the far right wing party Partie Nationaliste Francais et Europeen (PNFE).

On July 15th, Nationalist Brunerie, who is alleged to have attempted to kill French President Chirac, has been committed to a psychiatric ward. He has told the system cops he hated Chirac and wanted to kill him to save France. The judge declared him to be a danger to the public order.

On August 6th, there was system terror in France against the radical right. The French government has agreed to disband the far right-wing group Radical Unity and closed the Internet website too. Stalin likes these guys! Maxime Brunerie, who tried to shoot French President Chirac during the Bastille Day Parade in Paris on July 14th, had ties to this group too. Approximately 2,000 people were members of this group and was established in the year 1998. The only legal authority was legislation of the year 1938 against militias and private armies to disband the "Radical Unity."

On September 18th, WWII NS collaborator Maurice Papon was released from a French jail just hours after a court ordered that he be freed on health grounds. Papon, 92, was sentenced to 10 years imprisonment in 1998 for complicity in crimes against humanity by signing deportation orders which sent French Jews to concentration camps. The French government will go to an appeal proceedings.

AUSTRIA: Some days prior to September 21st, the Federal Chairman of the FPO (Freedom Party of Austria), Mrs. Riess-Passer, stepped down after disagreements about the cause of the FPO policy with Joerg Haider. She wanted the same party line as the conservative Austrian People's Party (OVP) in the government. The Austrian people do not need a second kosher OVP. On this Saturday, there was a special party convention to elect a new FPO federal chairman in the small town of Oberwart, Austria. Mathias Reichhold was elected with 92

of the 655 present party members. He is the new FPO chairman and his function in the fusion administration between FPO and OVP is Minister of Transport. On November 24th, there will be elections for the National Assembly of Austria.

SERBIA: On September 29th, there were presidential elections in Serbia. The leader of the right-wing party, the Serbian Radical Party (SRS), Vojislav Seselj reached the third place with nearly 23% of the votes nationwide.

MASSACHUSETTS: The Associated Press, Boston, July 16. The trial of a son of civil rights activists and his girlfriend began with allegations that they plotted to incite a race war by blowing up black and Jewish landmarks. Defense attorneys said Leo Felton, the son of a white mother and a black father, and Erica Chase, who is white, were never serious about carrying out bombings. But prosecutors said in opening statements Monday that the pair hoped to wipe non-whites from society. Felton, 31, and Chase, 22, have pleaded innocent to charges of conspiracy, obstruction of justice, making counterfeit bills, firearms and explosives violations. Felton is also charged with bank robbery and conspiracy to commit bank robbery.

Felton became involved in white supremacist groups while in a New Jersey prison, where he served time for attempted murder in the beating of a black taxi driver. Chase began writing to Felton in prison in April 2000. Chase's attorney, Timothy Watkins, said she was a pawn for Felton. "Leo Felton exercised his power over Erica Chase to persuade her to do the things that he wanted," Watkins said. Assistant U.S. Attorney Theodore Merritt said the two were part of a small Aryan cell "committed to the idea that not all men were created equal."

To finance their plans, Merritt said, Felton made counterfeit money and robbed a bank of \$1,100 with a former fellow inmate, Thomas Struss. Struss is expected to testify that Felton told him he was making a fertilizer bomb like the one used in Oklahoma City to destroy the Holocaust Museum in Washington. Prosecutors said Struss agreed to testify in hopes of winning a reduced sentence on a gun possession charge in a separate case. Felton also kept a list of possible targets that included the Revs. Jesse Jackson and Al Sharpton, movie director Steven Spielberg and other well-known Jewish and black figures, Merritt said.

The case broke in April 2001 after Chase was arrested trying to pass a counterfeit bill at a doughnut shop. Police found bomb-making material in the couple's apartment along with newspaper clippings of an upcoming ceremony at the New England Holocaust Memorial and photos of the Leonard P. Zakim Bunker Hill Bridge, named after the late Jewish leader. "The agents discovered a veritable menu of how-to for the terrorist," Merritt said. Chase has told investigators that they were gathering material to detonate a bomb on a beach for "entertainment." She said they did not intend to bomb a target or hurt anyone.

Authorities also found a comic strip-like sketch starring a white supremacist who bombs African-American housing projects and Jewish landmarks. Merritt called this "Felton's script for his terrorist plans." Felton's attorney called them "just drawings."

Among the first witnesses was Kathy McGaffigan, a close friend of Chase, who testified about a phone call she got from Chase after the couple's arrest on the counterfeiting charge. McGaffigan, a 22-year-old Harvard University student, said Chase asked her to go to the couple's apartment and remove counterfeit bills, a gun, ammunition, a wiring and timing device and a 50-pound bag of ammonium nitrate. McGaffigan said she put most of the items in the trash, but kept the gun, ammunition and a box of letters at Chase's request. She also said that when she met Felton with Chase last year, they told her they were "planning a bomb."

MARYLAND: Jewish Defense League Activists Scuffle With White Supporters. Two Jewish Radicals Expelled From County Fair (08/16/02, 10:34:30 PM, LSN Staff). In Gaithersburg, two individuals who identified themselves as members of the radical Jewish Defense League organization suffered minor scrapes and bruises today after they were physically expelled from a campaign literature booth set up by supporters of Independent nominee for Maryland House of Delegates Bill White.

According to witness accounts, the two approached the booth and began screaming obscenities at booth workers, calling them "Nazis" and shouting phrases like "Fuck You." Booth workers asked the two to leave, and they refused, instead attempting to grab and destroy literature and campaign signs. White supporter John Latham, who was in charge of the booth and who works as an armed security guard and president of a local martial arts academy, then stepped between the two and the booth, and physically removed the two angry Jewish individuals, mildly injuring them in the process.

The two individuals then went to fair officials and stated they were officials of the Anti-Defamation League of B'nai B'rith, and that they had just been victims of a "hate crime." An incident then occurred involving the two, who continued to shriek obscenities at the top of their lungs to fair officials, fair security, White supporters, and the Montgomery County Police. Police and fair officials were able to determine after the incident that the two were not, in fact, officials of the ADL, and determined that they were known to police as having a history of provoking similar incidents.

White, who was not present at the scene, spoke to fair officials that evening, and was told that the incident was considered "over." White apologized for the confrontation, one of several minor incidents that have occurred during the week and that have irked fair officials. The incident represents the sixth time that White supporters have been assaulted during this campaign season. In the most well known incident, a White supporter was assaulted by a Van



Hollen for Congress campaign worker, leading local television to fill their evening news casts with video of White throwing the Van Hollen worker into a wall. White and his supporters have also been assaulted on street corners during their recent petition drive, mostly by non-political people who appeared to be somewhat unstable. White's campaign spoke to an estimated 15,000 people in order to gather more than 2,100 signatures for two candidates for the local state legislative elections.

"The incident that occurred today doesn't particularly bother me," White told the press, "because these incidents occur all the time. The fact is that for every three or four thousand people you approach at random on the street, one is going to assault you. We've pushed out nearly 10,000 pieces of assorted literature at the fair, and odds dictate that we are going to encounter some people who are going to be combative. That's why I put John in charge of the booth when I'm not there -- he is the one person besides myself that I know won't take any crap from people." (Note: That's right! Kick their butts hard whenever they raise their stinking heads!)

GEORGIA: On July 20th, about 16 people turned out for a meeting of the newly forming central Georgia group. The business part of the meeting was relatively short, as the main business of the group at the moment was to find and secure its resources.

John Michael gave a short talk which included a memorable statement. He said that there is nothing he has which he is not willing to sacrifice to the movement. And, he said, the enemy cannot kill him because he is already dead. He died years ago. It so happens that John Michael is very talented with the use of written English, and so he can illuminate his own meaning of that at whatever time he chooses. However that statement inspires this tired, old activist to offer up a few words about the living dead. In the first place, when you have anything at all in this life which you care about very deeply, you eventually discover that it owns you. It is the things you love which determine who and what you are. It is the things you love, and not your personal welfare or fortune, which guide your decisions and initiate your battles. As an individual you soon realize how small you are. Secondly, your confidence in the decency and humanity of your fellow humans dies a slow, hard death. Promote any view that is not absolutely mainstream and you will have to endure the slings and arrows of the mob. People will not be content just to criticize and mock you. They will actively seek to do you damage. They will try to stir up trouble on your job and get you fired. They will try to stir up trouble in your neighborhood and get you run out of your home. They will try to stir up trouble with the police and get you investigated and harassed and, if at all possible, arrested. You will be accused of everything from child abuse to insanity. Thirdly, we are all social animals, we humans. We like to be loved and respected and all that. But if your views do not set well with the mobs then you may have to live without those things. In the racist movement, the veterans all know they will be hated by most and loved by few. The people of the

mob not only fail to respect you, they get together in gangs to throw things at you and try to humiliate you. They sometimes resemble a pack of dogs enjoying the pursuit of a rabbit, setting up a big howl and drooling for a taste of the prey. As you, the rabbit, continually dodge the fury of the pack, your individual self gets even smaller. Fourthly, we need not only people who love us but also people that we can love. This is the part that can bring us to our knees in tears. Our family and former friends may not be able to withstand the fury of the pack and may turn from us. New friends may turn out to be informants or spies. Time after time we face abandonment and betrayal. This is the part that delivers the finishing blow to your egotistical, proud, individual self. And yet that thing that we love and that owns our lives does not allow us to choose any other path. By the time we become hardcore radicals we are indeed dead. Does anyone remember how the press ranted over the stony faced way in which Timothy McVeigh received the poison of Iron Heel? But we all know he had already died years before that. All that was left to him at that point was his physical body, and that had become a source of misery, imprisoned as it was in the ugly steel box of the oppressors in solitary confinement.

But at the point where one is dead, one becomes Superman. From that day forward there is no limit to the things one can accomplish. From that day forward, you will amaze even yourself. In a sense, there is no life until after death. That was the lesson of Odin as he hung on the tree. It was also the lesson of Jesus as he hung on the cross. And he was human enough to feel all of the pain. Most Christians value their religion because of the promise of life after death. But Jesus followed his path even though he knew how it would end. And look at the life he had BEFORE he died. When you have found something for which you are willing to give up your life, that is when you can truly live.

But, back to the meeting. When the business was over, there was good music, good conversation and plenty to eat. Bags of rolled literature, "ready-to-throw", were provided for the departing guests. The central Georgia group is full of youth and enthusiasm. Stay tuned! (Article provided by Auntie Racist)

INDIANA : On August 2, 3 and 4 of 2002, White Pride Fest was hosted in Osceola, Indiana, by the National Knights. I camped on the grounds along with a number of others. Most of the musicians let us down for one reason or another, but the Johnny Tat Band showed up like real troupers. OHS handled the security and they counted 154 people into the gates. The Imperial Klans of America provided security for the special dinner for the leaders that was held afterward. The speeches were radical.

Terrible Tommy Metzger was, of course, Terrible and made several memorable statements. "I'm not a right winger", he said, "the right wing has failed. I'll pick from the left and from the right, whatever I want." He said some of the so-called left wingers are more clued in to what's going on than the racists are. He also said Aryans should not waste any effort fighting communists, ARAs or blacks. (Actually he said "nig-



gers", but Auntie Racist tries to be polite.) None of those people have the power or money to successfully oppress white people, he said. He laughed off the idea that he directs a dangerous group of followers. "I don't have members", he said, "I just have quiet people out there in the shadows who know what they need to do and they don't need my instruction."

Matt Hale spoke next and I was sitting there taking notes, expecting to jot down a few notes from each one of the speeches, when Reverend Loy approached and asked if I would speak. I was somewhat astonished, as I have been a writer for years but I am not a speaker. So I missed out on the other speeches as I hurriedly tried to compose one of my own. So the only other speech I can quote is mine.

I tried to point out that our view of the nature of life and survival constitutes a fundamental difference between the racials and the "left" radicals (except that, not being a very good speaker, I didn't say it that well). To us, as soon as we are born our survival is a matter of aggressive action. If you survive, it's because you survive. A verb in present active. Life is not static. You act or you perish. Even an infant is required to cry when it is hungry or it won't get fed. That is the meaning of the life rune.

The left wing seem to believe that survival is the natural and moral state of existence and that if anything interferes, it has to be a breach of justice somehow. They seem to believe that the only reason the entire human race can't survive on some kind of moral inertia alone is because some evil force has corrupted nature.

Although I didn't get to hear them all, the line-up of speakers was impressive: Tom Metzger/WAR, Matt Hale/WCOTC, Ted Dunn/SS Action Group, Mike Schuler/NSM, Bill Blankenship/Blood and Honour, Harold Bertram/Nationalist Times, Ron Edwards/IKA, Rev. Richard Loy/Church of National Knights, Rev. Ray Larsen/Church of National Knights. There were participants from all over the country. Included among the guests was a photographer who was recording the event for Rolling Stone magazine.

This is the first major event in this area since Pastor Miles died back in '92. The National Knights hope to make this an annual event. They did a great job on the first one, so we all have something to look forward to. (Article provided by Auntie Racist)

IDAHO: July 8, 2002--Congratulations to everyone! With all your help, we did it. We sent the so-called Kootenai County Task Force on Human Relations packing their bags for another location.

This organization will not be allowed to promote their agenda of "homosexuality" and "diversity" from the North Idaho College campus any longer"! Our sources have confirmed that hundreds of phone calls and e-mails were sent to Idaho elected officials and to North Idaho College Administration, demanding the removal of this task force from the college

campus.

How dare this task force use our college to promote its agenda of "homosexuality" and "diversity" upon our community and our impressionable young children. Did you know that "diversity" actually promotes sex between animals and humans? It also includes sex with children. WASHINGTON: On July 6, 2002, near Yelm, Washington, approximately 55 skinheads and other White Nationalists attended a fund-raiser concert for an Hammerskin of an EHS (Eastern Hammerskins) chapter who is currently facing federal racially motivated assault charges. Entry fee was \$20 and another \$20 was asked for all-you-can-drink keg beer. Four kegs of beer were consumed and some attendees brought their own beverages.

The first Oi band to perform was Portland's Jew Slaughter which played such favorites as "Jew Slaughter", "Nigger Kill 88", "Youth of Hitler" and "Sharp Shooter." As the slam dance began, one of the dancers accidentally kicked or slammed into a dog which wanted to dance too supposedly. The dog snapped at the dancer's T-shirt. Then the dog went after an overweight (by life insurance company standards) skinhead, almost taking a bite out of his spare tire. In no time, the skinhead put on a T-shirt and kept it on for the rest of the event.

Final War from Orange County, California, was the next band to perform which played such songs as "Hail the New Dawn" and "Nigger, I'm Going to F--k You Up."

The third band was Portland's Intimidation One which performed such songs as "Sturmfuehrer", "O'Leary Remembered" and "Oi, Oi, Portland."

The fourth band to perform was Max Resist from Detroit (MI) which performed such numbers as "RJM" (for Robert J. Mathews), "RAHOWA" and "88."

Finally after some of the crowd had dispersed, the singer of the famous German band "Radikahl" backed by members of Intimidation One and Max Resist sang four German favorites such as "Swastika", "Resistance" and "Brawlers of the Night". (These are all translated titles of course.)

Radikahl is currently here in the United States recording a split CD with Intimidation One, and playing one more gig in Denver, Colorado, on the weekend of July 11th. The band was flown to record here because of our good freedom of speech laws that, unlike the laws of their land, allow the right to speak freely within the music's text.

During a break between band performances, an effigy of a Negro was brought from behind the house so three small children could learn racial patriotism. As the effigy was held in the air, dangling from a long stick, the children took turns swinging a stick at it as though the effigy were a Mexican pinata. Everybody thought that was pretty funny. After the effigy was nearly demolished, some others at the gathering kicked what was left of the effigy until it was almost beyond recognition.

There were no real problems at the event. It was reported that some law enforcement vehicles were outside the private property so an announcement was made, now and then, that anybody who was drinking under age needed to stop. Also, because of the Hammerskin Nation's "No Drug Policy" among its members, another announcement was made that anyone who was caught using drugs on the premises, would be beaten down.

A person who looked like a Negro was asked to leave because of his dark skin although his hair texture was that of a White person. The trigger incident for this is not clear although some people felt uncomfortable with this guy's presence. As security personnel lead the darkie away, it was announced by the current band leader that "Sammy Davis, Junior" was being escorted off the property.

Another person escorted off the property by security was a young skinhead who was not necessarily a bad person but he had engaged in irresponsible drinking and the alcohol got the best of him. Exactly what the problem was with this fellow is not known to this writer but it must be fairly stated that there were plenty of drunks who were just that and did not cause problems.

All \$1,100 dollars in expenses were recovered plus a profit of \$300 that will be donated to the member of EHS who is being charged with the charges stated in the beginning of this article. The event started at about 3 o'clock and seemed to have ended at midnight.

## BUSINESS

The following is from an imprisoned paralegal who has had good results, allowing prisoners to receive literature. He writes, "I have received the two N.S.V. Reports that you mailed together. Those were OCT/DEC 2000 and JAN/MAR

2001. As far as other prisoners not receiving their reports, the quotes and case law received from 'Stormwatch' when it was still putting out their publication says, 'Material of a radical or revolutionary political nature may not be censored solely because of the beliefs expressed .... Similarly, racial and religious literature may be censored only if it actually incites or encourages violence; mere statements expressing or supporting racial antagonism cannot be suppressed.'

United States ex rel. Larkins Vs Oswald, 510 F. 2d 583, 587-588 (2d Cir. 1975); Aikens Vs Jenkins, 534 F. 2d 192, 751, 753 (7th Cir. 1976); Jackson Vs Godwin, 400 F. 2d 529, 535 (5th Cir. 1968); Long Vs Parker, 390 F. 2d 816, 822 (3rd Cir. 1968); Jackson Vs Ward, 458 F. Supp. 546, 558, 562 (W.D.N.Y. 1978).

## IN MEMORIAM

FRANK DESALES BIRDSALL (27 JUL 36 - 29 JUL 02) died of a massive heart attack.

His first involvement in our Movement was during 1963 when he would drive 60 miles every Saturday to attend our National Socialist street rallies in the Yorkville section of Manhattan. As the owner of the largest fence building business in Orange & Rockland Counties, he was also a major donor of finances to the American Nazi Party. In 1988, he sacrificed his business when he held a Klan/National Socialist picnic upon his property and the publicity of that, in the Jew controlled media, caused him not only to lose his business but to be dismissed from the City Council, where he was constantly challenging every Liberal member on every issue.

Adhering to his wishes, Mr. Frank Birdsall has been cremated and his ashes spread in the Hudson River. Let us all say a warm Farewell to this hero of a man, one who will not be forgotten by his friends and family! Frank was a very close personal friend of mine and I shall miss him dearly! (This information was provided by NSM Comrade Bill Hoff.)

Frank's daughter, Kimberly, provided us with the following additional information. Frank had one sister, Grace Seaver, and five children--Frank Birdsall, Jr; Mark Birdsall; Eric Birdsall; Charlene Meyers; Kimberly Birdsall. He was the owner of Birdsall Fence Company, Newburgh, New York. He was married to Martha Birdsall for 36 years.

My father did not want an obituary in the local paper in New York,,,he said he did not want his enemies having a celebration (smile). That's my dad for ya. I remember Charlie Holland from when I was a child. I also know Bill Hoff--he was very nice to me when I was young.

WILLIAM PIERCE (11 SEP 33 - 23 JUL 02), one of America's most famous and influential pro-White activist, writer and organizer, died at about 12:00 noon of cancer at his mountaintop home in Mill Point, (WV).

Author of the famous incendiary novel of America's future, "The Turner Diaries", Pierce also wrote the novel "Hunter." Both were written under the pen name Andrew Macdonald, a nod to his Scottish heritage. By itself, "The Turner Diaries" probably recruited more people to the cause of White racialism than any other publication, person, organization or event (with exception of Black riots).

Pierce was born in Atlanta, Georgia. His early years were spent mainly in the South, especially Texas, where he attended a military school for a short time. His first love from his early years was science. He was experimenting with chemistry and other sciences in his parents' garage and basement when he was just a boy. He continued his own experiments in his private workshop almost until his death.

Pierce went on to be awarded a masters and a doctorate in physics from the University of Colorado after earning an undergraduate degree at Rice University and briefly taking graduate classes at Cal Tech. Pierce later described his almost total immersion in his experiments for his degrees. He spent days in the laboratories, sleeping next to the table where he was working. Pierce then taught physics at Oregon State University from 1962-1966, where he attained tenure in less than three years, about twice as fast as usual.

During his time at Oregon State, Pierce began becoming racially and politically aware after previously being almost totally unaware of politics and current events. Briefly he joined the John Birch Society. As his politics quickly became more radical he stopped teaching and began reading heavily about politics, European History, race differences and other related matters. He considered writing his own book about what he had discovered, then found to his amazement that such books had been written years before with no lasting effect on the public or elite. This caused him to begin searching for another way to stop the destruction of the White race.

About this time, in late 1966, Pierce wrote a long letter to a man he felt was doing the most to advance the cause of White Americans to American Nazi Party leader George Lincoln Rockwell. Rockwell's long gracious letter in return had a life-long effect on Pierce, and not only for its political content. Pierce made a habit of personally answering many of the letters sent to him for the rest of his life, convinced that many people could be brought to the cause of White Nationalism with such personal attention to their inquiries.

Pierce moved to Washington, D.C., that same year and, while never officially joining the ANP, he worked closely with Rockwell on many projects such as editing and writing for the Party publication the National Socialist World. Pierce also worked in the print shop for the ANP and quite quickly gained knowledge of the printing business that would be of

great use in the future. It was at the print shop that he first met another Rockwell associate, a man whom he instantly disliked and who eventually was kicked out of the ANP, and returned to assassinate Rockwell.

Most important of all, Pierce spent many hours in Rockwell's personal office watching and listening to Rockwell handle the running of his organization. This experience would also prove very valuable for the future.

After Rockwell's assassination on August 25, 1967, Pierce became one of the leaders of the new National Socialist White People's Party, the successor group to the ANP. In 1970 he was expelled from the NSWPP and joined the National Youth Alliance, which had metamorphosed out of the Youth for Wallace campaign organization started by Willis Carto. Several other ANP members also joined. Ongoing problems with Carto led the NYA to split into factions. By 1974 Pierce led the new faction now called the National Alliance, headquartered in Washington (DC). This organization and its ideology continue almost unchanged as today's National Alliance.

In the early years of the NA Pierce attempted to answer the spiritual questions and yearnings of members by starting the Cosmotheist Church, a religion sharing the philosophy of the NA and stressing the unity of man with nature, and the value and spiritual and biological continuity of the White Race. Contrary to many criticisms of the Cosmotheist Church by the mainstream press and Jewish militant organizations as merely a tax-dodge, Pierce and his followers were very serious about the new religion and its philosophy; in fact for a time separate meetings were held by regular NA members and by those more interested in Cosmotheism.

The National Alliance quickly began publishing a magazine for sale to the general public called "Attack!" After it was clear that the street-fighting and other disruptions of the 1960s were over, Pierce declared a change of tactics, but not strategy, and renamed the magazine "National Vanguard." NV was a more sophisticated magazine, designed to appeal to the professionals and others that Pierce felt were needed to build a revolutionary organization. It was in "Attack!" and the early "National Vanguard" that Pierce laid down the ideological basis for the Alliance; an ideology that has stood the test of time and had much to do with the Alliance's subsequent long-term success. The pertinent articles are available from National Vanguard Books in *The Best of Attack!* and "National Vanguard."

In 1985, Pierce moved the Alliance from Washington (DC) to a 400-acre parcel of land in Mill Point, West Virginia, near Hillsboro. In one of the most isolated, mountainous and unpopulated regions east of the Mississippi the Alliance was free to grow without the interference of the local, state or federal governments. This move showed great foresight on the part of Pierce. Where almost every other pro-White organization has suffered some type of attack by governments and lawyers the Alliance has been relatively free of such hindrances.



Pierce and the NA began a large number of ambitious projects designed to spread their message, attract new members and raise money to fund their work. Most projects were an ingenious combination of outreach and fundraising. National Vanguard Books, Inc. was started while still in DC to sell a wide variety of books important to White activists and scholars. In West Virginia, NVB grew very quickly with hundreds of titles, a yearly catalog and ever-increasing sales that required the building of a new warehouse.

Pierce also began a weekly broadcast called American Dissident Voices. At first a number of people, most notably Kevin Strom, wrote and broadcast the half-hour addresses but eventually the task fell solely to Pierce. The Alliance arranged contracts with a large number of AM and FM stations and also broadcast on Short-Wave radio. However, the ADV address is now mainly a product of the Internet and tens of thousands of people each week either read or listen to it on the Internet or receive it in the mail as the publication "Free Speech."

Membership in the Alliance grew rapidly in the 1990s. There are currently members in every state and in every part of the world where Whites live. The growth led to the creation of local units that could engage in Alliance activity as a group. Some regional coordinators were also appointed but generally Pierce felt that level of organization was not yet necessary.

Pierce began holding twice-yearly leadership conferences to find new leaders and spur growth and activities. The Alliance became known for its professional approach to White activism, for energetic recruiting and innovative ways of spreading the Alliance message.

In 1999 Pierce and the Alliance purchased the assets of Resistance Records, a White Power music producer and distributor. Soon after Pierce also oversaw the purchase of the assets of Nordland Records, further increasing the size of the new Resistance Records, LLC. With the recent sales of the video game Ethnic Cleansing, Resistance has captured the market for disaffected White youths and earned significant money and new recruits for the Alliance.

The Alliance, National Vanguard Books and Resistance Records gained an early and vitally important Internet presence. While Pierce himself never became Internet savvy (Eye problems severely hampered his use of computer screens.), or knew much about youth-market White Power music, he ably delegated these tasks to staff members and off-site Alliance members to keep the Alliance up to date technologically.

Pierce also during this time solidified ties with other large pro-White groups in Europe, most notably the British National Party and the NPD in Germany.

Pierce's strong leadership style and strict enforcement of rules helped the Alliance grow without the internal strife that eventually tears apart almost every other pro-White organi-

zation. His leadership abilities, communication abilities, vision, unending personal commitment and intelligence were the primary source of the group's ability, strength and influence.

Pierce had always attracted national media attention and did interviews with media outlets in America and around the world. One year ago a very even-handed book about Pierce was written by Professor Robert S. Griffin called *The Fame of a Dead Man's Deeds: An Up-Close Portrait of White Nationalist William Pierce*. The most informative and exhaustive book or article ever written about Pierce. The cost is \$23.95 and can be ordered from National Vanguard Books, P.O. Box 330, Rt. 39, Hillsboro, WV 24946.

In Griffin's book, Pierce is quoted as saying that he feared something in his past would catch up with him or something to that effect if he remained in the Washington, DC, area but he never gave any details.. It is this writer's belief that Pierce was part of a conspiracy to assassinate Rockwell. Rockwell and Pierce worked well together but Rockwell's way of doing things were not like Pierce's way. They had disagreements. Pierce wanted to head the NSWPP but Rockwell was in the way. Matt Koehl also wanted to run the NSWPP but Rockwell was in the way. At first, Pierce and Koehl got along but their differences eventually came to the fore. John Patler (AKA Patsalos) was eventually convicted of Rockwell's assassination but former ANP member Frank Smith is positive that Robert Lloyd was the killer. The queer Matt Koehl was having small talk with Doug Niles' wife as an alibi. Koehl dislikes small talk with women. Dr. Pierce provided the alibi for Robert Lloyd. For the remainder of Pierce's life, he kept in friendly contact with Koehl despite the fact that the two despised each other. For related information about Pierce, Koehl and Rockwell, see "NSV Report" issues for OCT/DEC 1993, JUL/SEP 1995 and Pierce's final evaluation of the NSWPP under Matt Koehl.

In the few months before his diagnosis Pierce and others noticed he was somewhat thinner and more drawn than usual. Pierce had also mentioned feeling far more tired than he had in the past. But his mind was as sharp as ever and with the Alliance busier than ever Pierce continued with his usual workload -- 12-14 hours a day, 7 days a week -- at his office in the Alliance headquarters complex.

Pierce never had much faith or trust in medical doctors and, until the cancer diagnosis, had almost always been in excellent health. Pierce's mother had lived into her eighties and most of those who knew Pierce expected him to be leading the Alliance for at least that long. His death therefore came as a shock to all concerned.
