## **WHAT IS TO BE MADE OF THE NATURAL DISASTER IN NEW ORLEANS**

## **EXPERTS WARN OF FUTURE TIMOTHY MCVEIGHS**

NEW YORK, April 18, 2005 -- A secret FBI report, obtained by ABC News, identifies 22 domestic terror organizations as the current subjects of 338 active FBI field investigations.

The Aryan Nations, and other white supremacist groups, are cited in the report for hate crimes, fire bombings, threats

via mail, as well as robberies and murders. The National Alliance, one of the largest neo-Nazi organizations in the world, is subject to 51 FBI investigations alone, according to the report. In fact there are "ticking time bombs," said Brian Levin.

## **BLACKOUT**

Remember, following the Oklahoma City bombing, the newspapers and TV went into great detail on how to make a fertilizer bomb - they were teaching people to make bombs for use against the government. Well, they are doing it again. Catch this from the N. Y. Times, August 17, 2003:

"While the caretakers of the grid might be able to compensate for a single such attack, he added, "a coordinated attack on two stations" would be a catastrophic double whammy that the grid's control system is not designed to handle."

## **REVIEWS**

"Law and Order" television program had an episode which was a loose parallel to the Portland (OR) case of Tom Metzger. A teenage girl is murdered in a woody area near New York City. She was new to the area, having relocated there from Philadelphia. She told one of her old Philadelphia friends that she had made new friends and was going to a

party in the woods with her new friends in New York City-- racist skinheads! The girl was brutally murdered and most of the show was showing how the authorities investigated the case. A man named Tom Willis was proved to have encouraged skinheads to commit acts of violence. Tom Willis had a website on the Internet and a paper but no members or organization. In the end, Tom Willis was convicted and sent to prison for inciting the skinheads to commit violence, however, it must be remembered that in reality, Tom Metzger never encouraged anybody to commit violence and the legal argument presented in this episode of "Law and Order" did not apply to Tom Metzger. Consequently, Tom Metzger was sued in a civil court (See "NSV Report" for OCT/DEC 1990.) by a combined team of Elden Rosenthal of the Anti-Defamation League and Morris Dees (who is as crooked as a dog's hind leg) of the Southern Poverty Law Center. On August 20, 2005 (This report is still three years behind schedule.), a man approached Dir. Cooper at Volksfront's Nordic Fest in Cascade Locks, Oregon, and asked him what the situation was with Tom Metzger regarding the October 1990 Portland law suit. Dir. Cooper explained to the man, whose name was not known, that as far as Cooper knew, Tom has been paying and still is paying over \$800 per month (\$845.83 to be exact) to an agent of the Southern Poverty Law Center towards the support of Henok Seraw, the son of the late Ethiopian, Mulugeta Seraw. Cooper stated that this court order was dated in the mid-1990s (January 29, 1996, to be exact) and is still in effect as far as he knew. (In Elinor Langer's book, "A Hundred Little Hitlers", one may find this same information on page 358.) Since the August 20th event, this man, whose name is still unknown to Cooper, E-mailed Tom Metzger, informed Tom that he had spoken to Cooper on August 20th and that Cooper was not sure of the current situation. The man asked Tom in his E-mail what Tom's current status was. Tom replied that he gets all his mail and checks, and that Rick Cooper is a "notorious rumor monger." Tom's answer to the man was a half-truth. Tom does get all his mail unopened (correspondence, checks, cash, money orders etc.) but he is still required to send \$845.83 by the 25th of each month towards support of Henok Seraw or the SPLC agent will take all money (not just one-third) which comes to P.O. Box 65 in Fallbrook. In a more recent E-mail to Tom, Tom refused to apologize, backtrack or withdraw his charge against Cooper.

Let it be known that Rick Cooper and Tom Metzger have been friends for decades, going back the very early 1970s. Tom should have never been charged in the Portland trial and he does not owe Henok Seraw anything. Unfortunately, Tom had to decide whether he was to lose all money at the Fallbrook P.O. Box or just one-third. He did what any one of us would most likely do which is agree to lose the one-third. After stipulation between parties was made for the fixed monthly amount of \$845.83, Tom raised the price of the "WAR" newspaper from \$20 per year to \$30 per year and

raised the price of items sold through his WAR organization. This way, Tom offset any legal loss at least partially by passing the debt onto his supporters. Please remember, people, that Tom's house rent in Fallbrook eats up most of his Social Security check so the money which comes to the Fallbrook P.O. Box is a survival necessity for him.

Certainly, Tom does deserve our sympathy because he is paying for problems not his fault. However, in retrospect, he should have been honest with the Movement in the first place. Nobody else does what Tom does so he has no equal there. Tom should not have referred to Rick Cooper as a "notorious rumor monger" in an effort to discredit Cooper's character when Cooper attempted to clear up any lies and confusion made against Tom by Tom's enemies and antagonists within the Movement. Finally, Tom should have never answered the unknown man's E-mail publically since Tom knows that Cooper is on his E-mail list. **TOM METZGER SECRETLY LEAVES FALLBROOK** by Diane Bell of the "San Diego Union Tribune", March 9, 2006. Fallbrook neighbors of white supremacist and ex-Ku Klux Klansman Tom Metzger say he has moved on after nearly four decades of making North County his home.

Robert Young, who lives four houses from Metzger's former rental property, says the head of the White Aryan Resistance packed up and left a few days ago after spending at least a decade in the same house on East Clemmens Lane. The phone of Metzger's TV repair business is disconnected, and there is no forwarding number.

Dorothy Kelsey, 81, owns the house that Metzger rented after Tom's own home was sold. (Proceeds were used to help pay a \$12.5 million court judgment in the race-related murder (sic) of an Ethiopian student in Oregon by a group of skinheads reportedly inspired by Metzger.) Kelsey says she did not realize who Metzger was when she first rented to him, but that he turned out to be a good tenant who paid his rent on time and kept the house in good condition.

Metzger's departure doesn't sit well with local attorney Jim McElroy. He is collecting Metzger's restitution payments for the son of the Ethiopian student on behalf of Morris Dees, the Southern Poverty Law Center attorney who sued Metzger and his son, John.

McElroy, contacted while vacationing in Mexico, was unaware that Metzger had moved. He said that after paying like clockwork, Metzger had been late with his February check and hadn't paid his March restitution payment. Metzger, 69, recently had notified McElroy he was about to retire and urged him to lower the \$845.83 monthly amount.

"He's not going to be able to avoid me," vows McElroy, adding that he can always seek payment from John Metzger, who lives in North County and is a joint debtor on the judgment. "My plan is to very aggressively pursue

them."

Bob Leonard, of the Fallbrook Chamber of Commerce, characterized Metzger's departure as good for local business. "In newspapers we would always read, 'Fallbrook racist Tom Metzger,' as if it were some sort of brand," says Leonard.

In McElroy's opinion, Metzger went from being one of the most powerful figures in the white supremacy movement with his toll-free hotline, TV appearances and W.A.R. newspaper, attracting about \$200,000 in donations a year from all over the world, to a virtual nobody. Only about \$1,500 a month has been coming in to his P.O. Box in recent years, McElroy says.

## OPERATIONS

GERMANY: Our German correspondent reports that on November 1st to 3rd that the German Party has established its own party youth organization with the name German Youth for the federal territory in the City of Fulda (German state of Hessen). He thinks it is an important progress for the right-wing party, German Party (DP), to win the youth. The following persons were elected through the youth organization members: The federal chairman for the youth party is Marcel Krense and his vice chairman is Dennis Makarewitsch. Mr. Oliver Lotze is the federal treasurer for the youth party organization.

On November 22nd to 23rd, during the night to Saturday, unknown nationalists threw molotov cocktails on a Turkish mosque in the City of Wolfenbuettel (German state of Niedersachsen). Damages were small on the mosque. One day later, five young nationalists (all between 16 and 22 years old) were arrested. The five nationalists made a confession about the arson on the mosque by the system cops. They told the cops that they do hate foreigners.

On November 25th, two more nationalists were arrested because of the arson on the Turkish mosque in Wolfenbuettel (state of Niedersachsen). All arsonists will get a charge of attempted murder because a Turkish family lived in the mosque.

AUSTRIA: November 24th was a very bad election day for the Freedom Party of Austria (FPO). The right-wing party, FPO, lost de facto two-thirds of the parliament seats in the Federal Parliament House of Austria. The FPO won 10.01% of the votes and 18 seats in the Federal Parliament.

On November 2nd, the FPO prime minister of the Austrian province Cathrine, Joerg Haider, demanded foreclosure proceedings against the FPO vice chancellor and former FPO chairman Mrs. Riess Passer, FPO Minister of

Finance Mr. Grasser, and the former FPO club chief, Mr. Westenthaler. It would be an internal purge of members because they do not follow the will of the voters and they were office-hunters to obtain money said Mr. Haider to the reporters. Haider is strictly opposed to repetition for a fusion administration between FPO and the kosher conservative OVP. It is considered unwise of Joerg Haider that he start an internal discussion about foreclosure proceedings just weeks before the elections. It may be that the FPO will lose a lot of votes through Mr. Haider's discussion by the November elections.

On October 31st, the new FPO chairman, Mathias Reichhold, stepped down after 40 days in office. This was recommended by his doctor because he has a heart disease. The new FPO chairman is the minister of the social policy, Mr. Werner Haupt.

CZECH REPUBLIC: On November 1st, there were police raids against a skinhead group in the Czech Republic. The group affected is not known. Several hundred music CDs, videos, photos and magazines were confiscated. The cops arrested nine skinheads.

ENGLAND: On November 21st, there was victory for the British National Party (BNP) in the City of Blackburn (Lancashire). The BNP candidate, Mr. Robin Evans, won the city council seat. It was a local government by-election in the City of Blackburn (Lancashire). The results were: BNP 578 votes (32%), Labour 562 votes (31%), Liberal Democrats 505 votes (28%), Tories 154 votes (9%).

CALIFORNIA: Friday, August 16, 2002, 9:07 PM: Subject: jousting on History Channel (report by April Gaede). A few months ago, I was invited to help some of my friends with their horses when they did a spot for the History Channel's new show "Mailcall".

The day we filmed it, the weather was about 112 degrees and it was filmed in a riverbottom so it was extra humid. The knights had leather on under their armor and we had to pack ice packs underneath their armpits and on the back of their necks to keep them from having heatstroke. The horses we kept spraying down with water. The armor got so hot that it would burn to the touch. So if you get to watch this, keep that in mind.

My friends Cliff and Dave Bassett are the jousters, a father and son team of Scottish descent that do demonstrations for Ren Faires. I have been training horses for their ranch for 20 years. This has got to be one of the really true White sports that we have left. I am proud that I know these people that keep this White sport alive and also proud that they asked me to be horse wrangler for them that day and get to be part of the filming. I hope that you all got to watch it.

Tuesday, September 17, 2002, 8:38 AM; Subject: Act of White Resistance in California (report by April Gaede). You may all remember a few months back when I sent you a picture of the stupid mestizo muds who were worshipping a



dead tree stump near my parents' house. Well they were still doing it up until last week.

If they had just worshipped it as a tree, that wouldn't have been so bad but they covered it with tinsel, crepe paper, dead peoples clothes, pictures, money, beads, candles, and worst of all, Mexican flags! We kept tearing them down but they kept putting them up. There was no toilet there so they were taking dumps in the bushes nearby. They parked in the road and a few got in wrecks when they saw "angels flying out of it". Letters to the editor of "The Fresno Bee" compared his cutting the tree stump down as an act akin to "the Taliban dynamiting the thousand year old statue of Buddha in Afghanistan". Wow, so it is Osama Bin Gaede now?

Ninety-eight percent of the feedback has been highly positive and it has brought the racial issue to the forefront here in the Fresno area, I believe. We need to follow this up with more racial and anti-immigration messages in the next few weeks and months in order to keep the people going on it. So many people here are so sick of the spics that they have made special trips by our house to tell my dad they will stand by him if the mestizos attack us.

I am very proud that my dad will be remembered as one old man (69 years old) who had the balls to be politically incorrect, tough enough to handle a big chainsaw, stand up and resist the mud invasion.

**TWO LESS CHRIST-HATERS:** Monday, November 4, 2002, 6:04 PM; Subject: Lawyer Says Jailed JDL Leader Is Brain-Dead. (from Associated Press). Jewish Defense League leader Irv Rubin (12 APR 45 to 04 NOV 02), jailed on charges of plotting to bomb a mosque and the office of an Arab-American congressman, was brain dead today after what federal authorities called a suicide attempt.

"We're told that he is brain-dead and on life support," said Rubin attorney Peter Morris. Rubin's wife and two sons were called to his bedside, he said. U.S. marshal's spokesman Bill Woolsey described Rubin's condition as critical after more than two hours of surgery at an undisclosed hospital.

Rubin used a razor to slash his neck and throat and then fell or jumped from a prison balcony as he and other inmates lined up for breakfast before 5:30 a.m., Woolsey said. Rubin was scheduled to appear in court Monday for a hearing in his case.

There were conflicting reports about Rubin's condition. His wife, Shelley, and son, Ari, told The Associated Press they were told by Rubin's lawyers that Rubin had died in surgery after slashing his neck with a razor and jumping over a railing as he was called out of his cell at the federal Metropolitan Detention Center. They said he fell up to 18 feet. Bryan Altman, one of the attorneys, refused to confirm that account but said he would issue a statement later. Laura Bosley, FBI spokeswoman, said agents were investigating it as a "crime in a government property" and hadn't confirmed whether it was a suicide attempt. "He sustained serious injuries," she said but wouldn't provide details.

Rubin and associate Earl Krugel were arrested December 11, 2001, on charges of plotting to bomb the King Fahd mosque in suburban Culver City and an office of Rep. Darrell E. Issa, R-Calif. Rubin and Krugel were arrested after an FBI informant delivered an explosive powder that authorities believed was the last component in making pipe bombs. The charges carry up to 40 years in prison upon conviction.

Rubin, who by his own account has been arrested more than 40 times, joined the JDL early in the 1970s and quickly moved up, becoming chairman in 1985. In 1989, the leader of the rival Jewish Defense Organization was charged with firing shots at Rubin and wounding three others in New York. Mordecai Levy was convicted of assault.

According to his biography, Rubin learned to fight anti-Semitism while growing up in Montreal, "where some hotel owners and other business people hung signs reading 'No Dogs or Jews Allowed' on their doors and where French Canadian schoolchildren taunted him because he was Jewish." His family emigrated in 1961 and he became a U.S. citizen and joined the Air Force in 1966, serving four years. In 1973 he served in Israel's civil defense corps during the Middle East war.

The JDL, whose symbol is a raised fist inside a Star of David, has the motto "Never Again," referring to the World War II killing of 6 million Jews. It was founded in 1968 by Rabbi Meir Kahane to mount armed response to anti-Semitic acts in New York City. The group was suspected in a 1985 bombing in Santa Ana that killed Southern California Arab anti-discrimination leader Alex Odeh, but no arrests were ever made. Kahane was assassinated in New York City in 1990.

**Aryan Brotherhood Accused of Prison Attack on Irv Rubin.** KABC 790 Radio, an L.A. Michael Eisner radio station, Irv Rubin's defense attorney Peter Morris mentioned the Aryan Brotherhood as possible suspects in the attempted murder of JDL Chief Irv Rubin.

Neither Irv Rubin's attorney nor his wife, Mrs. Shelley Rubin, believe that he attempted suicide. They said that it does not make sense that Rubin would have attempted suicide in the morning of the day before important motions were to be heard in court, motions that may have set him free. Also, attorney Morris said that Rubin was a family man and that he would have left a suicide note for his wife and children but no note was found. In addition, the attorney said that Judaism looks down upon Jews taking their own lives and that Rubin was deeply religious.

The doctor, attending Rubin at the hospital, said that he did not observe any slashes on his throat and that the only injuries were to his head sustained after dropping about 18 feet onto the concrete.

Attorney Peter Morris said that Irv Rubin had a lot of enemies and that there had been previous incidents involving the Aryan Brotherhood at the federal detention facility in downtown Los Angeles. There have also been numerous other suicides of prisoners at the facility. Most state and federal prisons in California are run by three groups, La Eme, the Black Guerrilla Family and the Aryan Brotherhood.

Rubin's attorney as well as his family have called for a thorough investigation. They have demanded copies of any videos taken by prison surveillance cameras.

"La Voz de Aztlan" (<http://www.aztlan.net>) has received E-mail expressing the opinion that the JDL Chief was actually the victim of Israeli operatives, possibly the MOSSAD. Irv Rubin had become a huge embarrassment to Israel and had been vocal against certain Ariel Sharon's policies. We received one anonymous E-mail that stated that Rubin was about to "spill the beans" in court about certain things the ADL of B'nai B'rith and Israel were doing here in return for clemency.

Rubin was fiercely passionate about his religion and background and was critical of the stalled Middle East peace process, which he called "suicide" in 1995. Rubin could often be found protesting outside courthouses where white

supremacists were being tried or even clashing with Ku Klux Klan members on "The Jerry Springer Show." He once offered \$500 to anyone who "kills, maims or seriously injures" a member of the American Nazi Party, and last year, he urged Jews across the country to arm themselves in the face of violence against minorities. Rubin was also shamed several times by Tom Metzger and his associates in street actions. The worst was in Rubin's failed attack by 15 JDL members on 8 Aryans at the Los Angeles train depot several years ago. After his men were beaten badly Rubin fled the scene leaving his men bleeding and bruised. In previous years members of the Nazi party in Los Angeles broke Rubin's large nose twice. Irv Rubin was certainly no Meir Kahane. Rubin died a coward's death, even breaking his beloved Jew law.

This following article is an AP article published in the SAN ANTONIO EXPRESS-NEWS, dated November 6, 2005. Also, this report is three years behind schedule. Bomb plotter is killed in prison: Activist was tied to scheme to hit mosque, lawmaker's office.

LOS ANGELES: A Jewish Defense League activist imprisoned for his role in a plot to bomb a California mosque and the office of a Lebanese American congressman was killed at a federal prison in Phoenix, an FBI spokesman said Saturday.

Earl Krugel, 62, was killed on November 5, 2005, in an assault Friday evening at the Federal Correctional Institution, FBI agent Richard Murray said. Murray wouldn't release further details but said federal authorities had opened a homicide investigation. Krugel's wife, Lola, said FBI investigators told her an inmate had struck her husband on the head from behind with a cement block. "Earl never saw it happening," she said. "He was exercising". He had been at the medium security prison for three days, according to his sister, Linda Krugel, also of Los Angeles.

Earl Krugel, a former dental assistant from Reseda, and late JDL leader Irv Rubin were arrested in 2001 and charged with conspiring to bomb the King Fahd Mosque in Culver City and a field office of Republican Rep. Darrell Issa, a Lebanese American.

Krugel pleaded guilty in 2003 to one count of conspiracy to violate the civil rights of worshippers at the mosque and one count of carrying an explosive device in connection with a conspiracy to impede or injure an office of the United States. Despite the plea, he was sentenced in September (2005) to 20 years in prison. The reasons for the collapse of an initial plea agreement were sealed, despite a lawsuit by news organizations, including the Associated Press, to make the details public.

Apparently Krugel was the number two man in the Jewish Defense League and apparently the Aryan Brotherhood got him.

This is what Tom Metzger prophesied about JDL second-in-

command Earl Krugel. In WAR's E-mail of February 4, 2004, Irv Rubin, who recently received Aryan justice, now is defamed into his grave by his long-time friend Earl Krugel. Krugel was a JDL member for decades and right-hand man to Rubin. Today in federal court, Los Angeles, Krugel agreed to dump everything onto Rubin in the bombing case. Krugel pled out of realizing his life would not be worth a plugged nickel inside the walls. Shelly Rubin, wife of Irv Rubin, was heard to say, "Krugel should be killed!"

There is one more of these obnoxious JDL members to go so now we are waiting for Mordecai Levy to screw up and land in prison. His days may be numbered too. (Note: Levy's mother has been institutionalized in an insane asylum in the past so Mordecai may end up in a state hospital rather than a prison if he commits a violent crime.)

IDAHO: We have recently received a copy of an arrest report dated May 4, 2000. (This report is three years old and the information contained therein six years old but should be noted by all Movement activists.) Coeur d'Alene Police Department report #326423 reveals that former Aryan Nations Chief of Staff Ricky Eugene Monbarren (AKA Reinhardt Von Baron) was arrested for a DUI (Driving Under the Influence) charge and also Possession of a Concealed Weapon. These charges mean nothing to Movement activists because we have plenty of drunks in the Movement and all of us carry guns from time to time, and this is no secret, however, now comes the interesting part.

During the sobriety test by officer(s), Rick Monbarren stated that he was an employee of the FBI (Federal Bureau of Investigation) and told the officer to verify his employment with William Long. Rick agreed to take the breath test but refused to give a urine sample, stating, "I don't know what to do until I talk to William Long of the FBI".

To this writer, Rick's confession comes as no surprise. Rick had no demonstrated track record of Movement activism, he came apparently from nowhere to be AN Chief of Staff and knew little of various Movement personalities. During the AN World Congress of July 14, 15 & 16, 2000, when Rick Monbarren was also acting as chief of security, the registration forms for that year's congress disappeared from the guard shack. Rick Monbarren was the most likely suspect in the theft because he was responsible. He tried to fool everybody by announcing from the podium that a no-good thief and cowardly snitch (in so many words) stole the registration forms, and that all delegates present must be searched (as if any thief would have those forms on his person). At a later date, then-heir to Aryan Nations, Ray Redfeairn, caught Rick Monbarren with the mailing list for the Church of Jesus Christ Christian and demanded that he return it to Pastor Butler under threat of physical harm. After Rick returned the list, Pastor Butler banned Rick from his home and property--for a while. On the day of Pastor Butler's death, September 8, 2004, the Coeur d'Alene police were in the process of securing the pastor's residence when they found Rick Monbarren snooping around the office, apparently looking for the mailing list. The police

ordered Monbarren out of the house. This information was given personally to this writer by Corky Witherwax, the pastor's son-in-law.

WASHINGTON: (This is good news from the "Seattle Post-Intelligencer" of August 29, 2002.) Bill Wassmuth who battled hate groups, dies. The former priest's home was once bombed by Aryan Nations. (by Nicholas K. Geranios)

Bill Wassmuth, a former Roman Catholic priest who became a leader in the fight against Aryan Nations and other hate (sic) groups, has died. Wassmuth, 61, died yesterday in Ellensburg after a lengthy battle with amyotrophic lateral sclerosis, or Lou Gehrig's disease, said Eric Ward of the Northwest Coalition for Human Dignity. Wassmuth founded the coalition after his home in Coeur d'Alene, Idaho, was bombed in 1986 by members of Aryan Nations seeking to end his activism. (See "NSV Report" for JAN/MAR 1997 and OCT/DEC 1986.)

"He touched thousands of people in the Northwest and symbolized the spirit of the Northwest in the fight against bigotry," Ward said yesterday. Idaho Gov. Dirk Kempthorne said Wassmuth knew what it was to be a target of hate groups. "Bill Wassmuth was a bright beacon in the gloom of hatred and evil, and he will be missed," Kempthorne said. "Because of his efforts, Idaho today is no longer home to groups that espouse hatred and violence."

"Bill Wassmuth's work in his church and in human rights helped change the hearts and minds of many people in the Northwest," said Tony Stewart, a North Idaho College professor and leader of the Kootenai County Task Force on Human Relations. Stewart noted that Wassmuth lived to see the bankruptcy of the notorious neo-Nazi hate group and its founder, Richard Butler, in a 2000 trial. "He was present for the verdict and present at the celebration that followed," Stewart said. Wassmuth was able to tour the group's 20-acre compound after it was purchased by a human rights organization, Stewart said.

In 1985, he became a leader in the fight against the growing presence of the Aryan Nations. Butler, a former aircraft worker from California, set up the neo-Nazi group's headquarters in nearby Hayden Lake. Wassmuth mobilized opposition to the group, including a human rights celebration that dramatically outdrew the Aryan Nations' annual World Congress being held the same week.

On Sept. 15, 1986, having returned from an evening run, Wassmuth was on the telephone in his living room when a pipe bomb shredded the back of his house. Three other bombs were later detonated throughout Coeur d'Alene, injuring no one. Authorities convicted Aryan Nations members of the bombings.

The attack prompted Wassmuth to leave the priesthood,

move to Seattle and create the coalition to mobilize efforts against hate groups in six Western states. Wassmuth was dismayed by what he perceived as an escalation of bigotry (sic) after the terrorist attacks of September 11th. He was particularly bothered by racial profiling of Arab Americans and Muslims, saying that targeting one group would lead to widespread discrimination against others.

In his 1999 book "Hate is My Neighbor," Wassmuth detailed his fight against the Aryan Nations. "To ignore hate groups, even though they usually include relatively small numbers of people, is to miscalculate the impact that they can have on a community," Wassmuth wrote, "and to miss an opportunity to bring a community together to take another step toward justice for all."

OREGON: On November 5, 2002, from 1120 to 1230 hours, NSV Management Director Rick Cooper was invited for the 13th consecutive year to address Professor Joseph Gallegos' Cultural Diversity in America Class at the University of Portland, a private Catholic School. There were 36 students, mostly White. There 3 or 4 Black students. There were enough students to keep the interest and conversation going up to the end of the class period. Since Director Cooper did not have 40 of the most recent issue of the "NSV Report", he left 40 issues of a back issue at the front of the classroom, apologized for the outdated report and stated that more current issues were available if the students were to write in for them.

After Professor Gallegos made a few comments to the class regarding their assignment about gays in society, Director Cooper gave the same basic introductory talk which was given as presented in the JUL/SEP 1991 "NSV Report" plus the NSV survival message. There was no mention of the Jewish so-called Holocaust or the coming race war but the questions seemed mainly to revolve around our racial separation position, some students using biblical references to counter the speaker's statements. The students were told that proof is something which exists in the minds of the believers and that if somebody does not want to believe something, then that something is not true and not proven. At least the students were given an alternative viewpoint so they can decide for themselves. There were no "Devil's advocates" and so it went to about 1225 hours when Director Cooper answered the last question.

#### IN MEMORIAM

JOSEF MLOT/MROZ: This is to inform everyone of the passing away of a great Christian believer, Patriot Josef Mlot/Mroz on October 31, 2002, in Groton, CT. Josef Mlot/Mroz totally put his life on the line many times in his statements, picketing, the pamphlets of Save Our Ship (SOS), and of his great signs with the wording of "Communism is Jewish." A Jewish star with a hammer and sickle in the center. Always remember the time back in October of 1991, Boston Anti-Abortion Rally, he held up a sign blaming Jewish doctors for abortion, and made reference to "cannibalism and barbarism." According to those



attending the rally, Cardinal Bernard Law sent a priest to ask Mlot/Mroz to eliminate the sign to which Josef responded, "Let the cardinal ask me himself." Cardinal Law then took the microphone and he said three times, "I want you to put that sign down," and then added, "No people in history have suffered as much hatred and violence as our Jewish brothers and sisters. we can never forget that." Josef finally did put the sign down as he thought the cardinal was going to have a heart attack if he didn't. I always remember his call to bail him out of jail in Portsmouth (NH) for picketing. Spoke for his behalf in court and had the charges dropped. Many of Josef's sayings were: "My Ambition: To give my life for my country and my heart to God!" "Freedom is a cause: Live, Pray, Work, Fight and Die for it!" "Patriotism In Defense of Freedom Is A Great Virtue...Cowardice In The Face Of Communism Is A Dangerous Vice!"

Josef Mlot/Mroz stood with many at the Crusade against Communism Summit Conference in Los Angeles (CA) February 19, 1984. Those in attending were, Col. Tom Wilkes, Jim Townsend, Col. Jack Mohr, Pastor Bob Miles, and Pastor Richard Butler and others. For Josef, 81 years, his long struggle is over and we now take over in the fight for Freedom and our Heavenly Father's coming Kingdom.

The author of the above is unknown to NSV Director Cooper but Cooper remembers meeting Frank Silva and Randy Evans there.

EMORY BURKE (26 AUG 15 - 20 NOV 02) was a life-long patriotic activist known by George Lincoln Rockwell, founder of the American Nazi Party. Burke's dedication reaches back longer than any other person in memory. He was widely known and greatly admired. Emory Burke was born in Montgomery, Alabama. In 1933, he joined William Dudley Pelly's anti-communist Silver Shirts organization in Asheville, North Carolina. In 1935, Burke moved to New York City to become secretary of the American Workers Progressive Party. They opposed New York's communists who were very strong at the time and Jewish groups which were advocating war with Germany. When the war did eventually break out, President Franklin Roosevelt had 35 right-wing, anti-war leaders indicted for "sedition." Roosevelt, who was elected President four times, thought he was a dictator. He even ordered the Ku Klux Klan to close down despite the fact that the Klan supported him in the 1932, 1936 and 1940 elections.

Burke moved back to Montgomery where he wrote "Letters to the Editor" to many papers, urging a negotiated peace rather than Roosevelt's "unconditional surrender" demand which greatly lengthened the war, costing hundreds of thousands more lives. (This war policy was formulated by the Jews and communists.) After Roosevelt died in 1945, all charges against his "sedition" opponents were dismissed. However, it left the right-wing greatly weakened.

Emory Burke and Homer Loomis were the first to form a new right-wing organization after the war in 1946. Burke

named it "The Columbian Workers Movement of America." This was later shortened to The Columbians. (Columbia is the poetic name of America, after Christopher Columbus.) The organization grew rapidly and they had uniformed members, patrolling White neighborhoods hit by Black crime. Many homes displayed signs with the thunderbolt symbol in the center which read, "Zoned as a White Community", (to keep Blacks from moving in). Other signs read, "Protected by The Columbians." Members patrolled troubled neighborhoods and made a number of citizens' arrests of Black law-breakers and turned them over to the police.

A communist front in New York, The Non-Sectarian Anti-Nazi League, was headed by Isadore Lipschutz, a Jewish diamond broker from Belgium. They sent agents to Atlanta and placed two paid stool pigeons in The Columbians. The pair gave Georgia Assistant Attorney General Dan Duke. faked evidence that The Columbians planned violence. Burke and Loomis were charged with usurping police powers. Burke was tried and given 18 months in prison. Just last year, it was revealed that British Intelligence had funded The Non-Sectarian Anti-Nazi League before World War II to smear all patriotic groups which opposed US participation in the war. The war was now over but, for some unknown reason, The Columbians were the last US target of British Intelligence. After Burke's conviction, the Anti-Nazi League went out of business.

In later years, Burke was a frequent speaker at patriotic meetings, including the Council of Conservative Citizens and The National Alliance. He wrote a book, "The Unlifted Curse", dealing with the tragedy stemming from the Negro presence in America. He also wrote the poem, "The Will of the West" which will be reprinted by "The Truth at Last" newspaper (P.O. Box 1211, Marietta, GA 30061).

As of the date this obituary reached us, there were three who were active and are proud to state that they were members of The Columbians back in 1946. They are Charles Kelley of Valdosta (GA), Max Nelsen of Chicago (IL) and Edward Fields of Marietta (GA).

CHARLES WEBER died on December 25, 2002. He was a long-time revisionist author. He was also an occasional contributor to "The Eagle Newsletter." His writings were always well researched and extremely relevant. He had also been on the NSV mailing list for about two decades. We regret his passing greatly. We also regret that Dr. Weber's widow did not help us with this obituary, therefore we do not know much about him. It seems that families and widows of the deceased are often reluctant to help immortalize the deceased but they are quick to complain if they find something in an obituary objectionable.
