ANSWP CLEARED IN CIVIL RIGHTS PROBE

The American National Socialist Workers Party, LLC, the core organization holding the assets of our party, our Commander, Bill White, and several of our Regional Directors, were cleared of all criminal or civil wrongdoing after the Department of Justice and allied "civil rights" firms spent over one million dollars attempting to frame our leadership for civil rights violations and various crimes.

Acting in response to pleas to "shut the ANSWP down" that Jesse Jackson and Al Sharpton made to the US President and Congress in the wake of Jena 6, the Federal Bureau of Investigation and various elements of the Department of Justice launched civil and criminal prosecutions of the ANSWP and our Commander, Bill White, on trumped up charges of conspiracy to violate the civil rights of American Negroes and various contempts of court stemming from the alleged destruction of party documents that had been subpoenaed by the DoJ.

A US Federal Court in Norfolk, site of one set of actions against the Party, ruled the ANSWP had the right to publish the names of attorneys and others and to even encourage non-violence protest against them, even if such activity was disruptive to a court proceeding. Another US Federal Court, this one located in Roanoke, Virginia, stayed a criminal show cause order against our Commander, in which Commander White had been accused of destroying or ordering the destruction of more than 54,000 party documents in order to prevent the Department of Justice from identifying party members or proving "conspiracy" between them.

A federal grand jury which had also been empanelled, under seal, to investigate the activities of the ANSWP also failed to return any indictments, causing federal agents, who attempted to bribe several ANSWP members, to abandon their efforts.

PARTY CONGRESS MEETS Role Of Directors Expanded

The American National Socialist Workers' Party's Second Party Congress met July 26, 2008, in Roanoke, Virginia, at the Holiday Inn Roanoke, where the Party's Directors and our Commander, Bill White, discussed the organization of the group, the platform, and the direction party organizing will take in 2008 and 2009.

Among key organizational changes made were an expanded role for the ANSWP's Regional Directors, who were given greater ownership interest in the party's corporations and expanded independence in their activities, and the redefining of the roles of the Deputy Commanders, who will be retained only for purposes of succession.

Party leadership also discussed membership requirements, tabling a motion to bar individuals serving probation for minor offenses from holding membership, and made numerous minor and administrative changes to the Party's

Articles of Organization.

The highlight of the meeting was the State of the Party address by Commander Bill White, where the Commander discussed the Party's recent legal battles, its fundraising, and what needed to be done to get the Party's core activities -- publishing, membership and fundraising -- back on track after the diversion of resources created by the Department of Justice's recent failed legal efforts to shut our organization down.

A road map for party leaders to follow in building their regions and their states was decided on, and, after the meeting, the Party's internet radio station was relaunched on Overthrow.com, and several organization building events for the fall were announced.

The Party also approved its official Gun and Wilderness Club, which is meeting regularly in Augusta, Georgia.

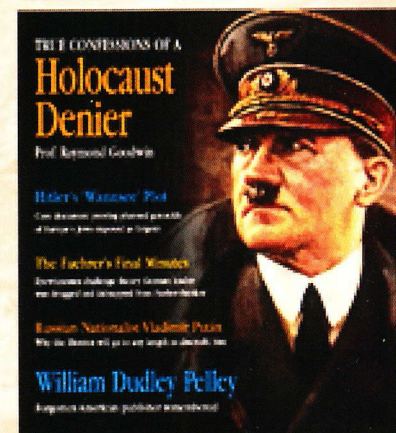

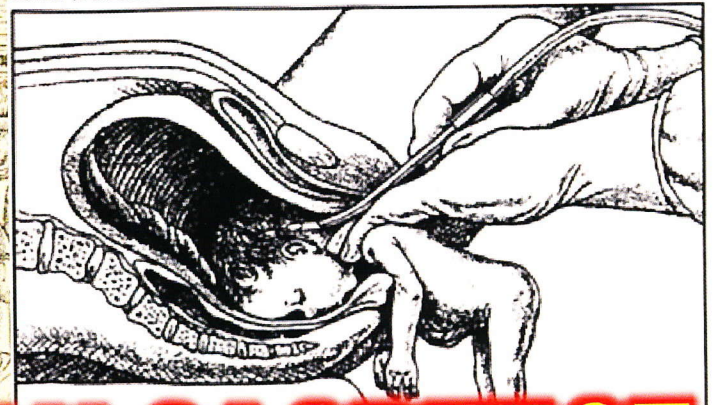

RITUAL HUMAN SACRIFICE

Abortion And The Jewish Lust For Blood

In the beginning, the Jews arrived in the Middle East as outcasts from Aryan society -- outcasts that quickly absorbed the culture and religion of the Semitic peoples. Within decades, they were worshipping an Earth-Mother, Asherah, and he consort, the Serpent. And as their religion developed, the earth-mother may have been dropped, and the Serpent elevated to Yahweh, but the fundamentals and rituals of the earth cult, which demanded the sacrifice of fresh blood in order to produce the harvests necessary for the tribe's life, remained.

Vestiges of this human sacrifice, with the implication of its normative value to early Jewish civilization, exist throughout the Bible. Jephthah offers what he thinks will be a servant in sacrifice to Yahweh without a thought, and his daughter finds nothing odd about the promise when she is the one accidentally selected. As Judges 11:39 puts it, with a bit of paraphrase, "And it came to pass at the end of two months, that she returned unto her father, who sacrificed her to Yahweh, as she was a virgin, according to the customs of Israel." Coming at a time of religious reform, being contemporary with the Deuteronian discovery of the Yahwehists, it shows how a practice that had been associated with a secondary cult became mainstream.

Ironically, Jewish Rabbis have generally opposed Jephthah's actions, not because he chose to make what we would consider to be a human sacrifice, but because his human sacrifice was a fellow

Jew, and an "animal" -- a non-Jew, slave or servant -- who had been consecrated to God using the appropriate rites. According to the Midrash Genesis Rabba, Jephthah should have redeemed his daughter by choosing to sacrifice a gentile instead.

As this form of human sacrifice was being adopted, we see another, more primitive form of human sacrifice being abandoned by the Jews. As Yahweh rose to prominence as the head of the pantheon, and not a mere lover of the earth-mother, Asherah, the human sacrifices that had been offered to his competitor, Molech, were brought to an end. While Christians often teach that the brutal practice of Jews sacrificing their children by burning them in the image Topheth was ended, what the Christians don't teach, and what only scholars of Biblical commentary know, is that the practice of sacrificing Jewish children was replaced with the practice of sacrificing gentiles -- a practice that has continued to hold a central place in the Jewish faith of this day.

By the time of the birth of Christ, the Jews, their religion stripped down and Hellenicized through centuries of Greek and Roman conquest, had forgotten much of their past. Yahweh had long run

out the cults of Moloch and Baal, having become top snake with the return of Ezra and the end of the Babylonian captivity, and had been transfigured from the pure serpent to the half-serpent, half-man form of Typhon, the demonic enemy of Zeus, and Set, the Egyptian God of Evil. As Judaism became more philosophical, and the Sadducees worked to bring the Jews more in line with Greek thought, the reasons for human sacrifice became forgotten among the Jews, but the practice itself did not die.

In a way, all of Judaism is a celebration of the death of non-Jews. Passover is a celebration of the day the Angel of Death killed all of the non-Jewish children in Egypt. Purim is the celebration of the massacre of the enemies of the Jews in the form of the Persians. And because these are the most bloody holidays for Judaism, they are the time when gentile children are most likely to disappear.

While the Middle Ages were packed with a hodge-podge of Jewish cults, isolated from the formal hierarchy of the Temple, who practiced child sacrifice in a hodge-podge way, some believing

children's blood to be a cure for leprosy, others doing it simply out of hatred for the Christian world, with the event of the printing press and the concomitant rise of a formal structure to the myriad religious practices that would become Kabbalah, child sacrifice was once again able to become systematized and conducted under the direction of a central Jewish religious authority.

Kabbalah begins with the *Sefer Yetzirah*, a short and rather silly work, derived from the writings of Pythagoras and the philosophy of Plato, but sufficiently butchered into a unique Jewish invention by its application to the Torah, that claims magical number patterns appear in the Old Testament, and that these magical number patterns govern the universe. Discussed in the Babylonian Talmud, and believed to be the foundation of the thinking in many of the Midrashes, this number theory became the basis of a medieval theory of magic, a kind of anti-human hermeticism, that culminates in the modern Rebbe cults, and the use of the blood of human sacrifices for the construction of magical rings and amulets.

In the 16th and 17th centuries, Rabbinical leaders claiming to be the Messiah -- figures so frequent in the Jewish world that they have been given their own name, Rebbes -- began to launch personality cults, particularly in Poland, Russia and Germany, part of which was the claim of being able to manufacture magical goods. The *Yalkut Shimoni*, one the early Jewish books on the manufacture of magical objects, mentions a magic pearl worn by Avrohom Avinu, the Biblical Abraham, which other Kabbalistic works mention as having been powered by blood from the sacrifice of his son Isaiah (according to a very different, and Jewish, formation of the Bible story). Moshe Rabbeinu (Moses) construction of snake idols to Yahweh, also allegedly "blessed" with human blood is sited in other Rabbinical works. With several centuries of translation and expansion, the result is that, today, large portions of the Jewish population believe they possess magical rings and amulets, and that these rings are almost universally "blessed" by the human sacrifice of children or particularly pure non-Jews.

Prior to 2003, for instance, the Shas Party, part of the government of the Zionist Occupation of Palestine, would pass out during elections thousands of

"magic amulets" reputedly blessed by their leader, Rebbe Yitzhak Kadouri, and made from the blood of non-Jews. In doing so, they were following the modern "magical" spell formulas of Chasidic Jewish leader Avrohom Yehuda Leib Schwartz, who published the generally accepted text on the production of so-called Segulah rings, magical "amulet-rings", formed with the blood of gentiles, that Chasidism believe grant them the power to heal and to manipulate the future.

women's movement that developed in the 19th century to give women the right to vote. The first identifiable advocate of abortion was Aletta Jacobs, a Jewish woman who took advantage of the opportunities created by the early woman's movement to become a doctor, then a communist, and then to open the first Jew-communist abortion clinic in Europe, which she founded in Amsterdam in 1878. Later in her career, she protested against the medical



While the mass media has often focused on Margaret Sanger, a gentile friend of Emma Goldman's, as the founder of the abortion movement, almost all prominent abortionists in the United States and the world are Jews, including, from upper left counter clockwise, Alan Guttmacher, former president of Planned Parenthood, Henry Morgentaler, who opened Canada's first abortion clinic, Bernard Slepian, one of several prominent abortionists who have been murdered, Lawrence Lader, founder of NARAL, David Gunn, the first abortionist murdered in the United States, and Etienne-Emiele Baulieu, born Etienne Blum, inventor of the abortion pill.

This kind of religious thinking also crept into Jewish secularism as well, particularly the secular movements towards Bolshevism and communism that have infested the Jewish culture-organism since the 19th century. With the religious and magical thinking stripped away, or at least regulated to a point outside the public view, the Jewish position comes down simply to child murder, and to the murder of moral gentiles in immoral wars -- and thus we see the linkage between the defining issues of Jewish communism: abortion "rights" and the constant demand for warfare and rebellion, whether in the name of "communism" or in the neo-conservative and Republican Jewish name of "democracy".

The abortion "rights" movement has been entirely Jewish since its inception, and largely alienated from the mainstream

examination and licensing of prostitutes to prevent the spread of sexually transmitted diseases, stating that the spread of sexually transmitted disease should be encouraged to punish men for "carnal lust."

While blurring these idiocies into the world, Jacobs befriended Emma Goldman, an American Jewish communist, who in turn befriended Margaret Sanger, a gentile, and assisted her in opening the first abortion clinic in the United States, in Brooklyn, New York, in 1916. Goldman and Sanger were both later tried, and Goldman jailed, for advocating abortion -- but during this time of practical application of the murder of pre-born children, Sanger had a change of heart and abandoned the Jewish position, stating instead that abortion should only be used

in the service of racial health, and that healthy white babies should be encouraged into the world, not murdered. This position alienated the Jewish communist world, and, to this day, Jews who pretend to oppose abortion cite Sanger, while omitting Goldman and Jacobs, in their discussion of "abortion rights".

In the 1960s, a mob of Jewish "feminists", all also communists, such as Betty Friedan and Gloria Steinem, helped push so-called "women's rights" through Congress, and the first federal subsidies of abortion advocacy began in 1967, through a set aside in the Orwellian named Child Health Act. Six years after the federal government began paying Jews to advocate abortion, the practice became legalized, and Jewish doctors across the country opened legal abortion clinics.

In recent times, the abortion movement has been completely controlled and conducted by Jews, who use a handful of gentile suckers as frontmen, and who use their near total control of both the press and the Christian Churches to prevent anyone from noticing the Jewish coloring of the abortion question. Alan Guttmacher was a defining president of Planned Parenthood. Henry Moganthaler opened Canada's first abortion clinic. Bernard Slepian is one of the most famous murdered abortion doctors; David Gunn was the first. Lawrence Lader founded NARAL. Etienne Blum invented the abortion pill. And the list goes on.

It is because of the Jewish character of abortion that the practice enjoys such unusual political protection in the United

States. No other type of criminal practice is so protected by protest-free zones, make believe Constitutional rights, and special prosecutions of its opponents as abortion clinics, and that special -- almost "Chosen" protection comes solely from the special and "Chosen" status of those who practice and advocate it -- the Jews.

Whereas in the Middle Ages, the Jews could only kill a handful of gentile children at a time, and only at great risk of prosecution, in the modern world, the Jews murdered, legally, between 1973 and 2003, over 33 million gentile children, approximately 22,000,000 of them white, in the United States alone. Not so ironically, the number of Jews wearing magic amulets and magic rings "blessed" with the blood of murdered gentiles has increased dramatically during that period as well.

While Americans sit deluded in the midst of the modern "political debate", where abortion is somehow linked to "women" and opposition to abortion is somehow linked to "the right wing", the Jews have sacrificed millions of gentile children to the Bible's serpent God, Yahweh -- and Yahweh has rewarded them, making them the controllers of both political parties, several nations, international finance, international trade, the mass media and most "Judaeo-Christian" religious movements. Whether this power is the result of the magic hoo-doo the Jews conjure when they sacrifice gentile babies to the serpent, a form of Satan keeping his bargain with his people, or whether the Jews merely believe

it is, the fact remains that the Jewish idea of ritual human sacrifice is central to the idea of abortion and so-called "abortion rights", and that the reason of Jewish advocacy of abortion and for the special protection abortion receives from the press is the Jewish belief that the murder of gentile children grants them the favor of their divine being.

And for the more adventurous of the world's Jews, old-school snatch and grab against the children of the world still occurs on occasion, a reward the Jewish elders provide for the most valuable of their servants. Recent demonstrations in Leipzig, Germany, against the Jewish ritual murder of an eight year old child, for instance, drew international condemnation from the Jewish press, as the protestors were denounced as "right wing" "bigots".

It was a scene that should be familiar to the "right wing" Judaeo-Christians of the United States, who honestly believe the lie that "Nazis" aborted healthy white fetuses and that the Jewish people "have always" stood by them in solidarity, because the killing of "human beings" is a "sin" to the Jewish faith. It has been the talent of the Jew that they have been simultaneously controlled both the pro- and anti- position of every argument through spurious reasoning and sophisms, and the control of the movement that threatens the human sacrifices at the heart of their demonic power is one of the oddities of the modern world. Only through the total extermination of the Jewish demon can this demonic practice be ended.



Zionism, an ideology which means the eventual destruction of the goyim, us gentiles, is the central point of the Zionist Occupation Government. To the Zionists, any threat to their plan of world control must be destroyed, and deception, subterfuge and brainwashing are their tools.

Their strategy is simple and it works: First, they immigrate to a country and agitate among its laborers, deceiving the working people into hating their leadership caste, creating division and starting an insurgency. Through this insurgency, they pressure the existing government into concessions, until they can gain control of the government, whether by direct coup d'etat or civil war, or through other means -- particularly the slow replacement of democratic politician with men of their leaning.

Psychological warfare is important to this, and is employed where it is most useful and most effective. A country or nation generally won't go for the sudden overthrow of its established government and mercantile caste, so a war of attrition is launched against the psyche of the nation. Brainwashing is key to this.

Brainwashing is indoctrination, and the means the Jews have chosen in the twentieth century to carry out this indoctrination is television. People often

learn through repetition; when a message is repeated to them, they come to believe it, whether true or not. While watching television, messages are constantly being sent, both overtly and covertly, into the viewers brain. Using the techniques of modern psychology, Jews use a subtle system of subliminal suggestion to sucker the sedentary masses.

As Henry Ward Beecher, Harriet Beecher Stowe's brother, once noted, "Even a liar tells a hundred truths to one lie; he has to, to make the lie good for anything." To be effective, television seems to portray reality, bringing in a hundred truths, while inserting throughout different variations of the one lie -- anti-racist internationalism -- that benefits the Jew.

Just observe anyone viewing television at anytime, especially during their favorite programs, or during the news. They will appear mesmerized or entranced, staring into the set, absorbing thoroughly the programs as if they were a real social frame of reference. Whereas, once, neighbors and associates formed one's idea of social norms, today, television, and artificial reality, create a new and equally artificial sense of "normal".

Through television, the Jews have introduced race-mixing, inter-racial

breeding, homosexuality and other deviant behaviors as "norms", whereas the majority of society would never define such behavior as "normal". By constantly interjecting such false social norms into portrayals that are otherwise in conformance with reality, the desired thoughts are subtly programmed into the viewer's minds. The use of varying images on a common theme make the programming easier to accept, while also making it hard to define, or to recognize as actual conditioning.

When dealing with the news media, the Jews add disinformation, deceptive reporting and distortion to their toolbox. A lie is not just an outright falsehood; it is also the crafting of cherry picked truths that, in sum, give an impression that is false without directly lying. Lying through omission -- through choosing not to report, as "irrelevant", those aspects of a story that do not conform to the Jewish theme -- is much more common in the Jewish news media than the mere statement of untruths, precisely because, as in the brainwashing techniques, it is much more difficult to detect, and, thus, is more difficult to define, recognize or confront.

By mutating America into a democracy, where the masses of people are able to set the laws, and by controlling the means to sway the masses of the people into their camp, by setting the apparent social "norms" that media-obsessed politicians must adhere to, the Jews have effective control of the American government. The result is a large minority of the public, particularly concentrated among the powerful without an original thought in their head, and whose social norms are not defined not by the actual norms of society but by the brainwashing, whether liberal or conservative, carried out by the media.

Television is the totalitarian brainwashing of George Orwell's 1984. Ironically, it is those who consume it the most that are unable to see it as an insidious conspiracy to contain and control the American people. Through its manipulation of the people and its establishment of anti-social social norms, television has paved the way for Zionism to make America a puppet of the Zionist Occupation in Palestine; allowing the Jews to open doors and occupy the banks, the Congress, the Courts, and the media here at home.

356 years ago Europeans landed on the shores of Table Bay in southwest Africa, known then as the Cape of Good Hope. For thousands of years the whole area, right across to its eastern seaboard, had lain a bushy wilderness inhabited by primitive Hottentots and Bushmen. Through much strife over the next 338 years, Europeans built the region up to one of the most powerful, productive, technically advanced and civilized Western outposts on the continent. Throughout my youth in the first half of the twentieth century, life here was as idyllic as anywhere in the world. Compared to Europe our prices were very low, while our educational system was equal to the best in the world. Order and safety pervaded the land, cities were clean and elegant; crime and disease statistics were very low; art and clothing fashions showed a high degree of culture.

Troubles almost always come from within. The biggest troubles throughout South Africa's formative years came not from the Hottentots and Bushmen and from Negroid tribes from central Africa, which had settled high up on the eastern seaboard and interior and had begun migrating westwards. Nevertheless, except for a small band of the usual troublemakers found in any peoples, the great majority of Negroes in the colony had absorbed a veneer of European culture and, attracted by the amenities and facilities they had never dreamed of before, had settled down to a peaceful existence within the 338-year period.

The European contingent southern Africa, having first-hand knowledge of the situation, had matters well in hand, including in the adjacent territory known as German Southwest Africa, which, after World War I, had been mandated into the care of South Africa by the League. Later, the globally-interfering United Nations (which, like the League, was in no way appointed by citizens on a democratic basis), dictatorially and unilaterally terminated South Africa's mandate over Southwest Africa. So chagrined by South Africa's refusal to accept its order, the United Nations' first action was to send secret agents to South Africa to stir up the Negroid population.

The Negroid population were essentially a primitive and simple peoples living peacefully, usually in kraals (a ring of grass huts in the Bushveld). They are, however, people who are easily roused to rise up in protest, the cause being unimportant, and their prancing to and fro can also turn very violent and destructive. The joker in the agent's pack was the South African government's policy of apartheid. Apartheid, the separation of different race groups into separate areas, is an ancient practice seen in a number of European countries, and had been standard practice in what was to be called "South Africa" since its birth. Neither Europeans nor non-Europeans raised any complaints

about it, even after the Nationalist Party came to power in 1948 and made it a policy, giving it its name.

However, after the agents provocateurs began exploiting their mischief amongst the Negroes, "apartheid" started on a years-long career of pariahdom. Snatched on by the world mass media, it was for years expanded and circulated round the world as the acme of evil and cruelty to mankind and poor, innocent non-whites in particular. People in distant lands, with no knowledge at all of conditions in South Africa, swallowed the sensational media medicine without a qualm. Within South Africa, Negroes went from being stable, peaceful people, to the world's number one troublemakers. South African apartheid became the "cause" of every black lack and misfortune from 1652 on out! All the rest of the world was told about apartheid was that it was a terrible word associated with all the bloody adverse sensation with which the media has imbued it.

Having set fire to South Africa, the United Nations, as the façade of the European-dominated "international community", threw its entire arsenal of sanctions, embargoes and travel restrictions at South Africa. This dirty, iniquitous campaign, plus further mischief by agent provocateurs, brought about the final downfall of the Nationalist government, capped from within by one de Klerk who, as the last Nationalist president, released a long-imprisoned Negro traitor and then proceeded to turn the presidency over to him. Such as the depths to which the once great British political leadership had fallen, that it promptly erected statues to both of them.

Thus was brought about a condition which no reasoning person would have ever considered: that a highly-developed, globally-contributing national unity

founded and developed by Europeans on a wild and barren continent was turned over, lock, stock, and barrel, to a politically poisoned section of primitive Africans. These actions of the European-dominated United Nations against the European culture of South Africa were and are one of the highest crimes against mankind which history records.

When considering South Africa, we must remember that another international governing body, the European Union,

squandered a king's ransom for six years equipping, training and funding the newly empowered Negroid freedom fighters. Their ultimate goal has been to venture into Africa and set up an African Union, designed, ultimately, to turn all of Africa into one single continental nation. It's the contagion of aberration and its ultimate goal: global domination.

No one can say anyone is safe in South Africa today. It does not matter whether you are walking in the center of a city, riding on a bus or a train, a tourist walking along a scenic mountain path, getting out of your car in the driveway of your house or snug in your own home. People in all of these places are frequently assaulted and robbed. From a very incidence of crime, South Africa has soared over the past fourteen years to one of the highest crime rates in the world – and it is not whites committing these crimes.

The government doesn't even keep economic statistics these days. Prices just leap up again and again, so that's its become a regular habit for shopkeepers to increase their prices, automatically, at least once a year. The wild, unrestricted printing of paper money by the government is the main cause for this wicked escalation of prices, and another factor in the country's ever increasing poverty.

Education, once a source of pride in South Africa, is now just another crisis, as political interference in education has turned it into a vehicle for hatred of Europeans. South Africa has experienced four straight years of educational decline,

and the Education Department seems to think the remedy is "prayer". "Equal Education" has filled even the best schools with primitive characters, introducing stabbing, rape, teen pregnancy and general insecurity as dominant distractions from study. Religion has been replaced by the

compulsory study of homosexuality and the Holocaust.

Order has been kicked out by a "freedom" loving government. Crime, filth and disease have become the order of the day. Cities are overcrowded, dirty, and untidy. South Africa has become the AIDS capital of the world. Every technical service introduced by Europeans is in a condition of crisis in the unable and unskilled hands of Negroes who never in their history developed such things. The latest crisis is the pollution of our streams by millions of foreign Negro squatters, followed by an electricity supply crisis brought about by the indiscriminate supplying of electricity to mushrooming

squatter camps and black townships. Almost everywhere you look you see CRISIS: doctors, nurses, teachers, governmental grants and the national airways. Now, foreign owned newspapers, national television, big money advertisers and the media in general show almost exclusively Negro bit players (because they think that is where the money is) and blacks and white fraternizing on sexual terms to show apartheid is dead. TV news is a recording of black goings on, particularly the perpetual misfortunes of poor black squatters living in euphemistic "informal settlements". And, a cultured European must see what passes as "art" in South Africa these days: strictly kindergarten level, occasionally touched with racial overtones.

The wholesale theft of South Africa is everywhere in evidence, and when one looks, one must ask if this is what the United Nations, aided and abetted by the European Union, hoped to achieve when it set its sights upon South Africa. From mankind's most advanced peopled on earth our nation has been degraded into nothing; this is the price of "freedom's" triumph over civilized order.

The white man's creative activities have been replaced with the Negro's mantra of "everything for nothing", as the world has allowed their race their greatest theft – the theft of an entire nation.

THE DARK TRUTH OF SUPERMAN

As June 30 marks the seventieth anniversary of the first appearance of Superman as a comic book "Super-hero" his true origin must be explored.

Superman was invented by two Khazars (pseudo-Jews) named Jerry Siegel and Joe Shuster. As this was in the 1930s, he was named in the context of National Socialist Germany and Fascist Italy's veneration of Nietzsche and his philosophical works. In this context, Superman was, and still is, a powerful propaganda tool.

In The Adventures of Superman, written 1942, the ruling body of Superman's hero-planet, Krypton (literally "hidden", like the origin of the Ashkenazic Jews) is the Council of One Hundred, suspiciously named after the Jewish Sanhedrin, aka the Council of Seventy. Superman's Kryptonian name is Kal-el, where el is a Jewish synonym for God, a deliberate reference to Superman's symbolic meaning for the Jewish faith.

In 1942, Superman was a killer; he had not yet taken his oath to lose his superpowers if he killed again. His victims were almost entirely "Nazis" and their supporters, and his antics received criticism in the German press, including in articles in the SS magazine, the Schwarze Korps, where it was noted:

"Well, we really ought to ignore these fantasies of Jerry Israel Siegel, but there is a catch. The daring deeds of Superman are those of a Colorado beetle. He works in the dark, in incomprehensible ways. He cries "Strength! Courage! Justice!" to the noble yearnings of American children. Instead of using the chance to encourage really useful virtues, he sows hate, suspicion, evil, laziness, and criminality in their young hearts."

After the war, Superman's propaganda values become less blatant and he mostly spent his time fighting normal criminals with minor psychiatric issues. One villain in the series, though, stands out -- Lex Luther. A bald man who resembles Benito Mussolini, Luther is a failed scientist who cannot succeed in his schemes. A proto-typical Jewish view of the "fascist", his introduction into the series allowed Superman to continue to propagandize against the "right wing".

Being fictional, Superman is easily changed to meet the need of the moment,

having been changed into a wimp, killed and resurrected, and mutilated in his character to become a tool of political correctness. Much of these changes mirror the inner psychological workings of his Jewish creators, who see themselves, in stereotypical Jewish fashion, as wimps living out their anti-"Nazi" fantasies with a bevy of exotic super-powers. Superman is the Nietzschean hero stolen and adopted to the Jewish personality.

How do we deal with this theft? Despite the decline of the comic book industry, he is still popular and makes appearances throughout popular culture. Because of this, whites must become

educated as to his true origins, and the role he has played in pushing Judaic values on mainstream America. The sinister propaganda message found in the alterations of Superman and spinoffs like the TV Show Smallville must be exposed and explained to children and others vulnerable to it. And Time Warner, the Jewish owned company that owns the Superman label, must be confronted and held accountable for these messages it sends.

"White racial heritage shall be defined as being able to trace seven of one's eight great-grandparents' ethnic origins to the Aryan peoples of the land now occupied by the following nations: Andorra, Albania, Austria, Belarus, Belgium, Bosnia-Herzegovina, Bulgaria, Croatia, Czech Republic, Denmark, England, Estonia, Finland, France, Germany, Greece, Hungary, Iceland, Ireland, Italy, Kosovo, Latvia, Liechtenstein, Lithuania, Luxembourg, Macedonia, Malta, Moldova, Monaco, Netherlands, Norway, Poland, Portugal, Romania, Russia, Scotland, Serbia, Slovakia, Spain, Sweden, Switzerland, Ukraine, or Wales ...

"Good morals shall be defined as: not having a spouse or custody of children of non-white racial heritage within five years of the date of application; not having had sexual relations with a person of non-white racial heritage within five years of the date of application; having not been convicted, incarcerated, or under probation or parole for an infamous crime within five years of the date of application; having never been convicted of murder, rape, or a sex offense, or conspiracy or accomplice to the same, or been thrice convicted of any other felony; having not been treated for a mental illness with delusory, hallucinatory, paranoid or severe abnormal personality characteristics within five years of the date of application; not having been treated for substance or alcohol abuse within five years of the date of application; having not had an abortion within five years of the date of application; being heterosexual and without any public display of sexual fetish or deviance; providing maintenance for one's children; being gainfully employed insofar as one is capable of being so, though this shall not exclude the right of those disabled by injury or disease to join the party; not being employed in an infamous profession; and not being active in any organizations whose goals run contrary to those of the party."
