Quoted from the Associated Press Nov. 4, 2005...

A savage assault on a bus passenger highlighted the dangers of travel in Paris' Muslim-filled and impoverished outlying neighborhoods, where the violence has entered its second week. The African immigrant attackers doused the woman, in her 50s and on crutches, with an inflammable liquid and set her afire as she tried to get off a bus in the suburb of Sevran Wednesday, judicial officials said. The bus

had been forced to stop because of burning objects in its path. She was rescued by the driver and hospitalized with severe burns.

During the worst days of the race-driven, anti-White riots across Europe, it was a world wide news story when I was branded a hate criminal by the media for an intellectual, non-violent speech in Sweden where I warned of the dangers of massive non-European immigration.

A Swedish prosecutor who opposes free speech urged police to open an investigation to see if any of my words could be construed as a "racial hate crime." A conviction could put me in prison for 5 years on each count.

She is nameless and faceless. There is no media focus on her, no interviews with her grieving family, and no condemnation of this horrendous act as a "hate crime." We are not even allowed to know her name.

This affront to free speech and free expression was trumpeted around the world as a justified action against a terrible "hate criminal."

Contrast the accusation of a hate crime against me for merely speaking out non-violently and not hatefully, as compared to the

burning alive of a handicapped White woman by a crazed Black mob!

Washington Post Reveals that America Now Runs **Torture Prisons in Old Soviet Compounds!**

Sometimes, a piece of news breaks that should shock every American down to the very depths of his heart. A recent article in the Washington Post shows that American intelligence operatives

(which are now under the direction of the Neocons), have taken over old Soviet-era compounds in Eastern Europe for use as secret detention-torture facilities.

Patriotic Americans used to look at the Soviets as the "Empire of Evil." A chief proof of this evil was the Soviet Gulag system and its systematic murder and torture of prisoners from the earliest days of the Bolshevik Revolution. "Only an evil state," our leaders would say, "would hold prisoners in secret, not even acknowledge their imprisonment, torture and abuse them at will, and forbid any international access or inspection."

The United States Government under Neocon direction now does exactly the same things for which the government and media used

to condemn Communists and Nazis. Here is an excerpt from the Washington Post article titled "CIA Holds Terror Suspects in Secret Prisons" from November 2, 2005. All the subsequent quotes are from that article.

It is illegal for the government to hold prisoners in such isolation in secret prisons in the United States, which is why the CIA placed them overseas, according to several former and current intelligence officials and other U.S. government officials. Legal experts and intelligence officials said that the CIA's internment practices also would be considered illegal under the laws of several host countries, where detainees have rights to have a lawyer or to mount a defense against allegations of wrongdoing.

Host countries have signed the UN Convention

Against Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment, as has the United States. Yet CIA interrogators in the overseas sites are permitted to use the CIA's approved "Enhanced Interrogation Techniques," some of which are prohibited by the UN convention and by U.S. military law. They include tactics such as "waterboarding," in which a prisoner is made to believe he or she is drowning.

These torture facilities are even kept from the knowledge of the U.S. Congressmen whose constitutional duty is to oversee such things!

The hidden global internment network is a cen-

tral element in the CIA's unconventional war on terrorism. It depends on the cooperation of foreign intelligence services, and on keeping even basic information about the system secret from the public, foreign officials and nearly all members of Congress charged with overseeing the CIA's covert actions.

There is no question spread torture is now

Although some American authorities used torture during the 20th Century, the most notable example being the Nuremberg Trials, never has torture become so routine as American policy as in the domination of the Trotskyite Neocons.

as to the fact that widebeing conducted by U.S. operatives. The President himself and his Neocon bosses formally

asked congress to exempt CIA operatives from American law that would bar torture of suspects. But the revelations of widespread prisoner

abuse in Afghanistan and Iraq by the U.S. military - which operates under published rules and transparent oversight of Congress - have increased concern among lawmakers, foreign governments and human rights groups about the opaque CIA system. Those concerns escalated last month, when Vice President Cheney and CIA Director Porter J. Goss asked Congress to exempt CIA employees from legislation already endorsed by 90 senators that would bar cruel and degrading treatment of any prisoner in U.S. custody.

It should be pointed out that torture has never been publicly acceptable by any American administration in our long history, not even for those duly convicted

of heinous crimes. The men being held and tortured are merely said to be suspects. They have not been charged with any crimes, tried for any crimes, allowed to mount any defense, have any lawyer, and are held totally incommunicado from their wives, children, family, and in secret with no oversight whatsoever!

Many have been psychologically damaged and even murdered.

The largest CIA prison in Afghanistan was code-named the Salt Pit. It was also the CIA's substation and was first housed in an old brick factory outside Kabul. In November 2002, an inexperienced CIA case officer allegedly ordered guards to strip

naked an uncooperative young detainee, chain him to the concrete floor and leave him there overnight without blankets. He froze to death, according to four U.S. government officials. The CIA officer has not been charged in the death.

Perhaps those of you my age or older can remember how we Americans once knew who the good guys

and bad guys were. Why, of course, the bad guys were the evil men who imprisoned and tortured their enemies in the blood-stained cellars of the KGB or the Gestapo. The good guys were those who would not resort to torture of suspects or of enemies. Folks, the bad guys are now us.

> American principles are the principles of the American Bill of Rights, the rule of law and due process. Now America follows the horrific Bolshevik-style pracitices of **Jewish Trotskyite Neocons!**



the world has ever known. And now under these "former" Trotskyites, Jewish Neocons have directed that former Soviet compounds are to be used as torture chambers.

The Dark Side of Diversity

This photo was sent by friends in Sweden. It shows a picture of a rape victim named Linda. She became one of the many Swedish recipients of multicultural enrichment at the hands of immigrants.

In Sweden, a nation with a 10 percent non-European population, most non-familial rapes and

practically all gang rapes are committed by non-Europeans. Sweden has undergone a radical increase in non-Whites over just the last 20 years. With that demographic change, robbery, rape and murder have increased many fold. Gang rape, a crime unknown in Sweden 20 years ago, is now far too common.

This vicious attack took place against two girls by a group of African immigrants. It happened in Gothenburg where I spoke earlier in the year. The two girls were on their way to a party and needed some directions. Thoroughly indoctrinated by the media to have no "racist" fears of Blacks they agreed to accompany a group of Blacks when

they told the girls they knew the way. Instead of leading them to the party, they kidnapped and separated them, and savagely beat them. One girl was raped while the other badly injured girl feigned death and avoided rape.
