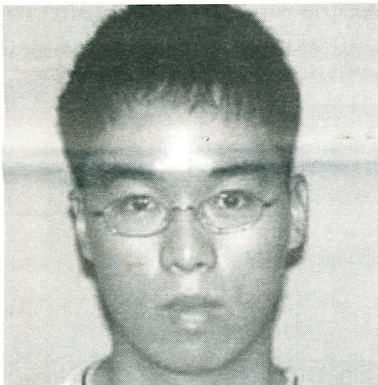

The media have been talking incessantly about the motivations of mass murderer Seung Hui Cho at Virginia Tech. But, few voices in media have dared to speak about what drove this Korean student to the intense hatred that led to the gory deaths of 32 students and faculty. Did race play a part in the worst mass killing in American history?

There is no question that at least part of the Korean immigrant's motivation came from the alienation of living in a society where he felt he did not fit in. Multiculturalism produced by massive immigration creates incredible amounts of alienation in any society that suffers from it. Alienation increases in both the immigrants and in the indigenous populations as well.

Endemic ethnic conflict rages in Rwanda with its different ethnic tribes periodically committing genocide against each other. It festers in Palestine from the introduction of great numbers of supremacist Jews into an Arab society, and it thrives in New York, London and the dormitories, classrooms and hallways of Virginia Tech. The more multicultural and multiracial a society becomes, every group becomes a minority

and loses its sense of belonging. Immigrants themselves generally come from a society where they are part of a fundamental cultural, religious and ethnic majority to nations where they become a minority of race and culture and are usually near the bottom of the social and economic structure.

Ironically, a significant portion of immigrants themselves are escaping from ethnic or religious turmoil in their own nations of origin. For instance, the federal government has just increased immigration quotas for Iraqis to come to the United States. Iraqis are themselves coming to America because of ethnic and religious conflict. One must look not much further than the Kurdish-Arab and the Sunni-Shia conflicts, conflicts that have produced the impetus of immigration from Iraq in the first place. America somehow seeks to alleviate the nefarious effects of ethnic conflicts around the world by sowing the seeds of it here.

Iraq is hardly the only nation where ethnic and religious conflict arises. It is the biggest source of conflict and hatred all over the world. You can see it in the recent ethnically driven riots in Paris and London. And the USA has had more than its share of race riots, anger, racial hatred, and racial violence over the years.

One may plaintively ask, as Rodney King did, "Why can't we all just get along?" But the fact of life is that in general we simply don't get along. Because we don't recognize and honor the differences among peoples, we are doomed to conflict and hate.

Recognition of the reality of deep ethnic differences affords us the opportunity to avoid the horrendous and inevitable societal problems produced by uncontrolled

immigration and multiculturalism. We must begin to understand that every nation has a right to preserve its unique ethnic identity, culture, religious expression, art, and tradition. Nations where the people share a common heritage, culture, and tradition find love and brotherhood far more attainable.

Also, the failure to recognize human differences and sovereignty leads to universalist religions and ideologies such as globalism and interventionism that lessen human diversity and freedom. For such models suggest that the different human races have no unique qualities but are just pieces of plastic to be molded in quest of some political, economic or religious vision. It is a basis for totalitarian repression and a major justification of war.

Although the multiculturalists preach incessantly about the enrichment and love that will emerge from a multiracial society, in reality ethnic conflict has been a greater source of violence, civil and international war, and hatred than any other single cause on earth. Multiracialism and multiculturalism, despite the media poster depictions of light and dark hands interlocked in friendship and love, generates incredible amounts of alienation, frustration, hatred and yes, violence. Nations composed of people that are similar to each other in culture, religion, shared history, and even in personality and genetic traits, tend to be more stable, more adjusted and comfortable, and less alienated in a nation that better fits their unique character.

Increasing numbers of alienated people are like explosives waiting for someone to light their fuse. Seung Cho's fuse was lit by minority attitudes that legitimize hatred, even violence against America and ultimately the White people who built it. At Virginia Tech and every other university in the United States, there is an incessant mantra complaining of "White privilege" and "White racism." Check out the blogs and the statements of major organizations on almost any American campus. Any individual fault, shortcoming, or even crime is laid at the doorstep of White people.

As the fine writer Steve Sailor wrote in recounting the words of an anonymous commentator: "I wonder how many times Cho heard the phrase 'white privilege' while he was in college?"

In fact, Cho's presence at Virginia Tech is proof that there is no longer any "White privilege" in America. Cho was an English major at VT and one only has to read his papers to quickly realize that his talents in the English language were appallingly poor. Does anyone not believe that better qualified European American students would have more competently filled his chair in the English classes he took? In fact, Virginia Tech and all major universities in the United States have programs that blatantly discriminate

against European Americans in admissions, graduate programs, and in the hiring of teachers and professors. Every White college graduate in English knows of the discrimination existing in graduate programs, and once the White student achieves a PhD he faces an uphill battle in finding a professorship. The great majority of universities are seeking to improve their minority teacher ratio. In their quest for increased minority faculty, they discount the better grades and evaluations of White students and the fact that many of them come from higher-rated academic institutions than their black counterparts.

The discrimination against European Americans can even be found in the news coverage of the tragic murders at Virginia Tech. At the present time I am lecturing in Europe, but I can tune in on the American media by way of CNN International. When I heard

about the killings, I tuned in and watched an hour wrap up of the coverage that evening. Although the overwhelming majority of the slain students and faculty (22 out of 32) were European Americans, most of the broadcast centered on an Israeli and an African American victim. The coverage centered on a Jewish victim of the shooting, a Holocaust survivor who was touted as a hero for trying to block the door with other students to keep Cho out of his room. CNN showed extensive interviews with his family in Israel. The other victim covered extensively was the lone male African American victim and again heartfelt interviews with his family and friends were aired. On the broadcast no other victim's family gave any interviews.

Librescu and Clark were mentioned in over 4,000 stories in national and international media listed on Google News. In comparison, Michael Pohl, a European

# It's More than Amnesty: It's Genocide for European Americans

**Comment by David Duke:** *H. Millard wrote the following article. I consider him one of the most brilliant writers and analysts in the European American civil rights movement. *Millard speaks about the reality of race, of genes, in a common sense and absolutely scientifically accurate fashion, but the Jewish supremacists who dominate the media don't want any other people to be concerned with their own survival, heritage and freedom.*

*Only the Jewish people are allowed to be concerned about their existence! Hence, they tell non-Jews that race doesn't matter for them, while they select immigrants to Israel based on their Jewish descent (which supersedes the immigrant's religion). A Jew by heritage who is an outspoken atheist critic of religion can immigrate to Israel from any nation in the world. In Israel, the government will let a non-religious Jew marry another Jew, but marriages between Gentiles and Jews are not legally allowed. Many of the leading Jewish anthropologists who tell*

American former member of the VT football and Lacrosse teams, who even after he was mortally wounded courageously fought to block the attacker, received only 540 mentions in a Google News search.

One of Cho's teachers in the English department at VT is the "celebrated" Nikki Giovanni. Not only is her poetry at the intellectual level of a twelve year old, it is imbued with vicious racial hatred against White people and makes a call for Black people to shed their role of "nigger" and become "real Black men" by murdering White people. Here is an excerpt from "The True Import of Present Dialog, Black vs. Negro." After reading this racist call to hate and murder by Cho's esteemed teacher, Nikki Giovanni, can you guess who was given the honor of delivering the closing remarks at the memorial service on campus for the slain 32 students and faculty? It was, of course, the same person who has advocated "... shoot straight... and splatter their brains in the street."

I can illustrate the double standard very easily by contrasting the media treatment of Professor Giovanni and me. Not only have I never advocated

violence or hate against anyone, I have never advocated discrimination against truly better qualified Black people in jobs or promotions or scholarships or college admissions or any other positions that they have earned by merit.

Yet, because I consistently advocate equal rights for all I am branded as a racist and hater, and the media consistently call my site, Davidduke.com, a "hate site." (Even though I am a former member of the House of Representatives in Louisiana and my site offers well reasoned, nonviolent and thoughtful political and social commentary, it is filtered and blocked by many institutions.)

Nikki Giovanni, on the other hand, is effusively praised by the media and even given the honored closing remarks in the campus memorial service. This, in spite of the fact that she has openly and brutally advocated exactly what Cho did.

The national media have not breathed a word about where Cho learned to hate. It came from the very same teacher and from inside the very same institution that now buries 32 of its own.

us that race doesn't exist, such as Jared Diamond, tell us how great it is that new DNA methods can identify Jews (by genetics).

The denial of existence of race is a weapon for them to reduce the loyalty of non-Jews to their own people, while for Jews teach that nothing is more important than their heritage. This weakens resistance of non-Jews to Jewish efforts for supremacy in media, politics and the economy. For instance, if a Palestinian who has been driven out of Palestine becomes convinced there is no such thing as the "Palestinian people," why should he support the resistance of the Palestinian people to the Zionists? After all, they don't even really exist. If a European American becomes convinced there is no such thing as race, why should he resent Jews (whom he perceives as no different) from controlling the American media and dictating American policy?

Of course, Jews understand their identity: they know they are different and they want to preserve themselves as they are. Any Google search on the Internet will find tens of thousands of more articles about the threat of intermarriage to the Jewish people than any idea that intermarriage would pose a threat to the European people. You see constant articles on the demographic threat to Israel. So less than two percent of the population of America and Europe have far more articles on the Internet about the dangers of intermarriage than the other 98 percent of people.

Jewish-led organizations, along with Jewish-dominated media, have long been the undisputed driving force behind opening America's borders and changing America from an overwhelming European nation to one in which European Americans will eventually become a small percentage. Read my book, **Jewish Supremacism**. The facts are irrefutable. And now, Jewish groups line up to support the new amnesty bill, a bill that could be the death knell for the European American people. As Millard says, the new immigration bill is nothing short of genocide. The genocide is not done with marching boots, but it quietly occurs across the United States. Yet, it has the same result as the classical images of violent genocide: the death of our people. Those of you who are not yet aware, read this article and wake up! Those of you who are aware, read this article and be motivated to do more for our heritage and freedom!

**H. Millard Article:** Genocide is the mass killing of a group of people as defined by Article 2 of the Convention on the Prevention and Punishment of the Crime of Genocide (CPPCG) as "any of the following acts committed with intent to destroy, in whole or in part, a national, ethnic, racial or religious group, as such: killing members of the group; causing serious bodily or mental harm to members of the group; deliberately inflicting on the group conditions of life, calculated to

bring about its physical destruction in whole or in part; imposing measures intended to prevent births within the group; and forcibly transferring children of the group to another group."

Here's a clarification I want to make with how I'm using the word genocide in this column. I'm using it to mean the destruction by any means of a genetic group. In my use of the term, criminal acts are not required. Gen=genes + cide=death. Death of genes.

Flooding the U.S. with non-European genes, coupled with the massive "anti-racism" conditioning of our age, leaves European Americans vulnerable and open to committing their own bedroom genocide.

Before going on, let me be very clear. I speak for myself. I'm not a member of any anti-immigration group and I expect many people, maybe even most, in these groups will disagree with me. So be it. We still have a little freedom of speech left in this country (but how long it will last is anyone's guess), and I choose to use a

little of my free speech to tell others about the continuing extinction of European genes that is happening right before our eyes.

You can be excused if you're one of the slow boiled frogs who can't see the genocide. It hasn't come with marching boots and gas chambers, but with walking shoes and smiles.

But genocide it is.

And, the amnesty and open borders scheme hailed by George Bush and some in congress is really just another chapter in the move to destroy distinctions between different peoples, nations, and religions and blend them all together into a bland and conformist Stepfordized world. Once again, I call that genocide.

You may say it is compassionate or modern or practical what George Bush and the other blenders are doing, but that's a

very short view of history. In the long run it may mean the destruction of the U.S. as we know it and the extinction of all distinct peoples. The first to become extinct will probably be White people—we are the recessive people on this planet.

To understand why I call what's going on genocide, we have to understand a few basic concepts that most people seem to ignore.

First, we have to understand that race is a reality. Race is to humans as breed is to dogs. "Race" is not a bad word. People come in races just as dogs come in breeds. The different races and different breeds have genetic differences from others of their respective species. Different races and different breeds also have different strengths and different weaknesses from others in their species. Greyhounds do run faster than poodles, for example. Different races of people do build different types of societies.

Second, evolution is all about differences. Current

scientific thinking holds that all humans probably evolved from pre-humans living in Africa. Similarly, all dogs—from Chihuahuas to Great Danes, and everything in between, sprang from wolves.

Now, as humans moved out of Africa, they adapted and changes as they lived under different conditions. In this regard, nature is automatically accommodating and constantly causes minor changes—mutations—to occur that may allow living things, including humans, the ability to survive in new environments.

Some of these changes spread through a population precisely because they do help people survive in certain conditions where it might not be possible or might be more difficult without these changes.

In fact, it has been estimated that nature makes about one “mistake” for every 10 million bases of DNA that are copied. That may not sound like many mistakes—mutations, again—but when you realize that each human carries about 3 billion bases, you can see that there are lots of changes going on all the time.

These little mutations may not continue to exist in the population if there is no survival benefit from them. But, if there is a survival benefit—such as white skin to let in more sun to produce a proper amount of Vitamin D to prevent rickets in cold and cloudy environments—they may become the norm in that environment.

That’s exactly what happened. Humans who moved to Europe adapted and developed white skin and many also became blond and blue eyed and acquired a whole host of differences from those who remained in Africa or who moved to other lands. As the centuries passed, more and more differences crept in, not only in the things we can easily see, but also in the way people were and what they valued and the types of societies they built.

And, speaking of white skin, recent research seems to indicate that a mutation in just one amino acid in gene SLC245A found in Chromosome 15 is why White people are white.

As it so happens, when you change one gene just a little, there is often a cascade of other changes that occur as a result. For example, you don’t just get white skin—you get all sorts of other things along with it. Some may be positive and some negative. In the latter category is a higher risk of skin cancer caused by the sun. It’s like the old, “if you want the bull, you have to take the horns” statement.

Given the ignorant temper of our times, it’s probably necessary to add at this point that awareness of human differences does not equal hate and it does not equal a belief in a general superiority of one group over another. There are just differences and they should be looked at and studied as coolly and scientifically as we look at differences between different breeds of dogs.

Once a group of people has such differences, it may wish to retain those differences. People in the group may like themselves just the way they are and not want to be changed. The usual way people state this is to say that they want their children to look like them. That is their natural right as human beings. Now, in order to remain the way they are, means that they have to retain and pass on the genetic traits that they possess.

Here comes the real problem with flooding Euro-

pean gene pools with non-European genes.

Many of the traits that are found in European descended peoples are recessive. This means that it takes two copies of a gene for these traits to be present for the trait to be expressed. That’s why I wrote, above, that Whites are the recessive people. It takes more effort to make us. In simplest terms, if you have blue eyes, blond hair and white skin, your best bet in having children with those traits is to mate with others who also have these traits. In this regard you may have read news stories this past year about how some scientists are saying that blond hair may become extinct. Why? Because of an influx of non-blond genes into the gene pool. Put another way, we could say the default is to non-White characteristics.

Generally speaking, many of the darker features: eyes, skin, hair are dominant. This means they only need one copy of a gene to be present in order to be expressed. So, if a blue eyed person and a dark eyed person have children, most of the children will have dark eyes. Again, blue eyes require blue eyed genes from both mother and father while dark eyes only require one parent to contribute dark eyed genes.

Genes are carried by chromosomes. Humans have 46 chromosomes. We get 23 from our father and 23 from our mother at the moment of conception.

Because, as we noted above, most uniquely European-American traits are recessive, we need to have two parents with European genes in order to have our genotype (our internal blueprint) and phenotype (our outward appearance) continue and not become extinct. Thus, we need 23 European chromosomes from the father and we need 23 European chromosomes from the mother. Now, it does get more complicated than that and there are millions of genes on those chromosomes, but this is the basic idea.

If you live in a country where there are many people with the genetic traits you want to preserve, your probability of mating with someone with those traits is higher than if you live in a country where there are few others with those traits. It’s just common sense.

Thirdly, the U.S. was a new Europe for most of its first hundred and fifty or so years of existence. Forget that sop about it being a “melting pot.” That term was coined when different European “nationalities” (not races) were coming here. In the U.S., the English married their Irish and French and German and Swedish and other European cousins. They then became a plain wrap European on the American shores.

They were still genetically like their cousins in Europe. Take any European-American and plop him down in any European nation and he’d pretty much fit in and not be seen as an outsider. Of course, the same thing holds true with African-Americans and Africa and Chinese-Americans and China as well as with other groups. In other words, we are our genes. That is the sources of our essential selves, not the country in which we live. Nationalities are artificial. Genes are authentic. That’s the point of this essay. Genes matter and genes are us. With different genes, we are, literally, not ourselves. With a nation full of different genes, the U.S. will become less and less like a new Europe and more and more like other parts of the world as Euro-



pean-Americans mate with the ever more available non-Europeans.

European-Americans have been browbeaten into submission in this country with the term "racism" and similar words. We have mostly learned to shut up and not be ourselves, lest we be called racists; which is usually defined to mean racial hatred.

My guess is that most European-Americans don't hate anyone because of their race or anything else, and generally we get along fine with all peoples. We cooperate with everyone in areas where we have common interests and we treat others as we want to be treated.

Still, no matter how much goodness is in our hearts, we fear that if we talk about our own people-European-Americans-or openly and honestly discuss race and genes, we will be put in the same column with those who might attack others because of their race.

Frankly, this must have been the way it was during the Witch hysteria in Salem, Mass. Anyone who spoke out against the injustice being done to some people was, in turn, also labeled a Witch, so people just shut up.

So, today, we self-censor ourselves. We shut up. And, in shutting up, we harm ourselves and those to come after us. We become like whipped dogs and we become less than we can be and should be. We are no longer fully functioning human beings with the intellectual and emotional freedom to let our minds go where they will. We become neutered. We become aracial eunuchs. Everyone else can have a race or ethnicity, but not us. We have to be "above" nature.

I'm saying this has to end. We must take back our right to be and we must take back our right to self-identity and self-determination and I also believe that this is directly related to controlling our borders and deciding who to let in and who not to let in.

On Thursday, key Republican and Democrat senators announced an agreement with the White House on an amnesty bill that will continue the invasion of the U.S. by millions and millions of non-Europeans who will

dump trillions and trillions of their genes in the gene pool which may eventually cause the extinction of European-Americans. Call it bedroom genocide. That's what it is. And, it will probably come one or two traits at a time. Fewer blonds. Fewer blue eyes. Darker skin. And then on and on and on. Soon, there will be no more Europeans in the U.S.

Of course, things are never as simple as they sometimes are written on paper. There are also moves among some non-European peoples to regain their own genetic heritages that have been watered down by the influx of European genes into their gene pools. We see this in Hawaii where the native Hawaiians are trying-but, they don't call it this-to distill out the European genes from their people. We also see it with various American Indian tribes. And, there are some Black groups who want to remain black and not be watered down by White genes.

Some of these peoples understand what many European-Americans are afraid to say: Genes matter. Without American Indian genes, for example, one is not an American Indian no matter how often one dresses up as an American Indian. It is the same with all other peoples. All peoples begin and end with genes.

The psychotic blending zeitgeist of our age demands that all peoples, all religions and all nations be blended together. This is anti-evolutionary, anti-life, and genocidal. People are not fungible. They are all different and they have a right to remain different.

George Bush and those who think like him are destroying distinct peoples, distinct nations and distinct religions. In the U.S. they're doing this by swamping the European gene pool with non-European genes. Why isn't this called genocide?

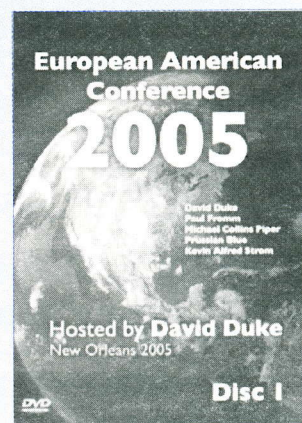

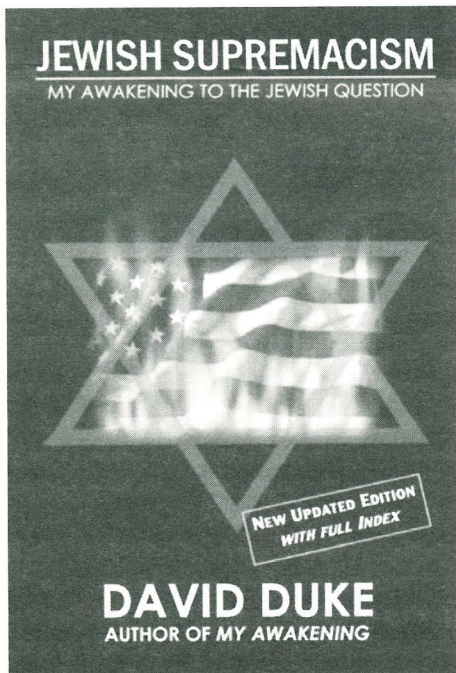
