

3) P.S.: See what I mean about reading? I noticed my omission of some topics. Further to the treatment of jews in Nazi Germany, there was no attempt made to intern them, as we did with Japanese Americans! Jews have told me they remained in place throughout the war. Everyone knew who they were, but they were left alone, unmolested smack in the middle of Nazi Germany! I read a 1944 Berlin telephone directory, with a red cover & black Swastika thereon, which listed at least a dozen jewish organizations in "Hitler's capital!" Since I was in pro-White politics, I was escorted to the airport, from which I flew to London. I have no desire to visit Cuba, but I was checking up on my status when I was passing through Mexico City that year. I'm back in the USA because my foreign contracts were concluded & Interpol informed me that I could return because certain zoglings had croaked. Apparently, J. Edgar Hoover's heirs torched tons of Justice Department documents soon after Hoover's death, so as to avoid embarrassment. At last inspection, all documents I have obtained under The Freedom of Information Act have been blacked out so thoroughly that I can't even use them for scratch paper, unless I were to use white ink! The "Cold War" is one more hoax to be added to the Holohoax. The reason the USA & other Zionist-Occupied countries have lies posing as history is because that's how our Zionist rulers want it. As the Zionist bankster told the righteous jew, Fieldmarshal Milch, "guilt or innocence did not matter" nor did the truth. "Any German can be tried for 'war crimes', regardless of his innocence."
