## President George W. Bush Commander in Chief, White House, Washington D.C.

Dear Mr. President,

Saturday June 8, 2002 marks the 35th anniversary of probably the most shameful day in American history. That day America's banner and honor was treacherously trashed by our so-called ally, Israel. Thirty four Americans were brutally slaughtered, 172 wounded, including myself, and America's most sophisticated intelligence ship was so badly damaged it had to be scraped. Israel deliberately attacked America's virtually unarmed USS LIBERTY in international waters, knowing full well our identity, in an assault that lasted as long as the attack on Pearl Harbor.

On that bright, sunny infamous day, the LIBERTY had a large American flag flapping in the wind and 10' high I.D. marking on her hull which were clearly visible during the full six hours (6:00 A.M. to 12:00 Noon) that low flying, slow moving, propeller recons distinctly marked with Star of Davids reconnoitered our ship. Overheard radio transmission of the pilots confirmed that the Israel had positively identified the LIBERTY as American.

Suddenly at 2:00 p.m., the government of Israel put a knife in the back of America. In a diabolic attempt at deception, the Israelis began the attack with unmarked et fighters using rockets, canons, and napalm on our unprotected ship. Then three motor torpedo boats arrived on the scene and fired 6 torpedoes at us, one hitting its mark, midship's on the starboard side instantly blowing to bits 25 of America's finest young men. The torpedo gunmen shot at our firefighters and stretcher bearers, using us as target practice, maining and murdering as many of America's sons as they could.

The captain ordered us to prepare to abandon ship as the ship was in grave danger of sinking from torpedo hit that left a 40'x40' hole in her. There were only 3 life rafts left that they hadn't already destroyed. We put them over the side to put as many wounded in as possible. The torpedo boats machine gunned the life rafts and sank two of them and took one aboard their boat no survivors were to be taken! Helicopters were overhead to board our ship with Israeli commandos at the ready to finish us off.

Responding to a S.O.S. from the LIBERTY, the USS SARATOGA launched their jets approximately 15 minutes into the vicious Israeli attack. Within minutes after the launch, incredibly and inexplicably, Washington shamefully and unconsciously recalled the jets, abandoning helpless American sailors under fire, and subjecting them to an additional two hours of barbaric Israeli bombardment and butchery.

Fortuitously when the Israelis picked up an invalid message that U.S. help was on the way, Israel reluctantly was forced to terminate its ongoing assault. Without that break, I would not be alive writing this letter.

Ironically help did not arrive until 18 hours after the attack when it was only 15 minutes away. When an American rescue ship finally arrived, what they found was shocking, the LIBERTY was in shambles, death on the water. There were 821 rocket and canon holes in her hull, thousands of 50 caliber armor piercing, bullets riddling her skin, a tunnel size torpedo cavity in her broad side, and the residue of napalm that had been dropped to burn us up. Blood and body parts were strewn across the deck. A sad, outrageous story, but unfortunately true.

The crew of the most decorated naval ship in American history was ordered to remain silent under threat of court martial, imprisonment or worse, and we all knew what worst meant. The U.S. government has never challenged the obviously phony Israeli excuse of "mistaken identity" nor have they attempted to expose the dishonorable cover up that continues to date. Truth and America's honor were ignominiously sacrificed to provide cover for Israel's transparent lies and despicable act of perfidy.

Israel's premeditated, sneak attack on the USS LIBERTY was a direct attack on America. The disgraceful refusal of unpatriotic American governmental officials of dubious allegiance to defend America and come to the aid of brave Americans under attack can only be characterized as treasonous.

Mr. President, on behalf of the courageous crew of the USS LIBERTY, dead and alive, I respectfully request that you commission a presidential panel to finally investigate the attack and cover-up of the USS LIBERTY, and report the truth to American people.

Thank you, Mr. President. God bless you! God bless America!

- 2) Gentile countries. Herzl also coined the term, "National Socialism," which he said would be the political-economic system for the new Israel. Thus, Zionists were the first Nazi-Sozis. Herzl also predicted that Zionists would find allies in anti-jewish governments, just as they did when Hitler came to power in Germany. The jew Zionists wanted to go to Israel, & the German Nazi-Sozis wanted to help them go there.
- (4) The Nuremberg Race Laws were drafted by the German Nazis, with the help of the jewish Nazis, namely Rabbi Leo Beck, who also wanted the jews' national emblem to be the Star of David, also known as The Mark of the Beast or The Death Star. The Nuremberg Race Laws were based on the race laws of the Old Testament & The Babylonian Talmud of the jews, so that Germans & jews could both agree who was jewish & who was not.
- (5) Swedish Count Folke Bernadotte was trying to reach a peace agreement between jews & Palestinians during the jewish takeover of Arab land in Palestine, for which he was assassinated by the jew terrorists.
- (6) I have no information on Johannes Blaskowitz.
- (7) "Abwehr" was German counter-intelligence, similar to the U.S. Army's C.I.C. or Counter Intelligence Corps. It was headed by the jew traitor, Admiral Canaris alias Meyerbeer, who was executed much too late for Germany. Canaris rejected "Lucy's" (a Turkish spy working for the Abwehr in Istanbul) intelligence on the proposed Normandy Invasion Plan & paid him with counterfeit money. "Amt Auslandsnachrichten und Abwehr" means "Department of Foreign Information & Counter-Intelligence," but I don't know what it did. It may have been under the command of Warlimont (sp?) who did electronic espionage (Elint) for Germany.
- (8) OKW was Oberkommando Wehrmacht, the High Command of the Defence Forces, similar to the U.S. Joint Chiefs of Staff.
- (9) RSHA was Reichsicherheits Hauptamt or National Security Headquarters.
- (10) Militärische Amt is "Military Department," but of what organization, I do not know.
- (11) SD was Sicherheitsdienst or Security Service. This was a branch of the RSHA. Part of its job was intelligence-gathering. I had a good friend who was in the SD, as interpreter for Fieldmarshal Kesselring in Italy.
- (12) The Geheimestaatspolizei, abbreviated as Gestapo, were the German equivalent of the FBI. Like the FBI, they arrested, interrogated, prosecuted, & when necessary, killed opponents of the Third Reich. Gestapo is translated as Secret State Police (of the German State).
- (13) I have no information on Paul Thuemmel.
- (14) "The Gestapo of the rue Lauriston" would be a Gestapo office located on that street (rue Lauriston), most probably in France.
- (15) I'd guess that "Englandspie" means "a spy for England," but in German it would be Spion, which means "spy."
- (16) Euthanasia means "a pleasant death," or a painless method of dying or inflicting death. Veterinarians usually put incurably ill animals to sleep, in which they die under sedation. The USA has tried to execute condemned prisoners painlessly by hanging, shooting, electrocuting, gassing & lethal injections. Hanging & shooting, when done correctly, are painless, since all one feels is the shock which breaks the neck or stops the heart. Electrocution is supposedly capable of knocking out the condemned, so he feels nothing, as the electricity kills him. I have seen electrocutions, & it doesn't look so painless, but it could be reflex action, as when a chicken runs around after its head is chopped off. Gassing is said to be painless, but I'm not sure, & so is lethal injection, which is now controversial in regard to pain.
- (17) I assume that the 4 Year Plan of 1936 was a further development of Hitler's program to achieve full employment, thereby getting Germany out of The Great Depression, as well as achieving German rearmament & other National Socialist programs.
- (18) The 1937 Hossbach Protocol sounds vaguely familiar, but I'd just be guessing as to its contents.
- (19) I have no information about "the SIPO Security," sorry!
- (20) Pseudo-Darwinian philosophy sounds like "social Darwinism," in which some points were selected from Darwin's book for application to social behavior &/or legislation, as Bible passages are used selectively to justify war or peace, for example.
- (21) My figure for the victims of The Katyn Forest Massacre is 15,000 Polish officers. I believe both the Germans, other national observers & the Soviets counted the bodies entirely. I have seen a film of the Germans exhuming the bodies, then the Soviet film of the same. The

3) Germans wanted to blame the Soviets for the massacre, which was true, since Stalin ordered the massacre & it was carried out by the jews of the Soviet NKVD, their version of the Gestapo. Later, the Soviets tried to blame the Germans for the massacre, by digging them up again, & by indicating how each corpse had been shot in the back of the head, just above the neck. Since both sides wanted to blame the other side for the massacre, they had motive to reveal the actual number of bodies. Why your source would claim a lower number is due to the failure of the USSR to blame the massacre on the Germans, as they tried to do, so they attempted to reduce the size of the Soviet atrocity. Forensic experts proved that the Poles died in 1940, at least a year before the German forces invaded that part of the Soviet Union, & that the trees planted over the mass graves showed at least a year of growth on the spot, before the Germans arrived. Hence, the Soviet Union was clearly responsible for The Katyn Forest Massacre. In fact, it was local people who informed the Germans of the mass grave's location.

22) Otto Skorzeny was brilliant, brave & versatile man. He tried to convince Hitler that German forces were just close enough to the Soviet industrial areas for him to launch a commando raid on key parts of Soviet industry, but OKW refused to approve the operation. He also advised Stalin's capture &/or execution by landing gliders in Red Square. Skorzeny also led the Brandenburger Division of soldiers who could speak foreign languages. The Brandenburgers would wear Red Army uniforms & use Red Army weapons & vehicles to fool the Red Army rearguard into thinking that the Germans were Red Army stragglers fleeing the German advance, so they would allow the trucks to cross a bridge before they blew it up. When the trucks reached the Soviet side of a bridge, the troops would leap out & shoot the Soviet demolition teams. This is what Skorzeny did to save the Romanian oilfields: he went in disguised in Red Army uniforms & shot the Reds who were going to blow up the oilwells. A friend of mine, geologist John Burton, was asked how much oil the Germans had. He reported "Two weeks, maximum!" The Germans were able to conserve what oil they had stockpiled, plus they captured the Romanian oilfields & they were able to make oil & rubber out of coal, so John Burton's estimates were way off, as he did not mind saying. Skorzeny was also in command of a Brandenburger operation to get German troops behind Allied lines during the Battle of the Bulge, wearing Allied uniforms. Rumors were that Eisenhower was their target, so the U.S. forces kept Eisenhower a prisoner in his H.Q.! Skorzeny retired to Madrid, Spain. His most publicized operation was the rescue of Mussolini from a mountaintop resort in Italy, where he was being held prisoner, after the Italians switched sides in 1943. Hitler returned Mussolini to rule Northern Italy until the end of the war.

23) ODESSA was the alleged escape & protection organization for former SS members. I'm not sure how much was reality & how much is jew propaganda.

(24) As far as I know, there were at least 40 divisions of the Waffen SS, each of which represented a nationalist organization. The accompanying photocopies refer. Sorry, I don't know all their names.

(25) I know very little about the National Socialist Movement. The jews always wanted a U.S. Nazi group which they could use as an excuse to raise funds for jewish groups, so we must ask, "cui bono?" Is such a group good for Whites, or for jews? I think that the White Power Movement was more appropriate for these times & this place, just as Hitler would not have chosen to call his political movement the "German KKK," & wear their bedsheets as uniforms. Hitler chose to call his pro-White movement "National Socialism" because those words meant something relevant to his people in his time, but do these words which were appropriate to Hitler's Germany have relevance to today's America? If the NSM is genuine & not a ZOG outfit, I wish them all the best, but I question their choice of name & garb as being outlandish & out of time. Why have a name which must always be explained, for one thing? Since there are jew National Socialists & Mexican National Socialists, it might be correct to have a White National Socialist Movement, too! But why not call it The White Power Movement?
