



## The Grand Misalliance

**D**iplomat, international lawyer and distinguished statesman (a former Undersecretary of State in the Kennedy and Johnson administrations), George W. Ball and his historian son, Douglas, have produced a landmark critique of the U.S.-Israeli relationship (*The Passionate Attachment: America's Involvement with Israel*, W.W. Norton: N.Y.). A detailed history of American involvement with political Zionism, the book discusses the ideological foundation of Israel; traces the sequence of events that brought America into this unique relationship; reveals why America became so deeply involved with Israel; discusses the immense moral, political and financial costs of the relationship; and, finally, offers recommendations to alleviate the major problems and tensions. Despite the stature and prestige of the senior author, the overall importance of the issues raised and the power of its arguments, this definitive study has been largely degraded or ignored by the mainstream media.



In the beginning was the WORD. The state of Israel, as conceived by Zionist ideologues, was to be: (1) independent of any other power; (2) a state exclusively for Jews, managed by Jews, for the benefit of Jews; (3) based on democratic principles.

Coupled with these objectives were detailed schemes for the forced deportation of non-Jews from the proposed Zionist state. The Balls write:

The Jewish plan for an exclusively Jewish state, free of the inconvenient presence of native peoples, was scarcely new. Theodor Herzl [founding father of modern Zionism] had laid out the framework for such a system in 1898, when he sought a charter from the Ottoman Sultan. . . for the Jewish Colonial Society. . . One of the provisions of that abortive charter gave the Society the power to deport the natives, and Herzl sought such powers whether the new Jewish homeland was to be in Argentina, Kenya, Cyprus or Palestine. The Jewish Land Trust incorporated this doctrine in its rules, which designated all its properties exclusively for Jewish use and even prohibited the employment by the Jewish tenants of non-Jews, thereby forcing such persons to seek employment abroad [p.29].

Predictably the Zionists ended up producing an Athenian democracy for Jews and second-class citizenship or feudal servitude for non-Jews (p. 65).

In contemporary American society the "ultimate sin" for a white Gentile is identification with any form of nationalism. America poses as the opponent of all forms of "racism," yet ardently promotes and subsidizes political Zionism—an ideology of Jewish exclusivism which is inextricably tied to plans for the forcible deportation of non-Jews. This egregious double standard explains how organized Jewry enforced its hypocritical dual code of "morality" on the American people.

Although the Balls do not comment upon the U.S. government's blatantly different treatment of Israel and South Africa, they note:

South Africa is moving. . . toward an abolition of apartheid and ultimately a more equitable sharing of power with its black majority; but no parallel reforms are visible in Israel's relations with its Palestinian residents [p. 290].

The title of the Balls' book was inspired by Washington's Farewell Address. The first president believed that America, in shaping its international relations, should abjure any "passionate attachment" to a foreign nation. Washington surmised, correctly as it turned out, such an attachment results in "concessions to the favorite nation of privileges denied to others."

American foreign policy grants Israelis the right to maintain a state exclusively for Jews, but consistently denies white South Africans the right to maintain a state exclusively for whites. No American president would ever demand that Jews and Palestinians forcibly integrate and create a "multiracial democracy" with power shared equally between the two groups. But our modern presidents stridently demand that South African whites and blacks integrate and that whites accept "black majority rule."

In the first part of *The Passionate Attachment*, covering U.S. administrations from Harry Truman to George Bush, the Balls assess America's growing involvement with the Zionist lobby and the state of Israel. They show how American policy in the Middle East was and still is a "progressive retreat from principle." With the exception of Dwight Eisenhower (and to a minor extent Bush), every president since 1947 consistently adopted policies that served Israel, while undermining American interests and peace in the region.

In his memoirs President Truman commented: "The Department of State's specialists in the Near East were, almost without exception, unfriendly to the idea of a Jewish state." The professional diplomats were well aware that the establishment of Israel would spell real trouble for

America and the rest of the world. Nevertheless, in 1948, when pre-election opinion polls showed Truman far behind his Republican rival, Thomas Dewey, he "knew he would need every vote he could get and that the Jewish-American population could very well turn the balance."

The rest is sad history, as Truman caved in to Zionist demands. On the eve of the election the President declared: "Israel must be large enough, free enough, and strong enough to make its people self-supporting and secure." Truman won, thanks partly to 75% of the Jewish vote, partly to Jewish media clout. In January 1949, Truman saw to it that Israel got a \$100 million loan. Subsequently the doctrine of Jewish exclusivism was combined with Zionist expansionism, thereby embroiling future generations in an endless series of Middle Eastern wars. Tom Segev, one of Israel's most credible journalist-historians, admits the obvious: "Israel was born of terror, war and revolution, and its creation required a measure of fanaticism and cruelty."<sup>1</sup>

In the course of Truman's dealing with Zionism a pattern emerged which has become all too familiar in American politics. The Balls observe: "Just as in Washington's day a powerful American faction was attached to France, today an even more powerful faction is passionately attached to Israel, producing a variety of evils [p. 10]." In starker terms the Zionist lobby is an alien element within America, prodding the executive and legislative branches of government to adopt policies that work against American interests.

The Balls have this to say about the Eisenhower presidency:

Because he had been elected by a landslide, in the face of overwhelming Jewish support for Adlai Stevenson, the general was under no obligation to the Zionists and was therefore largely immune to the domestic forces that had heavily influenced Harry Truman [p. 42].

Unlike his predecessors and successors, Eisenhower implemented policies which served U.S. not Zionist interests. His Secretary of State, John Foster Dulles, stated the administration's goals in these terms: "I am aware how almost impossible it is in this country to carry out a foreign policy not approved by the Jews. . . . I am going to try to have one [p. 47]."

During the 1956 Suez crisis Eisenhower ordered Israel to pull back its forces from the Sinai to the Israeli border. If Israel didn't comply, he would consider cutting off the flow of all aid. Running true to form, the American Jewish

lobby shifted into high gear to get the President to soften his policy. When Eisenhower refused to budge, Israel capitulated. In March 1956, Jewish troops withdrew from almost all the territories they had occupied in the Suez offensive (pp. 46-48).

Unfortunately the pattern set by Eisenhower was abandoned by successive U.S. presidents. The Balls underscore one of the major reasons:

Unquestionably, a large amount of campaign money raised—perhaps 90 percent—particularly for Democratic candidates, comes from Jewish sources. Eighty percent of the Democratic 1952 presidential campaign funds. . . came from that source. The Republicans, while less dependent, are thought to receive nearly 60 percent of their funds from Jewish contributions [p. 218].

The Balls describe Lyndon Johnson as a "man of notable acumen in domestic politics, well aware of the critical Jewish role in Democratic party concerns [p. 52]." It was during his tenure that the American branch of International Zionism rose to a position of dominant influence in American Middle East policy. His administration put the U.S. in the awkward position of being Israel's principal arms supplier and sole, all-out, uncritical backer (pp. 65-66).


The most shocking incident during the Johnson years was the attack on the *U.S.S. Liberty*. Although the ship flew the American flag and was painted with U.S. Navy colors, on the fourth day of the 1967 Arab-Israeli War, the Israelis attacked, presumably thinking it vital that the *Liberty* be prevented from informing Washington of their intention to violate a cease-fire with Syria before they had completed their occupation of the Golan Heights (p. 57).

Thirty-four Americans were killed and 171 wounded. Subsequently, Israel claimed that its forces mistook the ship for an Arab one, notwithstanding that it was a clear day and the ship was clearly marked. The attack was preceded by more than six hours of intense low-level surveillance by Israeli photo-reconnaissance aircraft.<sup>2</sup>

Commenting on this sordid affair, the Balls write:

The ultimate lesson of the *Liberty* attack had far more effect on policy in Israel than America. Israel's leaders concluded that nothing they might do would offend the Americans to the point of reprisal. If America's leaders did not have the courage to punish Israel for the blatant murder of American citizens, it seemed clear that their American friends would let them get away with almost anything [p. 58].

Ronald Reagan represented that branch of the WASP Establishment which, however wrongly, believed Israel to be a strategic asset. More specifically, he viewed the Jewish state as a bulwark against Communist expansionism in the Middle East and other areas of the globe. The U.S.-Israeli alliance blossomed during his eight years in office.

Was Reagan correct? Could it be, that in spite of Israel's nasty habits, the Jewish state is beneficial to U.S. interests? Israel's gatekeepers in the mass media enthusiastically respond "yes." In the words of Daniel Pipes, the director of the Foreign Policy Research Institute:

While charging Israel with being "monstrously" costly to the United States, the Balls ignore Israel's well-documented and considerable benefits to this country. Looking at just the military angle, Mideast expert Steven Spiegel has demonstrated that Israel's intelligence capabilities, combat experience, technical innovations and battlefield successes have saved or earned American forces many billions.<sup>3</sup>

The Balls reply by asking rhetorically: "Are we [the U.S.] getting anything faintly resembling a reasonable return from the costs we are incurring [p. 279]?" They would not deny that meager benefits have accrued to America from this "special relationship." They insist, however, that the costs far outweigh any alleged benefits.

With the collapse of communism in the Soviet Union and elsewhere, Israel no longer serves as a bulwark against Soviet imperialism. With hindsight it could be convincingly argued that America's backing of Israel during the Cold War actually bolstered Soviet aggression. By playing the role of Israel's unqualified supplier and backer, the U.S. actually drove many fervently anti-Communist Arab nations into the Soviet camp.

Counting up the financial costs, the authors point out that American aid to Israel well exceeds the total of what the U.S. paid to reconstruct postwar Europe. They calculate that between 1948 and 1991 America subsidized Israel to the tune of \$53 billion. They add:

No one can seriously deny that Israel receives from America at least \$4 billion of annual aid, plus extras, or that in seeking to support Israeli interests, America also provides Egypt over \$2.1 billion per year. Although those payments represent heavy costs for America, they are only a fraction of the total burden borne by all sectors of American society—taxpayers, industrial workers, bond or shareholders—when American companies have lost markets for political purposes or have been prevented from making lucrative sales by the intervention of AIPAC [American Israel Public Affairs Committee]. These losses occur at a particularly sensitive time when America is scaling down its defense purchases and there are heavy layoffs in the defense industries [pp. 278-79].

The moral and political costs of the "special relationship" are also enormous. While the U.S. transfers billions of dollars to Israel, the latter frequently and blatantly undercuts American aims not only in the Middle East but in other parts of the world as well. For example, the U.S. poses as the champion of human rights, yet stands silently by while the Israeli army systematically violates the human rights of the Palestinians in the occupied territories (pp. 283-84). America declares its opposition to the spread of nuclear, biological and chemical weapons, then turns a blind eye to Israel's activities in all these areas (p. 294). Also one must not forget the cases of deliberate Israeli attacks on U.S. property such as the Lavon Affair of 1954, when Zionist agents firebombed American Embassy

installations in Cairo and Alexandria in an attempt to sabotage U.S.-Egyptian relations.<sup>4</sup>

Regarding the alleged benefit of "Israel's intelligence capabilities," former CIA Director Admiral Stansfield Turner deemed this to be a myth:

Israeli military intelligence has failed. Ninety percent of statements made about Israel's contributions to America's security are public relations.<sup>5</sup>

According to former Mossad operative Victor Ostrovsky, in 1983 Israeli intelligence agents knew beforehand that the U.S. Marine barracks in Beirut would be attacked by a suicide truck-bomber, but deliberately failed to warn Washington, cynically choosing to let 241 Marines die to provoke American hatred for Arabs.<sup>6</sup>

Finally, in reference to Israel's combat experience, technical innovations and battlefield successes which have allegedly saved or earned American forces many billions, the claims are also to be taken with a grain of salt. Israel has the habit of re-exporting for profit highly classified U.S. military technology. While on the one hand their technical innovations may save the U.S. money, they stab America in the back when they re-export the same top-secret technology to nations around the globe.<sup>7</sup>

In his review of *The Passionate Attachment* the retired foreign service officer and publisher of the Washington Report on Middle East Affairs, Andrew Kilgore, correctly identified the "twin engines" of Zionist power in America: "the purchase of immense influence in Congress, and the manipulation of fanatical loyalty to Israel by individuals within the U.S. media."<sup>8</sup> The Balls extensively discuss Jewish influence over presidents and Congress, while writing next to nothing about Jewish influence in the mass media. Perhaps the primary reason America is so slavishly bound to Israel is not the political sellouts who have put the interests of Israel above those of their own country, but the Israeli Firsters who dominate the media and never cease harping on the non-fact that "the U.S.-Israeli alliance is good for America."

# John Tyndall—British Majority Leader

When the history of the English-speaking peoples in the 20th century is written, the name of John Tyndall will occupy an honored place. Tyndall, the leader of the British National Party and editor of *Spearhead* (Box 117, Welling, Kent DA16 3DW, England, \$25/12 issues), is an activist who has put his freedom on the line for all of us.

I obtained my copy of Tyndall's *The Eleventh Hour* from Historical Review Press (Box 2010, Decatur GA 30031). It was written while the author was a political prisoner in a British jail for an offense considered heinous and vile by our liberal-minority masters—namely, telling the truth to one's own people. Tyndall could not have been sent to jail in the U.S. for what he has said and written, not yet at any rate, though he was prevented from making a U.S. speaking tour in 1990, being put on the next plane back to England when he landed in Charlotte (NC). In a second try, in 1991, the immigration agents let him through and he spoke at right-wing rallies in several cities. The minor defeat no doubt inspired clumps of greasy shysters and ADL staffers, hunching over dimly-lit tables, to speed the day that America will have laws as repressive as Britain's.

Simply stated, the rot has gone to the bone in the U.K. You can be arrested and jailed for merely offending a minorityite. Although Tyndall was never informed exactly what it was that he said or wrote that landed him in jail, it was probably a mix of public comments and printed articles casting doubts on the notion that all races are equal. For that he had to spend six months in a miserable prison filled with the dregs of humanity.

Tyndall recently wrote an article for *American Renaissance*, an outstanding monthly newsletter (Box 1674, Louisville KY 40201, \$20/12 issues). Although most of the article deals with his experiences and travails in the Sceptred Isle, Britain's leading rightist also offers some good advice to Americans. He warns us of the dangers of so-called "hate gag" laws, designed to prevent the publication of pro-Majority political material. He urges our activists to keep their written material on a high plane and avoid crude, offensive jabs at our opponents. The "hate gag" laws in the U.S., he asserts, have done some good by forcing Majority writers to refine their thinking and inject more intelligence in their literary outpourings.

As Tyndall puts it, "I have read some American publi-

cations in which the writers, because they are free of legal restraints, express themselves in terms that are so downright lowbrow that they appeal only to the mentally mal-adjusted." Britain's #1 nationalist is right on target. We must all guard against the natural tendency to let our rage, bile and bitterness overflow the printed page. One day we have to take our country back, and we can only do it with the support of the vast mass of decent, ordinary Americans who understand and applaud frank, tough and honest talk.



They will not respond to naked calls for hatred. I admit I have to catch myself sometimes to tone down my comments. Humor directed at our enemies is acceptable, but when we write about serious topics, let's keep it serious.

While I consider all white activists my brothers and our British cousins to be our closest overseas allies, conditions in the two countries are quite different. We must recognize this and make the necessary allowances.

On the other hand, if the putrid plutocrats who are currently running Britain think that a Majority-ruled

America will stand idly by and allow the cradle of the Anglo-Saxon race to go down the drain, they are sadly mistaken. When America becomes America again, woe to any minority or socialist British government that thinks it will be able to toss men like Tyndall into the slammer for printing the truth about what is happening to his country. We will be prepared to respond in such a way that jailing British Majority activists will no longer be considered a practical political tactic. At such a time we won't care what a few dozen Pakistani, West Indian or Jewish M.P.s have to say about our intervention. As for the pack of racial traitors that are running once great Albion into the ground, we will develop a special plan for them.

Tyndall is a great figure in the British Majority movement and a great friend of America, our America, that is. While I respect his opinions, I believe that it is important that he and his British National Party activists understand what is going on here.

The U.S. as we have known it is dying. In this country we are headed for a violent confrontation with forces of the liberal-minority coalition. Nothing can stop this now. # Prophetic Guru Misses the Boat!

The bull market in the prediction and megatrend business that got underway several decades ago still shows no signs of a downturn. The times, nervous and shuddering, encourage political scientists and financial gurus to join the astrologers and psychics in the soothsaying trade. Prophecy is a solid prescription for a bestseller, provided it doesn't stray too far from the parameters of political correctness.

Paul Kennedy has emerged as the Establishment's chief chronicler of economic, technological and political trends, a prolific reader of the tea leaves piling up in the global cup. He hit the bestselling bull's-eye five years ago with *The Rise and Fall of the Great Powers*. His latest opus, *Preparing for the Twenty-First Century* (Random House, 1993), looks like another chartbuster.

Drawing on numerous sources both popular and scholarly, Kennedy marshals what he perceives to be the most significant trends that will shape the world for the next 30 years: the demographic explosion in the Third World; the looming environmental disaster; and the flood of technological advances, especially in the fields of robotics and biotechnology.

There's little bold prognostication in Kennedy's work, but rather a juxtapositioning of the views of the pessimistic neo-Malthusians (of which he may be considered a prudent camp follower) and those of the optimistic "cornucopians"—views embodied in a plethora of "on the other hand" cautions. Kennedy spins the wheel and sets the ball rolling, asking only that you place your own bets.

There's some merit in this approach since a modern Rosetta Stone to decipher the future is lacking. Forces that in 1993 can hardly be imagined may spring from the earth to alter the strongest currents. Still, some trends are so destructively potent that an excess of ambivalence serves poorly to elucidate them. If one is speaking with a tongue skewered by a politically correct fork, it will often be too tempting to opt for a confusing "balance" when a clear tocsin is what is desperately needed.

Kennedy, an Establishment pundit, is a Yale history professor who uses the word "white" only in quotes and prefers to refer to the onrushing demographic nightmare as a conflict between North and South, or, more often, between "developed" and "developing" countries. The population bomb, exploding northward from the south, is putting the "developed" lands "under siege from tens of millions of migrants and refugees eager to reside among the prosperous but aging populations of the democracies." One example: in 1950, Africa had a population half that of Europe; by 1985 it was even; by 2025 it is projected to be three times that of Europe—1.52 billion to 512 million.

All the "developed" countries, Kennedy states, are ex-

periencing negative birthrates, except Sweden. There the fertility rate has risen steadily from 1.6 in 1983 to 2.1 in 1990, which the author attributes to paid maternity and paternity leaves, extensive child care, comfortable housing and—oddly—widespread "gender equality." The question, though, is whether most of these births are of white babies or of the mudlings who have been crowding into Scandinavia.

In "developed" societies like the U.S., Kennedy muses that the "graying/browning tendency may be setting up a massive contest over welfare and entitlement priorities between predominantly Caucasian retirees and predominantly nonwhite children, mothers and unemployed, each with its own vocal advocacy organizations." (The problem here is that the chief advocacy group of the elderly whites, the American Association of Retired Persons, has long ago absorbed the propaganda of the other side.)

Japan also has a rapidly aging population, but steadfastly says no to immigration. The Japanese lead the world in robotics, which should mitigate any labor shortage that may develop in the future. As Japan imitated Western technology, the West could now wisely imitate Japan's policies regarding immigration and robotics.

Kennedy describes European and American resistance to massive immigration with the liberal scold terms, "nativist prejudice" and "nativist reaction." He then notes that Japan's ability to create wealth "rests upon strong foundations. These include the social and racial coherence of the Japanese people themselves, who have seldom intermarried with other ethnic groups. . . ." But looking over his shoulder for the ubiquitous Thought Police, he confesses to being "disturbed" by the "tactless" comments of Japanese leaders about American minority groups, which indicate a "deep streak of racism" in the Rising Sun. Further, "antiforeign political movements. . . hurt [the democracies'] long-term chance of 'preparing' for the future."

In his desire to cover all bases Kennedy constantly backtracks yet seems to believe that the sepia flow of bipeds from South to North is irreversible, perhaps even a natural phenomenon. He also intimates that the greed-motivated corporations of the new "borderless world" are the inevitable overlords of our future. (He does acknowledge, however, that there is more resistance to this concept in Europe than in the U.S., and that factory relocation to the Third World would be more effectively resisted in the mother continent due to a "deeper sense of company roots and more interventionist state traditions. . .")

The overmuch concern with regions and nations rather than bloodstreams, the failure to explore qualitative differences among human populations, serves to diminish the usefulness of *Preparing for the Twenty-First Century*, at least

to those who did not just perceive the gravity of the problem yesterday. Kennedy, a veteran guru, knows very well that an author gets published by a major house and sells tons of books only by working behind the Kosher Kurtain. For instance, in regard to the average decline in test scores, and thus in intelligence, among U.S. students, Kennedy says that "the root cause is still not clear." (Really, Professor?) At the same time he tells us that race is one of the many topics "vigorously debated" in the U.S.! (Will Random House publish *The Dispossessed Majority*, Professor?)

There are far too many such disingenuous comments, suggestions and omissions to make Kennedy's tome more than a mildly interesting survey. You won't find in it any statements, such as the one George Kennan made in a recent book: "[T]he inability of any society to resist immigration is a serious weakness, and possibly a fatal one."

It could be reasonably argued that a more candid and reality-based look at these megatrends would mean the certain end of a cushy Ivy League job and the Professor's descent into non-personhood. Given his position in a politically correct and politically corrupt pecking order, Kennedy might be credited for doing the best he could. That would be a valid argument if the work had been published about 20 years ago. Today it is just too late in the game for these lightweight and race-timid assessments.

Kennedy wishes us to believe that the "developing" nations are now in the same position as Europe was two centuries ago, i.e., agrarian-based, with births exceeding deaths. He thinks it "ironic" that the "developed" nations should now be complaining about immigration, since one of the ways they shed their own excess populations was by large-scale movements to North America, Australia and other far lands. At one point he poses the question:

What does it take to turn a 'have-not' nation into a 'have' nation? Does it simply require imitating economic technique, or does it involve such intangibles as culture, social structure, and attitudes toward foreign practices?

Please, Professor, listen up! The dark spots on the globe are *not* in the same position Europe was in 1800. The death rate then was being reduced by medical practices and techniques developed by those in the same gene pool as the rest of the burgeoning population. This is the same gifted gene pool that brought about the revolutions in agriculture which allowed its members to feed not only their own peoples, but many in the darker world as well. The population surges in the "developing" areas are due, as Kennedy himself notes, to the importation of Western medical practices. Consequently the dark birth boom is unnatural, artificial, the result of outside interference. The point is, the natives do not have the genetic ability to resolve their enormous problems. Their migrations to Western lands simply spread the misery and guarantee—if not stopped and reversed—unmitigated and universal disaster. So how does a "have-not" nation become a "have"? By importing several hundred million people from Northern Europe and Japan. There is no other way. Kennedy, however, does not have the courage to say so, nor will he ad-

mit that the most prosperous black masses on the Dark Continent reside in South Africa, the ungrateful beneficiaries of the White Man's Burden.

The hovering environmental catastrophe will surely descend on the world, without a drastic reduction in the nonwhite populations. While Kennedy admits that if the per capita consumption of the Chinese ever reached that of the U.S. "the environmental damage would be colossal," he goes on to smugly state that the "developed" nations are the major consumers of the world's energy resources. Yes, but we Westerners are also the ones who produce most of the world's wealth, the same wealth that feeds the hungry, fly-swarmed mouths of Africa. We too are the only ones with the genetic potential to control further environmental damage and to reverse at least some of it. Meanwhile the primitive peoples of the Amazon rain forest will burn down every last tree if there is no effective outside intervention.

With a "developed" political will the white nations can both control the forces of unrestricted global capitalism and stop and reverse the deadly invasion of darklings. In Somalia rations should have been given only to those women who agreed to accept Norplant. Increased rations (and perhaps some nice, shiny beads) could have been supplied to males who would accept vasectomies and females who agreed to be sterilized. Of course, the wailings from the professional darklings would have been thunderous. But with the requisite political will the bleatings of the slobbering "humanitarians" would fade into the night, while the long-term benefit to both the West and Somalia would be immense. In any case a regenerated political will dictates no food, medical or technological aid to the Third World without stern measures of population control.

If the whites do not at least replace themselves (in laboratory test tubes if necessary), the resulting devolutionary regression will inflict irreversible calamity upon the entire planet. We will all go forward to the past, to a primitive and undifferentiated world of squatting fellaheen and ultimately into the primordial swamp, all in a few historical milliseconds. As the Professor himself says:

As the better-off families of the northern hemisphere individually decide that having one or at the most two children is sufficient, they may not recognize that they are in a small way vacating future space. . .to faster growing ethnic groups both inside and outside their national boundaries. But that, in fact, is what they are doing.

The regeneration of the political will of the white world is *the* major consideration of the next century. How this comes about—whether gradually or as the final, frantic reaction of a man going under water for the third time—is not important. What is important is that it comes about at all. But Professor Kennedy neatly skips over the vital matters. Despite flashes of probity, in the end he seems more a tipster of modern democratic biases than a proper and prophetic guide to the harrowing decades in store for us.

## The Left-Right Business

**W**e have, all of us I am sure, struggled to get at the root of the left-right dichotomy. Most people associate the left with big government and the right with small government. Left-wingers are forever advocating programs that will expand government; right-wingers putting forth proposals to contract it.

But there are other aspects of the left-right dimension. Left-wingers tend to be moral relativists, when it comes to such matters as adultery and homosexuality, whereas right-wingers tend to be moral absolutists. Left-wingers champion cultural diversity, right-wingers this thing called Western Civilization.

Left-wingers depend on environmentalists for explanations of human behavior. On the subject of environmentalism there is no unified right-wing response. Some right-wingers champion free will, holding criminals and other deviants, as well as underachievers, responsible for their misbehavior. But other rightists believe biological factors are the chief causes of misbehavior and inequality. What unites these two right-wing sects is their unwillingness to hold society—other people—responsible for its acts. In any case, both kinds of right-wingers accept inequality of achievement as natural. Inequality can be traced to a lack of discipline and effort, say the free-will rightists. Biological inadequacies are to blame, say the hereditarians.

So perhaps the root idea behind the left-right division is not the size of government but the equalitarian doctrine. Left-wingers want big government, not really for its own sake, but in order to carry out the massive reforms of society that have led to “unjustified” inequalities. Inequality is nobody’s fault but society’s.

For leftists, intergroup inequality (racial inequality, especially) is just as much society’s fault as intragroup inequality (class inequality, usually). That the separate races ended up with equal mental capacities is, as readers here well know, an article of faith and nowhere the result of any scientific investigation. The odd thing is that free-will right-wingers accept this bit of unsubstantiated anthropology, but blame individual members of underachieving races for their lack of discipline and effort. It is only the hereditarian right-winger who will absolve everyone and everything from blame by stating that underachievement of certain races is not the individual’s fault nor society’s fault; it is the fault of evolution. Are we to indite evolution and bring him/her/it before the Court of Biological Laws?

The fact is, there are no true left-wingers, for if society is everything, so are the left-wingers, who are part and parcel of society. There is no point advocating reforms, if there is no free will to make them effective. Though we do have biological natures, the common practice of left-

wingers is to invoke social explanations, the great exception being to blame their critics for disagreeing with their agendas. Free will, of their opponents, now runs in full blast.

Well, back to the drawing board. The environmentalists stay on the left, but this time let’s add in the free-will crowd. The free-willers also love to blame things, different things, on individuals, not on society, and blame away they do. Free-will right-wingers very much want the various races to be all equally achieving and insist that it is possible. They claim that left-wing policies prevent this equalitarianism, whatever the leftists’ proclaimed intentions and hopes. Left-wing programs are perverse: they have perpetuated poverty. Let us be in charge, free-willers say, and the races shall become equal.

So free-will rightists do indeed blame society, not the oppressive nature of capitalist exploitation or racism, but the society engendered by big government with its affirmative action programs. The free-willers want to run things, not to run big governments necessarily, but to be in charge.

Hereditarians, by contrast to both groups, say none of this matters. Intragroup and intergroup inequality will persist no matter who is in charge. True enough, the nature of the social system will affect who gets on top: business entrepreneurs under capitalism, political entrepreneurs under socialism, and a mix under our current combination of big government and managerial capitalism. Nevertheless, the degree of inequality will not change much.

Hereditarianism, of the whole hog variety, is a caricature just like the other isms, since the inequalities of outcomes produced by racial differences are changing. The Japanese were not responsible for either science or capitalism, but their living standards are much, much higher, relative to those of Europeans, than they were a hundred years ago. Even their life expectancy is now longer, though this is partly due to diet. On the other hand, life expectancies are actually decreasing in a number of African countries. All in all, however, the overall trend worldwide during this century has been to reduce racial inequality. In the four centuries before that, racial inequality expanded as Europe left all other parts of the world in the dust.

If we think of equality as the fundamental idea behind the left-right dichotomy, environmentalists go on the left and free-willers and hereditarians on the right. But if we look at fixity as the fundamental idea, only hereditarians go on the right (remembering that fixity is not absolute).

Environmentalists and free-willers are both left-wing, since they both think racial inequality will disappear if they were in charge. However, most hereditarians today

tend quite strongly to be right-wing in other areas. So strong is their tendency to focus on individuals that maybe hereditarians and free-willers are more alike than they are different.

For hereditarians, it's heredity, free will and environment, in that order. For environmentalists, it's environment, free will and heredity. For free-willers, it's free-will, environment and heredity. No one puts free will last. There are three other possible rank orderings. Hereditarians could hold environment to be more important than free will. Recall the days when certain racists supported socialism. Free-willers could rank heredity ahead of environment. Some of the Old Right libertarians thought this way. Today, family-value Christians, neoconservatives and libertarians all put heredity last. It is also possible for environmentalists to put heredity ahead of free will, as did the Behaviorists who reduced man to a machine during the 1920s, not a few of whom were closet racists. You could add Karl Marx to this group.

As the writer of this article and almost all of his readers are hereditarians, first and foremost, with whom should we consider making alliances? There are not many socialist hereditarians out there any more. (Was Jack London a racist socialist or a socialist racist?) So we are just about

all the hereditarians that can be found. The current crop of free-willers usually rank heredity last. However much we are attracted to their insistence that free will is more important than environment, I think we should stay away from them. That we should stay even further away from the current environmentalists, since they have everything completely backward, goes without saying. Are we all alone? Not quite. There are a few Old Right libertarians around.

As a parting shot, here's something to think about. Left-wingers, for all their talk about moral relativism, are also universalists, globalonists, and centralizers. Right-wingers, especially when they have the Bible or the Pope in mind, speak of moral absolutes, yet advocate local government and national sovereignty. I see a gigantic contradiction here: one can't be both universalist and localist at the same time. Resolving it may get us to a deeper concept of left-right. Or it could be that relativism is the right idea after all and that leftists need to shed their environmentalism, egalitarianism and big governmentism and adopt Wilmot Robertson's vision of a world of ethnostates. An intriguing thought. We racists may have been the real leftists all along.

## Equalitarian Obscurantism Hamstrings Scientific Research

The essence of the scientific method is control. Only by eliminating extraneous sources of variation can we be sure that the factor or factors being manipulated in an experiment are the real cause of the results. To take a simple example. If you want to test whether an oil additive *really* increases automobile gas mileage, you would need to work with two groups of automobiles of identical make, year and mileage. Equally important, the tests would have to be conducted under identical driving conditions. The one and only difference would be that the gas tanks of the experimental group would have the oil additive. The control group would not.

Consider testing a new drug, say for high blood pressure. The easiest, least expensive and routine first step is again to make the control group and the experimental group as identical as possible. When animals are used, they are often rats of the same laboratory-produced strain.

Moving on to human testing, mem-

bers of the two groups should be of the same age, race and sex. Generally the group most prone to the ailment is used for the initial testing. If the results are significant, further experiments are performed, using larger groups matched for age, race and sex. Instead of comparing five whites against five other whites, you compare one group composed of five white males, five white females, five black males and five black females against a similar group. You must analyze not only the effect of the drug, but also the race/sex/drug interaction effects.

The rule all researchers learn in their experimental design classes in graduate and medical school is to "start simple." If successful, proceed to the more complex. Unfortunately the rule is no longer observed. Section 131 of the National Institutes of Health Revitalization Amendments mandates that women and members of minorities *must* be included as subjects in medical research experiments!

The medical researcher now must

choose between: (1) using small groups that are racially and sexually mixed for both his experimental and control groups (thus obscuring any results), or (2) greatly expanding the number of subjects and using more complex experimental designs that statistically adjust for sex and race, thus making the initial experiments prohibitively expensive. The net result is that fewer experiments will be performed. As we are forced to pay more for drugs, the U.S. will lose even more of its market share to the Japanese and Swiss, who will not be limited by such restraints.

The great irony is that just as the political establishment is mandating equality in medical research, the scientists are finding that genotype and race are critical variables in diagnosis and treatment. Huge scholarly tomes have been written recently on "Race and Medicine." The result of legislation like Section 131 is that all of us, women and minorities included, will get worse, not better, medical treatment.

The Chicana, 300 pounds of tortillas, guacamole and pulque, howls and rolls in the aisle. Clinton is on his feet in an instant, both hands reaching towards the sky.

Shouts from the back of the hall.


Let him speak! Keep talking!

# Washington Folderol

A D.C. friend who slaves for the Department of Energy recently took up new office digs in a sleazy building on (racially) dangerous North Capitol Street, not far from the city's imposing *fin de siècle* Union Station, an architectural testament to the city's Majority past, when normal folks walked safe streets to work. Relishing the chance of spending lunch hours rambling through the Station's Beaux Arts splendor, my friend soon realized that the five-minute sidewalk trek exposed him to all manner of shakedowns, curses, roustings (and worse) by North Capitol Street's black army of winos, pimps, whores and sexual degenerates—all, mind you, within slingshot distance of a police station. For this fellow and ten thousand other Capitol Hill workers, the simple act of daytime pavement trudging is mind-numbingly fearful. Even the toadies and poobahs of the political establishment, usually ensconced behind heavy oak-paneled doors, now find their privileged existence often violated by street dreck. Despite badges, closed TV surveillance and legions of guards, federal office buildings have become places of dangerous encounter, which gives a special, ironic meaning among the working whites to the annual ritual of "Black Awareness Month."

The biggest scandal yet to blow in the Washington bureaucracy may involve that grey old lady, the General Services Administration, custodian to all the office supplies, adding machines and real-estate leases that undergird the glacial pace of federal culture. Along with the Departments of Health and Human Services and Housing and Urban Development, GSA is the near-exclusive province of Afro-minority employment, a mindless milieu filled with incompetence, cynicism and worse. Though nobody yet knows why GSA continues to dote on the pricey products of IBM, the rest of humanity buys far more computers for far less under the generic heading "IBM-compatible." Apple Computer's John Scully not long ago gave a hint when responding to a reporter's question why his company didn't pursue the government market more vigorously. "We don't get involved with bribery."

Anyone with a moment's exposure to Washington well knows the sight of GSA blacks driving themselves, friends and families about in "Government-Use-Only" vehicles. Weekdays these jaunts may involve personal errands. Weekends are occasions for simple skylarking at taxpayers' expense to the shore or the mountains. For the laugh of it I once reported a miscreant I spied loading groceries into a GSA van. After four unsuccessful tries at getting a reply, I gave up. My description of Amos piloting his "gumm'unt" vehicle for personal purposes must have offended some GSA Andy.

Overtime work in the federal establishment often means passing through Shootout Village. One dark evening a nationally respected economist exiting his Commerce Dept. lair encountered four blacks lurking near his car, which unfortunately was parked well beyond the safety of the floodlights. Pausing to heft a 2 x 4 board from a nearby construction site, this former Marine announced in unmistakably unbureaucratic tones: "OK you black MFs, who's gonna dance first?" As if by biblical magic, the waters parted.

A common *modus operandi* of Roosevelt and Sambo is to drive along the Beltway till they spot an unaccompanied white female at the wheel. They draw abreast, slam their vehicle into

her car door and wait for the foolish inevitability of the young lady pulling to the shoulder of the roadway. The rest is such duck soup that one racial entrepreneur some years back took to enlivening his evening enterprise by finishing off his victims with shotgun blasts into their reproductive organs—an excruciatingly painful mode of death. Though the killer now resides manacled on Maryland's Death Row, it's unlikely that this Beltway bopper will be taking the Baltimore electricity cure any time soon, Governor Schaefer being of the opinion that electrocution amounts to cruel and unusual punishment.

Although my Virginia driver's license mentions an address in the outskirts of Washington, like it or not, I am a subject of the defunct French colonial empire. My neighbors, who claim residence in Arlington and Alexandria, adhere to a culture that reflects Tangiers, Marrakesh, Rabat, Dakar, Libreville, Brazzaville, Djenné, Addis Ababa, Beirut, Saigon and Fort-de-France. Like a thousand American 'burbs, the leafy-green of D.C. has become (noisily, odorously and dangerously) the North American equivalent of mountain villages of the Atlas, vanilla plantations of Madagascar and rice paddies of the Mekong. My newcomer neighbors—a wandering refuse of the second greatest and perhaps least productive colonial empire ever assembled—hate me and other white residents as much as they hated the French who attempted to "assimilate" them back in the heady days of French colonialism.

A liberal colleague of mine who makes his mite in the federal bureaucracy and who beds down on rat-infested Capitol Hill, is unhappy about the \$9,000 annual tuition he must pay to keep his ten-year-old daughter out of the D.C. public school system. Knowing that he has been, over the years, a partisan of nearly every form of race-integration measure, I somewhat disingenuously suggested that he save his money by sending Precious Daughter to the public school system he so vigorously fought to integrate. "Oh, no. I won't send Cathy to a segregated system!", he exclaimed. Cynical as that sounds, Federal Fred, as I will call my bleeding-heart associate, is, literally speaking, correct. At 97% black and Hispanic, D.C.'s public schools are, like those of nearly every other major municipality, no place for white kids. Reverse racism, mammoth violence, impossibly incompetent minority teachers and hopelessly inept and unmotivated minority students have driven whites to the private school alternative, urban schools being the way they are because white liberals, like my colleague, integrated them and then bolted. Sparing one's children the consequences of one's own idiocies may be the only the "human thing" to do, but where does it leave the legions of working-class white parents, most of whom opposed school integration from the start? Trapped in the public education system, since their families are unable to cover the tuition for private schools, their children suffer grievously while noisy white liberals bray about racism from the safety of the sidelines.

Recently Federal Fred has been optimistically talking of solving the \$9,000 tuition problem by the most conventional of escape routes: moving to the suburbs. His wife, a real-estate agent, believes the money saved by using the better (i.e., "whiter") public school system would just about cover the high mortgage payments of a house in the country. But before expending too much

criticism on Fred, we should understand that this get-out-of-town cop-out is routine for most whites working and living in a race-dominated world like Washington, where pro-forma acceptance of minorities and their endless peccadilloes is a prerequisite of professional survival. According to guidelines specified by the civil service, Fred must be evaluated on his willingness to promote the interests of minorities. So what else could be expected of this poor prototypical sap than double-facedly double-talking his way through this existential rat maze? Faced with the demands of his agency's Equal Opportunity nitpicker, he has been driven to lavishing trinkets of jewelry on his black female employees as a kind of sick quid pro quo to preserve his government salary grade. Each holiday season the bibulous minority bimbos on his staff sport new baubles of tribute to the great god Race.

Time once was when D.C.'s Georgetown University offered a provincially respectable Jesuitical education to the sons and daughters of East Coast Catholics. Today, thanks to the sociological handiwork of its recently deceased president, Rev. Timothy Healy S.J., Georgetown is now a hothouse of urban minorityism, a place where street obscenities have replaced the Hail Mary and where the concern of female students is no longer avoiding mortal sin, but campus rape. Symbolic of the school's conversion is the intimidating bulk of its (black) basketball coach, John Thompson, a man who never met a white player he liked. After his arrival two decades ago, Georgetown, as with most basketball powers, has fielded teams with the racial makeup of a Harlem hoe-down.

In the matter of winning seasons, the Thompson-Healy racial strategy has paid off. Georgetown teams regularly place in the nation's "top twenty," often make it to the NCAA finals and even manage to capture an occasional national championship. In addition to a sports budget which has ballooned into the millions, the school reaps the *gelt* that goes with national acclaim. The downside is that coach Thompson's street-toughs have earned a notorious reputation for on-court brutishness, prompting universal and derisive boos from basketball fans across the nation. (One can only wonder about the thoughts of those aging Jesuits who, as they dutifully attend each home game, must forbear the epithets regularly cascading from the stands.) As to degrees, less than one out of two of Thompson's merry men graduate. Even among those who do collect a sheepskin, after-college achievement is disappointing. Often the players merely return to their crime-ridden streets and dabble in the drug-and-dissipation culture of their peers, all to the enormous embarrassment of Georgetown's white students and alumni. School loyalists wince even more at the perplexing habit of nearly every D.C. black from age 15 to 45 to wear Georgetown's colors, the blacks' way of expressing satisfaction at having been racially, if not academically, accepted. Integration may be working at Georgetown, but only in the manner it operates elsewhere in the nation: blacks "playing games" and whites praying for deliverance.

Ironically it was an earlier president of Georgetown with the identical family name of Healy (Patrick, S.J.) who began the school's tradition of racial integration back in the 1880s. The enterprising Father was the offspring of the marriage of a white plantation owner from Macon, Georgia, and a black slave woman.

What's the story with blacks and BMWs? Seemingly, there isn't a ghetto street in Washington that doesn't sport a half dozen or so examples of car-happy people jamming themselves into this "best-of-Bayern" marquee and cavorting about the neighborhood with the giddy lust of a 1940s teenager ogling a Vargas Esquire nude. Over the last decade blacks have beaten such a path

to the BMW showroom that the car's reputation has begun to lose its cachet of exclusiveness. As with the old Henny Youngman gag, "I wouldn't want to belong to a club that would have me," the BMW no longer has its snobbish touch—unfortunate not only for *Bayrische Motorwerke* but for the blacks who use it as their psychological "substitute" for education, steady employment and worthwhile family life. How do minorities pay for such luxury? By drawing down on the cornucopia of drug loot endemic to their world. Forking over street cash to purchase a snazzy BMW helps Tyrone elude BATF and IRS surveillance. Because it's considered naughty to make cash sales in excess of \$10 thousand without reporting the matter to Internal Revenue, 83 salesmen of Washington's Rosenthal automobile chain currently face prosecution.

A more conventional method of minority financing is "pool-purchasing." A half-dozen or more of Tyrone's "extended family" chip in to cover the husky monthly payment involved in a BMW purchase or lease. Salesmen are familiar with a hundred Tyrone's trooping (and whooping) through their palm-fronded showrooms, while babbling about upgraded Grundig radios, glitzy paste-on decals and spiffy gold-anodized wheels. In an eye's wink salesmen shunt these social oddities to the back lot with such ploys as "Why not take this '87 five series just traded-in out for a spin? And take your time coming back!" When they do come back and they do buy or lease, the whole "extended family" lays on an obligatory trip to the Carolinas to show off their gleaming Germany buggy to the home folks. Watermelon smiles glitter, fingers pop wildly and a huge bottle of Ripple is provisioned carefully on mamma's ample lap for the voyage. Alas, racy camshafts do not a gentleman make. Alas, yesterday's minorityite cosseted in today's black BMW remains a ghetto denizen.

## Black Sports Figures in the News (May 1993)

- Dave Waymer, former Los Angeles Raiders' defensive back died from a cocaine overdose.

- A passenger in an auto driven by Terry Davis of the Dallas Mavericks was killed when the car hit a tree. Davis was drunk at the time.

- Phillip Harrison, father of NBA Rookie of the Year Shaquille O'Neal, was arrested for assaulting a visitor to Disney World. The previous day he was charged with assault on a man who is writing a biography of his son.

- Former Kentucky University assistant basketball coach Dwane Casey had the final year of a five-year suspension for violations of NCAA recruiting rules lifted.

- Dick Schultz, NCAA executive director, denied involvement in alleged illegal loans to athletes during 1982-1990, when he was athletic director at the University of Virginia.

- Butler University basketball player Quincy Bowens was kicked off the team after being charged with burglarizing the school's bookstore and possessing stolen property.

- A Michigan woman, who sued Magic Johnson for \$2 million for knowingly infecting her with the AIDS virus during a sexual encounter in 1990, was ordered by a U.S. District Judge to refile her suit under her real name instead of Jane Doe.

- Former Oklahoma University quarterback Charles Thompson, recently released from prison after serving 17 months for selling cocaine, signed a long contract with a Canadian Football League expansion team.

- Drug charges against former Washington University linebacker Danianke Smith was dismissed when the trial judge ruled the prosecution had dallied too long in providing defense attorneys with an informant's criminal history.

- Former Dallas Cowboy Colin Ridgway was found shot to death at his home. No weapon being discovered, police suspect murder.

- Notre Dame lost two football scholarships for 1993 after the NCAA determined that linebacker Demetrius Da Bose took money from a Seattle couple with ties to the university.

- Phoenix Cardinal linebacker Freddie Joe Nunn was released on bond following his arrest for what police described as an outburst of "domestic violence."

- Texas A&M linebacker Jesse Cox and wide receiver Brian Mitchell became the team's sixth and seventh players to be benched. They had been accepting illegal payments of up to \$200 a week.

- Pittsburgh Steeler running back Tim Worley was reinstated following a one-year suspension for missing two mandated drug tests.

- Golden State Warrior forward Byron Houston was nabbed for carrying a gun at Oakland International Airport.

- Temple University basketball center William Cunningham was acquitted on charges of conspiring to steal a Cadillac.

- Virginia University was placed on two year's probation by the NCAA for making improper loans to athletes.

- Chicago Bulls star Michael Jordan lost \$5,000 playing blackjack at an Atlantic City casino only hours before his team lost the second straight championship playoff game to the New York Knicks. Last year Jordan was called as a defense witness to explain how \$50,000 of his checks were held by the defendant, who was convicted as a major drug dealer. According to *Michael and Me* by former friend Richard Esquinas, Jordan lost \$1,252,000 to him in a 14-day period in 1991 betting on golf shots.

## Jesus in The News

Cain Hope Felder, a prominent Negro theologian, vigorously opposes the notion, entertained by some naive Christians and illustrated by many religious paintings, that Jesus had blue eyes and sandy hair. A professor of the New Testament at Howard University, Felder doesn't say Christ came from the Congo, but he does say, "He was an African-Asian man of his time." Felder also asserts that Mary and Joseph, owing to their alleged extra helping of melanin, blended easily into the dark-skinned population when they fled to Egypt. All this is pretty hard for Bible buffs to swallow. Even harder to ingest is Felder's claim that the Garden of Eden was in the Sudan, a country which looks far from Edenic today.

Speaking of Christ, a French multimedia production with a cast of 58, vivid film images and powerful sound effects was scheduled for a June 2nd opening in Radio City Music Hall, but it was postponed for three days while the ADL, the tax-deductible spy outfit whose offices in California were recently raided by police, ordered various revisions to get across the message that the Romans, not the Jews, were responsible for the death of Jesus. Not until the black robes and Darth Vader masks of the Sanhedrin were removed, not until the audience was pamphleted and harangued with "scholarly comments" absolving Jews from deicide, was the show allowed to go on, although it had already toured several other U.S. cities without incident.

Every ten years the *Passion Play* in Oberammergau is further bowdlerized to soothe Jewish sensibilities, and the scenery, dialogue and action—the core of the Jesus drama—restyled to "prove" that Jews were innocent bystanders at the crucifixion. If the trend continues, and there are signs it will even accelerate, the Christ dramas of the next century may have a Jewish hero who chases away the Roman soldiers, gently unnails Jesus from the Cross before he dies, and spirits him away to live out his life happily and holily in some ancient kibbutz.

## New Record in Miscasting

Having read a highly favorable review of a local production of *Dinner at Eight*, I was happy to be invited by friends to at-

tend a matinée. The cast has retained all the names of the original characters so I was prepared for the butler, Gustav, to be of Nordic extraction. Negative. He is a mulatto who vigorously pursues the young white downstairs maid. Many clinches and kisses. It is not until the third act that we realize that the eminent doctor has a black wife. That this couple would be invited to a dinner party as prestigious as this one is purported to be would have been unthinkable during the epoch portrayed. I reluctantly told my kind hosts that I resented these two examples of bastardizing the original script and that to me the whole production was utterly distasteful. Had I been alone, I'd have walked out.

**The Jewish Seat Is Refilled!**

What does one do with a Supreme Court that lifts the ban on Santeria, an Afro-Caribbean cult that originated in West Africa, mixes Christianity and voodoo, and is hipped on sacrificing roosters? What Clinton did was nominate Ruth Ginsburg to fill the seat vacated by Justice Byron White. A Federal Court of Appeals judge, Ginsburg and her husband, Martin, a university professor who teaches tax law and advises Ross Perot, have a net worth of \$6.1 million. As expected, the press gave the nominee the hearts-and-flowers treatment, depicting her as a moderate and centrist—one of the oldest tricks in the media book. Ginsburg's nomination was a payoff to the Jewish lobbies, which for decades

have been demanding the reestablishment of the so-called Jewish seat on the Court. Until Abe Fortas resigned in disgrace 24 years ago, one or more Jews had been sitting on the High Bench since the appointment of Louis Brandeis in 1916. Clinton, hearing his masters' voices, not only obliged but filled two quotas with one blow. His Jew was a Jewess.

When Ginsburg made a heart-tugging speech in the Rose Garden accepting the honor, tears welled up in the President's eyes, as they did during an earlier and somewhat similar speech by another Jewess, Madeleine Albright, when she was nominated Ambassador to the UN. He also cried when he spoke to the press after leaving Lani Guinier, his black choice for Asst. Attorney General for Civil Rights, in the lurch.

**No Cut for Israel**

Foreign aid may be cut next year by about 10%, according to a Congressional panel. Does that mean the \$3-billion annual tribute to Israel will be shaved? Not by one cent, promised the Clinton administration. Aid to Israel is the sacred cow of America's Zionized politics, especially since at least ten members of the House Foreign Affairs Committee are Jewish, as are at least five members on the Subcommittee on Europe and the Middle East.

**Jewish Political Dynasty?**

Howard Metzenbaum, a com-symp when he started out in politics, will quit his seat in the Senate when his term expires next year. He has promised to concentrate all his influence, political clout, money and Jewishchutzpah on the election of his hand-picked replacement, another Jewish multimillionaire, son-in-law Joel Hyatt, who made his pile setting up a chain of cut-rate legal clinics.

Metzenbaum distinguished himself some years ago by being paid \$250,000 for making one phone call on behalf of a Jewish constituent to expedite the sale of an exclusive Washington hotel. It was such an outrageous piece of influence peddling that Metzenbaum had to return the money, which must have caused him immeasurable grief. If Hyatt wins his Senate race, then the American people may expect the rise of a Jewish political dynasty on the order of the Kennedy family—but not on the order of the Adamases, who were statesman, not politicians.

Christian activists should be happy

Metzenbaum is quitting Washington. He is probably the foremost Democratic opponent of the religion that is still the overwhelming choice of Americans. At a hushed-up speech before the Wise Center in Cleveland, Nov. 6, 1988, he uttered these words, in what one might dare to say was a hate speech: "We will not allow the forces of evil to make America a Christian nation." He then called upon Jews to attack Christian TV programs and stand "in the forefront of the battle against the religious right."

**Still Facing the Noose**

U.S. District Judge Thomas A. Wiseman Jr. has ruled that Justice Dept. lawyers ignored or withheld evidence that cast strong doubts on the charge that John Demjanjuk, 73, now under a death sentence in Israel, was Ivan the Terrible, the guard reputed to have killed astronomical numbers of Jews at the Treblinka concentration camp. Since deliberately withholding evidence in a criminal trial is a crime, why aren't the Justice Dept. prosecutors in jail? And why isn't Demjanjuk, a Ukrainian-born American extradited to the country that didn't exist at the time of his alleged crimes, set free and recompensed by the Israeli government for wrecking his twilight years?

That's what should happen. But it won't. Judge Wiseman closed the case so the predominantly Jewish Nazi hunters could not be punished.

The Israeli Supreme Court has been hemming and hawing about Demjanjuk for months. The learned justices are supposedly leaning towards freeing the old gent on the Treblinka charge and starting a new prosecution that puts him at another concentration camp and committing equally evil deeds.

The legal proceedings against Demjanjuk have been a travesty of justice from the word go, which is not surprising in a criminal justice system infiltrated by men, both in the U.S. and Israel, who want vengeance at all costs—including the cost of trashing the U.S. Constitution. Charging people with crimes 40 or 50 years after the event (justice delayed is justice denied) and sentencing a man to hang after important evidence has been withheld from his defense lawyers, is just about the end of the road as far as the law is concerned.

**Special Case**

When a student at the University of Pennsylvania bestowed the sobriquet, "water buffalo" (a large black creature native to Africa), on a bunch of slap-happy black sorority sisters staging a commotion

outside his dormitory window, he would normally expect to be suspended, if not expelled. Such is the scenario that awaits the white college student who lets slip a racial slur or two.

This was not the scenario, however, that unfolded. The student, it turned out, was not the ordinary garden variety "racist." He was Edén Jacobowitz, a freshman from Israel. Considering what they were up against, the Negresses withdrew their vendetta in five days. Jacobowitz, after a brief hearing, was allowed to pursue his studies in peace.

The waffling president of the university, Sheldon Hackney, played an ignoble role in the affair by turning a deaf ear on the hullabaloo, presumably to avoid any possible action that might damage his nomination to head the National Endowment for the Humanities. A few months after the water buffalo incident, Hackney, a scalawag born in Alabama whose wife pals around with Hillary, also distinguished himself by his inaction when black students stole and trashed nearly 14,000 copies of a student publication which carried a column they denounced as racist. Some years earlier Hackney was not so lackadaisical when Andrés Serrano, the "artist" who gave the world *Piss Christ*, was severely criticized for his obscene blasphemy. Hackney lost no time rushing to Serrano's defense with ringing endorsements of free speech and free expression.

### Liberal Racists

Liberals are the perpetrators of the most grossly racist programs ever conceived in the altruistically saturated heart of late 20th-century man—programs like reverse discrimination, employment quotas, minority set-asides, all of which directly discriminate against the white majority. Liberal-sparked racism does not stop here, however, for the two most nefarious programs, minimum wage laws and welfare, actually hurt blacks far more than they help. The former cuts off entry-level opportunities for Negroes whose work is often not worth the minimum wage, but who might well be employable at a lower wage, a position that could be a stepping stone to a better job. Welfare allows many blacks to live—and produce more welfare dependents—without the need for gainful employment. With this one-two punch, liberals have destroyed black incentive, torn apart black families (who needs a father when Uncle Sam foots the bill?) and cut blacks off from jobs, the only real exit from ghetto life. By reinforcing parasitism and increasing black leisure time, the bleeding hearts have

made drugs and crime a virtual way of life for the melanistic set.

### Gelt Talks

"No other individual was more significant or helpful to Clinton's victory." *Pharmaceutical Medicine* (June 1993) confirms that racial and ethnic background are key factors in determining the efficacy of drugs. Asians, it was found, require lower doses than whites of drugs to treat anxiety, depression, and schizophrenia. Whites respond better than blacks to certain inhibitor drugs for cardiovascular diseases. Ashkenazi Jews have been known to suffer life-threatening side effects with clozapine, a drug used to treat schizophrenia. Although the study has been labeled "controversial," Dr. Robert Phillips, internist and pediatrician at Detroit Riverview Hospital, agreed that race is a particularly critical factor in the treatment of various ailments.

### Shysters Are Worried



- The issue of homosexuality is an important one and cannot be ignored or swept under the rug. It must be tackled if we are ever to get our country straightened out. I cannot imagine a revitalized, renewed, vibrant America overrun with swarms of faggots. We are not in this fight simply to get affirmative action laws overturned or oppose Jewish domination of the media or preserve Western culture. We are trying to rebuild our people, our race. We can only do that with individuals who are themselves healthy in body, mind and spirit. Our movement can easily absorb the odd nut and weirdo. The core, however, must be sound. Part of this soundness has to come from attracting men and women who have the intelligence, character and guts to do what needs to be done. The most important thing any of us can do is raise strong, healthy children. This is the whole point of life. Homos are one load we cannot carry. They are, in the literal sense, a dead end. An individual homosexual may claim to share our beliefs, may even attempt to prove it through good works. It is not enough. He will always be beyond the reach of our brothers and sisters.

**Dennis deLeon**, Zoo City's Human Rights Commissioner, ended all the tsk-tsking by finally admitting he had come down with AIDS. Two other city officials are in the same shape: City Councilman **Thomas Duane** and Mayor David Dinkins' AIDS Service Coordinator, **Ronald Johnson**.

**William A. Abrahamson**, 23, was arrested in Newport Beach (CA) on a charge of stealing a dozen pair of female underwear in ten house break-ins. The panty bandit also fancied videos of leotard-clad women working out.

#

In Brooklyn, when a Puerto Rican motorcyclist almost ran into a four-year-old Jewish boy who had darted out in the street after leaving a school bus, a cohort of **Hasidic Jews** caught the cyclist and beat him with crowbars. The Puerto Rican community reacted with bellows of anti-Semitic cusswords.

To illustrate her assertion that Asians have more oomph than blacks in San Jose (CA) politics, Councilwoman **Kathy Cole**, a Negress, pulled back the skin around her eyes to give them a slanted Oriental look. She then turned her ire on Hispanics, denouncing them as "pit bulls." Ms. Cole, though apologetic, refused to resign. Council members, while professing their outrage, dared not expel her.

#

**Four boys and three girls**, ages 12 and 13, of the Georgetown Elementary School in Columbus (GA), wanted to get rid of a hard-nosed teacher. One student slipped chemicals from his home chemical set into her tea. Another brought a handgun and a long knife to class, which he evidently planned to use if the police had not stepped in.

#

After Buffalo's Transit Valley Country Club, whose membership is as white as the stuff that fell in the blizzard of '93, had rejected **Grant Fuhr's** attempt to join, a swastika was burned into the 14th green and the phone rang with bomb threats. So club officials changed their minds and rolled out the red carpet. Fuhr, the black goalie of the Buffalo Sabres, was no longer interested.

#

**Manny Silver**, a scribbler for the Sun, a zero I.Q. tabloid, admits that 90% of what he writes comes "off the top of my head."

#

**Judge Leah Marks** of Manhattan Family Court ruled in late June that a **white lesbian foster mother** (name withheld) could adopt a handicapped two-year-old Negro

child born to a cocaine addict. The black grandmother had objected that the race and skewed sexuality of the foster mother boded ill for the pickaninny's future.

#

A **nonwhite gang** flaunting Uzis and the latest model machine pistols terrorized the passengers of four subway trains in upper Manhattan for almost three hours late Saturday and early Sunday, June 19-20. The straphangers were only robbed while the trains were moving.

#

**Dr. Anthony Richardson**, a black, pulls teeth in the Bronx. A 16-year-old girl (race unspecified) hired by the dentist as his summer receptionist stated that during her first day at work he lured her into his dental chair, gassed her, raped her, re-gassed her and re-raped her.

#

For cheating 154 advertisers out of \$120,000 (he charged them for direct-mail packages that were never sent), Philadelphia trade magazine publisher **Ned Borowsky** was sentenced to five months of house arrest. His father, **Irving**, peddled *TV Guide* to Walter Annenberg in 1952. Annenberg later sold *TV Guide* to mediocrat **Rupert Murdoch** for almost \$3 billion.

#

It took many months for the truth to emerge about **Pablo Garcia**, employed as a Santa Claus at a Miami mall last Christmas. He was arrested for child molesting six days before Yule. A few years earlier in Puerto Rico he had been jailed for having sex in a graveyard with an exhumed 17-year-old dead girl.

#

At the commencement exercises of Milton Academy, a middle-brow New England prep school, much was said about racism holding back minorities. The commencement address was given by a **black lawyer**. The headmaster of Milton is **black**. The head monitor was a **17-year-old black** who will soon be attending Yale (which now charges white students approximately \$100,000 for four years of liberal-minority indoctrination).

**Rhett Jacobs**, black Democratic candidate for the South Carolina House of Representatives, who listed education as his chief interest on a campaign disclosure form, itemized his election expenses under the headings of "filling fee," "campaign work" and "litature."

A 35-year-old Negro, **Alfonso Blanding**, moved from New York City to Port Townsend (WA) a year ago. Claiming to be the target of anti-black pejoratives, he let it be known he was going leave be-

cause he couldn't take any more "racism." He postponed his departure, however, in order to kidnap and violate a 15-year-old white girl in his trailer. Arrested in May, he pleaded guilty to four counts of child rape.

#

Scandalmonger **Charles Higham** directs his Semitic spleen against a famous Majority member in his latest book-length exposé, *Howard Hughes—A Second Life*. Hughes was no hero, but he did hold several aviation records and, although a one-time producer of bad movies and an eccentric investor in his latter Las Vegas days, he doesn't deserve being portrayed as a sex maniac. According to Higham, Hughes had homosexual encounters with Cary Grant, Tyrone Power and Randolph Scott, and heterosexual bouts with Ginger Rogers, Katherine Hepburn and Bette Davis, the last-named actress boasting that she was the only woman who could fully satisfy him. To wrap up his character assassination, Higham accuses Hughes of what has become the most reprehensible and unforgivable of all crimes. The lustful millionaire, says his unauthorized biographer, peppered his language with anti-Semitism.

#

The #3 man at HUD in the Reagan administration, Assistant Housing Secretary **Thomas T. Demery**, a black bureaucrat, pleaded guilty to two felony counts, obstructing justice and accepting a gratuity (taking a bribe) from Michigan developer Irving Seligman.

#

"Scarface," an unattractive mulatto or Hispanic with a three-inch scar on his right cheek, has been prowling around New York City suburbs for the last five months. He is suspected of raping a dozen or more white women, after which he burglarizes their homes. He sneaks in when the women take out the garbage or collect the mail. After cutting the phone lines, he waits for his prey.

#

South Carolina State Senator **Kay Patterson**, a male with a female first name, sent out invitations, printed at state expense, for a meeting to discuss black problems. The gathering was held in a government building. Only Negroes could attend. No whites allowed.

#

A black rap ditty inspired 19-year-old **Ronald R. Howard** to shoot and kill a white Texas state trooper, according to his lawyer, who quoted two unprintable lines

from *Souljah's Story*, a piece of syncopated "hate the police" doggerel by a Houston rapper and distributed by the culture vultures of **Time Warner**. An Austin jury, unmoved by the defendant's attempt to pass the buck, came in with a murder verdict. The state trooper's widow is suing Time Warner.

#

**Free speech** comes with a high price tag in New Albany (IN) High School. For alluding to watermelons and fried chicken in front of his black players and for informing a member of the junior varsity team that his "poor defense was bringing slavery back," basketball coach Jim Miller was fined six months' pay.

#

In Jacksonville (FL), Petty Officer 2nd Class **Albert Ruggiero** was sentenced to seven years in prison for raping an 18-year-old seaman (that's seaman not seawoman).

#

The **Senate Ethics Committee** refused to investigate **Senator Bob Packwood** (R-OR), who falsely claimed he was Jewish in a fundraising letter to Jews. Packwood is still holding on to his Senate seat although at least ten women have charged him with sexual abuse.

#

In the 1960s **Michael Lasky** was a Marxist-Leninist revolutionary. In 1980 he went to jail for mail fraud. In 1986 he ran unsuccessfully for the California Assembly. More recently he has been operating a scam called Publisher's Associates in San Diego, which makes him as much as an incredible \$12,500 a day. He cuts classified ads from other publications and sends tear sheets of same to companies running the ads, along with an invoice. Half of the firms pay up. At last report postal inspectors are on his tail.

#

Five-foot, two-inch **Irving Azoff**, known in the trade as "the poison dwarf," heads MCA Records. In *Stiffed: a True Story of MCA, the Music Business and the Mafia* (HarperCollins), William Knoedelseder, a former Los Angeles Times reporter, tells the sordid story of how Azoff brought in a mobster to run an important division of the record company. A Justice Dept. prosecutor assigned to the case was suddenly removed and fired for insubordination just as he was ready to take MCA to court.

#

The Board of Physician Quality Assurance in Baltimore has suspended the license of **Dr. Robert A. Hallowitz**, who has been charged with such "serious

transgressions" as: claiming he was God, dispensing illegal drugs, having mid-day rendezvous with patients in motel rooms, fathering two children with one patient, and warning all and sundry that if they talked about his unprofessional behavior they could be spiritually excommunicated and fall prey to the devil!

#

An adopted son of a Long Guyland Jewish family, **Joel Rifkin**, 34, described by neighbors as "gentle, quiet and pleasant," was caught with a female corpse in his pickup. He claimed a body count of 17 in his two-year extermination campaign of prostitutes.

#

When Chelsea Clinton was five years old, perhaps with a little coaching from her parents, she was very upset by President Reagan laying wreaths on the graves of two German SS men at Bitburg. As a reward for Chelsea's precocious sensitivity, two Little Rock Jews, **Joseph and Evelyn Bernhardt**, have planted a tree in Israel in her name.

#

Three hours before working his night shift on August 15, 1991, **Wade Hampton Taylor III**, a black with an aristocratic name but a plebeian job on the Baltimore police force, robbed an S&L. The familiar face that showed up on the camera film of the robbery was his. It took two years for the city fathers to get around to arresting the robber cop, who had resigned from the force last year.

The Justice Dept. has launched a criminal investigation of **Rabbi Pinchas Horowitz**, suspected of cheating Blue Cross and Blue Shield out of \$22.5 million. In cahoots with his father, also a rabbi, and a character named **Reuven Finkelstein**, he allegedly set up dummy companies that hired a mob of Israelis as employees, thereby qualifying them for cheap health insurance. The Israelis would then receive various types of medical treatment unavailable in the Holy Land, e.g., \$1-million bone marrow and heart transplants.

Jewish lawyer **Guy Saperstein** is making a fortune suing Majority corporations for sexual and racial discrimination. In little more than a year he pried \$229 million out of State Farm Insurance and \$132.5 million out of Shoney's. Most of the payoffs are supposed to go to his clients, but \$65 million of the State Farm settlement enriched the coffers of Saperstein's law firm. Companies that are victims of such shysterism have to make up their losses by raising the price of their products and services. Anyone who likes inflation should love Saperstein.



## Waspishly Yours

In the September 1992 issue I wrote about a sordid convert to Judaism, Robert Manning, who, after more than eight years, is still wanted by the FBI for questioning in connection with at least two pipe-bomb murders, one victim being the Arab-American poet, Alex Odeh, in 1985.

In the Safety Valve (Dec. 1992), Zip 319 upbraided me for "yellow journalism" and for lacking compassion, which, he contended, is an almost copyrighted trait of "White Gentiles." I sounded, he complained, as if I wanted to hang Manning from the rafters.

Were the Vikings vaunted for their compassion, 319? Were the Angles, Saxons and the Jutes compassionate towards the Picts and the Celts? Do you know anything at all about English history, perhaps the bloodiest in the West, which includes such bloodbaths as the 100 Years War, the Wars of the Roses, the Catholic and Protestant inquisitions and counter-inquisitions, and the ireful conquest of Ireland by Cromwell? If you don't go in for scholarly history, try reading Shakespeare's largely circumspect, when not downright "politically correct," plays that deal with the English past and tell me how much compassion you see therein. *Macbeth*, *Richard III* and *Henry VIII* might be a good place to start. I need not remind you that Shakespeare's versions of history were slanted to placate a salty virgin sovereign known as "good Queen Bess," who was, in point of fact, never particularly "good," probably was not a virgin and certainly was not swayed by "compassion" in matters of state or privacy. Just ask milord Essex, if you have any doubts on that discordant score. He lost his head, despite the fact that he probably did score.

If Shakespeare is not your dish of tea leaves for compassion, try reading a novelist like Dickens. Since compassion dictates that the "last shall be first, and the first shall be last," start with *Bleak House*. If you haven't read it already, rejoice! You have an interminable treat of compassion in store.

The French favored public performances of the guillotine—which were considered too gaudy for the English—well into the 19th century. The Brits favored public strangulation and "hanging, drawing and quartering." The victim was strung up until he was suffocated into unconsciousness—the merciful, anesthetic part of the ceremonies. When he was judged suitably close to extinction, when he had stopped twitching, he was cut down from the gibbet. Now the real fun began. Cut down from the gibbet, the victim was literally disemboweled and startled from his stupor by seeing his guts spilled into his lap. After the "drawing," came the "quartering." Granted sufficient time to contemplate the spectacle of his steaming guts, the victim had his arms and legs hacked off. Such is man's umbilical attachment to life, there are actually recorded cases of criminals who survived these festivities. As a finishing touch, dead or alive, his head was whacked off and deposited on a pike for the moral edification of the public.

My favorite incident in these public carnivals involved a case of what I would define as democracy in action. The condemned man actually burst his bonds after he had mounted the scaffold and began doing battle with the executioner to the point where the tables were turned and the executee was on the verge of executing the executioner—until several spirited members of the crowd rushed the scaffold and helped to overwhelm the rebellious brute. You can imagine the compassion which the execu-

tioner brought to his task when the legal carnival finally was resumed. (Whose side would the crowd be on today, especially if the brute was black?)

Zip 319 says I lacked compassion for Robert Manning because I wondered why it seemed impossible to extradite him from Israel for a trial in the United States, when it is quite suitable (pace John Demjanjuk) to extradite Americans for a trumped-up trial in Israel. What would Zip 319 have accused me of, if I had recommended the English compassion of hanging, drawing and quartering?

It's not that nice guys always finish last. It's that all too often they get finished off by the bigger fish even before they have a chance to finish at all. And unless you want to get scaled down and fried, Zip 319, you better fight before you jump for the sucker bait called "compassion." It sounds like you've already been landed and are still flopping around on the deck. Compassion, like literature and art, is a luxury of those who have already ensured their survival. St. Francis could afford to babble to the birds because he had a rich papa to run home to.

But we must do more than just survive; we must prevail without losing our humanity. Feeling sorry for suspected murderers who run to Israel rather than face the music, strikes a sour note with my muse. Feeling sorry for the likes of Robert Manning is the surest way I know of losing one's humanity.

I'd like to see Manning get a fair trial, which is more than the pipe-bombed Alex Odeh got. Since Manning is a Jew and descended in body or spirit from the authors of the Old Testament, I'd prefer to see justice administered "eye for an eye." Rather than hanging, I'd prefer to see something long and tubular packed with dynamite and then detonated, after having been inserted somewhere in Manning's anatomy, preferably where the sun don't shine.

Meanwhile, let's forget the phony hearts and flowers concerning "White Gentiles." Northern Europeans have manifested many virtues in their struggle for supremacy, but compassion hasn't always topped the list.

Were we compassionate towards the Indians? Didn't the British invent the concentration camp in their war against the Dutch Boers? How much compassion did Churchill show when he fire-bombed Dresden in 1945, a city full of hospitals and empty of industry? Didn't we use the Japs as guinea pigs to send a message to Uncle Joe when we A-bombed Hiroshima and Nagasaki? Who unleashed the Jews on the hapless Palestinians? Didn't Aryans like Ike Eisenhower deliberately starve tens of thousands of German POWs after WWII?

But don't worry about our monopoly on cruelty. The Japs killed thousands of Americans on the Bataan death march because they wanted to save all those starving, sick and wounded the trouble of a long, tiring trek. They refused to feed those exhausted blue-eyed devils because the Nips were too compassionate to kill the fish and to boil the rice that would have kept their prisoners healthy.

Zip 319 save your compassion for your kith, your kin and your kissin' cousins. Don't waste it on a suspected multi-murderer like Robert Manning, who, if the allegations against him are true, deserves a dynamite enema.

If there weren't enough minorityites on TV news, especially on the production and editorial end, CBS decided to further de-Majorityize its *Evening News* by presenting Dan Rather with a Chinese co-anchor, the wrinkleless, 47-year-old Connie Chung, whose husband is Jewish talk show host Maury Povich. David Brinkley, one of TV's first anchormen, who now hosts a Sunday gabfest, also has a Jewish spouse, Susan Adolf, and an adopted Jewish daughter, Alexis, the offspring of Susan's first marriage to Jewish attorney Peter Adolf. David has three sons from a previous marriage to a member of his own race. The only "pure" network news anchor is Tom Brokaw of NBC. Needless to say, he has a Jewish director and/or producer barking orders behind the TV camera.


Jews who used to be confined to writing and producing so much of prime time TV are now parading their Jewish faces in many of the nightly sitcoms. The following shows have or had specifically Jewish characters: *Homefront*, *L.A. Law*, *Love & War*, *Murphy Brown*, *Northern Exposure*, *Sisters*, *Flying Blind*, *Dream On*, *Reasonable Doubt*.

Michael Medved, the Jewish TV critic, whom the media label a conservative, sums up the situation thusly:

# Notes from the Sceptred Isle—John Nobull

In tune with the times, I feel it my duty to preach “politically correct” doctrines. One of these is that we have much to learn from other people’s cultures, which are superior to ours in almost every respect. Not just different—superior.

All over Africa, except in South Africa, where an unsympathetic legal system manipulated by the whites has forbidden it, the practice of female circumcision is very common. It consists cutting out the clitoris, so that the woman cannot experience pleasure in sexual intercourse and therefore dampens her enthusiasm for extramarital affairs. Another common custom, in many parts of the world, is beating wives. In England, by contrast, for centuries it was forbidden to beat one’s wife—with a stick thicker than one’s thumb. Thankfully, all that is behind us now. Not only do I have no desire to beat my wife, but I wouldn’t dare. All the same, I think it is our moral right to ask any feminist we meet whether we can, in all conscience, condemn such practices as wife-beating and female circumcision which have for so long constituted part of the African lifestyle.

Perhaps the same goes for suttee in India (which has now been revived and involves the wife burning herself to death when her husband dies) and for foot-binding in China. Did we do the right thing in forbidding such customs on British territory? Surely, even if they are reprehensible, we were wrong to “solve” the problem by forbidding it. Isn’t problem-solving a good definition of fascism? Nowadays, good liberals no longer speak of problems. They call them “challenges” instead.

It’s the same with slavery, still common in Mali and Mauritania, according to the British Anti-Slavery Society. If Malis and Mauritians emigrate (in any numbers they wish, of course) and take their “peculiar institution” with them, are we really justified in forbidding an integral part of their culture? I know that slavery in the American South was wrong, as I also know that it is wrong to refer to the Jews of Providence, Rhode Island, as the organisers of the middle-passage trade. But is it correct to condemn outright a practice which has endured in Africa for thousands of years?

It is the same with cannibalism, which was standard in pre-Columbian Central America and is still quite common in New Guinea. When these anthropophaguys emigrate, should we really stop them doing what comes naturally? West Africans build themselves mud huts, but in London a local council recently ordered a poor West African woman to tear down a mud hut she had built in her garden. Isn’t that tyrannical? It’s good to know that President Clinton has finally relented and allowed in a few AIDS-stricken Haitians. But what about the rest of the Haitian population? Is it fair to leave them out? One thing is sure, voodoo is a religion with a future in America.

Then there is the question of animals. We all know how immoral it would be to stop the Jews from bleeding animals to death without stunning them, as they do every day—by the thousands. Although this manner of killing seems unnecessarily painful, what right have we to impose our values upon our cherished minorities? When Koreans hang up dogs and beat them to death to tenderise the meat, it is presumptuous of us to criticise them. The Royal Society for Prevention of Cruelty to Animals may make a big fuss, but it has never done so over kosher slaughter.

In the British Empire the whip and the hangman’s noose were the ultimate deterrents. The lash curled round to bite into the back and bottoms of the idle and disaffected, while the hangman had the task of deciding just what length of drop was right to break the neck without taking the head off (which would be unprofessional). Sometimes I can’t sleep at night for thinking about this. The only way we can possibly atone is to show a more caring and understanding attitude towards whatever customs our new fellow citizens may care to practise.



“Black history,” forced on white students in America, is also being forced on British students, though not as intensively. One of its chief doctrines is that anyone originating from North Africa must have been black, an idea hotly rejected by present-day North Africans, whether of Berber or Arab origin. The idea would certainly have been rejected by the ancient inhabitants, none of whom was black, with the exception of a few Nubian slaves in Egypt. Not long ago, Martin Bernal, a Jewish “historian,” wrote a book called *Black Athena*, which purported to prove that Greek civilisation was practically stolen from Egypt and consequently had black origins.

Just how ridiculous this all is can be seen when we apply the doctrine to individual cases. Aesop, the Greek fabulist, is presented as a sort of Uncle Remus, St. Augustine as an early edition of Rev. Jesse Jackson, the Russian poet Pushkin (who was one-eighth or one-sixteenth Ethiopian) as a 19th-century Michael Jackson. (Michael is not just a jerkdancer, he is a poet, too, in case anyone wants to know.) Cleopatra, who was in fact a blonde Macedonian, also has to be represented as black—a 1st-century B.C. version of supermodel Naomi Campbell. As for Hannibal, he is conceived of as a Tshaka-like figure. “Hannibal the Cannibal,” we might call him.

The other day, when a Jewish American academic was introduced to me, I realised that the blacks are the Jews’ Achilles’ heel. He went on and on about his poor old parents in New Jersey, who had been robbed by a knife-wielding Negro (my description, not his). Getting the assailant’s race out of him was like drawing teeth. Then I asked the \$64-question: “But what is the *solution* to this problem of the black underclass?” He didn’t have one, but he looked deeply worried all the same. Later, he told me horror tales about the black drive-by snipers in his state.

In England, we are running almost as scared of the Jews as the Americans. But we are not as afraid of the blacks and other minorities. I often read the Jewish Chronicle because I want to know what’s really going on. At the end of March 1993, the new Jewish Lord Chancellor, with the unlikely name of John Taylor, was interviewed in Britain’s leading Jewish newspaper. Reminiscing about the long way he had come, he recalled that in the 1950s, when he was an aspiring young lawyer, an eminent jurist had travelled to his university in the North Country to speak and had made the following statement: “There are two causes of fires—lights and Israelites.” Taylor deeply regretted that he had not immediately left the room. The next day the Jewish Chronicle interview with Taylor found its way into the goy press. No mention of Jewish lightning.

Pat Buchanan has started a think tank, The American Cause, that will hold four conferences a year and publish a quarterly journal and monthly newsletter. It's *raison d'être*? To spark public debates on the moribund state of American culture. The initial conference, a two-day talk fest in Washington in May, included such luminaries as columnist Joseph Sobran and Dartmouth Professor Jeffrey Hart, plus a congeries of such Chosenites as Michael Medved, the Zionist-happy critic of culture-crunching Hollywood films, Bill Kristol, Dan Quayle's ex-chief of staff, and, last but by no means least, Rabbi Yehuda Levin. ### The Besieged Are Not Guilty

Randy Weaver is no latter-day Henry David Thoreau, though both were content to live in handmade cabins far from the madding crowd. Though Weaver's electricity-less, running-water-less abode in the wilds of northern Idaho is a long way in time and space from Walden Pond, Thoreau would have applauded his lifestyle, but might have wondered at the mountain man's belief that Identity Christians are the true Jews.

A onetime Green Beret, Weaver, who had never even had a traffic ticket, was set up by agents of the Bureau of Alcohol, Tobacco and Firearms, who persuaded him to sell them two illegally modified shotguns. Ordering him to appear for trial, they gave him the wrong date. When he didn't show, they classified him as a fugitive. Instead of nabbing him during his infrequent trips to town, they surveilled his plywood cabin round-the-clock for 16 months. When the 11-day siege began it involved as many as 400 heavily armed agents backed by helicopters and all the fanciest new people-killing gear. Three persons died in the totally unnecessary confrontation: one federal marshal and two members of the Weaver family: son Sam, 14, shot in the back and Vicki, Weaver's wife, shot in the forehead by an FBI sniper while standing in the doorway with her infant daughter in her arms.

In the trial the prosecution's case was so weak and snafued that even the judge had to admit it was of more help to the defense, which was conducted by a clever, showboating lawyer Gary Spence, who boasts he never lost a case. His record remained unblemished, when the jury acquitted both Weaver and Kevin Harris, who was staying with the Weavers and who killed the marshal, on the murder count, though Weaver may face up to 15 years in jail on weapons and conspiracy charges.

The federal agents and the Weavers should never have come to blows. The people on both sides should have been on the same side. But this will never happen as long as the rank and file of the FBI and BATF obey the commandments of a government that is more their enemy than Weaver ever was.

### Surprise Reception

There was quite an uproar in San Antonio recently. Three teenage Mexican punks burst into an Anglo-owned gun store, screaming obscenities and demanding guns and cash. Since they were all armed, they figured they'd have easy pickings. Not so. The owner, a rough-and-ready Majority type who'd shot and killed a bandit a few years ago, was ready. When he saw the Latinos climb out of their (stolen) car, guns in plain view, he scam-

pered into the back room for his own artillery. As the three goons kicked in the door, the store owner, an ex-cop, started shooting. One 17-year-old was the most surprised dead "youth" you ever saw. A second, who wound up with large holes in vital parts of his anatomy, is recovering at taxpayers' expense in a local hospital. Despite the best efforts of veterans' groups, the kid's father, having served a three-year hitch in the military, was entitled to plant his son among decent folk.

Namer is even more displeased by the grumblings of some of his advertisers who aren't happy about having their products huckstered on the same station which has an alleged anti-Semite on its payroll. The press, which is not always to be believed, has hinted that Duke is likely to be fired any day now. Duke-ites are keeping their fingers crossed.



**Canada.** British Columbia's ultra-left socialist government, the New Democratic Party, has recently brought forth a new bill to stamp out "hate." In reality it is just another of the many attempts these days to muffle free speech. Local journalists have dubbed it the "Kill Collins Bill" since one of its main purposes is to silence outspoken North Shore News columnist and staunch Instauratorist, Doug Collins. For years local liberal-minority agitators have called for his removal from the newspaper, a separation which is always possible because the NDP government has a long history of catering to the whims of minorities. Doug has never pulled his punches when describing the antics and aspirations of the East Indian, Jewish and homo crowd. He has publicly stated that he is ready to go to jail to test the validity of this new bill.

Kim Campbell, Canada's newly anointed Prime Minister has been married twice and divorced twice (without issue). Her first marriage, which lasted 11 years, was to Nathan Divinsky, whose first wife had presented him with three daughters. Divinsky, a Jewish math professor, had a profound influence on Ms. Campbell and was her guru in residence. Said a friend, "Everything she is she owes to Toozie [Divinsky's cute nickname] and her own hard work." Kim's mother, however, was not so enthusiastic about her Jewish son-in-law, whom she thought "rude" and "pushy." Kim's second marriage, which lasted five years, was to a non-Jewish lawyer, Howard Eddy. At the London School of Economics, where she got a Ph.D. in Soviet Studies, Kim's doctoral supervisor was Leonard Shapiro. The learned lady has a law degree and has been credited with proficiency in German, French, Russian and more recently—and most opportunistically—Yiddish.

Canada's first female Prime Minister is noted for having a sharp tongue. It's a wonder the party bosses of the Progressive Conservatives (an oxymoron if there ever was one) hoisted her so high on the political totem pole. In a magazine interview when she was Defence Minister she said she had joined the Anglican Church in an effort to "ward off the evil demons of the Papacy." As for apathetic Canadian voters, she denounced them as "condescending S.O.B.s."

Canada is becoming more Orwellian with every passing day. Ernst Zündel, the

indefatigable anti-Holocauster, having been cleared of all trumped-up charges by the Supreme Court, is still being hounded by Jews, who never forgive and never forget. The Chosen, crusading for more charges to be leveled against him, have staged noisy demonstrations in front of his home, organized sit-ins in front of the Attorney General's office and sent petitions with as many as 6,000 signatures to the Ottawa government.

Meanwhile, Trotskyite-led rent-a-mobs are making it almost impossible for right-wing organizations to do any serious recruiting. When the Heritage Front held a "rock concert" in Ottawa, leftist screaming meemies tried to break it up and succeeded in turning the affair into a riot. By the time the smoke had cleared, the house of a Heritage Front member in Toronto had been trashed and the group's leader, Wolfgang Droege, had been arrested on a weapons charge, jailed and then released on \$15,000 bail. The judge saddled him with a gag order not to speak to or associate with any members of his own organization. The publicity cost him his job in the Ontario bureaucracy. It wasn't the first time he had been in prison. He had spent a total of more than six years in U.S. jails for various sins connected with drugs and guns, and for taking part in a wild and woolly attempt to overthrow the Negro government of Dominica.

After another Heritage Front recruiting drive in the town of Kitchener, the Jewish owners of a Western clothing and gimcrack store claimed they had been insulted and threatened by two rowdy racists wearing Nazi regalia, who were promptly arrested by local police. Two days later they were released when a government attorney told the judge that the Jews admitted they had helped provoke the brouhaha and had made up a great deal of the story. The Jewish clothiers, unlike the young radical rightists they had set up, were not arrested.

Dr. Henryk Fenigstein, an 80-year-old Holocaust survivor, died in Toronto, shortly after pleading guilty to sexual misconduct. The octogenarian psychiatrist had persuaded a young woman patient to have sex with him over a six-year period beginning in 1974.

*From a subscriber.* The "orientation" of Vancouver continues at an ever-increasing pace. At the moment, local rid-

ing associations are nominating candidates for our forthcoming federal election. Chinese and East Indian candidates have found that the fastest road to victory lies in signing up as many of their ethnic comrades as possible and busing them by the hundreds to the nomination meeting. Recently in South Vancouver a Chinese dentist running against a white candidate packed the hall with busloads of his ethnic kin. The white, who tried to win friends by injecting a few Chinese words into his pitch, found himself looking out on a sea of hostile slanted eyes. The Sinitic audience had come to vote the straight racial ticket and wasn't interested in any political overtures from a hairy barbarian. Most got up and went out to make their X before he was halfway through his speech. The victorious dentist declared in his Hong Kong pidgin English, "Thisee is inclusive democracy in action!" Do I need to add that the defeated white candidate has continued to sing the praises of multiculturalism and ethnic diversity?

**Britain.** Winston Churchill's grandson picked a good time to bring up the immigrant issue—he never mentioned Jewish immigrants, of course—as Tory leaders are too confused to do much except dissociate themselves from his controversial ideas. The Party is mysteriously \$31.6 million in debt. At least \$11.6 million of the money which helped Conservative candidates win the recent election is known to have come from dusky or barely white billionaires, one of whom, Asid Nadir, a Turkish Cypriot, recently jumped bail and scooted off to Turkish North Cyprus, the source of his billions, which were mostly stolen from Greeks after the Turkish occupation. Leading Arabs are also quite friendly with Tory leaders, and Chinese Hong Kong Midases have been forthcoming with large political donations. It is odd after 14 years of Tory government during which North Sea oil came on stream, pouring billions into the Exchequer, that the Conservative Party is short of cash. Although many government-owned assets were sold off (privatised), producing more billions of pounds, Brits are now told that the financial situation is so desperate that there will have to be drastic cuts in the National Health, old age pensions and welfare.

## Primate Watch



(Britain)

- The new head of Britain's cloutful Commission for Racial Equality is **Herman Gusily**, a black born in Guyana. One of his first official acts was to have his picture taken with Judge Israel Feinstein, the president of Britain's Jewish Board of Deputies.

- Novelist **Howard Jacobson** chose Easter as the time of year to go on BBC-TV with a playlet that exonerates Judas from the charge of betraying Jesus.

- **Philip Hobsbaum**, professor of English at Glasgow University, has been given a publicity splash of late for being a main inspiration and driving force behind a whole crew of modern British writers. The Jewish professor once composed a poem to a lady friend that contained this deathless, tasteless line: "Truth lies between your legs and so do I."

**France.** Jacques Attali finally got the sack. The top-level Jewish civil servant, the organizer of the bicentennial of the French Revolution, the private counselor of Mitterrand, has lost his job as chairman of the European Bank for Reconstruction and Development. In addition to spending half his bank's annual budget on the decoration of the premises, Attali also had the bank pay him twice for a trip to Japan where he delivered a two-hour lecture for \$30,000. He contends that he

gave this money to charity, but the recipients were revealed to be strictly Jewish charity organizations. Attali's brother is the long-time chairman of Air France.

"Zero immigration" is the exaggerated aim of a bill passed by the French Parliament in mid-June. Jean-Marie Le Pen, leader of the militantly anti-immigration Front National, declared that the law was far too mild. (Some 60% of the 3.6 million foreigners in France come from non-European countries. About 130,000 immigrants enter the country each year, 40,000 illegally.) The fact is that Édouard Balladur, France's Prime Minister, has been stealing a lot of Le Pen's thunder on the immigration issue. Breaking the hard-and-fast rule never to lend any political respectability to the Front National, Balladur invited Le Pen and some of his chief aides to a private meeting. He was the first Prime Minister to do so.

A French court has thrown out Le Pen's slander suit against Paul-Elie Levy who, in the heat of a 1992 election campaign in Nancy, called him "a spiritual son of Hitler, Mussolini and Pétain."

Robert Faurisson, dragged into court with the magazine, Rivarol, for doubting the Holocaust, a crime in France, was warned by the lady judge that the next time he publicly expresses his doubts about the Six Million he'd be sent to jail. The doughty professor replied, "I'm ready to go." The Chosen want the court to fine Faurisson 50,000 francs (\$8,000), the magazine 30,000 (\$4,800).

Alain Guionnet, who edits the somewhat scholarly and very anti-Semitic magazine, Revision, was given a one-year jail sentence in June. So much for free expression in the "democracy" of France.

On June 27, the Front National won an important local election in Nice with 57% of the vote.

**Germany.** Günter Deckert, chairman of the tiny National Democratic Party, was fined 10,000 marks (\$5,600) for serving as an interpreter for Fred Leuchter, the U.S. expert on executions, when he made a speech in Germany last year. Deckert was also handed a one-year prison sentence that was suspended for five years, during which he will have to watch his tongue and curb his pen.

Germany has ended its extremely liberal asylum law which has been largely responsible for the arrival of 2 million aliens since 1989, 438,000 alone last year. From now on illegals will be sent back to the country from which they entered Germany. Air arrivals will be given 19 days to prove they are political and not economic refugees.

*From a subscriber.* Plenty of Germans still fall for the Allied line on WWII history. Plenty don't. Many young people are tired of hearing Jew this, Jew that, and that their fathers and grandfathers were a race of bigoted criminals. This quasi-theology doesn't sit at all well with Germans from the eastern part of the country that was overrun by Soviet troops and ruled by Moscow stooges for half a century. 

*From N.B.F.* A style of music gaining popularity in Europe goes by the name of "Oi," reportedly a greeting used by many British. Oi music, also known as "Nazi Rock," exudes heresy. The lyrics of one song nominate Adolf Hitler for the Nobel Prize. Other ditties urge listeners to "cosh" Pakis, the kind of thing that rap in America urges blacks to do to whites.

Oi is threatening to break out into the rock mainstream in Germany and elsewhere. The effects could be far-reaching. Imagine Americans swamped with their own brand of Oi. Interracial anything would quickly become passé. No more white kids pretending to be black rappers; no more Michael Jackson; no more blacks pawing white women on MTV. Hum! Not a bad idea. Maybe I should start a group. Funky Forrest and his Klan of Renown.

When the police of a major Western nation, Germany, are so scared of white racial movements that they waste their time breaking into people's homes to steal CDs and records, then we are half-way out of our time of troubles. But we shouldn't gloat. The next thing antiwhites may try will be lobotomies, or cutting off ears or tongues. Hell, they may go all the way—burn the stubborn white racists at the stake! Ethnic cleansing in the highest degree! And to make things even cleaner, they will recycle our ashes into soap.

**Austria.** Since 30 UN resolutions were critical or denunciatory of Israel in 1992, the World Jewish Congress at a meeting in Vienna has decided to establish a UN Watch.

**Italy.** From an itinerant subscriber. I was somewhat surprised by the extent of racial differences I found when I crossed the Alps. I had expected the northern Italians to be more like the Austrians and Bavarians. But the examples I saw in Verona, Vicenza and Venice were indistinguishable from primarily southern Italian and Sicilian stock I'm used to seeing in the States. Perhaps things have changed since Carleton Coon's day. No doubt there has been considerable southern Italian immigration to the north. Maybe I should have looked for the true northern Italian type in Milan or Genoa, not Verona and Venice. As it was, I would have to say that the racial distance between Vienna and Venice is much greater than the racial distance between Vienna and Stockholm, despite the geographical distance being much smaller. Most of the Viennese were definitely within the Nordish racial range. As individuals, most would not look out of place if seen walking the streets of Stockholm, although a representative group would be easily distinguishable from a Scandinavian group, as the very distinctive ultra-Nordish types so common among the Scandinavians are rare among the Austrians and Bavarians. But most of the Italians I saw in Verona and Venice were definitely out of the Nordish racial range. The racial difference between them and the southern Germans and Austrians, not to mention the Scandinavians, is striking and profound. I don't think I saw one who would not look obviously out of place in Stockholm. Racially, Berlin is about midway between Stockholm and Vienna, as it is geographically, and as one would therefore tend to expect. But in traveling between Vienna and Venice one takes a racial quantum leap. The Alps have evidently served as a very effective racial barrier. North of the Alps is Nordish country. The south belongs to the Mediterraneanans.

**Serbia.** As noted in the June Instauration, Jezdimir Vasiljevic fled to Israel with what was left of his Belgrade bank's assets. What was not mentioned is that he swindled some 500,000 Serbs out of their life's savings. At one time Vasiljevic owned 16 banks, dozens of farms, a TV station, and a sumptuous Adriatic villa.

The international newspaper, The European, reported that Mossad had smuggled 1,700 Jews out of the various fragments of what remained of Yugoslavia. The quid pro quo was Israeli arms for Belgrade. If true, this means that the Zionist state illegally breached the UN embargo.

**Macedonia.** The U.S. has some 300 troops in this minuscule country, which declared its independence from Yugoslavia in 1991. The Serbs have some strong historical ties to the area. Should they invade, the U.S. would then be in a Balkan war, one more military adventure that in the end would accomplish nothing but the expenditure of vast sums of money and vast numbers of American lives.

When the U.S. is being invaded every day by thousands of Latinos, it might have seemed more reasonable for the 300 American troops to have been sent to guard the borders of Mexico. The Serbs are not menacing the U.S., but Hispanic illegals and the Hispanic birthrate have already conquered large areas of the Southwest and Florida and bid fare to conquer much larger stretches of territory in coming decades. Nevertheless, U.S. troops continue to be stationed everywhere but where they are most needed.

**Russia.** A radio engineer, returning from the Congo with AIDS, was the trigger for infecting 260 babies with the deadly disease in south Russia. He passed the HIV virus along to his wife, who infected their child, who was hospitalized. The doctors then proceeded to infect 260 babies by reusing tainted syringes. Officially Russia has 637 cases of AIDS.

A raggedy group of Russians, who have erected a tent city outside Moscow's television center, waves banners saying, "Russian TV Means TV Without Jews." One of the protesters told a reporter, "Both main TV channels are totally anti-Russian. They don't stand up for our interests." Yuri Luzhkov, the acting mayor of Moscow, has declared the tent city illegal, but so far no one has been rushing to tear it down.

Some faculty members of the University of Madrid have released the latest set

of figures on the "Red Terror" in the Soviet Union from 1917 to 1945: 56 million murdered; 7 million shot and 11 million deaths in labor camps in 1929-35, the bloodiest period, which the Spanish research team said was a greater mass massacre than the Holocaust.

**Israel.** An Israeli publisher has come out with a new book that tells how Jewish gangsters plotted to kill Adolf Hitler in 1933 (Daily Telegraph, March 27, 1993).

The power of the word! Recent archaeological digs along Israel's Mediterranean coast have revealed that the Philistines were a highly cultivated people and far from the boors and barbarians described by the ancient Hebrews in the Old Testament.

Ami Poper, a 24-year-old Israeli, set a record for mass murder in 1990 when he shot and killed seven Arabs and wounded 11 others on a road south of Tel Aviv. On June 23, Sarah Goldberg, 25, daughter of a New York doctor, married Poper in the education center of Ayalon Prison, where he is serving seven life sentences plus 20 years. Close to 70 relatives and friends attended. Prison authorities gave the newlyweds permission to spend their one-night honeymoon alone on the jail grounds. Bride and bridegroom are acolytes of the late Jewish supremacist, Rabbi Meir Kahane.

Using the technique developed by Dr. Ronald Erikson, that separates male and female sperm, Dr. Yisrael Brooke is offering Israeli couples the opportunity to choose the sex of their babies for a \$1,000 fee. Accuracy of 75% to 85% is guaranteed.

What makes the Chosen so chosen? The answer is Jewish genes, says Yehoshua Shteinberger, the man in charge of health affairs of the Haredi Communities:

Of course there are Jewish genes, but they can be improved, they can be made better. We should arrange this matter orderly, and we are working on that. Within five years there will be a great revolution here. We already now conduct genetic examinations before weddings. It is not that our genes are so bad, heaven forbid, obviously the genes of the Goyim are full of many more illnesses, and along the years some of us have been contaminated by all kinds of genetic influences from the Goyim. Our genes must be cleaned and protected from new Gentile influences.

**South Africa.** Pessimists or realists believe South Africa is only two or three decades ahead of the U.S. in the descent



into barbarism. When voting rights are handed over to blacks in April of next year, the country will at worst sink into chaos or at best break up into several black states and a white ethnostate. Whites are already beginning to show signs of meaningful resistance by founding a new organization, the Volksfront, pledged to fight to preserve some semblance of civilization in what is still the most civilized country in all Africa. The head of the Volksfront is Constand Viljoen, who was once the commanding general of the South African Defence Forces, which under his leadership, were noted for inflicting severe punishment on Cuban troops in Angola.

The World Trade Center in New York was bombed in February. The World Trade Centre in Johannesburg was invaded in June by an armored truck driven by members of the boisterous Afrikaner Resistance Movement (AWB). Trailing behind the truck, hundreds of whites, some with babies, filed into the convention hall where renegade whites and African National Congress semi-savages were sketching out a new constitution.

It is interesting to note that rich whites in South Africa are pushing for a black-run nation. Poor and working-class whites are ferociously against any such change. The white workers are the bedrock of South Africa's infrastructure. If black racism, as now seems possible, manages to kill them off or chase them out of the country, South Africa will quickly join the Third World.

Signs of the End Times. The first Chosenite in 50 years to be appointed a cabinet minister, Louis Shill, a South African businessman, is the new Minister of National Housing and Public Works. Although billionaire Jews like Harry Oppenheimer own an immodest share of the South African economy, most of the country's 80,000 Jews, fearing the black rule that they are helping to bring about, want to leave—not to Israel but to Australia or Canada.

*From a subscriber.* De Klerk is doing his best to keep up appearances since it is now clear he has lost a great deal of white support. Joe Slovo, the Jewish Communist from Lithuania, who is one of the big bosses of the ANC, is treating the Prime Minister with disdain.

The Volksfront is organizing public meetings all over the country and the audiences are way beyond anything South Africa has ever seen.

I attended the meeting Constand Viljoen addressed in one town. The gist of his speech was that blacks are now fomenting violence in the townships against other blacks, against the Zulus in Natal, and against the whites on the farms, along the highways and in bars. Their aim is to make matters so difficult for de Klerk and the existing order that he will be forced to surrender at the negotiating table. They have already compelled him to accept a one-man, one-vote general election which the African National Congress is bound to win.

The generals and the Volksfront are mobilizing whites all over the country. Certain "passive resistance" actions will be organized soon. In the meantime, men and women are arming themselves and learning how to handle their weapons.

Our enemies in the outside world are not going to walk over us as they did in the case of "colonialist" white communities elsewhere in Africa.

**Gabon.** An African-American summit in this bankrupt country in late May was attended by 1,000 delegates, including Louis Farrakhan, Virginia Governor Wilder and the widow King. Rev. Jesse Jackson, who manages to worm his way into any meeting that could give him some publicity, called on Western countries to come up with a huge package of reparations for slavery. Though he didn't say so, Jesse seemed to hint that if Jews can play the reparations game, why can't blacks? Warmly applauded for his plea for reparations, which was dutifully picked up by the American press, Jackson congratulated the current dictator of Nigeria, General Olusager Obisayo, for his "efforts at democracy," assuring him, "You are our friend."

Back in the United States, Rev. Jackson, having urged District of Columbia residents not to pay their taxes until it becomes a state, has been ordered by the Federal Election Commission to repay \$122,031 of expenses he couldn't account for in his 1988 presidential election campaign.

**Ivory Coast.** A court in Abidjan has sent three self-confessed cannibals and witches to jail for seven years. The three were charged with eating four people,

one of them a boy. The cannibal/witch accused of eating the boy said she had not killed him for food, but had only gobbled him up after he had died of an illness.

**Caribbean.** A retired military friend who teaches shop at a Puerto Rican high school asked his students why they were so eager to learn how to repair automobiles. The chorused reply: "So we can earn lots of money stealing cars on the Mainland."

When St. Croix was flattened by a tropical hurricane last year, nearly the entire populace, including all but one or two of the local police, proceeded to loot every shop, market and warehouse on the island. The FBI, summoned to restore a modicum of order, initiated an island-wide, house-to-house search for the mountains of filched appliances, furniture and clothing. The G-men, however, didn't figure on the split loyalties of the St. Croix National Guard, which had truck-lifted the bulk of the incriminating evidence safely out to the local dump (making prosecution a practical impossibility). In what must rank as a low-point in Caribbean cravenness, the (white) head of the island's Rotary Club dismissed the looting as the logical reaction to a threat posed by the storm: "These people can't be blamed. Who knows how long that storm might have lasted!"

**Australia.** White primary school children in Queensland will be taught to call themselves "Gubbaoriginals," in line with the new compulsory studies course.

*From a subscriber.* We've been having a bit of fun over here. The federal government is proposing a "race hate" law, presumably similar to the one with which Canada is blessed. This is simply a pre-election bribe to the Zionist lobby. The forces of light have succeeded in making a song and dance about it at public hearings, in letters to the editor and on talk-back radio. This has opened up cracks in the Jewish community, with the more moderate ones realizing that their Zionist leaders have overplayed their hand.

Then hot on the heels of all this—and for the same reason—the government banned a proposed visit by David Irving. In the resulting hullabaloo, every major daily in the country editorialized against this censorship. Several of them featured articles on the disproportionate power of Jews in Australia. Now some of the Zionists are being challenged by moderates from within their own ranks.
